Fire Brigades Act, 1942-1951. ORDER IN COUNCIL.

Ex. Co. No. 1426.

WHEREAS it is enacted by section 5 of the Fire Brigades Act, 1942-1951, that the municipal and road districts mentioned in the Second Schedule to the said Act are, for the purposes of the Act, constituted fire districts by the names as in the said Schedule stated, and that the Governor may by Order in Council, inter alia, unite the districts of or portions of the district of two or more local authorities with any portion or portions of another or others into one fire district by such name as the Governor may think fit; and whereas it is deemed to be desirable and expedient to enlarge the Albany Fire District as mentioned in Part IV

of the Second Schedule to the Act by adding portion of the Albany Municipal District: Now, therefore, His Excellency the Lieutenant-Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby, for the purposes of the Act, reconstitute the Albany Fire District as mentioned in Part IV of the Second Schedule to the Act by including in the Albany Fire District as part thereof those portions of the land comprised in the Albany Municipal District which are more particularly defined and described in the Schedule hereunder.

Schedule

Fire District and Portion of Albany Municipal District to be included in Albany Fire District.

Albany—All that portion of land bounded by lines starting at the intersection of the Eastern side of Seawolf Road and the high water mark of Princess Royal Harbour and extending generally South-Westerly along that high water mark to a point in prolongation South-Easterly of the centre line of the Drain Reserve passing along the South-West-ern boundaries of lot 134 of Plantagenet Location 33, as shown on Land Titles Office Deposited Plan 3571; thence generally North-Westerly to and along that centre line to the South-Eastern side of the South Coast Road; thence Westerly, crossing that road to the intersection of its North-Western side and the centre line of the Drain Reserve aforesaid; thence generally Westerly along that centre line to the South-Eastern side of Robinson Road; thence North-Easterly along that side to a point in prolongation Southerly of the Easternmost boundary of Gledhow Townsite; thence Northerly to and along that boundary to the centre of Cuming Road; thence Easterly, Northerly and again Easterly and Northerly along the centre line of Cuming Road, Cull Road, Marbellup Road and Le Grand Street, respectively, and onwards to the centre of Drome Road; thence Easterly and South-Easterly along the centre line of that road and the Albany Highway to a point in prolongation Westerly of the Northern boundary of reserve 936; thence Easterly to and along that boundary to the South-Eastern corner of location 135; thence Northerly along the Eastern boundary of that location to the centre of Bronte Street; thence Easterly, North-Easterly, generally, South-Easterly, and generally. The Land Act, 1933-1950. ORDER IN COUNCIL.

The Country Towns Sewerage Act, 1948. Albany Sewerage Areas—Reticulation Area No. 1.

ORDER IN COUNCIL.

P.W.W.S. 356/48.

WHEREAS by the Country Towns Sewerage Act, 1948, it is enacted that subject to the provisions of the said Act the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend works, and whereas it is provided by Section 12 of the said Act that the Governor may exempt works from certain sections of the said Act. Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, and of all other powers in this behalf enabling him, doth hereby approve of the construction by the Minister for Water Supply, Sewerage and Drainage of the following works under the said Act, and doth hereby exempt such works from the operation of Sections 12, 13, 14 and 15 of the said Act.

Description and Location of Reticulation Works Approved and Exempted.

A six-inch diameter reticulation pipe sewer commencing at a new manhole No. 71A situated in part lot 4 of S.129 Serpentine Road, 3ft. from its Eastern boundary and 152ft. from the Southern boundary of Serpentine Road and proceeding in a Northerly direction parallel to and 3ft. from the said Eastern boundary of part lot 4 into and through part lot 3 of S.129 to an inspection opening 3ft. within the Southern boundary of part lot 2 of S.129 a total distance of 56ft.

Also a six-inch diameter reticulation pipe sewer commencing from an existing inlet at manhole No. 71 situated in the North-West corner of part lot 4 of S.129 and proceeding in a North-Westerly direction into and through lot 2 of S.128 Serpentine Road, across the R.O.W. being part of the said lot 2 and into lot 1 of S.128 Serpentine Road to an inspection opening a total distance of 108ft.

This Order in Council shall take effect from the 28th day of August, 1952.

Amendment of Regulations.

C.S.D. 362/51; Ex. Co. No. 1422.

THE Fremantle Harbour Trust Commissioners, acting pursuant to section 65 of the Fremantle Harbour Trust Act, 1902-1951, hereby amend the regulations made by them and in force under the said Act, as published in the Government Gazette of the 5th day of September, 1934, and amended from time to time thereafter (reprinted by the Government Printer with all amendments to the 25th day of January, 1952), and since further amended by notices published in the Government Gazette on the 16th day of May, 1952, in the manner mentioned in the Schedule hereunder:—

Schedule.

The abovementioned regulations are amended as follows:-

- 1. By inserting before the word "No" in line one of Regulation No. 305 the letter "a" in brackets thus "(a)"; and
 - 2. By inserting in Regulation No. 305 a new paragraph (b) as follows:—
 (b) Notwithstanding anything contained in paragraph (a) of this Regulation, no person in charge of any vehicle shall cause or permit the vehicle to stand within 3ft. 6in. of any railway line which is constructed on the South side of Victoria Quay Roadway and which connects with other railway lines on the roadway.

BUNBURY HARBOUR BOARD ACT, 1909-1928.

Amendment of Regulations.

Resolution.

C.S.D. 337/49; Ex. Co. No. 1425.

THE Bunbury Harbour Board, acting pursuant to section 61 of the Bunbury Harbour Board Act, 1909-1928, hereby amends in the manner mentioned in the Schedule hereunder, the regulations made by the said Board under and for the purposes of the said Act, as published in the Government Gazette of the 26th day of November, 1909, and amended from time to time thereafter by notices published in the Government Gazette.

ALBANY HARBOUR BOARD ACT, 1926.

Albany Harbour Board-Resolution.

C.S.D. 81/50; Ex. Co. No. 1420.

THE Albany Harbour Board constituted under and by virtue of the Albany Harbour Board Act, 1926, and acting pursuant to section 61 of the said Act doth hereby amend the regulations made by them and in force under the said Act, as published in the Government Gazette of the 30th day of March, 1951, in the manner mentioned in the Schedule hereunder:—

Schedule.

The abovementioned regulations are amended as follows:-

- 1. By adding the following additional notes to Regulation No. 74:-
 - (14) Wharf Haulage on vehicles, tractors, agricultural machines or similar items occupying separate rail trucks shall be charged at a minimum of five tons per four-wheeled or 10 tons per eight-wheeled truck used. When Railway ropes are used to secure the vehicles or machines, charges shall be at 2s. per rope.
 - (15) Fuel Oil upon which a full inward wharfage rate of 5s. per ton has been paid shall, upon being subsequently bunkered for a vessel's own use, be granted a rebate of 50 per cent. of such wharfage.
- 2. By adding the following new regulation after Regulation No. 98.

No. 98a. Handling Charges in Special Cases.—When any variation occurs in the method of or in the conditions relating to the handling or custody of cargo whereby the complete service as contemplated by or defined in these Regulations is not rendered by the Board, or when any handling service not defined by Regulation is required, the Secretary shall determine the appropriate rate or amount of handling charges payable in each case.

- 3. By adding the following new regulation after Regulation No. 122:—
 No. 122a. Notwithstanding any thing contained in regulations numbers 121 and 122, the Secretary may—
 - (1) where handling services may be advantaged generally upon the wharves or in sheds by the non-removal of any particular goods within the prescribed period before storage charges become payable, or
 - (2) where such non-removal is conducive to the free flow of other goods, or
 - (3) where such non-removal is of advantage to the Board, or
 - (4) where excessive overtime is worked by vessels, including Sundays or public holidays, to the detriment of the ordinary delivery of cargo, or
 - (5) in the case of goods permitted to be placed on wharves or in sheds to await shipment,

grant such an extension of the period prescribed for the removal of the goods, either generally or in particular, by such length of time as, in his opinion, is justifiable and reasonable in the circumstances, or he may, in his discretion, determne that some lesser rate or rates of storage charges than those prescribed in these regulations, shall be payable in respect of any particular goods, whether awaiting shipment or delivery elsewhere.

4. By adding the following new section after Regulation 273.

Cranes and Mechanical Appliances.

No. 274—Applications.—Every person desiring to use any crane or any mobile cargo handling plant of the Board shall make application at the Office of the Board on the form provided, and, as far as possible the cranes or other appliances shall be available for use in the order of the applications received and as near to the time specified in such application as can be arranged. The Members shall not be bound to supply any crane or appliance at any time to any applicant.

All charges for hire shall be payable when making application, and shall be at the rates prescribed hereinafter.

The Secretary may at any time re-allocate the cranes or plant or remove a machine from any hirer if, in his opinion, conditions require such action.

No. 275—Calculation of Hire.—Hire shall be payable from the time at which the crane or plant is ordered to be ready for work and shall continue until the officer in charge of the machine has been informed by the hirer that it is no longer required. Should a crane require to be shifted for the convenience of the hirer the hirer shall pay the labour costs of shifting, in addition to the hire charge.

In the event of an applicant for hire of any crane or plant not being ready to make use thereof at the time mentioned in his application, he shall lose his turn if another applicant is waiting for or ready to use the crane or plant. The minimum charge for continuous work in respect of each application shall be as for two hours hire for other than steam crane for which the minimum shall be as for four hours hire.

No. 276. The Members shall not be liable for any loss or expense incurred by applicants for cranes or plant owing to the machines not being available for hire at the time appointed.

No. 277. Any expense incurred through the failure of an applicant to make use of the crane or plant at the time appointed shall be paid by the applicant.

No. 278. Hirers of cranes or other plant shall be responsible for and indemnify and keep indemnified the Members from and against all actions, claims, proceedings, demands, costs and expenses in respect of any loss, damage or injury caused or suffered by or through or arising out of the working of the crane or plant.

No. 279. The Members will work the cranes or plant but will not supply nor accept any responsibility for the safety of slings for lifting cargo out of or into vessels. The Members will supply a driver for each crane or appliance hired, who will, as far as possible and consistent with safety, be subject to and obey the instructions of the hirer, his stevedore or agent, but the Members shall not be liable for any loss or damage whatever which may occur while such driver is operating the crane or plant during the period of hire, unless such loss or damage is proved to be the direct result of wilful misconduct or wilful disobedience of any reasonable order on the part of the driver.

No. 280. The cost over and above the ordinary cost of day work, of all labour and supervision employed by the Board in connection with the working of cranes or plant during other than working hours of the Port, as defined by these Regulations, whether in continuous work or special lifts, as per scale hereunder, shall be paid to the Board by the hirer in addition to the amount set down for the hire of the crane or plant.

No. 281. No person shall tamper with any crane or plant or any of the electric mains or connections or other portions of the electrical equipment, or climb about any crane or plant.

No. 282. All lifts of over three tons weight shall be specially arranged for and shall be charged for as special lifts.

No. 283.—Scale of Charges for Hire of Cranes and Mobile Cargo Handling Plant, including driver and power:—

- (1) Continuous work in loading or unloading vessels, or in handling goods on wharves or in sheds, or handling goods into or out of vehicles, or for other purposes approved by the Secretary, to include in each case all lifts up to computed three tons weight, per hour or portion thereof, £1; minimum two hours.

WHEREAS under the provisions of the Health Act, 1911-1950, a local health authority may make or adopt by-laws and may amend, repeal or alter any by-laws: Now, therefore, the Municipality of Cottesloe being a local health authority and having adopted Model By-laws Series "A" as published in the Government Gazette on the 8th day of April,

1927, and other subsequent dates as its by-laws for the Cottesloe Health District, doth hereby amend its said by-laws as follows:—

By adding after by-law 35 of Part I of Model By-laws a new sub-heading as follows:—

Repairs to Houses.

- 35. (a) The owner of every house used for human habitation shall maintain such house and any laundries, bathrooms, lavatories attached to or used in connection therewith in good-order and condition and properly repaired and fit for use and in particular shall:—
- 1. Repair or replace any roof or part thereof which shall become in disrepair.
- 2. Repair any brick or stone work which shall show signs of fretting and treat or repair any walls which may become damp.
- 3. Replace all decayed or ant-eaten timber therein.
- 4. Repair and replace with new material where necessary any verandah or the roof, floor supports or other parts thereof which may become in disrepair.
- 5. Repair and replace where necessary any steps or handrails thereof which may become in disrepair.
- 6. Repair or replace any fiashings which may become in disrepair.
- 7. Replace any ant stops which shall be miss-
- ing or in disrepair.

 8. Repair or renew any ventilators which shall become in disrepair or be missing.
- 9. Keep all floors even in surface and free from
- cracks.

 10. Replace or repair all skirtings, architraves and fixtures, which may become a harbourage for vermin.
- 11. Keep all walls and the plaster and wall paper thereon in good repair, and repair any cracks and renew any plaster or wallpaper which may become dilapidated or in disrepair.
- 12. Refit and repair any doors which may become in disrepair or which shall cease to fit properly.
- 13. Repair or replace with new, any window frames or sash cords which may become broken or in disrepair and re-glase any windows which may become broken or cracked.
- 14. Keep all water service in such state of repair and condition as shall comply in all respects with all of the provisions of the Metropolitan Water Supply, Sewerage and Drainage Act and Regulations and by-laws made thereunder.
- 15. Keep all electric wiring and fittings in such state of repair and condition as shall comply in all respects with all of the requirements of the Fire Underwriters' Association of W.A.

Retain all natural lighting free from any obstruction which would reduce the natural lighting below the ratio of one square foot of lighting to each 10 square feet of floor area.

This subclause shall not apply in cases where it is customarily for an employee to return to his employer's premises to perform a specific job outside his ordinary working hours, or where the overtime is continuous (subject to reasonable meal break) with the completion or to reasonable meal break) with the completion or commencement of ordinary working time.

Clause 6.—Sunday and Holiday Work.
