WHEREAS by sections 223 and 225 of the Municipal Corporations Act, 1906-1947 (6 Edward, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the *Government Gazette*, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a public highway within the meaning of any law now or hereafter in force; and whereas the City of Perth has requested that certain land named and described in the Schedule hereunder which has been used for a street or way within the City of Perth, be declared a public highway: Now, therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be a public highway, and such land shall, from the date

of this Proclamation, be absolutely dedicated to the public as a highway within the meaning of any law now or hereafter in force.
