PRICES CONTROL ACT, 1948-1951. Prices Control Order No. 757.

Scrap Copper.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

This Order may be cited as Prices Control Order No. 757.

Revocation.

Prices Control Order No. 551 is hereby revoked.

Maximum Price.

3. I fix and declare the maximum price at which scrap copper may be sold by any person to be £300 per ton.

Variation of Maximum Prices by Notice.

4. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which scrap copper specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

Virgin Zinc.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:-

Citation.

1. This Order may be cited as Prices Control Order No. 758.

Revocation.

2. Prices Control Order No. 294 is hereby revoked.

Definition.

3. In this Order, unless the contrary intention appears-

"prevailing margin" means in relation to virgin zinc, the margin for any particular quality, quantity or shape, or in respect to any particular term or condition of sale, that existed between the price of £22 per ton and the particular vendor's selling price on 31st December, 1948, of virgin zinc of that particular quality quantity or shape that particular quality, quantity, or shape, or sold under that particular term or condition of sale.

Maximum Prices.

I fix and declare the maximum price at which virgin zinc may be sold by any person to be £95 per ton, plus the prevailing margin where that person's selling price on 31st December, 1948, was greater than £22 per ton, or minus the prevailing margin where that person's selling price on the aforesaid date was less than £22 per ton, as the case may be.

Variation of Maximum Price by Notice.

Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which virgin zinc specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that

Definition.

"prevailing margin" means, in relation to virgin pig lead, the margin for any particular quality, quantity, or shape, or in respect to any particular term or condition of sale, that existed between the price of £22 per ton and the particular vendor's selling price on 31st December, 1948, of virgin pig lead of that particular quality, quantity or shape, or sold under that particular term or condition of sale.

I fix and declare the maximum price at which virgin pig lead may be sold by any person to be £95 per ton, plus the prevailing margin where that person's selling price on 31st December, 1948, was greater than £22 per ton, or minus the prevailing margin where that person's selling price on the margin where that person's selling price on the aforesaid date was less than £22 per ton, as the case may be.

Variation of Maximum Price by Notice.

Bread rolls.

Smoothing irons, domestic.
Ball and roller bearings of all types, and parts thereof.

Carbide of calcium.
Paint and varnish removers.
Paints and colours, including—

(a) colours in oils;

(b) distempers;

(c) enamels;

(d) kalsomine;

(e) lacquers;

(f) water paints.

Patent dryers.

Resins, including synthetic resins.

Shellac, sandrac, mastic and other dry gums.

Thinners.

Varnishes and oil stains.

Waterproofing compounds.

White lead.

Bags, sacks, packs and bales, excluding bags made from calico.

Battery boxes.

Batteries, dry. Batteries, lead acid storage and components thereof.
