### PRICES CONTROL ACT, 1948-1951.

Prices Control Order No. 777.

Rubber Garden Hose.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantine Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

#### Citation.

1. This Order may be cited as Prices Control Order No. 777.

#### Revocation.

2. Prices Control Order No. 604 is hereby revoked.

#### Definition.

3. In this Order, unless the contrary intention appears, "Perth Metropolitan Area" means all that area of Western Australia comprised within a radius of 12 miles from the General Post Office at Perth.

#### Maximum Retail Prices.

4. I fix and declare the maximum price at which any type or description of rubber garden hose specified in the first, second and third columns of the Schedule to this Order may be sold by retail to be—

- (a) in respect of sales by any person whose place of business is situated in the Perth Metropolitan Area—the price specified in the fourth column of that Schedule;
- (b) in respect of sales by any person whose place of business is situated outside the Perth Metropolitan Area—the price specified in the fourth column of that Schedule, plus one half-penny per foot.

#### Exhibition of Price Tickets.

5. (1) Every person who has for sale by retail rubber garden hose the maximum price of which is fixed by or under the provisions of this Order, shall attach to or display with those goods a ticket or label setting forth his selling price thereof.

(2) Any ticket or label required by subparagraph (1) of this paragraph to be attached to or displayed with rubber garden hose shall be in such form as to be easily legible to any person inspecting or viewing those goods and as to be properly associated with such goods.

### Variation of Maximum Price by Notice.

6. Notwithstanding the foregoing provisions of this Order, I declare the maximum price at which any rubber garden hose specified in a notice in pursuance of this paragraph may be sold by any person to whom such notice is given to be such price as is fixed by the Commissioner by notice in writing to that person.

PRICES CONTROL ACT, 1948-1951.

Prices Control Order No. 778.

Cement Tiles, Cement Ridgecaps, Cement Shell Ends, Cement Apex Pieces and the Fixing and Constructing therefrom of Roofs for Buildings.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantine Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 778.

Revocation.

2. Prices Control Order No. 686 is hereby revoked.

Definition.

3. In this Order, "Perth Metropolitan Area" means all that area comprised within a radius of 20 miles from the General Post Office at Perth.

Maximum Prices—Cement Tiles, Cement Ridgecaps, Cement Shell Ends, Cement Apex Pieces.

4. I fix and declare the maximum price at which any of the types or descriptions of cement tiles, cement ridgecaps, cement shell ends and cement apex pieces specified in the first column of the First Schedule to this Order, and of the colours specified in the second column of that Schedule may be sold by any person to be the price set out in the third column of the First Schedule opposite to each such type or description and colour.

Maximum Rates—Supply of the Service of Fixing or Constructing Roofs from Cement Tiles, Cement Ridgecaps, Cement Shell Ends and Cement Apex Pieces.

5. I fix and declare the maximum rate at which any person may supply the service of fixing or constructing a roof from cement tiles, cement ridgecaps, cement shell ends and cement apex pieces, which are not supplied by that person to be—

- (a) in respect of a roof for any building upon any building site situated within the Perth Metropolitan Area—25s. per 100 square feet of roof;
- (b) in respect of a roof for any building upon any building site situated outside the Perth Metropolitan Area—27s. 6d. per 100 square feet of roof:

Provided that the rate fixed by this subparagraph may be increased by an amount being the cost actually incurred and properly recorded in his books of account by that person in respect of—

- (i) travelling from his place of business to the building site, and
- (ii) board and lodging other than his normal board and lodging during the period actually worked in fixing or constructing the roof,

of any person actually engaged in fixing or constructing such roof.

Provided further that any rate fixed by this paragraph shall include the nailing of battens, the wiring or nailing of tiles, and the cementing of ridgecaps, apex pieces and shell ends.

Maximum Rates—Supply of Cement Tiles, Cement Ridgecaps, Cement Shell Ends and Cement Apex Pieces, and the Fixing or Constructing therefrom of Roofs.

6. I fix and declare the maximum rate at which any person may supply the service of supplying cement tiles, cement ridgecaps, cement shell ends and cement apex pieces of any of the colours specified in the first column of the Second Schedule to this Order, and from such goods fixing or constructing a roof, to be—

- (a) in respect of a roof for any building upon a building site situated within the Perth Metropolitan Area—the rate specified in the second column of the Second Schedule opposite such colour set out in the first column thereof;

(b) in respect of a roof for any building upon a building site situated outside the Perth Metropolitan Area where such service is supplied by any person whose place of business is situated within the Perth Metropolitan Area—the rate specified in the second column of the Second Schedule opposite such colour set out in the first column thereof:

Provided that the rate fixed by this subparagraph may be increased by an amount being the cost actually incurred and properly recorded in his books of account by that person in respect of—

- (i) travelling from his place of business to the building site, and
  - (ii) board and lodging other than his normal board and lodging during the period worked in fixing or constructing the roof,
- of any person actually engaged in fixing or constructing such roof;
- (iii) cartage to the building site of tiles and other materials used in fixing or constructing such roof.

Provided further that any rate fixed by this paragraph shall include the supplying of all cement, battens, nails and wire used in the fixing or constructing of any roof.

**Delivery of Invoices or Dockets.**

7. Any person who sells any cement tiles, cement ridgecaps, cement shell ends or cement apex pieces shall deliver with those goods an invoice or docket specifying the following particulars:—

- (a) His name and place of business.
- (b) The name and address of the purchaser of the goods.
- (c) The date of sale of the goods.
- (d) A full description and quantity of each item of goods sold.
- (e) The price charged for each item of goods sold.
- (f) The total amount charged for each item of goods sold.

**Variation of Maximum Prices or Rates by Notice.**

8. Notwithstanding the foregoing provisions of this Order—

- (i) where in any notice in writing to any person in pursuance of this paragraph—
  - (a) a maximum price is fixed in relation to the sale of cement tiles, cement ridgecaps, cement shell ends and cement apex pieces; or
  - (b) a maximum rate is fixed for the service of supplying cement tiles, cement ridgecaps, cement shell ends and cement apex pieces, and from such cement tiles, cement ridgecaps, cement shell ends and cement apex pieces, the fixing or constructing of a roof for any building; or

(c) a maximum rate is fixed for the service of fixing or constructing a roof for any building from cement tiles, cement ridgecaps, cement shell ends, and cement apex pieces which are not supplied by that person;

I declare the maximum price at which such goods may be sold, or the maximum rate at which such service may be supplied, to be such price or rate as is fixed by the Commissioner by notice in writing to that person;

(ii) where any notice in writing fixing a maximum price or rate, for any of the goods or services covered by this Order was given in pursuance of any Order which was by virtue of the Prices Control Act, 1948-1951, in force immediately prior to the commencement of this Order, that notice in writing shall be deemed to have been given under this Order and shall continue in full force and affect.
