ORDER IN COUNCIL.

WHEREAS by the Forests Act, 1918, it is provided that a dedication under the said Act of Crown Land as a State Forest may be revoked in whole or in part in the following manner:—

(b) After such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall, by Order in Council, revoke such dedication.

SUPREME COURT ACT, 1935-1950.

The Rules of the Supreme Court, 1909.

WE, the Honourable Sir John Patrick Dwyer, K.C.M.G., Chief Justice of Western Australia, the Honourable Albert Asher Wolff, the Honourable James Leonard Walker, the Honourable Lawrence Walter Jackson and the Honourable John Evenden Virtue, Puisne Judges of the Supreme Court of Western Australia, acting in pursuance of the powers contained in the Supreme Court Act, 1935-1950, and of every other power enabling us in this behalf, do hereby

amend the Rules of the Supreme Court, 1909, in the manner hereinafter mentioned, and declare that such amendments shall come into operation on the 21st day of December, 1952.

Order IX is amended as follows:—

1. Strike out rules 1 and 2 and insert the following:—
 1. The writ shall be served on the defendants in person, or, if there are more defendants than one, on each defendant in person.
 2. Service may be effected by delivering to the defendant a copy of the writ and statement of claim and offering to produce the original. If the defendant refuses to receive the copy it shall be good service if the copy is brought to his notice.
 3. Where a solicitor has undertaken in writing to accept service on behalf of any defendant or defendants such defendant or defendants may be served by delivering during business hours at the office of the solicitor for all the defendants for whom such solicitor accepts service one copy of the writ and statement of claim.
 4. The writ may be served by the proper officer of the Court or by the plaintiff or any person employed by the plaintiff for that purpose.
2. The remaining rules of the Order are re-numbered 5 to 9 consecutively.

Order LXIV is amended as follows:—

Rules 1 to 13 are rescinded and the following new rules are made:—

1. The time prescribed by these rules or fixed by any order may be enlarged or abridged by the Court with or without terms, or by consent in writing of the parties concerned, notwithstanding that in any case the time has expired.
2. Where clear days are prescribed by these rules or fixed by any order the time shall be reckoned exclusively of the first and the last day. Where any number of days not expressed to be clear days is prescribed or fixed the time shall be reckoned exclusively of the first and inclusively of the last day.
3. Where less than seven days is prescribed by these rules or limited by any order for doing any act any day on which the Central Office is closed for business shall not be reckoned.
4. Where the time prescribed by these rules or limited by any order for doing any act expires on a day on which the Central Office is closed for business and in consequence such act cannot be done on that day the time shall be extended to the day on which the Central Office shall next be open.
5. In the computation of time for filing delivering or amending any pleading subsequent to the statement of claim the period or any part of the period which is between the 24th December and the 5th January next following shall not be reckoned unless the Court orders.
6. Where any security is ordered to be furnished by a party the time prescribed by these rules or fixed by any order for the taking of any step by another party contingent on due compliance with the order for security shall be deemed to be extended by the period between service of the order for security and the furnishing of security.
7. Where no proceeding has been taken in any action or matter for a period exceeding a year a party who desires to proceed shall give one month's notice in writing to every other party. A summons on which no order has been made shall not be deemed to be a proceeding within this rule.
8. An application to set aside or remit an award may be made at any time within twenty-one days after such award has been published to the parties.

HEALTH ACT, 1911-1950.

Mandurah Road Board—Resolution.

P.H.D. 1903/49, Ex. Co. No. 1966.

WHEREAS under the provisions of the Health Act a local authority may make or adopt by-laws and may alter, amend or repeal any by-laws so made or adopted, and whereas the Model By-laws described as series "A" have been prepared and published in the *Government Gazette* on the 4th day of December, 1944: Now, therefore, the Mandurah Road Board, being a local authority within the meaning of the said Act and having adopted the said Model By-laws doth hereby resolve and determine that the said model by-laws shall be amended as follows:—

1. Transfer of Land Act 1893-1950 contained or implied or by reason of the exercise or attempted exercise of any of the powers contained or implied as aforesaid including costs of all solicitors, architects, surveyors, agents or other persons employed by the Commission.

10. Tenthly.—In case of any default in the observance or performance of any of the foregoing covenants it shall be lawful for but not obligatory upon the Commission (without prejudice to or concurrently with any of the powers hereby or by the Transfer of Land Act 1893-1950 granted or implied and all other powers and remedies) to pay such rates taxes assessments or outgoings carry out such regulations notices or orders effect such repairs pay such premiums costs charges and expenses and do all such acts sign and execute such documents and pay such money as in the discretion of the Commission is necessary or desirable for the observance of every such covenant or for the protection of the mortgagee against risk or loss or damage by reason of such default by the mortgagor and all moneys or payments so expended or made and all costs and expenses paid or incurred shall be repayable by the mortgagor to the Commission upon demand and be deemed part of the moneys covered by and a debt under this security and carry interest accordingly at the rate first hereinbefore mentioned until payment.

Eighteenthly.—That all the provisions contained in the Act and regulations relating to advances made under Part VI of the Act and conferring upon the Commission any rights powers authorities and remedies of a mortgagee in respect of the principal sum secured by this mortgage are hereby deemed to be incorporated in and form part of this mortgage as if the same were expressly stated herein.

19. Nineteenthly.—That if the mortgagor shall at any time fail or neglect in any manner or in any respect duly to observe perform and comply with any covenant hereinbefore contained then the Commission may forthwith exercise under this Mortgage all the rights powers authorities and remedies impliedly or expressly conferred upon a mortgagee by the provisions of the Transfer of Land Act 1893-1950 or conferred upon the Commission by the provisions of the Act or by this mortgage and which are exercisable by a mortgagee and by the Commission as a mortgagee in the event of a breach of covenant by a mortgagor or the mortgagor.

That notwithstanding anything elsewhere contained in this Mortgage if at any time it appears to the Commission that an increase in the cost of the building work mentioned in Clause 2 hereof may prevent the mortgagor carrying out the purpose set forth therein (of which matter the Commission shall be the sole judge) the Commission shall notify the mortgagor accordingly and within fourteen days from the receipt of the said notification the mortgagor shall:—

The Treasurer—£195 per annum.

(2) Whenever an officer appointed under the Public Service Act, 1904-1950, or an officer or a teacher appointed under the Education Act, 1928-1943, is appointed to fill any of the offices mentioned in section ten of the National Fitness Act, 1945, or in the preceding regulation, he shall not thereby cease to be an officer under the Public Service Act, 1904-1950, or an officer or teacher under the Education Act, 1928-1943, as the case may be, and, while his appointment under section ten of the National Fitness Act, 1945, continues, he shall, except as otherwise provided by these regulations, retain all rights and privileges and be subject to the same terms and conditions, including the classification of his duties for the purpose of salary and promotion, as he would have been entitled to, or subject to, if his duties, as defined in these regulations, were duties related to his appointment under the Public Service Act, 1904-1950, or the Education Act, 1928-1943, as the case may be; and he shall be paid the relative allowance or allowances mentioned in this regulation in addition to his salary or remuneration as such officer or teacher as aforesaid.
