To Alan Gregory Smith, Esq., Stipendiary Magistrate, of Perth.

I, the said Governor, acting with the advice and consent of the Executive Council, do hereby appoint you, Alan Gregory Smith, to be a Royal Commission to inquire into and report upon allegations against Snowden and Willson Proprietary Limited and Snowden and Willson (Housebuilders) Proprietary Limited or either such Company or against any shareholder or employee of either such Company—

- (1) made or referred to in the speeches, as reported in *Hansard*, of Mr. E. P. Oldfield, M.L.A., in the Legislative Assembly on 17th September and 22nd October, 1952, or
- (2) made to the Commission by any purchaser of land from, or through the agency of either such Company in relation to—
 - (a) any one or more of the terms of the contract of sale relating to the land;
 - (b) the circumstances leading to the making of the contract or under which the contract was entered into or performed, including any inducement, representation, demand or request made to the purchaser, whether concerning money, documents, papers or otherwise;

(c) money charged to the purchaser under, arising out of or connected with the contract or the land or any erection on or work done to the land, including "extras."

And I declare that you shall, by virtue of this Commission, be a Royal Commission within the Royal Commissioners' Powers Act, 1902, as reprinted in the Appendix to the Sessional Volume of the Statutes for the year 1928, and that you shall have the powers of a Royal Commission and the Chairman thereof under that Act.

And I hereby request you as soon as reasonably may be to report to me in writing the result of this your Commission.

The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 829/34.

WHEREAS by section 7 of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is enacted that the Governor may by Order in Council from time to time alter or extend the boundaries of the Metropolitan Water, Sewerage and Drainage Area or of any district; and whereas it is desirable to extend the boundaries of the said area and of the Metropolitan Water and Sewerage District as hereinafter described: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, doth hereby order and declare as follows:—That the boundaries of the Metropolitan Water, Sewerage and Drainage Area, and of the Metropolitan Water and Sewerage District, are hereby extended by including therein the land described in the Schedule hereto:—

Schedule.

All that portion of land bounded by lines starting at the North-Eastern corner of reserve 21815 a point on a Southern boundary of the Metropolitan

Water Supply, Sewerage and Drainage Area, and extending Easterly along that boundary to the North-Eastern corner of Peel Estate Lot 681, a point on the Western side of the tramway reserve; thence generally Southerly along that side to the South-Eastern corner of lot 622; thence Westerly along the Southern boundary of that lot to a point in prolongation Northerly of the Eastern boundary of lot 1055; thence Southerly to and along that boundary and onwards to and along that of lot 1060 to the South-Eastern corner of that lot; thence generally South-Westerly along the Southern boundaries of that lot and the Northern side of road No. 8798 to the South-Westernmost corner of lot 609; thence Southerly along the prolongation of the Western boundary of that lot to the Southern side of road No. 1607; thence generally Westerly along that side to the Western side of road No. 6104; thence generally South-Westerly along that side to the Northern boundary of part of a Southern portion of Cockburn Sound Location 16; thence Westerly along that boundary to the low water mark of the Indian Ocean; thence generally North-Westerly along that low water mark to a point in prolongation Westerly of the Southern boundary of location 700 (part of Commonwealth Reserve 255) a point on a Southern boundary of the Metropolitan Water Supply, Sewerage and Drainage Area and thence generally Easterly and Northerly along boundaries of that area to the starting point, as shown in green on Plan M.W.S.S. & D.D., W.A., No. 7087.

ORDER IN COUNCIL.

M.W.S. 869/25.

WHEREAS the enactment contained in section 74 of the Constitution Act, 1889, whereby the appointment of all public officers under the Government of the State is vested in the Governor in Council does not apply to minor appointments which by Order in Council are vested in the heads of departments or other officers or persons within the State; and whereas it is desirable that the appointment of foremen and all other persons employed at a daily wage on water supply, sewerage and drainage works under the control of the Metropolitan Water Supply, Sewerage and Drainage Department should be vested in various officers: Now, therefore, His Excellency the Governor, by and with the advice of the Executive Council, hereby further amends Schedule appended to the Order in Council gazetted on the 6th April, 1939, by the addition of the names of S. F. Feldman, W. M. Davies and J. H. Rogers and of any person or persons appointed temporarily to act in the place of such officer.

The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 1656/52.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Water Supply Extensions.

Proposed Water Supply to Riverton—North-Western Sector.

The construction of 4in. and 2in. diameter water mains, together with the installation of valves, hydrants and all necessary apparatus, as shown on Plan M.W.S.S. & D.D., W.A., No. 7728.

This Order in Council shall take effect from the 19th day of December, 1952.

Limeburners Creek Catchment Area.

ORDER IN COUNCIL.

Dog Act, 1903-1948.

Mandurah Road Board.

ORDER IN COUNCIL.

L.G. 354/52.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, hereby makes the following Order under the authority of section 35A of the Dog Act, 1903-1948, namely that the Mandurah Road Board are hereby empowered to make by-laws in pursuance of section 35 of the said Act, to have effect within the Mandurah Road Board District, imposing as an absolute prohibition and obligation on the owner of any dog that the dog shall not enter or be in (i) such places as may be prescribed in any circumstances whatever; or (ii) such places as may be prescribed, unless on a leash held by a person. Subject to the conditions that no such by-law shall be valid and effectual unless it has, prior to notification of its making being published in the *Government Gazette* been submitted to and approved by the Governor.

Manjimup Road District.

Re-description of District Boundaries and re-division into Wards.

ORDER IN COUNCIL.

L.G. 420/52.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council under the provisions of the Road Districts Act, 1919-1951, doth hereby—

(1) (a) Re-describe the District Boundaries of the Manjimup Road District as described in Schedule "A" hereto.

(b) Re-divide the Manjimup Road District into six wards with names, and boundaries as described in Schedule "B" hereto.

(2) Consequent upon such re-division declare that the number of members to constitute the Manjimup Road Board shall be thirteen (13) in lieu of ten and doth determine that the thirteen (13) members shall be allocated as follows:—

Manjimup Ward—Three members;
North Ward—Two members;
Pemberton Ward—Two members;
Warren Ward—Two members;
Northcliffe Ward—Two members;
Perup Ward—Two members.

(3) Declare and direct that the existing members for the Warren and Pemberton Wards shall go out of office on the 18th day of April, 1953, on which day an election shall be held for the purpose of returning one additional member for the Manjimup Ward and two members each for the Warren, Pemberton and Northcliffe Wards.

4056 to the latter location's North-Eastern corner; thence Southerly along the Eastern boundary of that location to a point in prolongation Westerly of the Northern boundary of location 6682; thence Easterly to and along that boundary and onwards to the Western boundary of location 3884; thence Northerly and Easterly along boundaries of that location to a point in prolongation Southerly of a Western boundary of location 12099; thence Northerly along that prolongation to a South-Western corner of that location; thence generally Easterly along the Southern boundaries of locations 12099, 3692, 1361, 2186, 3842 and 1337 to a Western boundary of location 3476; thence Northerly, Easterly, Southerly and again Easterly along boundaries of locations 3476 and 3834 to the South-Western corner of location 1648; thence Northerly, Easterly and South-Easterly along boundaries of that location to its Easternmost corner; thence East, crossing the South-Western Highway, to a Western boundary of location 1281; thence generally North-Easterly, Easterly and Southerly along boundaries of locations 1281 and 1214 to the North-Western corner of location 2684; thence Easterly along boundaries of locations 2684 and 2339 to the latter location's North-Eastern corner; thence Southerly, Easterly and again Southerly along boundaries of locations 2339 and 2340 and onwards to the Northern boundary of location 3581; thence Easterly, Southerly, again Easterly, again Southerly and Westerly along boundaries of locations 3581, 2413 and again 3581 to the Western boundary of location 2738; thence Southerly along the Western boundaries of locations 2738 and 2739 to the Northern side of road No. 4959; thence generally South-Easterly along that side to a point in prolongation Westerly of a line joining survey marks HF56 and HF57; thence Easterly to and along that line and onwards to a point in prolongation Northerly of the Eastern boundary of location 2200; thence Southerly to and along that boundary to the North-Western corner of location 10456; thence Easterly and Southerly along boundaries of locations 10456 and 2199 and onwards to a point in prolongation Westerly of the Northern boundary of location 11341; thence Easterly to and along that boundary and onwards to a point in prolongation Southerly of the Eastern boundary of location 5250; thence Northerly to and along that boundary and onwards to a point in prolongation Westerly of the Northern boundary of location 2222; thence Easterly to and along the Northern boundaries of locations 2222 and 3232 and onwards to a point in prolongation Southerly of the Western boundary of location 3537; thence Southerly along that prolongation to the Northern boundary of location 3682; thence Westerly and Southerly along boundaries of that location and onwards to the Northern boundary of location 1784; thence Westerly, Southerly, Easterly, again Southerly and again Easterly along boundaries of locations 1784, 2889, 1693 and 3461 to the latter location's North-Eastern corner; thence Easterly to and along the Southern boundaries of locations 2302, 7115 and reserve 11774 to the South-Eastern corner of that reserve; thence generally North-Easterly along the Northern side of a one-chain road and the Southern boundaries of locations 4496 and 11331 to the latter location's South-Eastern corner; thence generally Easterly along a surveyed track to a point North of a point on the Northern boundary of location 5053 and situate 18 chains Westerly from the South-Western corner of location 863; thence South to the Northern boundary of location 5853; thence Easterly along boundaries of locations 5853 and 863 to the latter location's Easternmost corner; thence North-Easterly to the South-Western corner of location 785; thence Easterly along the Southern boundary of that location to its South-Eastern corner; thence North-Easterly to the North-Western corner of location 7979; thence generally Southerly along the Western boundaries of that location to the Northern boundary of location 7980 (reserve 11745); thence Westerly, generally Southerly and Easterly along boundaries of that location to the North-Western corner of location 7978; thence generally Southerly, South-Westerly, generally North-Westerly and again generally Southerly along boundaries of locations 7978, 7977, 6432, again 7977 and 7976 and onwards to the Northern side of road No. 405; thence generally South-Easterly along that side to a point in prolongation

Northerly of the Eastern boundary of location 7708; thence Southerly, Easterly, again Southerly and Westerly to and along boundaries of locations 7708 and 7709 to the Eastern boundary of location 7095; thence Southerly and Westerly along boundaries of locations 7095, 7094 and 7710 and onwards to the North-Eastern corner of location 7705; thence Southerly along the Western side of a one-chain road passing along the Eastern boundaries of locations 7705 and 7707 to its intersection with Poorginup Gully; thence generally South-Easterly along that gully to the right bank of the Frankland River; thence generally Southerly downwards along that bank to a point in prolongation Southerly of the Western boundary of location 4172; thence Southerly along that prolongation, crossing the Frankland River, to its left bank; thence generally Westerly and South-Westerly along that bank and the shores of Nornalup Inlet to the low water mark of the Southern Ocean; thence generally North-Westerly along that low water mark to the left bank of the Donnelly River; thence generally North-Easterly upwards along that bank and that of Carey Brook to the Northern side of road No. 116; thence generally North-Westerly along that side to a point in prolongation Westerly of the Southern boundary of location 1178; thence Easterly and Northerly to and along boundaries of that location to its North-Eastern corner; thence North-Easterly to the South-Eastern corner of reserve 3; thence Northerly, Easterly and again Northerly along boundaries of that reserve and location 3694 and onwards to the right bank of the Donnelly River aforesaid; thence generally North-Easterly upwards along that bank to a point in prolongation Southerly of the Western boundary of location 6165; thence Northerly to and along that boundary to the North-Western corner of that location; thence Northerly and Easterly to and along the Western and Northern boundaries of locations 6162 and 6161 to a point in prolongation Southerly of the Western boundary of location 6163; thence Northerly to and along that boundary to the North-Western corner of that location; thence North-Easterly to the South-Western corner of location 6178; thence Northerly, Easterly and again Northerly along boundaries of that location to its North-Western corner; thence North-Easterly to the South-Westernmost corner of location 6179; thence Northerly, Easterly and again Northerly along boundaries of that location and onwards to the Southern boundary of late Timber Lease 61/11; thence Easterly and Northerly along boundaries of that late timber lease to the South-Western boundary of location 4047 and thence North-Westerly and generally North-Easterly along boundaries of that location to the starting point, inclusive of adjacent islands.

By-laws for the Management and Use of the
Port Hedland Hall.

L.G. 646/52.

WHEREAS by the Road Districts Act, 1919-1951, the Road Board of any district is empowered to make by-laws for all or any of the purposes mentioned in the said Act; and whereas the Port Hedland Road Board in pursuance of the powers vested in the said Board under and by virtue of the said Act and of every authority enabling it in that behalf, doth hereby make and publish the following by-laws:—

1. Interpretation Clause.—In the construction of these by-laws:—

- (a) the word "Board" shall mean the Port Hedland Road Board;
- (b) the word "Hall" unless otherwise stated, shall mean the Port Hedland Hall and shall include any room, corridor, porch, verandah or annexe of such hall;
- (c) the word "chairman" shall include a vice-chairman or person acting in that behalf;
- (d) the word "secretary" shall mean the secretary of the Board or any duly authorised person acting in that behalf;
- (e) the word "hirer" shall mean the person whose signature appears on the application form for use of the hall, or any organisation or club, association, committee, etc., for whom such person signs as agent.

2. Application for the use of the hall or any portion thereof shall be made in Form 1 of these by-laws and such application shall be accompanied by a deposit of one pound (£1). All applications must be made to the secretary.

3. The hire fees shall be as set out in the Schedule to these by-laws.

4. In the event of two or more applications being received for hire of the hall and furniture at the same date and hour, the Board may, without considering priority of application, determine to which applicant the hire of the hall shall be granted.

5. (a) The hirer shall comply with the provisions of the Entertainment Tax Act, and any other Act in force for the time being applicable to the hirings and use of the hall. If in the opinion of the Board all the necessary actions have not been taken to comply with the provisions of the Acts abovementioned the Board may at any time prior to or during the term of the engagement forbid and prevent the use of the hall.

(b) The hirer must accept full responsibility, in the event of any dispute arising in connection with compliance with the provisions necessary under this by-law.

(c) In the event of the use of the hall being forbidden or prevented under this by-law, the hirer shall forfeit the full amount paid for the hire of the hall, as if the hire had been duly fulfilled, and the Board shall not be responsible for any loss or damage thus sustained or incurred by the hirer.

6. The Board may at any time demand that the hirer shall, prior to the term of engagement, deposit an amount decided by the Board and sufficient to cover any cleaning that might occur during the term of such engagement, and upon such demand being made, the hirer shall immediately deposit such estimated sum with the Board.

7. The Board reserves the right to refuse to let the Hall or any part thereof to any applicant, without assigning any reason for such refusal.

8. The Board may at any time cancel any booking or engagement of the hall by giving reasonable notice in writing except as set out in by-law 5 in which case the provisions of that by-law, shall apply as far as notice is concerned.

9. No spirituous liquors, wine, ale, beer, porter, cider, or perry shall be brought into and/or consumed in the hall during the term of any engagement, except when permission has been granted by the Board, in writing.

10. No person shall, in any part of the hall or grounds thereof:—

- (a) enter or be allowed to enter whilst under the influence of liquor.
- (b) use of profane or improper language;
- (c) be guilty of any misbehaviour whatever;
- (d) damage, mark or deface any wall or other part of the building or outhouses; any person who does, permits or suffers any such damage to be done, shall be liable to pay the cost of such damage, in addition to any penalty imposed by these by-laws;
- (e) stand, loiter, or cause any obstruction whatsoever in the entrance porch, hall, exits, or passageways of the hall or on the hall grounds.

Any person so doing shall immediately desist, on being requested so to do by the secretary, caretaker of the hall or any other person duly authorised by the Board, or any police constable whether in uniform or otherwise.

11. No offensive impersonations or representations of living persons or anything calculated to produce a disturbance, riot or breach of the Peace, shall be permitted in the hall.

12. The hirer of the hall shall be responsible for:—

- (a) maintaining good order and the due observance of these by-laws by persons in, upon, or about the hall.
- (b) any damage done to the building, fixtures, fittings, furniture, crockery, cutlery, kitchenware, or other property of the Board at or attached to the hall or out-buildings.

13. The chairman, secretary, caretaker, or other person duly authorised by the Board shall be permitted to have free ingress to the hall or any part thereof, and every facility shall be given them for enforcing these by-laws. This by-law does not apply to functions of a strictly private nature.

14. Every person who does, permits, or suffers any act, matter, or thing contrary to these by-laws, or commits or permits any breach or neglect thereof, shall be deemed to be guilty of any offence against these by-laws, and shall be liable to a penalty not exceeding £20 for each offence.

By-law for Dog Pound and Control of Dogs.

L.G. 372/52.

PURSUANT to an Order in Council under section
 35A of the Dog Act, 1903-1948, and in exercise of
 other powers thereto enabling the Roebourne Road
 Board doth hereby make the following by-law for
 the establishing of a dog pound and the control
 of dogs in the townsite of Roebourne.

1. The Roebourne Road Board may, subject to
 the provisions of the Road Districts Act, 1919-1948,
 establish and maintain a pound or pounds for the
 impounding of dogs seized pursuant to the pro-
 visions of the Dog Act, 1903-1948.

2. Any dog seized pursuant to the provisions
 of section 19 of the Dog Act, 1903-1948, shall be
 held and disposed of in manner provided in this
 by-law:—

(a) Subject to compliance with the first proviso
 to section 19 of the Dog Act, 1903-1948, such dog
 may be destroyed or sold by an authorised officer
 of the Board at any time after expiration of 48
 hours from time of seizure, unless the owner thereof
 or a person authorised by him shall have paid the
 fees hereinafter provided for, and shall have taken
 delivery of the dog, and upon such sale the pur-
 chaser shall become the lawful owner of the dog.

(b) No owner or person authorised by him shall
 be entitled to release of a dog while any such fees
 shall remain unpaid in respect of the dog.

(c) No owner or person authorised by him shall
 be entitled to release of a dog at a time outside
 the normal working hours of the authorised officer
 in charge of the pound.

(d) Notwithstanding anything hereinbefore con-
 tained, but subject to the first proviso to section 19
 of the Dog Act, 1903-1948, such dog may be de-
 stroyed at any time upon authority from the secre-
 tary, if, in the opinion of the secre-
 tary, it is too savage or noisy to be kept, or is
 suffering because of injury or sickness.

(e) A person applying for release of any such
 dog shall prove to the satisfaction of the authorised
 officer in charge of the pound the ownership of
 the dog and his authority to take delivery. Such
 officer may accept such proof as he considers satis-
 factory, and no person shall have any right of
 action against him or the Road Board in respect
 of a delivery pursuant thereto.

3. The respective fees to be payable in respect
 of the seizing, care, detention and destruction of
 dogs seized as aforesaid shall be as follows:—

(a) The seizure of any dog—ten shillings.

(b) The care and detention of any dog—five shill-
 ings for each period of 24 hours from the seizure
 and for any fractional part of such period.

(c) The destruction of any dog—five shillings.

Such fees shall be the liability of the owner of
 the dog in respect of which the same are payable
 and shall be a debt due by such owner to the
 Road Board.

4. If the Road Board shall at the request of
 the owner destroy any dog, whether seized as afore-
 said or not, such owner shall pay to the Road Board
 a fee of five shillings.

5. The proceeds of the sale of any dog sold
 pursuant to these by-laws shall be the property
 of the Road Board and receipt of such proceeds
 shall not relieve the owner of liability for fees.

6. The payment of fees in respect of the seizure,
 care, detention or destruction of any dog shall not
 relieve the owner of liability to a penalty under
 any other provision of this by-law.

7. No person shall release any dog from a pound
 except in accordance with these by-laws.

8. Any owner or person having the charge or
 control of any dog shall keep such dog chained
 or under effective control from sunset to sunrise.

9. Any dog not so kept under control and found
 wandering at large may be instantly destroyed and
 the owner of any such dog shall be guilty of an
 offence against this regulation and shall be liable
 to a penalty not exceeding five pounds (£5).

10. No person shall obstruct or hinder any employee of the Roebourne Road Board, or member of the Police Force in the performance of anything authorised by the Dog Act, 1903-1948, or these by-laws.

11. Any person who shall commit any breach of any of these by-laws shall be liable to a penalty not exceeding five pounds.

69. (1) No sheep shall be travelled by road or conveyed by rail, motor or other transport into the compulsory dipping area as defined in regulation 63 (2) of these regulations from any part of Western Australia situated outside the compulsory dipping area without the written permission of an Inspector of Stock, and the Inspector shall not issue a permit for the movement of the sheep unless he is satisfied that they were dipped or sprayed subsequent to shearing with a preparation known to be fatal to tick and lice and until he has received from the owner or his manager a Statutory Declaration in the form of Form No. 7A of the Third Schedule hereto stating the last date of shearing, the date of dipping, the number of sheep dipped, and the quantity and brand of the dip used. Every person contravening this regulation by act or omission shall be punishable summarily and upon conviction be liable to a penalty not exceeding fifty pounds and not less than ten pounds.

(2) Where sheep are affected by drought and are too weak to be dipped subsequent to shearing or are intended for immediate slaughter at a meat works or for export for slaughter they may be moved into the compulsory dipping area subject only to the written permission of an Inspector of Stock and to the condition that the property to which any such stock exempted from dipping because of drought are transferred shall be ordered into quarantine which shall be maintained until the total number of the sheep on the said property have been dipped to the satisfaction of an Inspector.

WORKERS' COMPENSATION ACT, 1912-1951.

Hospital Charges.

WHEREAS under the provisions of paragraph (d) of the proviso to paragraph (c) of clause 1 of the First Schedule to the Workers' Compensation Act, 1912-1951, it is enacted that the compensation payable to an injured worker to cover hospital charges shall not exceed that from time to time prescribed by the Workers' Compensation Board: Now, therefore, the Board, in exercise of the power conferred by the Act, doth hereby prescribe that as from the

19th day of December, 1952, the hospital charges referred to in proviso (d) to paragraph (c) of clause 1 of the First Schedule to the Workers' Compensation Act, 1912-1951, shall not exceed—

- (I) (a) one pound fifteen shillings (35s.) per day for hospitals situated within a radius of 15 miles from the General Post Office, Perth;
- (b) one pound ten shillings (30s.) per day elsewhere,
- while the injured worker necessarily and properly remains in hospital, provided that such rates shall be regarded as maximum rates only and shall not exceed the *bona fide* charge to the worker for ward accommodation;
- (II) for operating theatre fees such amount as would normally be payable to the hospital concerned in a non-compensation case, or in the case of a governmentally controlled hospital, the sum of £2 2s.

Whereas the parties hereto being the parties to an Agreement dated the 7th day of December, 1951, and published in the *Government Gazette* (No. 4) dated the 11th day of January, 1952, have mutually agreed that the Agreement be varied, now the said Agreement shall be and the same is hereby varied in the manner following, that is to say:—

1.—Clause 4—Draftswomen.

Insert the following new subclause (d):—

(d) A draftsman who has completed not less than twenty years of continuous permanent service shall be paid an allowance equivalent to the difference between her rate of pay and the next higher grade in the incremental scale, such allowance to be increased to the difference between her

rate of pay and the second higher grade in the said incremental scale at the completion of a further twelve months of continuous permanent service: Provided that payment of these allowances shall be subject to the conditions prescribed in clause 6, subclause (j) of this Agreement.

2.—Clause 6—Female Clerk-Typists, Typists and Machinists.

(a) Delete the word "adult" appearing in the first line of subclause (d) and insert the word "officer" in its place.

(b) Insert the following new subclause (h):—

(h) An officer who has been retained in the automatic range and who has completed not less than twenty years of continuous permanent service shall, subject to the provisions of subclause (j) hereof, be paid an allowance equivalent to the difference between her rate of pay and the next higher grade in the incremental scale, such allowance to be in addition to the allowances referred to in subclauses (d), (e) and (f) hereof.

(c) Insert the following new subclause (i):—

(i) An officer who has obtained promotion to either class 1, 2 or 3 as set out in clause 3, subclause (a) of this Agreement—

(i) shall, subject to the provisions of subclause (j) hereof, be paid an allowance equivalent to the difference between her rate of pay and the next higher grade in the incremental scale upon completion of twelve months of continuous service on the maximum of her classification; and

(ii) shall, subject to the provisions of subclause (j) hereof, be paid an allowance equivalent to the difference between her rate of pay and the second higher grade in the incremental scale, provided she has been in receipt of the allowance referred to in paragraph (i) above for a continuous period of twelve months, and provided further that she has completed twenty years of continuous permanent service.

(d) Insert the following new subclause (j):—

(j) Payment of the allowances referred to in subclauses (h) and (i) of this clause shall be subject to the receipt by the Commissioner of a report from the permanent head as to the good conduct, diligence and efficiency of the officer and continuance of payment of such allowances shall be subject to the receipt by the Commissioner of similar annual reports from the permanent head.

(e) Insert the following new subclause (k):—

(k) An officer shall not be entitled to receive approval to the payment of more than one allowance under this clause in any period of twelve months.

3.—Clause 7—Females—General Division.

Insert the following new subclause (c):—

(c) A female officer classified under subclause (a) hereof, except one classified into a class 4 or higher position, shall, upon completion of not less than twenty years of continuous permanent service, be paid an allowance equivalent to the difference between her rate of pay and the next higher grade in the incremental scale: Provided that payment of this allowance shall be subject to the conditions prescribed in clause 6, subclause (j) of this Agreement.

4.—Clause 8—Female Laboratory Assistants.

(a) Insert the symbol "(a)" before the word "The" appearing in the first line.

(b) Insert the following new subclause (b):—

(b) A female laboratory assistant who has completed not less than twenty years of continuous permanent service shall be paid

an allowance equivalent to the difference between her rate of pay and the next higher grade in the incremental scale: Provided that payment of this allowance shall be subject to the conditions prescribed in clause 6, subclause (j) of this Agreement.

5.—Clause 9—Female Telephonists and Assistants.

(a) Insert the symbol "(a)" before the word "The" appearing in the first line.
