PRICES CONTROL ACT, 1948-1952.

Prices Control Order No. 795.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:—

Citation.

1. This Order may be cited as Prices Control Order No. 795.

- cleansers, household;
 - cocoa butter;
 - food drinks in powder form excepting Bournvita, Milo and Ovaltine;
 - vegetables, canned;
 - vinegar;
 - sewing machines—domestic;
 - smoothing irons—domestic;
 - stoves and stovettes—domestic;
 - wash troughs and coppers;
 - ball and roller bearings of all types and parts thereof;
 - floor coverings and mats of rubber;
 - bandages and surgical dressings;
 - cotton wool;
 - mineral turpentine;
 - batteries, dry;
- is hereby revoked.

4. Prices Control Orders Nos. 660, 661 and 662, as amended by Prices Control Orders Nos. 664 and 742 (Retail Prices of Groceries—various North-West Areas), are hereby severally revoked, insofar as they relate to—
- baked beans, or baked beans with meat;
 - biscuits;
 - breakfast foods, excepting oatmeal, flaked oats and rolled oats;
 - caustic soda;
 - cleansers, household;
 - copha;
 - dripping;
 - food drinks in powder form excepting Bournvita, Milo, Ovaltine and infants' and invalids' foods;
 - gelatine;
 - lard;
 - methylated spirits;
 - oils, non-edible other than lubricating oil;
 - turpentine and mineral turpentine;
 - vegetables, canned;
 - vinegar;
 - whiting.
