WHEREAS it is enacted by section 11 of the Native Administration Act, 1905-1947 (Reprinted), that the Governor may by Proclamation declare any

Crown lands to be Reserves for Natives, and abolish any reserve so declared; and whereas by Proclama-tion issued under the Aborigines Act, 1905, and tion issued under the Aborigines Act, 1909, and published in the Government Gazette on the 16th day of July, 1926, the Governor declared an area at Middle Creek, near Tableland, more particularly described as Reserve 3305 and defined in the Schedule to such Proclamation to be a Reserve for Natives; and whereas it is now deemed desirable and Natives; and whereas it is now deemed desirable and expedient to abolish the said reserve: Now, there-fore I, the said Governor, acting with the advice and consent of the Executive Council and in exer-cise of the power in that behalf conferred by section 11 of the Native Administration Act, 1905-1947, do hereby abolish the reserve for natives declared and described and defined in the herein-beforementioned Proclamation published in the Government Gazette on the 16th day of July, 1926, as aforesaid as aforesaid.
