Workers' Compensation Act, 1912-1952.

WHEREAS it is enacted by section 13 (6) of the Workers' Compensation Act, 1912-1952, that when an employer, exempted from the operation of section 13 pursuant to the proviso to subsection (1) of that section, shall apply to the Minister for a revocation of the exemption referred to in that proviso and shall apply to the Minister for the return of securities lodged by him with the Treasury discharged from the charge referred to in that proviso and shall prove to the satisfaction of the Minister that the employer has obtained from an approved insurer within the meaning of section 13 a policy of insurance for the full amount of liability to pay compensation under the Act to all workers employed by him the Governor may by Order in Council revoke the exemption and order that the securities be discharged from the charge and returned to the employer: Now, therefore, His Excellency the Governor acting with the advice and consent of the Executive Council and in exercise of the powers conferred by section 13 (6) of the Act doth hereby revoke the exemption granted The Swan River Shipping Company Limited of Fremantle from section 13 of the Act and order that the securities deposited by that Company at the Treasury, to wit, a bond for five thousand pounds given by the Union Bank of Australia Ltd. of St. George's Terrace, Perth, be discharged from the charge and returned to The Swan River Shipping Company Limited.

MARKETING OF ONIONS ACT, 1938-1952.

PURSUANT to the provisions of section 15, subsection (2), and section 19, subsection (1) of the Marketing of Onions Act, 1938-1952, The Western Australian Onion Marketing Board hereby makes the following regulations:—

These regulations shall be known as the Marketing of Onions Board (Conflicting Claims) Regulations.

1. (a) Where the Board receives conflicting claims in respect of payments to be made in respect of any onions delivered to the Board, the Secretary of the Board shall give notice in writing to each of the claimants in the Form No. 1 in the Appendix to these regulations

(b) At the expiration of 14 days after the date of service of such notice on the claimants the Board may, if a notice has not been lodged in accordance with regulation 2 requesting that the dispute be referred for decision by the Local Court, forthwith proceed to settle and adjust the conflicting claims and the decision of the Board shall thereupon be binding on all the parties to the dispute.

2. (a) A claimant to whom notice has been given in accordance with regulation 1 may, within 14 days after date of service of the notice lodge at the office of the Board a notice, in duplicate, in accordance with the Form No. 2 in the Appendix to these regulations requesting that the dispute be referred for decision by the Local Court held nearest to the office of the Board in accordance with subsection (2) of section 15 of the Act.

(b) The claimant shall pay to the Secretary of the Board at the time of lodging the notice the fee prescribed under the Local Court Rules for filing the duplicate copy of the notice in the Local Court as hereinafter provided.

(c) A copy of the notice shall also be served by the claimant on all the other parties to the dispute within seven days after the date of lodgment of the notice at the office of the Board and an affidavit of service of the notice shall be filed in the Local Court prior to the hearing of the application.

(d) Upon receipt of the notice in duplicate the Secretary of the Board shall forthwith file one copy of the notice at the office of the Local Court held nearest to the office of the Board.

3. The Clerk of the Local Court in which the notice mentioned in regulation 2 has been filed shall forthwith fix a date for the hearing which shall be not less than 14 days after the filing of such notice and shall send to every party to the dispute a notice of day of hearing in accordance with Form No. 3 in the Appendix to these regulations.

4. At the hearing of the dispute and with the consent of the Magistrate the parties may appear in person, or by counsel or solicitor, or by their representatives.

5. (a) If a claimant fails to appear at the hearing of the dispute the Magistrate may adjourn the hearing or proceed to hear and determine the dispute on such evidence as is adduced by the claimant or claimants present at the hearing.

(b) If none of the claimants appears at the hearing, the Magistrate may adjourn or strike out the proceedings.

6. On the termination of the hearing, the Magistrate may make such order as he thinks fit and may order costs to be paid by any party to the proceedings.

7. Any such order as the Magistrate makes shall be deemed to be an order of the Local Court and shall be given effect to by the Board according to the tenor thereof and any order made as to costs may be enforced in like manner as other orders of the Court.

8. The hearing shall follow as near as practicable the practice, procedure and rules of evidence relating to a trial of proceedings in a Local Court and the rules and practice in operation in the Court shall, in so far as they are not inconsistent with these regulations, apply to applications for hearing disputes hereunder.

The abovementioned regulations are amended by deleting regulation 185 and substituting a new regulation 185 as follows:—

185. Subject to regulation 186 of these regulations allowances (as at 1/1/51) may be paid to students according to the following scale:—

- (i) An unmarried minor—where the home of the parent or guardian of the minor is so situated that, having regard to all the circumstances of the case including the availability of public transport and the distance to be travelled by the minor to the college, the minor could reasonably be expected to travel daily between the home and the college—£186 per annum.

- (ii) Any other unmarried student—£243 per annum.
 (iii) A married male student with a wife and no children—£337 per annum.
 (iv) A married male student with a wife and with one or more children—£385 per annum.

Allowances mentioned in items (i), (ii), (iii) and (iv) of this scale shall be varied proportionately with basic wage adjustments.

- (v) A student shall be entitled to recoup of expenditure not exceeding the sum of ten pounds per annum incurred by him in the purchase of textbooks and teaching aids required for use during training.
