AT a meeting of the Executive Council, held in the Executive Council Chamber, at Perth, the 22nd day of July, 1953, the following Orders in Council were authorised to be issued:—

Municipality of Albany and Albany Road District.

Alteration of Common Boundary.

ORDER IN COUNCIL.

L.G. 61/52.

HIS Excellency the Lieutenant-Governor, acting by and with the advice and consent of the Executive Council, under the provisions of the Road Districts Act, 1919-1951, doth hereby sever from the Albany Road District the land described in the Schedule "A" hereto, and annex it to the Albany Municipal District so as to constitute that portion of the annexed areas shown in Schedule "B" hereto as a portion of the North Ward, and that portion of the annexed area shown as Schedule "C" hereto as a portion of the North-East Ward. This Order in Council shall take effect as from the 1st day of July, 1953.

Schedule "A."

All that portion of land bounded by lines starting at the intersection of the prolongation South-Easterly of the South-Western side of Marbellup Road and the centre of King River Road, a point on the municipal boundary, and extending generally North-Easterly along the centre of King River Road to a point in prolongation Westerly of the centre of Hudson Road; thence Easterly to and along the centre of that road and onwards to the centre of Range Road; thence Northerly along the centre of that road to a point in prolongation Westerly of the centre of Bond Road; thence Easterly to and along the centre of that road and onwards to the Western boundary of lot 30 of Plantagenet Location 43, a point on the Western boundary of that location; thence Southerly along that boundary to the Northern side of Ulster Road; thence generally South-Easterly along that side to the Southernmost corner of lot 36 of location 43 aforesaid; thence Southerly to the Westernmost corner of lot 18 of that location; thence South-Easterly along the South-Western boundary of that

lot to the North-Western side of Collingwood Street, a point on the municipal boundary and thence South-Westerly and North-Westerly along that boundary to the starting point. (Public Plans Albany Townsite, Sheets 1, 2, 3 and 4.)

Schedule "B."

All that portion of Albany Municipality bounded by lines starting at the intersection of the prolongation North-Westerly of the North-Eastern side of North Road and the centre of King River Road and extending generally North-Easterly, generally Easterly and Southerly along the centre of King River Road and the municipal boundary to the Northern side of Ulster Road; thence generally South-Westerly along that side to the North-Eastern side of North Road aforesaid and thence North-Westerly along that side to the starting point. (Public Plans Albany Townsite, Sheets 1 and 2.)

Schedule "C."

All that portion of Albany Municipality bounded by lines starting at the intersection of the North-Eastern side of North Road and the Western side of Ulster Road and extending generally North-Easterly and generally South-Easterly along that side and the municipal boundary to the North-Western side of Collingwood Street, a point on the Northern boundary of Albany Townsite and thence South-Westerly and North-Westerly along that townsite boundary to the starting point. (Public Plans Albany Townsite, Sheets 1, 2, 3 and 4.)

(2) Re-describe the district boundaries of the Dardanup Road District as described in Schedule "B" hereto.

Transfer of Territory from the East Ward to the South Ward.

All that portion of land bounded by lines starting at the North-Western corner of Wellington Location 1237 and extending Easterly along the Northern boundaries of locations 1237 and 946 to the South-Western corner of location 2464; thence Northerly, Easterly and Southerly along boundaries of that location to the North-Western corner of location 694; thence Easterly, Southerly and again Easterly along boundaries of locations 694, 843 and 3235 to the Western boundary of location 601; thence Southerly, Westerly and again Southerly along boundaries of locations 601, 750 and 2848 to the Northern boundary of location 3363; thence Westerly and Southerly along boundaries of that location to the North-Eastern corner of location 477; thence Westerly and Northerly along boundaries of location 1245 to the North-Eastern corner of location 543; thence Westerly, Southerly and again Westerly along boundaries of locations 543 and 701 to the South-Western corner of location 1397; thence Northerly and Easterly along boundaries of that location to the Westernmost boundary of location 3243; thence Northerly along that boundary to a South-Eastern corner of location 843; thence Westerly and Northerly along boundaries of locations 843 and 2871 and onwards to the South-Easternmost corner of location 2237; thence generally North-Westerly along the South-Western boundaries of that location to a point in prolongation Easterly of the Southern boundary of location 2236 and thence Westerly, Northerly, again Westerly and again Northerly to and along boundaries of locations 2236 and 1237 to the starting point. (Public Plan 411D/40.)

location 1097; thence Southerly along that boundary to the Northern boundary of location 1053; thence Easterly, Southerly and Westerly along boundaries of that location to the Eastern boundary of location 247; thence Southerly, Westerly and Northerly along boundaries of that location to the South-Eastern corner of location 286; thence Westerly, Southerly and again Westerly along boundaries of locations 286 and 874 to the Eastern boundary of location 588; thence Southerly, Westerly and Northerly along boundaries of that location to the North-Eastern corner of location 1256; thence Westerly and Southerly along boundaries of that location to the North-Eastern corner of location 3302; thence Westerly along the Northern boundary of that location and onwards to the Western side of road No. 588; thence generally South-Westerly along that side to the Northern boundary of location 2136; thence Westerly, Southerly and Easterly along boundaries of that location to the North-Western corner of location 1244; thence Southerly along the Western boundary of that location to the South-Eastern corner of location 2407; thence Westerly and Southerly along boundaries of locations 2405 and 2419 to the Northern boundary of location 1108; thence Westerly and Southerly along boundaries of that location to the Southern boundary of late Pastoral Lease 3420/102; thence Westerly along that boundary and onwards to the Eastern boundary of location 2725; thence Northerly and Westerly along boundaries of that location and onwards to the Eastern boundary of Boyanup Agricultural Area Lot 207; thence Northerly along the Eastern boundaries of lots 207, 206, 205, 204, 333, 202, 196 and 303 to the North-Easternmost corner of the latter lot; thence North-Easterly and North-Westerly to and along boundaries of Wellington Location 4506 to the Southernmost corner of Boyanup Agricultural Area Lot 193; thence Northerly along the Eastern boundaries of lots 193, 191, 190, 189 and 25 to the South-Eastern corner of lot 21; thence Westerly along the Southern boundary of that lot and onwards to and along that of lot 22 to the Eastern boundary of lot 23; thence Northerly and Westerly along boundaries of that lot to its North-Western corner; thence Westerly, crossing the Bunbury-Boyanup Railway Reserve and the South-Western Highway, to the Easternmost corner of lot 282; thence Westerly, Northerly and again Westerly along boundaries of that lot and onwards to the right bank of the Preston River; thence generally North-Westerly downwards along that bank to the Easternmost boundary of Wellington Location 12; thence Northerly and Westerly along boundaries of that location to the right bank of the Preston River aforesaid; thence generally Northerly downwards along that bank to the North-Western corner of location 10; thence Easterly along the Northern boundary of that location to the South-Western side of road No. 50; thence generally North-Westerly along that side to a point in prolongation Southerly of the Western boundary of Collie Agricultural Area Lot 37; thence Northerly to and along the Western boundaries of lots 37, 56 and 50 and onwards crossing the South-Western Railway Reserve and the South-Western Highway to the latter's North-Western side; thence generally South-Westerly along that side to the South-Easternmost corner of lot 46 and thence North-Westerly and Northerly along boundaries of that lot and Leschenault Location 26 to the starting point. (Public Plans Bunbury Townsite Sheets 2 and 4, 411A/40, 411C/40, 411D/40 and 414A/40.)

Re-description of Ward Boundaries. North Ward.

(Public Plans 411A/40 and 411D/40.)

West Ward.

All that portion of the Dardanup Road District bounded by lines starting at the intersection of the prolongation Westerly of the Southern boundary of Boyanup Agricultural Area Lot 308 and the right bank of the Preston River, a point on the Road District boundary, and extending generally Northerly and generally Easterly along that Road District boundary to its intersection with the Westernmost boundary of the North Ward; thence Southerly, generally North-Easterly and generally Southerly along boundaries of that Ward and road No. 1165 and onwards to the Northern boundary of Wellington Location 37; thence Westerly and Southerly along boundaries of locations 37, 128 and 80 to the Northern boundary of location 130; thence Westerly and Southerly along boundaries of that location to the North-Eastern corner of location 153; thence Westerly and Southerly along boundaries of location 153 and 131 to the North-Eastern corner of location 76; thence Westerly along the Northern boundary of that location and onwards to the Easternmost boundary of Dardanup Estate Lot 31; thence generally Southerly along the Eastern boundaries of Estate Lots 31 and 32 and reserves 13749 and 302 to a point in prolongation Easterly of the Northern side of road No. 864 (Venn Road) and thence Westerly to and along that side to the starting point. South Ward.

All that portion of the Dardanup Road District bounded by lines starting at the intersection of the road district boundary and the Southernmost boundary of the West Ward and extending generally North-Easterly along the Southern boundaries of that ward and the Northern boundaries of Wellington Locations 37, 232 and 377 to the North-Eastern corner of the latter location; thence Southerly along the Eastern boundary of that location to the Southern side of road No. 952; thence Easterly along that side to the Westernmost boundary of location 9; thence Southerly and Easterly along boundaries of that location to the South-Western side of road No. 952 aforesaid; thence South-Easterly along that side to the North-Eastern corner of location 2988 (reserve 8439); thence Westerly Southerly, again Westerly and again Southerly along boundaries of locations 2988 and 2301 to the South-Western corner of the latter location; thence South-Westerly to the North-Eastern corner of location 3003; thence Southerly along the Eastern boundary of that location and onwards to a point in prolongation Westerly of the Southernmost boundary of location 1142; thence Easterly along that prolongation to a point in prolongation Northerly of the Eastern boundary of location 1049; thence Southerly to and along that boundary and onwards to the North-Eastern boundary of location 1516; thence South-Easterly along that

boundary to the Northern boundary of location 1237; thence Easterly along the Northern boundaries of locations 1237 and 946 to the South-Western corner of location 2464; thence Northerly, Easterly and Southerly along boundaries of that location to the North-Western corner of location 694; thence Easterly, Southerly and again Easterly along boundaries of locations 694, 843 and 3235 to the Western boundary of location 601; thence Southerly, Westerly and again Southerly along boundaries of locations 601, 750 and 2848 to the Northern boundary of locations 3363; thence Easterly and Southerly along boundaries of that location and onwards to the Northern boundary of location 1097; thence Easterly and Southerly along boundaries of that location to the North-Western corner of location 1829, a point on the road district boundary, and thence generally South-Westerly and generally North-Westerly along that road district boundary to the starting point. (5) Repair and replace where necessary any steps or handrails thereof which may become in disrepair.

(6) Repair or replace any flashings which may become in disrepair.

(7) Replace any ant stops which shall be missing or in disrepair.

(8) Repair or renew any ventilators which shall become in disrepair or missing.

(9) Keep all floors even in surface and free from cracks.

(10) Replace or repair all skirtings, architraves, and fixtures, which may become a harbourage for vermin.

(11) Keep all walls and ceilings and the plaster and wallpaper thereon in good repair, and repair any cracks and renew any plaster or wallpaper which may become dilapidated or in disrepair.

(12) Refit and repair any doors which may become in disrepair or which shall cease to fit properly.

(13) Repair or replace with new any window frames or sash cords which may become broken or in disrepair and reglaze any windows which may become broken or cracked.

(14) Keep all water service in such state of repair and condition as shall comply in all respects with all of the provisions of the Metropolitan Water Supply, Sewerage and Drainage Act and regulations and by-laws made thereunder.

(15) Keep all electric wiring and fittings in such state of repair and condition as shall comply in all respects with all the requirements of the Fire-writers' Association of W.A.

(16) Retain all natural lighting free from any obstructions which would reduce the natural lighting below the ratio of one square foot of lighting to each 10 square feet of floor area.

(2) Repair any brick or stone work which shall show signs of fretting and treat or repair any walls which may become damp.

(3) Replace all decayed or ant-eaten timber therein.

(4) Repair and replace with new material where necessary any verandah or the roof, floor supports or other parts thereof which may become in disrepair.

(5) Repair and replace where necessary any steps or handrails thereof which may become in disrepair.

(6) Repair or replace any flashings which may become in disrepair.

(7) Replace any ant stops which shall be missing or in disrepair.

(8) Repair or renew any ventilators which shall become in disrepair or be missing.

(9) Keep all floors even in surface and free from cracks.

(10) Replace or repair all skirtings, architraves and fixtures which may become a harbourage for vermin.

(11) Keep all walls, ceilings and the plaster and wall paper thereon in good repair, and repair any cracks and renew any plaster or wallpaper which may become dilapidated or in disrepair.

(12) Refit and repair any doors which may become in disrepair or which shall cease to fit properly.

(13) Repair or replace with new any window frames or sash cords which may become broken or in disrepair and re-glass any windows which may become broken or cracked.

(14) Keep all water service in such state of repair and condition as shall comply in all respects with all of the provisions of the Metropolitan Water Supply, Sewerage and Drainage Act and regulations and by-laws made thereunder.

(15) Keep all electric wiring and fittings in such state of repair and condition as shall comply in all respects with all of the requirements of the Fire Underwriters' Association of W.A.

(16) Retain all natural lighting free from any obstruction which would reduce the natural lighting below the ratio of one square foot of lighting to each 10 square feet of floor area.

(17) Maintain all gutters, downpipes and storm water drains in good order and repair.

3. After By-law 31 of Part 1 insert a new By-law 31A, as follows:

31A.—Provision of Water Supplies.

(a) The owner of every house shall cause such house to be provided with water piping with all necessary bends, tees, taps, and fittings of sufficient size to deliver to the kitchen, bathroom, laundry and lavatory of such house, an adequate and continuous supply and pressure of potable water.

(b) He shall cause all such pipes to be connected to the water reticulation mains of the Metropolitan Water Supply, Sewerage and Drainage Department.

(c) He shall maintain all such pipes, bends, tees, taps and fittings in good and efficient repair and action.

4.—Part VII—By-law 20: Wrapping of Foodstuffs.

Delete all words from paragraph (a) after the word "contamination" in line 3 of that paragraph.

After paragraph (f) add new paragraphs (g) and (h) as follows:—

(g) No person shall sell or permit to be sold any food in or from any shop, stall or barrow for the purpose of being carried away from such shop, stall or barrow, unless such food is wrapped or packed so as to be protected from contamination.

(h) When paper is used for such wrapping or packing, only clean new white or brown paper shall be used, and such paper shall have no writing or printing thereon, except upon the outside thereof. Provided that vegetables, including salad

vegetables, may be wrapped in clean newspaper obtained direct from the publisher thereof and not previously sold or used for any purpose.

(g) A covering of sawdust to a depth of not less than 3in. shall be maintained on the floors of all poultry houses or sheds.

The fences of the poultry runs shall be constructed of 6ft. galvanised wire netting, supported by uprights of 3in. x 2in. jarrah, or equivalent thereof, set at not exceeding 8ft. centres with 2ft. in the ground.

Classification of District.

L.G. 2689/52.

A By-law of the Municipality of Claremont made under Section 180 of the Municipal Corporations Act, 1906-1951, and numbered 125 for classifying the district pursuant to the Town Planning and Development Act, 1928-1947.

IN pursuance of the powers conferred by the said Act the Mayor and Councillors of the Municipality of Claremont order as follows:—

1. All that part of the Claremont Municipal District described in the Schedule hereto (hereinafter called "the classified district") is hereby classified as a district for residences and residential flats.

2. Except as provided in Clause 3 hereof no building in the classified district shall be erected or altered, and no building or land in the classified district shall be used or adapted to be used, for any purpose other than the following:

- (a) single occupancy residences;
- (b) residential flat buildings;
- (c) private gardens;

(d) private garages and outbuildings reasonably necessary to a building permitted in the classified district and on the same subdivisional lot, and in which no business or industry is carried on.

3. (1) If at the time when this by-law comes into operation any building is being used for purposes other than those permitted by this by-law (hereinafter called "a non-conforming use") such building may continue to be used for such non-conforming use and subject to any Act or any other by-law limiting such extension it may be extended so as to cover the whole of the subdivisional lot on which it stands at the aforesaid date.

(2) When a non-conforming use has been discontinued it shall not thereafter be recommenced.

(3) No building which is damaged by fire or other casualty to the extent of more than 75% of its value shall be repaired or rebuilt or thereafter used except in conformity with this by-law unless the express permission of the Council of the Municipality of Claremont is first obtained.

4. Any person committing a breach of any of the provisions of this by-law shall be liable on conviction for every such offence to a penalty not exceeding £20.

5. The time limited for the making of claims in respect of injurious affection of land or property by reason of the operation of this by-law is six months from the date of the coming into operation of this by-law.

- (a) outside of town sites, be constructed with not less than four wires and with posts at not more than 12ft. intervals, such posts to be not less than 18in. in the ground, and to have the tops properly aligned; such fence shall be cattle-proof;
- (b) in town sites, be constructed in conformity with a plan and specification previously submitted to and approved by the Board.

The whole of the fence shall be erected in a manner to the satisfaction of the Board.

(4) Any person failing to comply with any order made under these by-laws, or offending against any of the provisions of these by-laws shall, for every such offence, be liable to a penalty not exceeding £20.

Decoration of the Building.

4. Hirers may decorate the building, using only those fixtures which are especially provided for the purpose, and no person shall drive a nail into any part of the walls, windows, doors, floors, etc., or otherwise deface the building. All decorations must be done during daylight, otherwise a charge of two shillings (2s.) per hour or part thereof shall be made for the use of the lighting. Unless the

consent of the Secretary is obtained for decorations to be left in the Hall, any person decorating must remove the decorations used in connection with any entertainment and dispose of these to the satisfaction of the Secretary by twelve o'clock noon on the day following the entertainment.

Deposit.

5. The Board shall, in the case of balls, dances, wedding receptions, social evenings, and concerts, and may, at the discretion of the secretary, in all other cases, demand that the hirer shall, prior to the term of engagement, deposit the amount of one guinea (£1 1s.) to cover the cost of removal and disposal of any decorations or refuse not so removed by the hirer within the time specified in the preceding by-law.

Right to Let or Hire.

6. The Board shall have the right to let or hire, or to refuse to let or hire, any part of the building, fixtures, furniture, or fittings, etc., to any applicant without assigning any reason for so doing.

Cancellation of Hire.

7. The Board may at any time cancel any arrangements made for hiring of any part or all of the building, fixtures, furniture, or fittings, etc., by giving such reasonable notice in writing as may be possible, but which shall not be less than seven (7) days.

Discretion of Hire.

8. The Board may, without considering priority of claim of any applicant, determine to which applicant the hire of the building or part thereof shall be granted in the event of two applicants desiring to hire such building or part thereof at the same time and on the same date.

Compliance with Acts of Parliament and Regulations.

9. The hirer of the building or part thereof shall comply with the provisions of the Health Act, Entertainment Tax Act, Performing Rights Association Act, or any other Act and/or Regulations in force for the time being and applicable to the hiring and use of the building. If, in the opinion of the Board, all necessary actions have not been taken to comply with the said Acts or any Acts in force the Board may, at any time prior to or during the term of engagement, forbid and prevent the use of such building or part thereof. The hirer must accept full responsibility in the event of any dispute arising in connection with the provisions of necessities under this By-law or the non-compliance therewith.

Hire Fees upon Breach.

10. In the event of the use of the building or any part thereof being forbidden or prevented under the last preceding By-law the hirer shall forfeit the full amount paid and the Board shall not be responsible to the hirer for any loss or damage sustained.

Spirituos Liqueurs, etc.

11. No spirituous liquors, wine, beer, stout, cider, sherry, etc., shall be brought into and consumed in any part of the building during the term of engagement, or the period of hire except by written consent or permission of the Board.

Offences and Disturbances.

12. No person acting in an offensive manner, or offensively impersonating living person(s), or anything calculated to produce a disturbance, riot, or breach of the peace shall be permitted in or about the premises.

Conduct of Entertainments.

13. No person shall, in any part of the building or premises—

- (a) Enter, or be allowed to enter, whilst intoxicated or under the influence of drink;
- (b) be guilty of any misbehaviour whatsoever;
- (c) use profane or improper language;
- (d) damage, mark, inscribe, indite, or deface any wall or any other part of the building.

Any person who does, or suffers to be done, any such damage, shall be liable to pay the cost of any such damage in addition to any penalties imposed by these By-laws.

- (e) Stand, loiter, or cause any obstruction whatsoever, in the exits or passageways.

Any person so doing shall desist on being requested to do so by the Secretary or other authorised person, or Police Officer.

This order shall take effect from and inclusive of the date hereof: Provided that payment of the amounts by which the basic wages have been increased by virtue of this order may at the employer's option be delayed until the end of the first pay period which commences after this date.

STATE TRANSPORT CO-ORDINATION
ACT, 1933-1948.

Exemptions.

IT is hereby notified, for general information, that the Western Australian Transport Board has approved, under the provisions of the State Transport Co-ordination Act, 1933-1948, of the under-mentioned transport being exempt from the licensing provisions of the Act, namely—

- (a) the carriage of livestock, poultry, fruit, vegetables, dairy produce or other perishable commodities, wheat, oats, barley or rye from the place where they are produced to any other place in a vehicle owned by the producer thereof;
- (b) the carriage on the return journey of not more than an equivalent weight of requisites for the domestic use of such producer or for use by him in the production of the commodities herein named: Provided that where the weight of commodities carried on the forward journey shall exceed two tons a greater weight of such requisites may be carried on the return journey.
