To Alan Gregory Smith, Esq., Stipendiary Magistrate, of Perth:

I, the said Governor, acting with the advice and consent of the Executive Council do hereby appoint you, Alan Gregory Smith, to be a Royal Commission to inquire into and report generally upon allegations recently made in the State Parliament, or to the Government, or which may be made to you in writing by or through Mr. J. H. Ackland, M.L.A., or Mr. A. R. Jones, M.L.C., concerning bribery on the part of one or more of the members or officers of the Western Australian Transport Board, and in particular to inquire into and report upon—

(1) Whether or not any member or officer of the Western Australian Transport Board has committed an offence under section 82 or section 83 of the Criminal Code, in that he—

- (a) has corruptly asked for, received or obtained, or has agreed or attempted to receive or obtain, any property or benefit of any kind for himself or any other person on account of anything already done or omitted to be done, or to be afterwards done or omitted to be done, by him in the discharge of the duties of his office; or
- (b) has taken or accepted, for the performance of his duty as such member or officer, any reward beyond his proper pay and emoluments, or any promise of such reward.

(2) If any such offence has been committed, and in relation to each such offence, the parties involved and the full circumstances.

(3) Should any, and, if so, what action be taken in relation to any such member or officer.

And I declare that you shall, by virtue of this Commission, be a Royal Commission within the Royal Commissioners Powers Act, 1902, as reprinted in the appendix to the Sessional Volume of the Statutes for the year 1928, and that you shall have the powers of a Royal Commission and the Chairman thereof under that Act.

I desire that you should not refrain from granting to a witness at your inquiry a certificate under s. 11 of the Evidence Act, 1906-1930, merely because of any doubt as to the applicability of the section to your inquiry. The Crown will not prosecute any witness to whom you shall grant such a certificate for anything done before such grant in respect of matters touching which the witness is examined, except for an offence under s. 127 of the Criminal Code (which relates to the giving of false evidence before a Royal Commission).

And I hereby request you as soon as reasonably may be to report to me in writing the result of this your Commission.

INDUSTRIAL AGREEMENT.

No. 11 of 1953.

Registered 5th August, 1953.

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1952, this 3rd day of August, 1953, between the State Electricity Commission of Western Australia (hereinafter referred to as "the Commission") of the one part, and the Operative Bricklayers and Rubble Wallers' Industrial Union of Workers, Perth (hereinafter referred to as "the Union") of the other part, whereby the said parties mutually agree as follows:—

1.—Title.

This Agreement, which supersedes Industrial Agreements numbered 33 of 1949 and 1 of 1950, so far as the parties to this Agreement are concerned, shall be known as the State Electricity Commission's Bricklayers' Agreement.

3. Area and Scope.

This Agreement shall apply to members of the Operative Bricklayers and Rubble Wallers' Industrial Union of Workers, Perth, employed by the State Electricity Commission in the State of Western Australia.

4.—Term.

This Agreement shall operate for three (3) years from the date hereof: Provided that at any time after the expiration of twelve (12) calendar months from the date hereof the Court may alter or amend same on the application of either party.

5.—Definitions.

1. "Bricklayer" means a worker engaged in bricklaying, brickcutting, firework (including kiln work), furnaces or furnace work of any description, setting cement bricks, cement blocks and cement pressed work, setting coke slabs or coke bricks, or plaster partition blocks, or any other work which comes or which may be adjudged to come within the scope of brick work generally.

2. "Rubble waller" means a worker who does all or any of the following classes of work, whether hammer dressed or sawn:—

- (i) Foundation work.

- (ii) Building random rubble uncoursed; or building squared rubble in courses or regular coursed rubble; and dressing quoins or shoddies in connection with any such work; but this definition shall not of itself be taken to prejudice or affect the right of any other classes of tradesmen or workers to do any class or kind of work they have hitherto been accustomed to do.

3. General:—

- (a) "Casual worker" means a worker employed for less than one (1) week continuously, but does not include a worker who, when work is available, leaves his employment before the expiration of one (1) week.
- (b) "Permanent worker" means a worker other than a casual worker employed under the terms of this Agreement.

6.—Contract of Service.

(a) No worker, other than a casual, shall leave the Commission until the expiration of fourteen (14) days' written notice of his intention so to do without the approval of the Commission.

(b) Except in the case of summary dismissal for misconduct, peculation or theft, fourteen (14) days' written notice shall be given by the Commission to any worker other than a casual whose services are no longer required and the reason for dismissal shall be stated in such notice.

(c) The Commission shall be entitled to deduct payment for any day or portion of a day on which the worker cannot be usefully employed because of any strike by the Union party to this Agreement or by a union or unions affiliated with it or by any other association or union associated with it, or through the breakdown of the Commission's machinery, or any stoppage of work by any cause which the Commission cannot reasonably prevent.

7.—Absence from Duty.

(a) Any worker losing time through sickness or injury shall, as soon as possible, notify his foreman, or other officer in charge, in sufficient time to permit of arrangements being made for the performance of his duties.

(b) Subject to the provisions of clause 8 (Payment for Sickness) any worker losing time through sickness or special leave shall be reduced in wages only to the extent of the time actually lost through sickness or granted as special leave.

8.—Payment for Sickness.

(a) (i) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week's pay for each completed month of service.

(ii) The liability of the Commission shall in no case exceed one (1) week's wages during each calendar year in respect of each worker, but the sick leave herein provided shall be allowed to accumulate, and any portion unused in any year may be availed of in the next or any succeeding year.

(iii) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(c) No worker shall be entitled to the benefit of this clause unless he produces proof to the satisfaction of the Commission or its representative of sickness, but the Commission shall not be entitled to a medical certificate unless the absence is for three (3) consecutive working days or more.

(d) No payment will be made for any absence due to a worker's own fault, neglect or misconduct.

9.—Annual Leave.

(a) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by the Commission after a period of twelve (12) months' continuous service with the Commission.

(b) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(c) (i) Subject to paragraph (ii), when computing the annual leave due under this clause, no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays: Provided that no deduction shall be made for any approved period a worker is absent from duty through sickness with or without pay, unless the absence exceeds an aggregate of thirteen (13) weeks, in which case deduction may be made for such excess only.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six months only of any such period shall count as service for the purpose of computing annual leave.

(d) In the event of a worker being employed by the Commission for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with the Commission.

(e) Any worker who may resign or be dismissed from the service for any cause other than for peculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service: Provided always that if the worker has been dismissed for peculation or theft, no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(f) When work is closed for the purpose of allowing annual leave to be taken, workers with less than a full year's service shall be entitled to payment during such period for the number of days' leave due to them: Provided that nothing herein contained shall deprive the Commission of its right to retain such workers at work during the close-down period as may be essential.

(g) "Ordinary wages" for the purpose of subclause (a) hereof shall mean the rate of wage the worker has received for the greater proportion of the calendar month prior to his taking the annual leave.

(h) The provisions of this clause shall not apply to casual workers.

10.—Public Holidays.

(a) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Union Picnic Day, Christmas Day and Boxing Day.

(b) (i) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day, he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it were an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave, or to be taken at some subsequent date if the worker so agrees.

(ii) If any worker is required to work on a public holiday prescribed as a holiday under this Agreement, which falls on a non-working day, he shall be paid the rate which he would have been paid if the day had not been a public holiday, and in addition shall have one day for each holiday so worked added to his annual leave.

(c) In the case of workers working a five-day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.

(d) Payment for holidays shall be in accordance with the usual hours of work.

(e) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such

absence shall not be treated as a paid holiday. Where the worker is on duty or available on the whole of the working day immediately preceding a holiday, or resumes duty or is available on the whole of the working day immediately following a holiday as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

(f) Day workers employed on Sunday work will be entitled to half ($\frac{1}{2}$) of one day extra on their annual leave for every four (4) Sundays worked during the year. Sunday work shall not be counted for the purpose of this subclause unless at least three (3) hours' actual work is done.

(g) A casual worker shall not be entitled to payment for any holiday referred to in this clause.

11.—Rest Period.

(a) Subject to the provisions hereinafter contained, a rest period of seven (7) minutes from the time of ceasing to the time of resumption of work shall be allowed each morning. This interval shall be counted as time off duty without deduction of pay and shall be arranged at a time and in a manner to suit the convenience of the Commission. Morning tea may be taken by employees during this interval, but the period of seven (7) minutes shall not be exceeded under any circumstances. Upon proof of breach, by any employee of any provision hereinbefore expressed or implied, the Court may grant the Commission exemption from liability to allow the rest period aforesaid.

(b) Workers engaged on essential work or on work or on some process in course (e.g., concreting) may be required to take the prescribed tea break at such time and in such manner as considered necessary by the officer in charge of the job, or in his absence, by the foreman.

12.—Long Service Leave.

The conditions relating to full-time Government wages employees generally as in force as at the date of this Agreement, and as may be amended from time to time, shall apply to all workers employed under the provisions of this Agreement.

13.—No New Designation.

No new designation shall be introduced during the currency of this Agreement so as to reduce the status of any worker covered thereby.

14.—Shop Stewards.

Subject to the recognition of properly constituted authority, shop stewards to be appointed by the Union shall be recognised by the Commission.

15.—Hours of Duty.

1. (a) Forty (40) hours, exclusive of Saturday and Sunday work, shall constitute a week's work. No day's work shall exceed eight (8) hours.

(b) The ordinary hours of duty shall be between the hours of 7.30 a.m. and 5 p.m., Monday to Friday.

(c) The usual hours of duty within the scope as provided in subclause (b) hereof shall not be altered without consultation with the Union concerned party to this Agreement.

2. (i) The Commission may require any worker to work reasonable overtime at overtime rates, and such worker shall work overtime in accordance with such requirement.

(ii) The Union or any worker or workers covered by this Agreement, shall not in any way, whether directly or indirectly, be party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

(iii) This subclause shall remain in operation until otherwise determined by the Court.

16.—Guaranteed Week.

(a) The Commission shall guarantee to each worker, other than a casual, a full week's work, exclusive of Saturday and Sunday work, except during such period as by reason of any action on the part of any section of its workers, or for any other cause beyond its control, the Commission is

unable wholly or partially to continue operations at the generating stations and/or at any of its undertakings. Each week shall stand by itself.

(b) The guaranteed period may be reduced or affected as follows:—

- (i) Where a worker is suspended, the provisions of clause 17 (Wages during Suspension) shall apply.
- (ii) In respect of any day when, as a result of a vote taken by the workers concerned, with the consent of the Commission or by agreement between the Commission and the Union, a holiday is taken.
- (iii) In respect of any day a worker is absent, except through sickness as provided for in clause 8.

17.—Wages during Suspension.

(a) Where a worker is suspended and the charge not proven, full wages for the period of suspension shall be paid.

(b) Where the charge is admitted or proven, the worker may be deprived of wages for the whole or any portion of the period of suspension, but in such case the Commission shall decide the amount of wages of which it is intended to deprive the worker, and any such deprivation shall be recorded and regarded as part of the punishment.

(c) Unless proceedings on any charge are commenced within seven (7) days of the first laying of the charge and finalised within one month of such date, the charge shall lapse and full payment of wages made to the worker for the complete period, unless proceedings are delayed by causes outside the control of the Commission.

18.—Overtime and Sunday Work.

1. Any worker who is called upon to work overtime for more than two (2) hours shall be paid an allowance of three shillings (3s.) for a meal or shall be supplied by the Commission with a reasonable meal in lieu of such payment.

2. Any worker who has left the premises at which he is employed and is recalled to work after the usual ceasing time for less than one (1) hour shall receive payment for one (1) hour at overtime rates.

3. If a worker is required to work during the recognised meal period so that the commencement of the meal period is postponed for more than half ($\frac{1}{2}$) an hour, that worker shall receive payment at double time rates until he gets his meal.

4. Subject to the preceding subclause, if a worker who is required to work during the recognised meal period does not in consequence obtain during the shift the full continuous meal period, or loses any portion of the meal period, he shall be paid at double time rates for the period not obtained or any portion lost.

5. The expression "recognised meal period" means the period customarily observed as the meal period between fixed times on the job, or at the works, as the case may be, except where the time of commencement of the customary period is altered by mutual consent of the Commission and the workers on a job to suit the convenience of the workers or the Commission, in which case the altered times shall be the basis of any rights under the preceding subclauses (3) and (4).

6. A worker who commences at or after midnight shall be paid double time until 6 a.m. the following morning, and subject thereto, all work performed outside the normal limits of the hours of labour shall be paid for at the rate of time and a half for the first two (2) hours and double time thereafter.

Subject to the provisions of subclause (2) of this clause, for the purpose of this subclause, the normal limits of the hours of labour shall be ascertained by reference to the time of commencement and time of finishing generally observed in regard to the worker in question for the particular job on which he is engaged.

7. All time worked on Sunday shall be paid for at the rate of double time.

19.—Away from Home Allowance.

(a) When a worker is instructed to proceed on duty from the place where he is then or is usually employed, the Commission shall pay all fares, including sleeper and, except when a camp allowance is paid under clause (b) hereof, proper allowance at current rates for all necessary meals and board and lodging. Fares shall be second class except when travelling by coastal boat, when saloon fares shall be paid and shall include return fares on completion of the job.

(b) (i) When a worker is required to live in a tent or hut away from his usual residence or home station he shall be paid a camping allowance of four shillings (4s.) for each working day he is required to hold himself and does hold himself available in a camp throughout the said day, whether or not work is done on the said day: Provided, however, the total amount payable under this provision shall not exceed twenty shillings (20s.) per week.

(ii) Provided further that if suitable accommodation, not being a tent or hut, is provided for a married worker and his dependants, there shall be no obligation to pay any allowance under the previous subclause.

(iii) Rent may be charged for any tent or huts or other accommodation supplied, at rates to be fixed, or failing agreement, as decided by the Board of Reference.

20.—Payment of Travelling Time.

(a) A worker going to work away from or returning to his home station shall be paid at ordinary rates for the actual travelling or waiting time for the first eight (8) hours, and thereafter at half the ordinary rates in any one period of twenty-four (24) hours.

(b) Where waiting time exceeds four (4) hours and suitable accommodation is made available at the Commission's expense, the worker shall be deemed to be booked off duty, and shall not be entitled to payment for the time he is booked off.

(c) Sunday travelling time shall be paid at the same rates and on the same conditions as on week days.

(d) In respect of a worker who is provided with a sleeping berth in a passenger train, travelling time shall not count between 10 p.m. and 7 a.m.: Provided this shall not operate to reduce the travelling time to be paid for below four (4) hours in any one (1) day: Provided further that where by virtue of the length of nature of the journey the sleeping berth is available for six (6) hours or less, travelling time shall be paid for such period with a minimum of four hours.

(e) A worker residing within the suburban area who is required to start work at some place other than his home station within the suburban area shall—

(i) if notified the previous evening, travel one way from or to work in his own time, provided that there is suitable transport available;

(ii) if not so notified, the worker shall travel both ways in the Commission's time.

The Commission shall provide free travelling from the home station. Provided, however, that no worker sent on relief duty within the suburban area shall claim or be allowed extra travelling time if the station at which he is to work is nearer his residence than his home station.

21.—No Reduction.

This Agreement shall not in itself operate to reduce the wages of any worker who is at present receiving above the minimum rates prescribed for his class of work.

22.—Preference to Unionists.

Preference of employment shall be given to financial members of the Union. Before being engaged an applicant in the metropolitan area shall produce evidence that he is a financial member. This provision shall also apply outside the metropolitan area, provided, however, that if the applicant is unable to produce satisfactory evidence immediately, he shall furnish same within a reasonable period.

23.—Boards of Reference.

(a) The Court appoints, for the purpose of the Agreement, Boards of Reference. The boards shall each consist of a chairman and two (2) other representatives nominated by the parties. There are assigned to such boards, in the event of no agreement being arrived at between the parties to the Agreement, the functions of—

- (i) classifying and fixing wages, rates and conditions for any machine, occupation or calling not specifically mentioned in the Agreement;
- (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Agreement or any of them;
- (iii) deciding any other matter that the Court may refer to the Board from time to time.

(b) Separate boards may be appointed for different sections corresponding to the occupations, callings or vocations referred to in this Agreement and/or for different districts.

(c) The provisions of regulation 92 of the Industrial Arbitration Act, 1912-1952 (Appeal from Board) shall be deemed to apply to any board of reference appointed hereunder.

24.—Right of Entry.

On notifying the officer in charge, any officer of the Union authorised in writing by the president and secretary of such Union shall have the right to enter any place or premises, during ordinary working hours, wherein members of such Union covered by this Agreement are engaged, for the purpose of conversing with or interviewing the workers in such place or premises.

Provided that such officer shall not hamper or otherwise hinder the workers in the carrying out of their work. The officer in charge shall determine whether workers are being hampered or hindered in their work.

25.—Allowances, Special Provisions, Etc.

1. A casual hand shall be paid ten per cent. (10%) in addition to the minimum rate specified.

2. Reasonable change room lockers and washing facilities shall be provided for the workers.

3. Workers employed on the following work shall be paid at the rate of fourpence (4d.) per hour in addition to the prescribed rate whilst so employed.

(a) Boat-type or Swinging Scaffold.—In this subclause the term "swinging scaffold" means any scaffold suspended from overhead gear and not supported from the ground and which, by reason of the operations carried out on it, or by reason of the wind force or vibration, is likely to swing or sway.

(No employer shall permit an apprentice who has served less than two (2) years to work on a boat-type or swinging scaffold and no such apprentice shall work on any such scaffold.)

(b) Excessively dirty work or demolition work which is likely to render the worker or his clothes dirtier than the normal run of work (with a minimum payment as for four (4) hours when employed on such work).

(c) Insulating work in an average temperature of forty-five (45) degrees F. or under.

(d) Working for more than one (1) hour continuously in the shade in places where the temperature is raised by artificial means to exceed 130 degrees F.

(e) Working in dust-laden atmosphere caused by the use of materials for insulating, deafening or pugging work (as, for instance, pumice, charcoal, silicate of cotton or any other substitute).

4. Workers required to work in a confined space in and around a building shall be paid at the rate of fourpence (4d.) per hour in addition to the prescribed rate whilst so employed: Provided that workers engaged in furnace work shall be paid an allowance of 3s. per day when working in a confined space.

"Confined space" means one of which the dimensions are such that the workmen must work in an unusually stooped or cramped position or without

adequate ventilation, or where confinement within a limited space is productive of unusual discomfort to them.

5. Workers employed on the following work shall be paid at the rate of twopence (2d.) per hour in addition to the prescribed rate whilst so employed.

(a) Working for more than one (1) hour continuously in the shade in places where the temperature is raised by artificial means to between 115 and 130 degrees F.

(b) Bricklayers employed on chimney shafts over fifty (50) feet from the ground. For every additional fifty (50) feet or fraction thereof, an additional twopence (2d.) per hour shall be paid.

6. Workers employed on repairs to ovens or furnaces or on under-pinning shall be paid ten per cent. (10%) in addition to the prescribed rate whilst so employed.

7. Workers, while working in any place where water is continually dripping, so that the workers' clothing becomes wet with soakage, or where there is water under foot so that the workers' feet become wet, shall be paid at the rate of ten per cent. (10%) in addition to the prescribed rate whilst so employed. This shall not apply to natural surface made wet by rain.

8. Provision of Boiling Water.—The Commission shall provide on each job boiling water for the use of the workers, including for the morning tea and lunch period.

9. Protection of Workers' Tools.—The Commission shall, where practicable, provide a place on each job apart from its plant and material for the safe keeping of the workers' tools when not in use.

10. Attendants on Ladders.—No worker shall work on a ladder at a height of over twenty (20) feet from the ground when such ladder is standing in any street, way or lane where traffic is passing to and fro without an assistant on the ground.

11. Sanitary Arrangements.—Proper sanitary arrangements shall be made on each job of the Commission for the convenience of all workers, and be kept in a clean and hygienic condition, and where sewerage facilities exist, proper connections must be made. If a pan system is used, thunder boxes are to be installed.

26.—Leading Hands.

A worker placed in charge of—

- (a) not less than three and not more than six other workers covered by this Agreement shall be paid two shillings and ninepence (2s. 9d.) per day extra;
- (b) more than six and not more than twelve other workers covered by this Agreement shall be paid four shillings (4s.) per day extra;
- (c) more than twelve other workers covered by this Agreement shall be paid five shillings and ninepence (5s. 9d.) per day extra.

Where the leading hand works under the supervision of a foreman for the major portion of the day, the extra rates set out in this clause shall be halved.

27.—Rates of Pay.

The minimum rates of wages payable to workers under this Agreement (other than duly registered apprentices) shall be:—

28.—Provision of Appliances.

1. Bricklayers.—The employer shall supply scutch combs and blades when required.

2. A worker in receipt of a tool allowance shall provide himself with all necessary tools, kept in suitable condition for the performance of his work (other than those tools to be provided by the employer in accordance with this clause). A worker who fails to provide all such tools when required shall be guilty of a breach of this Agreement and shall not be entitled to the tool allowance prescribed in this Agreement until he complies with this clause.

29.—Apprentices.

(a) Apprentices shall be allowed to the brick-laying trade.

(b) The term of apprenticeship shall be five (5) years.

(c) The maximum number of apprentices allowed to the Commission shall be as allowed under the Building Trades Apprenticeship Regulations.

(d) Wages—

Provided that where an apprentice is twenty-one (21) years of age or over at the commencement of his fifth year he shall be paid the full basic wage, and that when an apprentice becomes twenty-one (21) years of age in the course of his fifth year, he shall be paid the full basic wage for the period following his twenty-first birthday. Provided further that the foregoing proviso shall not apply where the apprenticeship has been revived under the Re-establishment and Employment Act, 1945, and the apprentice is in receipt of a tradesman's rate through Government supplementation.

(e) The employment of apprentice bricklayers shall be governed by the provisions of the Building Trades Apprenticeship Regulations.

(f) A tool allowance of 2s. per week shall be paid to apprentices in their third, fourth and fifth years: Provided that apprentices shall be supplied with tools as selected by the foreman up to the value of £2 5s.

INDUSTRIAL AGREEMENT.

No. 12 of 1953.

(Registered 7/8/53.)

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1952, this 31st day of July, 1953, between the Kalgoorlie Brewing Company Limited whose registered office is situated at Brookman Street, Kalgoorlie (hereinafter called "the employer") of the one part and the Breweries and Bottleyards Employees' Industrial Union of Workers of Western Australia registered under the provisions of the Industrial Arbitration Act, 1912-

1952, and having its registered office at the Trades Hall, Perth (hereinafter called "the Union") of the other part whereby it is agreed as follows:—

Interpretation.

(a) "Casual hand" shall mean any person who is employed for not more than 40 ordinary working hours. The number of "casual hands" shall not exceed one in every ten permanently employed or portion of the first 10 by the said company.

(b) "Cellarman" whenever used in this Agreement shall mean a worker who is generally employed at a majority of the undermentioned occupations, namely, filling, preparing, carbonating and racking beer from storage tanks and/or tends filter and shall not mean any employee who is casually employed in any one of the last mentioned processes.

(c) "Bottle washer" shall mean any person employed washing bottles by hand or machinery.

(d) "CO₂ bottler" shall mean any person employed in bottling CO₂ gas.

(e) "Leading hands" are employees who are in charge of and responsible for the work of others.

(f) "Motor drivers"—Motor drivers shall not include one who drives a motor vehicle for the removal of refuse, slops or liquid waste.

(g) "Shiftmen" shall be applicable to topmen and cellarman.

1.—Schedule.

In view of the difference in trading conditions prevailing on the Goldfields as compared with trading conditions elsewhere in the State the parties to this Agreement mutually agree that the minimum rate of wages that shall be paid by the employer to the persons employed by it within the area covered by this Agreement in the capacities undermentioned respectively is as follows:—

Cold Rooms.—Workers in cold rooms or cellars with a temperature of less than 45 degrees F., shall be paid 5s. per week in addition to the minimum rate.

Storage Tanks.—Reconditioning storage tanks and vats which shall include painting, cleaning and scraping cylinders inside and outside. For all time during which they may be employed inside cylinders or vats at this class of work workers shall be entitled to be paid at the rate of one shilling (1s.) per hour in addition to the margin above prescribed. Whilst engaged on this class of work outside of cylinders or vats, workers shall be entitled to be paid at the margin above prescribed plus the cold room allowance where applicable.

Boiler Cleaning and Ammonia Coils.—For all time they may be employed scraping and cleaning boilers and chipping, cleaning, scraping or painting ammonia coils, workers shall be entitled to be paid at the rate of one shilling (1s.) per hour in addition to the rates prescribed herein for their ordinary classification.

Oilers and Aprons.—Employers shall, for use in their work only, supply oilskin coats, cash and docket satchels, leather aprons, gaiters or leggings to motor lorry drivers free of cost.

Adult Labourer.—The employer shall make it a condition of employment that all workers must be covered by this Agreement and shall be members of this union or become so immediately on their first pay day.

Boots.—The employer shall, for use during working hours only, supply suitable boots to those employed at the bottle washing, at the tanks, at the tubs, at the filters, at the cask washing shed, at the bottlers, and to any employees working in or about water, such boots to be supplied free of cost.

2.—Hours.

Shift Cellarmen.—Forty hours shall constitute a week's work for shift cellarmen and the hours to be worked shall be:—

(a) Day Shift—Week days—8 a.m. to 12 noon, 1 p.m. to 3.40 p.m.; one hour off between 12 noon and 1 p.m. for lunch. Saturdays—8 a.m. to 11 a.m., 12 noon to 3.40 p.m.; one hour off between 11 a.m. and 12 noon for lunch.

(b) Afternoon Shift.—4.20 p.m. to 11 p.m., inclusive of 30 minutes for crib Mondays to Saturdays.

(c) Night Shift.—11.40 p.m. to 6.20 a.m., inclusive of 30 minutes each shift for crib, Mondays to Saturdays.

Shift Topmen.—Shift topmen shall mean one, two or three sets of men engaged for the sole purpose of brewing and working shifts for five days each of eight hours from Monday to Friday inclusive, the hours of work to be—

1st Shift—7.30 a.m. to 3.30 p.m.

2nd Shift—3.30 p.m. to 11.30 p.m.

3rd Shift—11.30 p.m. to 7.30 a.m.

Other Workers.—Forty hours shall constitute a week's work spread over five days from Monday to Friday inclusive eight hours per day, the working hours to be from 7.30 a.m. to 12 noon and from 1 p.m. to 4.30 p.m.

3.—Additional Allowances to Shiftworkers and Casual Hands.

(a) All workers employed on regular shift work shall be paid an allowance equal to 5 per cent. of their ordinary weekly rate of pay for any week during which they work afternoon shift and an allowance equal to 10 per cent. of their ordinary weekly rate of pay for any week during which they work night shift.

(b) Shift workers called on to work shifts without having been previously rostered shall be deemed "casual shift workers" and shall be paid an allowance for the first week only of fifteen shillings (15s.) per week in addition to their ordinary rate of pay.

(c) The additional allowances mentioned in sub-clauses (a) and (b) hereof shall be taken into consideration when calculating overtime rate for any overtime for work done beyond eight (8) hours per day on Mondays to Fridays inclusive. Except as aforesaid the above allowances shall not be included for purpose of calculating any other penalty rates under this Agreement.

(d) Casual hands shall be paid by the hour at the rate of ordinary pay plus two shillings (2s.) per day.

4.—Overtime.

If any employee works earlier than his starting time or later than his ordinary quitting time, he shall be paid overtime at the rate of time and a half for the first four hours and double time thereafter, each day to stand alone. The same rates shall be paid for Saturday work.

5.—Record Book.

The Company shall keep a record of the time of each employee of the time he starts and finishes each day and of the total amount of hours worked, and of the wages paid to each employee. Such record shall be open to the inspection of the secretary of, or any person appointed by the employees' Union, during working hours. Each employee shall sign the record kept for all moneys received by him.

6.—Sundays.

All work performed on Sundays by employees in any department shall receive payment for the same double time rate. Workers who are required to work shift work shall be allowed one Sunday off in three.

7.—Holidays.

(a) All work performed by workers in any department on the undermentioned holidays shall be paid for at a rate equal to one and one-half (1½) times the ordinary rate of pay, and in addition such workers shall be paid one (1) day's pay for the holiday. All holiday shifts shall rotate. One ordinary day's pay shall be paid for the undermentioned holidays to workers who do not work that day.

(b) The days to be observed as holidays according to the provisions of this Agreement are Christmas Day, Boxing Day, New Year's Day, Annual Picnic Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day (in June), Kalgoolie Cup Day, Boulder Cup Day and Sovereign's Birthday. In case any of the above holidays (except Labour Day and Easter Monday) fall on a Saturday, a Sunday or a Monday another day as near as possible to the following Wednesday shall be observed in lieu thereof.

(c) It is agreed between the employer and Union that in the event of any driver being called upon to work on holidays such driver is to be paid in accordance with subclause (a) per hour worked (a part of an hour to be paid for as a full hour) up to 10 a.m. and if such driver works after 10 a.m. he shall be paid for the full shift in accordance with subclause (a).

(d) Any employee (excepting drivers) working any part of a shift shall be paid for the full shift in accordance with subclause (a).

8.—Annual Leave.

Each employee on completion of 12 months' service shall be granted two week's annual leave on double pay and one week's leave on single pay, such leave to be taken at times to be mutually agreed upon between the workers and the employers between the 1st March and the 31st October in each year. The annual leave shall be in addition to the holidays mentioned in clause 7 hereof. On termination of service of a worker who has been continuously employed for more than three months he shall receive a pro rata payment in lieu of leave on the basis of two and one-twelfth days' pay for each completed month of service.

On termination of service of a worker who has been continuously employed for more than one month, but less than three months he shall receive a pro rata payment in lieu of leave on the basis of one and one-quarter day's pay for each completed month of service.

9.—Absence Through Sickness.

(a) A worker who is unable through sickness or accident to attend his duties shall notify the employer not later than 10 a.m. on the day he first absents himself from duty.

(b) A worker shall be entitled to sick pay in respect of any period of absence on account of sickness after the 1st day of January, 1948, on the basis of one-half day's pay for each completed month served with the employer between the said 1st day of January, 1948, and the date of the commencement of such absence provided that in calculating the amount due to a worker in respect of any particular period of absence through sickness there shall be deducted therefrom any sum or sums previously paid to him hereunder.

(c) The term "sickness" shall not include any case where the worker is entitled to compensation under the Workers' Compensation Act.

(d) No worker shall be entitled to the benefits of this clause unless he produces proof of his sickness satisfactory to his employer. This proof shall be in the form of a medical certificate if the absence is for three days or more. The employer shall have the right at any time to have the worker examined by a doctor on behalf of the employer.

(e) Except as aforesaid, a worker shall not be entitled to payment for time lost through sickness or accident.

10.—No Contract or Piecework Shall be Permitted.

All work of any employee in the capacity as mentioned in this Agreement in or about a brewery or bottling works or in connection with the business of brewing or beer bottling shall be carried

out departmentally by bona fide breweries' employees engaged and paid direct by the brewery proprietors and not by agents or contractors. This clause shall not apply to contractors erecting, repairing or making alterations to building or machinery or to carriers being engaged for the delivery of goods other than beer or empties or brewing materials as has been the practice or custom prior to this date. The employer agrees that such carriers employ only bona fide members of the Transport Workers' Union.

11.—Engagement.

The engagement between the employee and the employer shall be weekly; a week's notice from either party to terminate same except in the case of any employee absenting himself from duty not obeying lawful commands or being guilty of misconduct or of the works of the employer being stopped through fire or tempests or damage by the Queen's enemies when such agreement shall be terminated immediately.

12.—Discharge and Re-engaging Hands.

The question of dismissal and re-engagement of Union members shall be administered in a just and fair spirit according to the seniority of service but reserving to the employer the right to depart from the rule of seniority of service in circumstances where the employee is technically unqualified for the work, is incompetent or guilty of misconduct or in the opinion of the employer inconvenience would be occasioned to the employer owing to the inclusion in the dismissals of some essential man or the inability of the employer to re-engage some essential man. This clause to apply only to men of at least one year's continuous service. The following departments shall be considered as separate employment for the purpose of this clause:—

- (a) Bottle department.
- (b) Brewery.
- (c) Delivery.

13. No employee who has previously been in receipt of higher wages than arranged for in this schedule shall be reduced in wages under his present employment and shall receive a similar increase to all other employees.

14. Any employee who considers himself unfit or not capable of earning the wages hereinbefore prescribed may be paid such less wages as may be agreed upon between the employer and the secretary of the Union. In default of such agreement being arrived at within 24 hours after application has been made in writing to the secretary of the Union the matter may be referred to the nearest Resident Magistrate for settlement. Any employee whose wage has been so fixed may work and be employed by any employer for such less wage for a period of six calendar months then next ensuing and thereafter until 14 days' notice in writing shall be given to such employee by the secretary of the Union requiring his wages to be again fixed.

15.—Annual Bonus.

The employer shall pay each employee receiving wages under this Award a week's pay by way of bonus in the last week in December in each year. Any employee leaving the employer's service for reasons other than misconduct, dishonesty or neglect of duty before the payment of such bonus in any year shall, when leaving, be paid a pro rata payment in lieu thereof; any employee who shall not have been in the employ of the employer for a year in the first week in December shall receive a part of his week's pay bearing the same proportion to a week's pay as the period of his service bears to a year.

16. All employees on day shift in or about a brewery or bottling works shall, if required to work more than one hour overtime after the usual finishing time be entitled to knock off for one hour after the usual finishing time for refreshments. Any alteration to be by mutual arrangement.

17. Where an employee is required to take a "leading position" he shall during the time he occupies such position receive the sum of £1 per week in addition to his ordinary rate of pay.

18.—Long Service Leave.

(a) All workers who from time to time shall complete 25 years' of continuous service with the employer shall be given long service leave. Such long service leave shall be taken at the conclusion of 25 years of continuous service and shall comprise 13 weeks' leave of absence for recreational purposes.

(b) Should a worker who has completed 15 years of continuous service be retired compulsorily on medical grounds on the advice of a medical officer appointed by the employer, or by reason of being over the employer's retiring age, or die before completing 25 years' continuous service, there shall be paid by the employer to such worker or to his dependants as the case may require, a sum of money bearing the same relation to 13 weeks' pay at his rate as his service with the employer bears to 25 years.

"Dependant" shall mean the widow and/or children under the age of 16 years or any child in fact dependant of any worker and in the case of a single worker shall mean such dependant (if any) as such single worker may in writing notify to the employer during his lifetime accompanied by proper proof of actual dependency.

(c) Continuous service shall include any interval spent on service with Her Majesty's Armed Forces during the duration of any war on which Her Majesty may be engaged and shall also include any interval spent during the duration of any war on which Her Majesty may be engaged with any national service into which a worker is compulsorily drafted for defence purposes.

(d) Unless otherwise agreed in individual cases long service leave shall be taken at such period as shall be mutually agreed upon within two years of it becoming due. In default of agreement it shall be taken at such time within such period of two years as the employer shall determine.

(e) Except in the case of a worker who at the time he becomes eligible for long service leave is of an age exceeding 60 all long service leave shall be taken by way of actual holiday and not by way of payment in lieu thereof on retirement. A worker who at the time he becomes eligible for long service leave is beyond 60 years of age shall have the option of taking actual holiday under this scheme or of receiving payment in lieu thereof on retirement. Such option shall be exercised by a notice in writing addressed to the employer at the time of becoming eligible for long service leave.

(f) Workers on long service leave shall while on such leave continue to be paid at the actual rate (exclusive of overtime or other allowance) enjoyed by them at the commencement of such leave. Except in special circumstances payment shall be at the same times as during normal employment but may be made by cheque by mutual arrangement.

(g) It shall be a condition of every worker's taking long service leave that he (or she)—

- (i) shall not under any circumstances be engaged in any gainful employment while on such leave;
- (ii) shall return to the active service of the employer forthwith at the expiration of the leave; and
- (iii) shall not draw any sick or accident pay simultaneously with long service leave pay.

A breach of condition of (i) above will result in immediate discharge from the employer's service accompanied by forfeiture of all rights (if any) to retiring allowance or other similar payments or benefits. A breach of condition (ii) above (except as on the grounds of illness necessitating retirement or additional leave on the advice of a medical officer appointed by the employer) will result in forfeiture of all rights (if any) to retiring allowance or other similar benefits or payments.

(h) In order to avoid manning difficulties the long service leave of workers who become entitled to the same in the first year of operation of the scheme shall be taken during such periods during the first two years of the scheme as shall be mutually agreed upon and in default of agreement at such times as the employer may decide.

(i) For the purpose of computation and allotment of long service leave all long service leave shall be deemed to become due on the 1st January next following the completion of the periods of 15 and 25 years' continuous service.

(j) The employer shall have the right in cases of emergency to recall any worker from long service leave in which case the unexpired leave shall be made up on some mutually convenient date.

(k) In order to avoid confusion and embarrassment workers whilst on long service leave shall not without the prior permission of the officer in charge of the particular establishment visit any of the premises of the employer except for the purpose of collecting pay or transacting genuine business with the employer's officers. Social visits shall not be indulged in. "Establishment" means any brewery, cooperage or workshop but does not include hotels or annual picnics or sports or usual weekly competitive sporting activities.

(l) The benefits of long service leave shall be in addition to all benefits at present or hereafter to be enjoyed by workers.

(m) In the event of any Governmental or similar long service leave scheme being introduced for industry as a whole the parties concerned shall meet to consider alterations necessary in order to adjust the scheme to such new conditions.

(n) Notwithstanding anything in this clause contained no worker nor his legal personal representative shall be entitled to any of the benefits by this clause conferred in any of the following circumstances:—

(i) When in the opinion of the directors of the employer a worker has committed fraud upon the employer or any defalcation in relation to the employer or breach of trust or similar act prejudicially affecting or likely to so affect business or interests of the employer and is dismissed.

(ii) If the worker shall become a bankrupt or insolvent debtor within the meaning of any Act of the Parliament of the Commonwealth of Australia or of the State of Western Australia or shall assign alienate or charge his benefits hereunder or any part thereof or attempt to do so or if through his own act or default or by operation or process of law the same shall become vested in or payable to some other person, firm or company.

19.—Area.

This Agreement shall apply to the Eastern Goldfields district which district for the purpose of this Agreement shall mean that area enclosed by a circle drawn with a radius of 150 miles with the Kalgoorlie Post Office as the central point.

20.—Term.

This Agreement shall be for a term of twelve (12) months from the 29th November, 1952.
