ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1950, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient that Reserve Class A No. 11290 near Rocky Gully should vest in and be held by the Plantagenet Road Board in trust for the purpose of Camping Ground and Resting Place for Travellers and Conservation of Indigenous Timber and Flora: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Plantagenet Road Board in trust for the purpose aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

Metropolitan Water Supply, Sewerage
and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 1210/53.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections and estimates in respect of the works herein-after mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Water Supply Improvements.
Rockingham Road District.
Kwinana Water Supply.

Proposed 18in. and 24in. Feeder Mains.

(1) The laying of approximately $\frac{3}{4}$ -mile of 18in. nominal diameter steel water main.

(2) The laying of approximately 2½ miles of 24in nominal diameter steel water main.

This Order in Council shall take effect from the 25th day of September, 1953.

Dog Act, 1903-1948.
Municipality of Northam.

ORDER IN COUNCIL.

L.G. 1684/52.

HIS Excellency the Governor Acting by and with the advice and consent of the Executive Council, hereby makes the following order under the authority of section 35A of the Dog Act, 1903-1948, namely, that the Municipality of Northam is hereby empowered to make by-laws in pursuance of section 35 of the said Act, to have effect within the Northam Municipal District—(1) Empowering it, subject to the provisions of the Act under which it is constituted to establish and maintain a pound or pounds for the impounding of dogs seized pursuant to the provisions of the Act; (2) for the care, detention, release, disposal and destruction of dogs so seized; (3) prescribing fees to be payable in respect of the seizing; (4) prescribing the liability of any person in respect of payment of the fees referred to in the last preceding paragraph; (5) prohibiting the release from any pound of any dogs except in accordance with the regulations; (6) prohibiting the obstruction or hindrance of any employee of the Municipality of Northam or any member of the Police Force in the performance of anything authorised by the provisions of the Act or the regulations made in pursuance of those provisions; (7) imposing as an absolute prohibition an obligation on the owner of any dog that the dog shall not enter or be in—(i) such places as may be prescribed in any circumstances whatever, or (ii) such places as may be prescribed unless on a leash held by a person.

Dominion Civil Service Fellowships—British
Programme, 1954.

THE Commonwealth Fund Fellowships for study and travel in the United States were inaugurated in 1925 by the Commonwealth Fund. In maintaining international fellowships within a range of philanthropic interests, the directors of the Fund

are impelled by a belief in the value of international education and travel, and by a conviction that mutual understanding and amity between countries will thereby be forwarded.

The Fund's programme of international fellowships includes annual awards to candidates from the universities of the United Kingdom, to selected officers from the Home, Colonial and Dominion Civil Services within the British Commonwealth.

Appointments to the Dominion Civil Service Fellowships will be made on selections by the nomination committees in the dominions.

Five fellowships are offered in 1954 to outstanding men and women holding civil service appointments under the Commonwealth and State Governments of Australia.

8. The maximum number of licenses for the hawking of the same or substantially the same kind of goods, wares or merchandise which shall be in force under this by-law at the one time shall be four.

9. Before issuing a hawker's license the secretary of the Board may require the applicant to produce evidence as to his character and fitness to hold such a license, and the secretary may refuse to issue a license to any applicant who in his opinion is not a fit and proper person to hold a hawker's license: Provided that if the secretary so refuses the applicant shall be entitled to have his application considered by the Board.

10. The Board may cancel any hawker's license if in the opinion of the Board the holder thereof is not a fit and proper person to hold such a license.

CHITTERING VERMIN BOARD.

PURSUANT to the powers conferred on it by section 96 of the Vermin Act, 1918, the Chittering Vermin Board hereby orders as follows:—

(a) The respective occupiers and (where no person is in actual possession) owners of all holdings within the district of the Board, shall commence the work of destroying rabbits on such holdings and upon roads bounding or intersecting same not later than the 1st November, 1953, and shall continue and systematically carry out the said work for a period of 12 months commencing on the said date.

(b) The means which shall be adopted for carrying out the said work shall be one or all of the following:—

- (1) To lay poison baits not more than eight feet apart in a well defined trench or furrow at all localities on the said holdings where the evidence of the presence of rabbits exists.
- (2) The fumigation or complete destruction by ripping of all rabbit warrens.

Any person failing to comply with the requirements of this order will be liable to prosecution under Section 97 of the Act without further notice.

INDUSTRIAL AGREEMENT.

No. 14 of 1953.

(Registered 3rd September, 1953.)

THIS Agreement made in pursuance of the "Industrial Arbitration Act, 1912-1952" this twenty-fifth day of August One thousand nine hundred and fifty-three, between the West Australian Local Government Bodies' Officers' Association Union of Workers, Perth, of the one part; and the Perth Road Board of the other part, whereby it is mutually agreed by and between the parties hereto as follows:—

Clause 1.—Title.

This Agreement shall be known as the Perth Road Board Officers' Agreement, 1953.

Clause 2.—Agreement.

Clause 3.—Scope.

This Agreement shall apply to all Officers in the employ of the Perth Road Board excepting Health Inspectors.

Clause 4.—Area.

This Agreement shall have effect over the area comprised within the boundaries of the Perth Road Board, and the area comprised in any office or land upon which any undertaking of that Road Board is being carried on.

Clause 5.—Term.

The term of this Agreement shall be for a period of three (3) years from the date hereof.

Clause 6.—Definitions.

(a) "Board" shall mean the Perth Road Board.

(b) "Engineering assistant" shall mean an officer classified as such and qualified by training or experience to work under the direction of the Engineer or the Assistant Engineer on surveys, draughting and/or design or works, structures and or general routine work of the Engineering Department, but excluding a fourth-year university engineering student.

(c) "Executive Officer" shall mean and include the Secretary, Engineer, Assistant Secretary and Accountant, and the Assistant Engineer.

(d) "Temporary Officer" shall mean one who is engaged for less than one week.

(e) "Union" shall mean the West Australian Local Governing Bodies' Officers' Association.

(f) "Year" shall mean from the 1st July to the 30th June next ensuing.

Clause 7.—Hours of Duty.

(a) Except as hereinafter provided the hours of duty of officers shall be 8.30 a.m. to 5 p.m. Monday to Friday inclusive with a break of one hour for lunch between noon and 2 p.m.

(b) The hours mentioned in sub-clause (a) hereof may be varied by agreement between the Board and its officer or officers and, where the duties appertaining to any office cannot be efficiently carried out within the prescribed hours, then in default of such agreement the hours of work shall be determined by the Board of Reference.

Provided however that the officer or officers concerned shall not be required to work (except subject to the provisions of the next following clause) a greater number of hours than those specified in sub-clause (a) hereof.

(c) The hours of duty of foremen and other officers who exercise control over non-clerical workers shall be the same as those of the men over whom they exercise control.

Clause 8—Overtime.

(a) All work done outside the hours specified in Clause 7 hereof shall be paid, subject to sub-clause (b) hereof, at the rate of time and a half for the first four (4) hours and double time thereafter each day, or on Sundays at the rate of double time, or alternatively time off during working hours may be allowed equivalent to the time worked outside the ordinary hours, or such time may be allowed to accumulate and may be added to the period of annual leave hereinafter prescribed.

(b) Attendance at meetings for any Executive Officer shall not be considered as time worked outside the prescribed hours, except insofar as any of such meetings exceed in the aggregate twelve hours per month.

(c) No officer, other than an Executive Officer, shall be entitled to claim payment for overtime unless such overtime worked has been authorised beforehand by an Executive Officer.

(d) A statement of the overtime worked shall be submitted at each meeting of the Board containing particulars of all overtime alleged to have been worked since the expiration of the preceding meeting, by any officer. No claim for overtime shall be payable or other allowance made thereunder, after three (3) months from the expiration of the time when the overtime is alleged to have been worked unless the statement relating thereto hereinbefore referred to has been furnished to the Local Authority.

(e) Where an officer is required to work on after the usual time for ceasing duty, he shall, where such additional duty necessitates taking a meal away from the usual place of residence, be reimbursed for each meal at the rate of four shillings and sixpence (4s. 6d.) and shall be reimbursed the cost of each meal necessarily taken away from the usual place of residence on Saturdays, Sundays and public holidays at the rate of four shillings and sixpence (4s. 6d.) for each meal. Provided that in each case the overtime worked before and after a meal break totals not less than two hours.

Clause 9.—Higher Duties.

(a) Where any adult officer performs the duty of a position higher than that in which he is usually employed for a period exceeding one month, he shall be paid while performing any such duty, at a rate not less than the salary payable to the officer relieved.

(b) Where any officer regularly carries out the duties, or occupies a dual office, he shall be paid the salary pertaining to the higher office.

Clause 10.—Resignations or Dismissals.

Subject to the provisions of the Road Districts Act or Acts for the time being in force, the following provisions shall apply:—

(a) The Secretary, Engineer, Assistant Engineer, Assistant to the Building Surveyor, Building Inspector or any Engineering Assistant shall not leave his position until the expiration of one month's notice in writing of his intention so to do without the approval of the Board.

(b) One month's notice shall be given by the Board to any officer coming within the provision of sub-clause (a) hereof whose services are no longer required; provided that this sub-clause shall not apply to cases of summary dismissal for misconduct.

(c) In the case of officers not included in (a) and (b) hereof, one week's notice on either side shall be deemed sufficient notice to terminate the contract of employment; provided that after ten (10) years' service in the employment of the Board, one month's notice on either side shall be required to terminate the contract of employment of an officer; provided further that this sub-clause shall not apply to cases of summary dismissal for misconduct.

(d) One day's notice on either side shall be deemed sufficient to terminate the contract of employment of temporary workers.

Clause 11.—Holidays.

(a) The following days, or the days observed in lieu, shall be granted as holidays and paid for, namely:—New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Queen's Birthday, Christmas Day and Boxing Day, and any other day or days which may be proclaimed as a public holiday under the Public Service Act as a holiday for persons employed in the Public Service of the Government of Western Australia.

(b) Where an officer is required to be on duty on any of the abovenamed holidays, he shall be allowed equivalent time off duty or an equivalent number of days may be added to his Annual Leave.

Clause 12.—Annual Leave.

(a) All officers shall be entitled to two weeks' annual recreation leave (exclusive of intervening holidays) on full pay. The leave shall be taken at a time mutually convenient to the officer and the Board, at any time within six months of its becoming due.

(b) By agreement between the Board and any of its officers, leave may be allowed to accumulate up to and including a period not exceeding that allowed for three years' service.

(c) An officer not completing one year's service shall be granted pay in lieu of Annual leave in proportion to his or her length of service.

(d) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

Clause 13.—Sick Leave.

(a) No worker shall be entitled to payment of salary or wages on the grounds of ill-health except on the following terms and conditions:—

(i) On production of a medical certificate satisfactory to the employer or other evidence of a satisfactory nature, an officer shall be entitled to sick leave on the following scale:—

(a) First eighteen months' continuous service, up to a total of three weeks on full pay.

(b) Over eighteen months' continuous service and up to three years; three weeks on full pay and three weeks on half pay.

(c) Over three years' continuous service and within each subsequent triennial period from the expiration of the first three years; three months on full pay.

(ii) When an officer is in receipt of payment under the Workers' Compensation Act and is entitled to payment under the preceding sub-clause, the obligation of the employer hereunder shall be deemed to be discharged upon the payment of the difference.

(b) When an officer absents himself from duty without reasonable cause or in excess of the allowance herein provided for, the employer may deduct from his pay a sum proportionate to his time of absence.

Clause 14.—Record.

(a) A readily intelligible Record shall be kept by the Board containing the following particulars:—

- (i) The name of each officer.
- (ii) The class of work upon which the officer is engaged.
- (iii) The hours worked each day.
- (iv) The salary (and overtime, if any) paid to each officer.

(b) Such record shall be signed by the officer and shall be opened for inspection, during office hours, by the Secretary or an accredited representative of the Union, and such person may take extracts therefrom.

Clause 15.—Instruments.

The Board shall provide and maintain all instruments and equipment.

Clause 16.—Board of Reference

(a) The Court may appoint, for the purpose of this Agreement, a Board or Boards of Reference. The Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties hereto as prescribed by the Regulations to the "Industrial Arbitration Act, 1912-1952." There is assigned to the Board in the event of no agreement being arrived at between the parties to this Agreement the functions of—

- (i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of this Agreement or any of them;
 - (ii) deciding any other matter that the Court may refer to such Board from time to time.
- (b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to the "Industrial Arbitration Act, 1912-1952."

Clause 17.—Financial Statements.

The Financial Statements of the Board shall be made available to the inspection of the Secretary of the Union and a copy shall be supplied to the Union upon request.

Clause 18.—No Reduction.

No officer who at the date of this Agreement is in receipt of a higher rate of pay than is herein provided shall have his or her pay reduced as a consequence of this Agreement.

Clause 19.—Salaries.

The minimum salaries payable under this Agreement shall be as set out hereunder:—

(f) for the purposes of adjustment and payment, the weekly salary shall be calculated as one-fifty second (1/52nd) of the annual salary.

(g) Any officer who at the date of commencement of this Agreement has been employed in the classified position in which he is the present occupant for at least two years shall be entitled to the rate applicable to the third year. Any such officer who has been employed in such position for at least one year shall be entitled to the rate applicable to the second year. Any such officer who has been employed in such position for less than one year shall be entitled to the rate applicable to the first year.

(h) Any officer who, following the date of commencement of this Agreement, completes one year in the classified position of which he is an occupant shall be entitled to the rate applicable to the second year for such position, and after com-

pleting two years in such position shall be entitled to the rate applicable to the third year. Any officer who, following the date of commencement of this Agreement, is appointed to a classified position shall be entitled to the rate applicable to the first year.

(i) Temporary workers shall be paid at the rate of ten per cent. (10%) in addition to the rates prescribed herein.

IN THE COURT OF ARBITRATION OF WESTERN AUSTRALIA.

Between Western Australian Amalgamated Society of Carpenters and Joiners' Industrial Union of Workers, Applicant, and Minister for Works and others, Respondents.

THE Conciliation Commissioner, in pursuance of the powers and duties conferred upon him by section 108B of the Industrial Arbitration Act, 1912-1952, and in pursuance of a remission made to him by the Court of Arbitration, doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties.

1.—Title.

This Award shall be known as the "Carpenters' 1953 Government Award" and replaces Award No. 25A of 1947 as amended.

3.—Definitions.

Carpentry and Joinery.

(i) "Carpenter and joiner" means a worker engaged upon the erection, repair, ornamentation and demolition of work in wood for re-erection, or of any form of construction work in wood, and upon the work usually done by carpenters and joiners in any engineering or millwright shop or yard, the building of bridges, jetties and/or wharves, or the fixing of any other work in wood, metal or plastic usually done by carpenters and joiners in hospitals, mills, freezing works, cool stores, and all other places where carpenters and joiners are usually employed, and upon the making, preparing and fixing of any other materials usually used in joinery or construction necessitating the use of carpenters' tools or machines in lieu thereof, including—

- (a) metal ceilings, the fixing of the following asbestos products—plain and corrugated sheets, gutters, downpipes, ridgings, rain heads, ventilators and skylights, fascia and barge-boards;
- (b) metal shop front and fittings;
- (c) the setting out and laying of wood blocks or parquet flooring;
- (d) all pre-fabricated buildings in wood construction in factories or on site.

(ii) "Setter out" means a carpenter and joiner who sets out work (other than wood blocks or parquet flooring) for three (3) or more carpenters and joiners.

(iii) "Detail Worker" means a carpenter and joiner who sets out and works upon staircases, bar, kitchen or office fittings or any similar detail work from architects' plans or blue prints.

4.—Scope.

This Award shall apply to all carpenters and joiners and apprentices in such callings employed by the Minister for Agriculture, the Minister for Health, the Minister for Lands, the Minister for Works, the Minister for Water Supply, Sewerage and Drainage, the Minister for the North-West, the Minister for Trading Concerns, the Minister for Education, the Rottne Board of Control, the Main Roads Board, and the State Shipping Service: Provided this Award shall not apply to workers employed under Awards Nod. 46 and 46a of 1948, and any amendments thereto.

5.—Area.

This Award shall have effect over the whole of the State.

6.—Term.

The term of this Award shall be for a period of three (3) years from the date hereof.

7.—Contract of Service.

(a) The contract of service shall be by the day and shall be terminable by one (1) day's notice on either side, except in the case of a casual worker, when one (1) hour's notice shall suffice.

(b) The employer shall be under no obligation to pay for any day not worked on which the worker is required to present himself for duty, except such absence from work is due to illness and comes within the provisions of clause 25, or such absence is on account of holidays to which the worker is entitled under this Award.

(c) This clause does not affect the right to dismiss for misconduct, and in such cases wages shall be paid up to the time of dismissal only.

(d) The employer shall be entitled to deduct payment for any day or portion of a day on which the worker cannot be usefully employed because of any strike by the Union or unions affiliated with it, or through the breakdown of the employer's machinery, or any stoppage of work by any cause

which the employer cannot reasonably prevent, with the exception of wet weather, in which case the decision as to whether it is too wet to work shall rest with the officer in charge of the job, if available, and, in his absence, the foreman.

(e) The rate of payment in the "Wages" clause is, for the purpose of convenience, expressed in weekly amounts.

8.—Terms of Service.

(a) Each worker shall faithfully serve his employer on the work in which he is employed, in compliance with the terms and conditions of this Award.

(b) A worker employed by an employer shall not without the express consent of such employer and the Union accept temporary or other employment with any other employer whilst in such employ, nor shall such worker undertake a contract or sub-contract to perform any other work whilst his employment by the firstmentioned employer continues.

9.—Preference to Unionists.

(a) Preference of employment shall be given to financial members of the Union party to this Award.

(b) Before being engaged, an applicant in the metropolitan area shall produce evidence that he is a financial member. This provision shall also apply outside the metropolitan area, provided, however, that if the applicant is unable to produce satisfactory evidence immediately he shall furnish same within a reasonable period.

(c) The employer shall not continue to employ a person not a member of the applicant Union if a member of the Union is available at the job and ready to perform the work, and produces reasonable proof of his experience on the class of work being performed.

(d) The benefits of this clause shall not apply to any worker who has taken part in a strike or stop-work meeting during the currency of this Award.

10.—Payment of Wages.

(a) Workers shall be paid weekly where practicable.

(b) When a worker is discharged before the usual pay day he shall be paid his wages when he ceases work or it shall be forwarded to his address within seven (7) days by registered post at the employer's risk.

11.—Rates of Pay.

The minimum rate of wages payable under this Award (other than to duly registered apprentices) shall be:—

The latter allowance shall not be payable to a worker for any week in which he is employed for the major portion of the time in the maintenance depots, e.g., Wittenoom Street, Perth; Mouatt Street, Fremantle, or who is permanently employed on maintenance work at any one establishment.

(d) Casual Workers.—Any worker who is employed for less than one week shall be considered casual, and shall receive ten per cent (10%) per day in addition to the rates prescribed in this Award: Provided this subclause shall not apply in the case of a worker dismissed for misconduct or incompetence.

12.—Under-rate Workers.

(a) Any worker, who by reason of old age or infirmity is unable to earn the minimum wage, may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

13.—District Allowances.

In addition to the wages prescribed in clause 11 the following allowances shall be paid to workers in the undermentioned areas:—

Provided that where the employer provides or pays for board and lodging pursuant to clause 15 of this Award, the above allowances shall be halved.

14.—Special Rates and Provisions.

(1) Leading Hand.—Any tradesman placed in charge of three (3) or more tradesmen or of six (6) workers shall be paid as a leading hand tradesman.

Leading tradesmen shall receive fifteen shillings (15s.) per week above the minimum rates in the district in which they are employed.

(2) Workers employed on the following work shall be paid at the rate of fourpence (4d.) per hour in addition to the prescribed rate whilst so employed:—

- (a) Working on a boat-type or swinging scaffold.—"Swinging scaffold" means any scaffold suspended from overhead gear and not supported from the ground and which by reason of the operations carried out on it or by reason of wind force or vibration is likely to swing or sway. (No employer shall permit an apprentice who has served less than two (2) years to work on a boat-type or swinging scaffold and no such apprentice shall work on any such scaffold.)
- (b) Excessively dirty work which is likely to render the worker or his clothes dirtier than the normal run of work (with a minimum payment as for four (4) hours when employed on such work).
- (c) Insulating work in an average temperature of forty-five (45) degrees F. or under.
- (d) Working for more than one (1) hour continuously in the shade in places where the temperature is raised by artificial means to exceed 130 deg. F.
- (e) Working in dust-laden atmosphere caused by the use of materials for insulating, deafening or pugging work (as, for instance, pumice, charcoal, silicate of cotton or any other substitute).

(f) Working in any confined space in and around a building. "Confined space" means one of which the dimensions are such that the workman must work in an unusually stooped or cramped position or without adequate ventilation or where confinement within a limited space is productive of unusual discomfort to him.

(3) While working in a place where water is continually dripping so that the worker's clothes become wet with soakage, or where there is water underfoot so that the worker's feet become wet, the worker shall be paid one shilling and fourpence (1s. 4d.) per day in addition to the prescribed rate. This subclause shall not apply to natural surfaces made wet by rain. Where watertight boots are provided by the employer, no claim shall be allowed under this provision for wet feet.

(4) Offensive Allowance (Robbs Jetty).—Workers working in the effluent at Robbs Jetty shall be paid an allowance of fourpence (4d.) per hour extra.

(5) Bitumen or Tar Work.—Any worker actually coming into contact with hot or viscous tar or bitumen whereby his clothing becomes injuriously affected shall be paid an allowance of one shilling and sixpence (1s. 6d.) a day in addition to the prescribed rate of pay unless protective material is used.

(6) Setter Out.—A "setter out" in a joiner's shop shall be paid one shilling and sixpence (1s. 6d.) per day extra above the minimum rate hereinbefore prescribed for his trade, but where a worker qualifies for an allowance under this subclause and also under subclause 1 hereof, he shall be entitled to whichever allowance is the higher, but not to both.

(7) Detail Worker.—A joiner engaged on detail work shall be paid one shilling and sixpence (1s. 6d.) per day extra above the minimum rate hereinbefore prescribed for his trade, but where a worker qualifies for an allowance under this subclause and also under subclause 1 hereof, he shall be entitled to whichever allowance is the higher, but not to both.

(8) The employer shall provide suitable grinding facilities, together with the required power (hand or driven) where such facilities are reasonably necessary for the use of workers other than casual workers (and where an emery stone is provided it shall not be less than one and one-quarter inches in width) or, at the option of the employer, pay the sum of one shilling and sixpence (1s. 6d.) per week extra where no such grinding facilities are available on the job for the use of workers.

(9) First Aid Outfit.—Where ten (10) or more workers are employed on a job, the employer shall provide a supply of bandages and antiseptic dressing for use in cases of accident.

(10) Provision of Boiling Water.—The employer shall, where practicable, provide boiling water for the use of his workers on each job at lunch time.

(11) Attendants on Ladders.—No worker shall work on a ladder at a height of over twenty (20) feet from the ground, when such ladder is standing in any street, way or lane where traffic is passing to and fro, without an assistant on the ground.

(12) Sanitary Arrangements.—The employer shall comply with the provisions of section 102 of the Health Act, 1911-1952.

(13) Change Room.—The employer shall, where practicable, provide on each job a suitable and convenient change room where the workers may change their clothes. The change room shall not be used for storing lime, cement or other similar materials.

(14) Protection of Workers' Tools.—Carpenters—A secure and waterproof place shall be provided by the employer where the carpenter's tools may be locked up apart from the employer's plant or material.

15.—Country Allowance.

(a) When a worker is instructed to proceed on duty from a place where he is then or usually employed, the employer shall pay all fares, including sleeper and a proper allowance at current rates for all necessary meals, or board and lodging. Fares

shall be second class, except when travelling by coastal boat, when saloon fares shall be paid, and shall include return fare on completion of job, or after twelve (12) months on job.

(b) Travelling time shall be at ordinary rates, at place of departure, with a maximum of a day's pay when travelling by boat or in a sleeper. When travelling by night without a sleeper, the worker shall be entitled to receive an extra day's pay for such travelling. No time to be lost for travelling.

(c) The employer shall provide free transport for the worker's tools.

(d) (i) If a worker who has been transferred from his place of employment to duty away from his home in accordance with subclause (a) hereof, elects to return to his home at the week-end after three (3) months' continuous service away from home in the employ of the one employer and thereafter at the end of each three (3) monthly period, he shall be paid a second-class return rail or bus fare on the pay day which immediately follows the date on which he returns to the job, unless travelling facilities are provided.

(ii) This provision shall only apply where it is reasonably practicable for a worker to travel to his home and return by rail or road transport other than in working hours or within such additional time as may be approved by the employer, and the worker shall not be re-imbursed for such fares unless his return to the job is within the aforementioned times.

(iii) Where such a worker has been employed by the one employer for six (6) months to work at a distant place from where it was not practicable to return to his home at the end of three (3) months he shall be entitled to return at the end of six (6) months and the provisions prescribed in paragraph (ii) hereof shall apply.

16.—Fares and Travelling Allowance.

(a) The Department shall, in all cases, pay all travelling expenses actually and reasonably incurred by the workers in going from the shop or yards of the Department, or from one job to another.

(b) The shop or yard is the recognised depot in each district. On construction work the job shall be the recognised depot: Provided, however, on construction work employees under this Award shall be allowed the same conditions as to fares as are prescribed by award or agreement for the joint body of employees of the industry in which they are employed.

(c) In all cases where a worker is not required to attend at the shop or yard as above, of the Department, but goes direct to the job, the Department shall pay all fares actually and reasonably incurred by a worker in excess of one and sixpence (1s. 6d.) per day, and which are incurred in travelling from his usual place of residence to such job, or from such job to his residence.

Provided that where the distance necessarily travelled from a worker's place of residence to the job and return is in excess of twelve (12) miles per day, the worker shall be paid a travelling allowance at the rate of fourpence (4d.) per mile for each mile in excess thereof; provided that the maximum daily allowance under this subclause shall be four shillings (4s.): Provided further that if the employer provides a conveyance for more than half of the distance travelled, the allowance payable shall be reduced by one-half. Provided that this subclause shall not apply to workers required to attend at the shop or yard of the Department.

(d) Where the worker uses any kind of conveyance (including a push cycle but not including a public conveyance, or a conveyance provided by the employer) the amount of fares for which the employer would have been liable in accordance with subclause (c) of this clause, if the worker had used a public conveyance, shall be paid by the employer to the worker.

(e) During the hours of work all travelling time from and to the employer's place of business or from one job to another shall be paid for by the employer at ordinary rates. The employer shall pay all fares in connection with such travelling.

(f) When a conveyance is provided by the employer and such conveyance is regularly used for the transport of workers to and from work, such conveyance shall be provided where reasonable with suitable seating accommodation and weatherproof covering.

17.—Camp Allowance.

(a) Workers required to live in tents at or in the neighbourhood of the job shall be paid the same allowance and receive the same camping conditions as are prescribed by award or agreement for the joint body of employees of the industry in which they are employed.

(b) Pitching and Striking Camp.—In cases where the nature of the work necessitates the pitching of a temporary camp, and when such camp is shifted to suit the requirements of the work, then the employer shall allow full pay for the actual time reasonably taken in striking and pitching camp and the erection of bunks. The employer or his representative shall decide as to what is a reasonable time for the striking and pitching, and payment shall be made accordingly. In the event of any dispute arising under this subclause, the same may be decided by the Board of Reference.

18.—Hours.

(a) Forty (40) hours shall constitute a week's work.

(b) Subject as hereinafter provided, such hours shall be worked on the first five (5) days of the week and eight (8) hours shall be worked on each day between the hours of 7.30 a.m. and 5 p.m., with an interval of not less than forty-five (45) minutes for lunch.

Provided, however, that in the case of repairs and renovations to shops or business premises, where the work is likely to cause discomfort and inconvenience to the users of the premises, the foregoing hours may be altered to 7 a.m. to 6 p.m. on the first five (5) days of the week, but a shift shall not be broken except for the duration of the meal period. Where the employer avails himself of the proviso to this subclause he shall notify the Union in writing within forty-eight (48) hours of the commencement of the job.

19.—Overtime.

(a) (i) All time worked in excess of or outside of the usual working hours shall be paid at the rate of time and a half for the first four (4) hours after the usual stopping time and double time thereafter, provided that all work after 10 p.m. on Monday to Friday, inclusive, or 5 p.m. on Saturday, shall be paid at double time up to the usual starting time: Provided, also, that workers called upon to start work within an hour and a half of the usual starting time shall be paid at time and a half until the usual starting time.

(ii) Unless otherwise agreed between any respondent and the Union in the case of a worker who works a five (5) day week, Monday to Friday, inclusive, under a determination pursuant to subclause (b) of clause 18, and who works overtime on a Saturday, for the first four (4) hours of overtime, time and a half rate and thereafter double time rate, shall be paid, but if the worker works in any period after 5 p.m. on a Saturday he shall be paid double time rate for all time worked after that hour.

(b) Systematic overtime shall not be worked. Overtime shall be considered systematic when two (2) weeks' continuous overtime has been worked: Provided that this subclause shall not apply to cases where, after application to the unions has been made, extra labour is not forthwith available. No worker shall be required or permitted to work more than eighteen (18) hours' overtime in any one (1) week, except in the case of a breakdown of the employer's plant.

(c) For all work done on Sunday, double time shall be paid with a minimum of two (2) hours.

(d) A worker called back after completing a day's work, or called out on a Sunday, shall be paid a minimum of two (2) hours at overtime rates, but if he is called out within any period of two (2)

hours of a call, he shall not be entitled to any further payment for time worked within the period of two (2) hours from the time when he commenced work in response to his first call.

(e) When a worker is required to continue working after knock-off time for more than one (1) hour without being notified the previous day, he shall be supplied with any meal required, or be paid 3s. for such meal.

(f) When a worker is required for duty during any meal hour he shall be paid overtime rate until he be allowed the usual length of time for a meal.

(g) Notwithstanding anything contained herein—

(i) an employer may require any worker to work reasonable overtime and such worker shall work the overtime in accordance with such requirement;

(ii) an organisation party to this Award, and/or a worker or workers covered by this Award, shall not in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with (i) above;

(iii) the provisions of this subclause shall remain in operation only until otherwise determined by the Court.

20.—Shift Work.

(a) When shift work is required, all shifts except the day shift shall be paid for at the rate of time and a quarter: Provided, however, that on construction works, when the work is performed by the workers covered by this Award, is subsidiary and auxiliary to that of the majority of workers on such works (e.g., reservoir and drainage construction works) and on which no penalty rate is payable to the other workers, the workers covered by this Award shall work all shifts at ordinary rates. On such works, workers shall be allowed to rotate shifts and change of shifts as far as possible be arranged to suit transport facilities. Provided, also, that if penalty or extra rates for such other workers are provided now or hereafter for such shift work, the workers covered by this Award shall also be entitled thereto.

(b) Work other than day shifts shall not be recognised as night shift unless five (5) consecutive nights are worked, but shall be deemed to be overtime: Provided that where a shift is not worked on account of a holiday such shift for the purpose of this clause shall be counted as if it had been worked.

(c) Overtime on night shifts shall be calculated on the basis of the rate paid for night shift.

(d) For the purpose of this clause "day shift" shall be construed to mean the ordinary working shift ending at or before 6 p.m. on Mondays to Fridays.

(e) In connection with two-shift work when the workers are camped at or near the job, the first shift shall work eight (8) hours not including any crib time and all other shifts shall be of eight (8) hours, including half an hour's crib time, i.e., seven and a half (7½) hours actual working time. Provided that where, for the convenience of the Department, the two (2) shifts are confined within a total spread of sixteen (16) hours, each shift shall be entitled to half (½) an hour crib time within the eight (8) hour shift.

Where two (2) shift work is in operation, the ordinary hours of commencement shall not apply to the first shift.

(f) This clause shall not apply to the Architectural Division.

21.—Walking Time.

Any worker employed on work away from his usual place of occupation more than one (1) mile by the shortest possible route from the nearest railway station or public transport facility shall receive sixpence (6d.) per day in addition to his ordinary pay unless travelling in the Department's time. This clause will not operate in regard to workers living on a job.

22.—Rest Period.

(a) Subject to the provisions hereinafter contained, a rest period of seven (7) minutes from the time of ceasing to the time of resumption of work shall be allowed each morning.

This interval shall be counted as time off duty without deduction of pay and shall be arranged at a time and in a manner to suit the convenience of the employer. Morning tea may be taken by employees during this interval, but the period of seven (7) minutes shall not be exceeded under any circumstances. Upon proof of breach by any employee of any provision hereinbefore expressed or implied, the Court may grant the employer concerned exemption from liability to allow the rest period aforesaid.

(b) Workers engaged on essential emergency work or on some process in course (e.g., concreting) may be required to take the prescribed tea break at such time and in such manner as considered necessary by the officer in charge of the job, or in his absence, by the foreman.

23.—Holidays and Annual Leave.

(a) Holidays.

(i) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Union Picnic Day, Christmas Day and Boxing Day.

(ii) Union Picnic Day shall be the fourth Monday in November in each year: Provided, however, that where on a particular job a day other than Union Picnic Day is observed, that day shall be observed in lieu of Picnic Day.

(iii) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day, he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday, he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(iv) In the case of workers working a five-day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.

(v) Payment for holidays shall be in accordance with the usual hours of work.

(vi) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker is on duty or available on the working day immediately preceding a holiday, or resumes duty, or is available on the working day immediately following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

(b) Annual Leave.

(i) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.

(ii) If any award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(iii) (a) Subject to paragraph (b), when computing the annual leave due under this clause, no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays: Provided that no deductions shall be made for any approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deductions may be made for such excess only.

(b) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six (6) months only of any such period shall count as service for the purpose of computing annual leave.

(iv) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with such employer.

(v) Any worker who may resign or be dismissed from the service for any cause, other than for pecculation or theft, shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service: Provided always that if the worker has been dismissed for pecculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(vi) When work is closed down for the purpose of allowing annual leave to be taken, workers with less than a full year's service shall only be entitled to payment during such period for the number of days' leave due to them: Provided that nothing herein contained shall deprive the employer of his right to retain such workers at work during the close-down period as may be essential. Provided that on Government maintenance work, by arrangement with the employer, annual holidays may be rostered, subject always to the convenience of the employer.

(vii) Workers regularly working for the Government North of South latitude 26 shall be allowed to accumulate annual leave for two (2) years, subject to the convenience of the Department. Such workers who proceed to Fremantle and Geraldton during the period of such leave shall be allowed once in each two (2) years reasonable travelling time on the forward and return journeys between the place of their employment and either of the said ports.

(viii) "Ordinary wages" for the purpose of sub-clause (i) hereof shall mean the rate of wage the worker has received for the greatest proportion of the calendar month prior to his taking the leave.

(c) General.

The provisions of this clause shall not apply to casual workers.

24.—Long Service Leave.

The conditions governing the granting of long service leave to full time Government wages employees generally shall apply to workers covered by this Award.

25.—Absence through Sickness.

(a) (i) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week's pay for each completed month of service.

(ii) The liability of the employer shall in no case exceed one (1) week's wages during each calendar year in respect of each worker, but the sick leave herein provided shall be allowed to accumulate and any portion unused in any year may be availed of in the next or any succeeding year.

(iii) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act, 1912-1944.

(c) No worker shall be entitled to the benefit of this clause unless he produces proof satisfactory to his employer or his representative of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) consecutive working days or more.

(d) No payment shall be made for any absence due to the worker's own fault, neglect, or misconduct.

26.—Board of Reference.

(a) For the purpose of this Award, a Board of Reference is hereby appointed which shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. The said Board shall have assigned to it, in the event of no agreement being arrived at between the parties to the dispute, the functions of—

- (i) adjusting any matters of difference which may arise from time to time, except such as involve interpretation of the provisions of this Award or any of them;
- (ii) dealing with any other matter which the Court may refer to the Board from time to time.

(b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

27.—Reporting for Work.

When notice is given to a worker by his employer or his responsible representative to present himself for work, and he complies, but for reasons other than wet weather conditions, his services are not required, he shall be paid the equivalent of two (2) hours' pay in addition to any allowance under clause 16.

28.—Record Book.

The wages sheets of the Department shall be open for inspection at head office by the secretary of the Union upon reasonable notice being given of his desire to inspect same.

29.—Interviewing Workers.

On notifying the officer in charge any officer of the Union authorised in writing by the president and secretary of such Union shall have the right to enter any place or premises during ordinary working hours wherein members of the Union covered by this Award are engaged, for the purpose of conversing with or interviewing the workers in such place or premises.

Provided that such officer shall not hamper or otherwise hinder the workers in the carrying out of their work. The officer in charge shall determine whether workers are being hampered or hindered in their work.

30.—Union Stewards.

Stewards appointed by the Union shall be recognised by the various Departments hereinbefore mentioned in this Award. The secretary shall notify in writing the names of the stewards and any subsequent alteration. The stewards shall not be paid for any time occupied on Union business during working hours.

31.—Notice Boards.

A notice board shall be provided by the employer on all jobs where, in the opinion of the officer in charge, it is considered essential for the convenience of the Union to have a notice board.

32.—Building Trades' Award—Application of.

On all construction jobs undertaken by the Architectural Branch of the Public Works Department estimated to cost over five hundred pounds (£500) the Public Works Department shall work under the award or agreement which would operate on the work if constructed by a private contractor.

33.—Provision of Appliances.

(a) Carpenters.

The employer shall provide the following tools when they are required on the job:—Dogs and cramps of all descriptions, bars of all descriptions, augers of all sizes, bits not ordinarily used in a brace, all hammers except claw hammers, glue

pots and brushes, dowel plates, trammels, hand and thumb screws, soldering irons, spanners from three-quarters of an inch ($\frac{3}{4}$ in.) upwards, steel tapes, asbestos cutters, and all power driven tools and machines on construction jobs.

(b) A worker in receipt of a tool allowance shall provide himself with all necessary tools, kept in suitable condition for the performance of his work (other than those tools to be provided by the employer in accordance with this clause). A worker who fails to provide all such tools when required shall be guilty of a breach of this Award and shall not be entitled to the tool allowance prescribed in this Award until he complies with this clause.

34.—Apprentices.

(a) The term of apprenticeship shall be five (5) years.

(b) The maximum number of apprentices allowed to any employer in any branch shall be in the following proportions:—

Carpentry and Joinery.—One (1) apprentice to every two (2) or fraction of two (2) journeymen employed by him, provided the fraction shall not be less than one (1).

(c) Wages—	Percentage of Basic Wage.
First six months	20
Second six months	25
Second year	35
Third year	55
Fourth year	80
Fifth year	95

Provided that where an apprentice is twenty-one (21) years of age or over at the commencement of his fifth year he shall be paid the full basic wage, and that when an apprentice becomes twenty-one (21) years of age in the course of his fifth year, he shall be paid the full basic wage for the period following his twenty-first (21st) birthday. Provided further that the foregoing proviso shall not apply where the apprenticeship has been revived under the Re-establishment and Employment Act, 1945, and the apprentice is in receipt of a tradesman's rate through Government Supplement.

(d) The employment of apprentices under this Award shall be governed by the Court's 1941 Standard Apprenticeship Regulations, subject to the following amendment:—

(i) Add to regulation 37 the following sub-clause:—

(c) An apprentice shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident or sickness arising out of his own wilful default.

(ii) Delete regulation 40.

(e) The employer shall be under no obligation to teach an apprentice to carpentry and joinery any work in connection with metal ceilings where that work is not performed by such employer.

(f) A tool allowance shall be paid to apprentices in their third, fourth and fifth years as follows:—

Carpentry and joinery—5s. per week.

Provided that apprentices shall be supplied with tools as selected by the foreman as follows:—

Carpentry and joinery—Up to the value of £12.

35.—Liberty to Apply.

Liberty to apply is reserved to either party in respect of clause 16 (c).
