LAND RESUMPTION.

State Housing at Queens Park (Maniana).

NOTICE is hereby given, and it is hereby declared, that the several pieces or parcels of land described in the Schedule hereto—being all in the Canning District—have, in pursuance of the written approval and consent of His Excellency the Governor, acting by and with the advice of the Executive Council, dated the 25th day of September, 1953, been set apart, taken, or resumed for the purposes of State Housing at Queens Park (Maniana).
