Prices Control Order No. 895.

Safety Matches.

IN pursuance of the powers conferred upon me by the Prices Control Regulations, 1949, I, Constantin Paul Mathea, Prices Control Commissioner, hereby make the following Order:-

Citation.

This Order may be cited as Prices Control Order No. 895.

2. Prices Control Order No. 872 is hereby amended by omitting paragraph 8 thereof and in-serting in its stead the following:---

Sales by Retail.

I fix and declare the maximum price at 8. which safety matches may be sold by any person by retail to be-
