WHEREAS by section 9 of the Fisheries Act, 1905-1951, it is provided that the Governor may, by proclamation, prohibit all persons from taking fish of any specified species, by any specified means of capture, in any specified portion of Western Aus-tralian waters during any specified time in any specified year or during a specified portion of every year: and whereas such proclamation may, by secspecified year or during a specified portion of every year; and whereas such proclamation may, by sec-tion 11 of the said Act, be subject to any specified exception as regards place or time: Now, therefore, I, the said Governor, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid, and of every other power enabling me in this behalf, prohibit all per-sons from taking crabs by means of sunk set nets in that portion of Western Australian waters known as the Swan and Canning Rivers (including their tributaries) for a period of five (5) years from 1st December, 1953, to 30th November, 1958, except within those portions of the said rivers as so defined in the Schedule hereto, from 15th December in each of the years 1953, 1954, 1955, 1956 and 1957 to 30th April of each of the succeeding years re-spectively. spectively.

(1) The waters of the Swan and Canning Rivers upwards (or Easterly) from a line drawn from the South-West extremity of Point Resolution to Point Walter Jetty to-

- (a) A line drawn from the Southern extremity of the Swan Brewery Wharf (situated on the Western side of the river near Eliza Point) to the Mill Point (or Belches Point) spit post.
- (b) A line starting at the intersection of the Eastern side of Canning Beach Road (road No. 8869) and the Southern side of road No. 10002 and terminating at the Westernmost corner of lot 3 of Canning Location 37, as shown on Land Titles Office Diagram

11877, a point near the Northernmost intersection of Melville Parade and Canning Highway.

(2) All that portion of the Canning River from a line starting at the intersection of the South-Eastern side of Canning Highway and the Western side of The Esplanade and terminating at the intersection of the Eastern side of Leonora Street and the North-Eastern side of Wooltana Road to a line starting at the intersection of the Southern side of Canning Avenue and the South-Western side of The Esplanade and terminating at the Southern-most extremity of the foreshore of Mount Henry.

- (11) keep all walls and the plaster and wall paper thereon in good repair, and repair any cracks and renew any plaster or wallpaper which may become dilapidated or in disrepair;

- (13) repair or replace with new, any window frames or sash cords which may become broken or in disrepair and re-glass any windows which may become broken or cracked;

- (c) she has received the approval of the Board, by virtue of the fact that she has had adequate experience in the administration of obstetric analgesia, and in this connection she shall have submitted to the Board an application for approval giving full details of the experience, the apparatus used, the application being supported by the signature of one or more medical practitioners as the case may be;
- (2) the patient has, within the thirty days preceding her confinement, been examined by a registered medical prac-titioner who has handed to the nurse a certificate in writing that the patient at the time of the examination was in a fit condition to undergo the administration of an anaesthetic for obstetric analgesia; and
- (3) one other person, being a person acceptable to the patient, and who, in the opinion of the nurse, is suitable for the purpose, is present at the time of the administration of the anaesthetic.

15B. A nurse shall not administer any anaesthetic to a patient or use any anaesthetic apparatus, other than the anaesthetics and apparatus prescribed in this regulation; nor shall she use any anaesthetic apparatus other than in conjunction with the anaesthetic prescribed in this Regulation.

- (a) Anaesthetic—Nitrous oxide and oxygen. Apparatus—C.I.G. type "A" or apparatus of similar construction.

PURSUANT to an Order in Council promulgated in the Government Gazette on the 28th day of August, 1953, under section 35A of the Dog Act, 1903-1948, and in exercise of all other powers thereto enabling it the Bayswater Road Board doth hereby make and publish the following by-laws for the establish-ment of a dog pound and the control of dogs within the area of the Bayswater Road Board.

In these by-laws the term "Board" shall mean the Bayswater Road Board.

2. The Board may establish and maintain a pound or pounds for the impounding of dogs seized pursuant to the provisions of the Dog Act, 1903-1948.

3 A dog seized by the police or by an officer authorised by the Board may be placed in a pound.

4. Where a dog has been seized or placed in a pound the keeper of the pound or other officer authorised by the Board shall, if the owner or person usually in charge of the dog is known to him, forthwith notify such person that the dog has been impounded.

5. If the owner or person apparently acting on behalf of the owner of a dog seized or impounded shall claim such dog then upon payment of the fees specified in the Schedule hereto the dog shall be released to such person.

The pound keeper shall be in attendance at 6. the pound for the release of dogs at such times and on such days of the week as shall from time to time be determined by the Board.

7. Any person applying for the release of a dog seized or impounded shall prove to the satis-faction of the pound keeper or other officer author-ised by the Board the ownership of the dog and his authority to take delivery of it. The pound keeper or officer may accept such proof as he considers satisfactory and no person shall have any right of action against him or the Board in respect of the delivery of a dog in good faith.

8 If a dog shall not be claimed and the said 8. If a dog shall not be claimed and the said fees paid within 48 hours of its being seized or if a dog having a collar around its neck with a registration label for the current year affixed thereto shall not be claimed and the said fees paid within 48 hours of the service of a notice upon the registered owner the pound keeper or other officer authorized by the Beerd may call sub dog officer authorised by the Board may sell such dog.

9. Upon the sale of a dog the proceeds of sale shall be the property of the Board and may be disposed of in such manner as the Board thinks fit. The owner of a dog sold pursuant to these by-laws shall have no claim against the Board in respect of the proceeds thereof.

10. If within the times mentioned in by-law 8 hereof or at any time before the destruction of a dog the dog has not been claimed as aforesaid and the said fees paid and if no offer has been received for its purchase the dog may be destroyed.

Notwithstanding anything herein contained but subject to the provisions of section 19 of the Dog Act, 1903-1948, any dog seized or impounded may at any time be destroyed upon the authority of the secretary, the dog is too savage or noisy to be kept or is suffering from an injury, disease or sickness.

12. If the Board shall destroy a dog at the request of its owner whether such dog shall have been seized or impounded or not the owner shall pay to the Board the fee specified in the Schedule hereto.

13. No person shall-

- (a) unless a pound keeper or other officer of the Board duly authorised in that regard release or attempt to release a dog from a pound:
- (b) destroy, break into, damage, or in any way interfere with or render not dog-proof any pound:
- (c) destroy, break into, damage, or in any way interfere with or render not dog-proof any dog cart, vehicle or container used for the purpose of catching, holding, or conveying dogs which have been seized.

14. The owner of a dog shall keep such dog chained or under effective control from sunset to sunrise.

15. The owner of a dog shall prevent that dog from entering or being in any of the following places:-

- (a) A public building.(b) A theatre or picture gardens.
- (c) A house of worship.
- (d) A shop or other public business premises.

16. The owner of a dog shall prevent that dog from entering or being in any of the following places unless on a leash held by a person:----

- (a) A sports ground.
- (b) An area set aside for public recreation.
- (c) A car park. (d) A school.
- (e) Any land vested in or under the control of the Board other than a road.

No person shall obstruct or hinder an em-17. ployee of the Board or member of the Police Force in the performance of anything authorised by the provisions of the Dog Act, 1903-1948, or the regulations made in pursuance of those provisions.

The payment of fees in respect of the seizure, care, detention or destruction of a dog shall not relieve the owner of it of liability to a penalty under any of the provisions of these by-laws.

In these by-laws the term "Board" shall mean the Perth Road Board.

.2. The Board may establish and maintain a pound or pounds for the impounding of dogs seized pursuant to the provisions of the Dog Act, 1903-1948.

A dog seized by the Police or by an officer authorised by the Board may be placed in a pound.

4 Where a dog has been seized or placed in a pound the keeper of the pound or other officer authorised by the Board shall, if the owner or person usually in charge of the dog is known to him, forthwith notify such person that the dog has been impounded.

5. If the owner or person apparently acting on behalf of the owner of a dog seized or impounded shall claim such dog then upon payment of the fees specified in the Schedule hereto the dog shall be released to such person.

6. The poundkeeper shall be in attendance at the pound for the release of dogs at such times and on such days of the week as shall from time to time be determined by the Board.

7. Any person applying for the release of a dog seized or impounded shall prove to the satisfaction of the pound keeper or other officer authorised by the Board the ownership of the dog and his authority to take delivery of it. The pound keeper or officer may accept such proof as he considers satisfactory and no person shall have any right of action against him or the Board in respect of the delivery of a dog in good faith.

8. If a dog shall not be claimed and the said fees paid within 48 hours of its being seized or if a dog having a collar around its neck with a registration label for the current year affixed thereto shall not be claimed and the said fees paid within 48 hours of the service of a notice upon the registered owner the pound keeper or other officer authorised by the Board may sell such dog.

9. Upon the sale of a dog the proceeds of sale shall be the property of the Board and may be disposed of in such manner as the Board thinks fit. The owner of a dog sold pursuant to these bylaws shall have no claim against the Board in respect of the proceeds thereof.

If within the times mentioned in by-law 8 10. hereof or at any time before the destruction of a dog the dog has not been claimed as aforesaid and the said fees paid and if no offer has been received for its purchase the dog may be destroyed. 11. Notwithstanding anything herein contained but subject to the provisions of section 19 of the Dog Act, 1903-1948, any dog seized or impounded may at any time be destroyed upon the authority of the secretary of the Board if in the opinion of the secretary the dog is too savage or noisy to be kept or is suffering from an injury, disease, or sickness.

12. If the Board shall destroy a dog at the request of its owner whether such dog shall have been seized or impounded or not the owner shall pay to the Board the fee specified in the Schedule hereto

By-laws Governing Long Service Leave to be Granted to Employees of the Dardanup Road Board.

L.G. 1430/52.

THE Dardanup Road Board, under and by virtue of the powers conferred on it in that behalf by the Road Districts Act, 1919-1951, and all other powers enabling it, doth hereby make and publish the following by-laws:-

1. In the interpretation of the by-laws, the following words shall have the meanings assigned to them hereunder:-

(a) "Board" means the Dardanup Road Board. "Employee" means and includes all persons em-ployed in any capacity by the Board, and who are in the regular and full time employ of the Board.

(b) "Continuous Service" means service in the employment of the Board during which an em-ployee has not been absent from the service of the Board for a continuous period of more than two days or an aggregate period of more than 10 days without leave of absence being granted by the Board.

2. All present and future employees of the Board shall, after each period of 10 years' continuous service as permanent full time employees thereof, commencing from the 1st day of January, 1943, be entitled to three months' long service leave.

3 (a) The Board may grant long service leave to an employee of the Board who has been granted long service leave for 10 years' continuous service, if, before a further period of 10 years' continuous service is reached, such employee leaves the service of the Board, or retires from the Board's service owing to having reached the retiring age of 65 years, or is retired on the grounds of ill-health, or is dismissed through staff retrenchments, in which case the long service leave may be adjusted pro rata.

(b) The long service leave which may be granted under this by-law shall be for a period not exceeding one and three-tenths weeks for every completed year of service since the conclusion of the period of service which qualified the employee for his previous long service leave, and shall be on full pay.

4. An employee dismissed by the Board for neglect of duty or for irregular practices shall not be paid any sum in pursuance of the preceding by-law.

5. Absence on account of sickness shall not be deemed to be a break in continuity of service, provided the period of absence shall not exceed three months in any year, unless otherwise decided by the Board.

6. Long service leave shall be taken at the con-venience of the Board, who will, as far as possible, meet with the wishes of the employee, but the Board may require the employee to take leave by giving not less than three months' notice.

7. In the event of the retirement or death of an employee, the Board may pay to such employee (or in the case of death, to his personal repre-sentatives, or if there be none, to his dependants) a sum of money equal to his wages or salary for the period of long service leave which the Board is empowered under these by leave to creat to creat period of long service leave which the Board is empowered under these by-laws to grant to such employee at the date of his retirement or death, or if the Board, after consideration of all the circumstances, direct that the death of an employee be presumed, the Board may authorise the pay-ment to the dependants of the employee a sum conjugate to the constant of the employee as the second equivalent to the amount of wages or salary which would under this by-law have been granted the employee immediately prior to the date of his death, such date to be determined by the Board.

8 (a) Employees due to take long service leave shall be paid their salary or wage for the period thereof at the rate equivalent to the salary paid in the week immediately preceding the taking of long service leave.

(b) The Board may, at its discretion, either (1) pay to an employee his wages or salary periodically during long service leave, or (2) pay to the em-ployee in advance a sum representing the amount of his wages or salary for the period of his long service leave.

All annual leave to which an employee is entitled or will become entitled before the expiration of his long service leave shall be taken by the employee in conjunction with his long service leave, but any public holidays which may occur during the taking of his long service leave are not to be paid for over and above the long service leave, but are to form part of such long service leave.

10. Long service leave shall be considered as special period of recuperation after a lengthy term of service with a view to fitting the employee for a further term, and during such leave no employee shall undertake any form of employment for hire or reward, unless by special permission of the

Board. Any contravention of this subclause shall entitled the Board to dismiss the employee from its service and to cease paying or to recover any amounts paid in advance on account of long service leave.

(b) "Continuous Service" means service in the employment of the Board during which an em-ployee has not been absent from the service of the Board for a continuous period of more than the Board for a continuous period of more than two days or an aggregate period of more than 10 days without leave of absence being granted by the Board, provided that an employee who was employed by the Board on a permanent basis im-mediately prior to entering continuous full-time service with the Armed Forces of the Commonwealth of Australia, or who was directed by the Manpower Directorate to serve elsewhere between the 3rd day of September, 1939, and the 3rd day of March, 1947, shall have such service counted as continuous service with the Board, provided the requisite proof is produced.

All employees of the Board shall, after each 2 period of 10 years continuous service as permanent full time employees thereof commencing from the 1st day of January, 1944, be entitled to three months' long service leave but no long service leave shall be granted to an employee unless he has completed a qualifying period of 10 years.

(a) The Board may grant long service leave to an employee of the Board who has been granted long service leave for 10 years' continuous service, if, before a further period of 10 years' continuous service is reached, such employee retires from the Board's service owing to having reached the retiring age of 65 years, or is retired on the grounds of ill-health, or dismissed through staff retrenchments, in which case the long service leave may be adjusted pro rata.

Provided that no such grant shall be made to an employee of the Board who prior to completing a further period of 10 years' continuous service resigns his employment with the Board.

(b) The long service leave which may be granted under this by-law shall be for a period not ex-ceeding one and three-tenths weeks for every completed year of service since the conclusion of the period of service which qualified the employee for his previous long service leave, and shall be on full pay.

An employee dismissed by the Board for 4 4. An employee dismissed by the Board for neglect of duty or for irregular practices shall not be paid any sum in pursuance of the preceding. by-law.

5. Absence on account of sickness shall not be deemed to be a break in continuity of service, pro-viding the period of absence shall not exceed three months in any year, unless otherwise decided by the Board.

Long service leave shall be taken at the convenience of the Board, who will, as far as possible, meet with the wishes of the employee, but the

meet with the wishes of the employee, but the Board may require the employee to take leave by giving not less than three months' notice. 7. In the event of the retirement or death of an employee, the Board may pay to such employee (or in the case of death, to his personal repre-sentatives, or if there be none, to his dependants) a sum of money equal to his wages or salary for the period of long service leave which the Board is empowered under these by-laws to grant to such employee at the date of his retirement or death, or if the Board after consideration of all the cir-cumstances, direct that the death of an employee cumstances, direct that the death of an employee be presumed, the Board may authorise the pay-ment to the dependants of the employee a sum equivalent to the amount of wages or salary which would under this by-law have been granted to the employee immediately prior to the date of h death, such date to be determined by the Board. his

8. (a) Employees due to take long service leave shall be paid their salary or wage for the period thereof at the rate equivalent $t_{Q_{c}}$ the salary paid in the week immediately preceding the taking of long service leave.

(b) The Board may, at its discretion, either (1) pay to an employee his wages or salary periodically during long service leave or (2) pay to the employee in advance a sum representing the amount of his wages or salary for the period of his long service leave.

9. All annual leave to which an employee is entitled or will become entitled before the expira-tion of his long service leave shall be taken by the employee in conjunction with his long service leave, but any public holidays which may occur during the taking of his long service leave are not to be paid for over and above the long service leave, but are to form part of such long service leave

10. Long service leave shall be considered as a special period of recuperation after a lengthy term of service with a view to fitting the employee term of service with a view to fitting the employee for a further term, and during such leave no em-ployee shall undertake any form of employment for hire or reward, unless by special permission of the Board. Any contravention of this subclause shall entitle the Board to dismiss the employee from its service and to cease paying or to recover any amounts paid in advance on account of long service leave.
