A BY-LAW of the City of Perth made under section 180 of the Municipal Corporations Act, 1906-1951, and numbered 36 for the general management of the municipal baths at Crawley.

In pursuance of the powers conferred by the said Act the Lord Mayor and Councillors of the City of Perth order that by-law No. 36 be repealed and that the following by-law to be numbered 36 be substituted in lieu thereof:—

1. In this by-law, unless the context otherwise. requires:-

"Baths" means reserve No. 23510 at Crawley referred to in section 5 of the Reserves Act, 1952.

"Council" means the Council of the City of Perth.

"Town Clerk" means the Town Clerk or acting Town Clerk of the City of Perth.

"Superintendent" means the superintendent or other person appointed for the time being by the Council to have control of the Baths and includes any lessee or tenant holding the Baths under the City of Perth.

2. From the 1st September to the 31st May inclusive, the Baths shall be open daily (except on Sundays) from 6 a.m. to 10 p.m. and on Sundays from 7 a.m. to 9 p.m.

- 3. No person over the age of four years shall appear in public unless sufficiently clad to preserve decency.
- 4. If any person appears in public in such a condition as to be in the opinion of the Super-intendent indecently or unsuitably clad the Superintendent may direct him to resume ordinary clothing and such person shall forthwith comply with such direction.
- 5. No person shall dress or undress or remove any part of his bathing costume except in a dressing shed or enclosure provided for that purpose.
- 6. No person shall enter the Baths save through the gates or turn-stiles set apart for entrance purposes.
- 7. No person (save the officers or workman of the Council) shall enter the Baths except upon payment of the charge herein prescribed.
- The following shall be the sums to be paid for admission to and the use of the baths and the requisites supplied therein:-

- 9. Every person using the Baths shall obey all reasonable directions of the Superintendent with regard to such use.
- 10. No person shall in any way obstruct the Superintendent in his control of the Baths and of persons therein.
- 11. Every person who hires a costume or towel at the Baths shall before leaving the Baths return such costume or towel to the Superintendent or person appointed by the Superintendent to receive the same.
- 12. Every person who uses his own costume or towel in the Baths shall when leaving the Baths produce such costume or towel for inspection by the Superintendent or other person appointed by the Superintendent for the purpose.
- 13. No person shall enter the Baths without either being in possession of a costume and towel or hiring the same unless he obtains an "onlookers" ticket and on leaving the Baths he shall surrender such ticket to the Superintendent or other person appointed by the Superintendent to receive the same.
- 14 No person shall enter or be in the Baths while in an intoxicated condition.
- No person shall take into the Baths or have in his possession therein any intoxicating liquor.
- 16. No person shall while suffering from any cutaneous, infectious, or contagious disease enter or use the Baths.
- No person in charge of any dog shall allow such dog to enter the Baths.
- 18 No person shall bring or deposit any filth or rubbish into the Baths.
- 19. No person shall eat in or take into a dressing shed or enclosure any food of any kind what-
- 20. No person shall disfigure or write in or upon any part of the Baths.
- 21. No person shall behave in an unseemly, improper, disorderly or riotous manner, swear or use any indecent, obscene or abusive language, or gamble or misconduct himself in the Baths.
- 22. No person shall smoke in any building in the Baths.
- 23. No person shall climb up to or on any fence, wall, partition or roof of the Baths.
- 24. No person shall waste or wastefully use fresh water.
- 25. No person shall spit or expectorate in the Baths or commit any nuisance on or in any part of the Baths.
- 26. No person shall damage or interfere with or use improperly any part of the Baths or the furniture or fittings therein.
- 27. No person shall in any way annoy or interfere with any other person in the Baths.

- 28. No person shall enter or attempt to enter any bathroom or dressing box that is already occupied, without the consent of the occupier.
- 29. No person shall enter any part of the Baths set apart for the exclusive use of persons of a different age or sex to that of the first mentioned person.
- 30. (1) No person shall for profit teach, coach or train any other person in the Baths unless with the prior written permission of the Council.
- (2) The Council may grant such permission subject to such conditions as they think fit and may at any time withdraw such permission.
- 31. Every person who shall in the Baths find any article which may have been left therein shall immediately deliver same to the Superintendent, who shall thereupon register a description of such article and all particulars relating thereto in a book which shall by him be kept for that purpose and on any person claiming such article and who satisfies the Superintendent that he is the lawful owner of the same such person shall have such article returned to him and on receiving such article he shall sign for the same in the book before mentioned.
- 32. The Superintendent shall on every Monday report to the Town Clerk regarding all articles found in the Baths and handed to him, and whether any such have been claimed and returned to the owners thereof, at the same time he shall hand to the Town Clerk any such article unclaimed, who shall hand the same to the Police.
- 33. If any person commits any breach of this by-law the Superintendent may direct him to leave the Baths and such person shall as soon as possible comply with such directions.
- 34. (1) The Council may give written direction to the Superintendent that any person named in such direction shall not be admitted to the Baths.
- (2) While such direction remains in force the Superintendent shall not admit such person to the Baths or suffer him to be therein, and such person shall not with knowledge that such direction is in force enter or attempt to enter the Baths.
