Fisheries Act, 1905-1951. PROCLAMATION

WESTERN AUSTRALIA, TO WIT, CHARLES HENRY GAIRDNER, Governor. [L.S.] By His Excellency Lieutenant-General Sir Charles Henry Galrdner, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Companion of the Most Honourable Order of the Bath, Commander of the Most Excellent Order of the British Empire, Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

IN pursuance of the provisions of section 9 of the Fisheries Act, 1950-1951, I, the Governor of Western Australia, by and with the advice and consent of the Executive Council, do hereby, in exercise of the powers aforesaid and of every other power enabling me in this behalf, prohibit the taking by any means whatsoever of the fish known as or called "Crayfish" in all Western Australian waters specified in the Schedule hereto for a period of three years from 1st April, 1954.

Schedule.

1. All that portion of the Indian Ocean bounded by lines starting at a point on the Southernmost extremity of Wreck Point on Pelsart Island in the Pelsart Group, situate at approximate Latitude 28° 59′ 15″ South, Longitude 113° 58′ 20″ East and extending South to the outermost extremity of the Western Australian waters of that group situate at approximate Latitude 29° 2′ 45″ South; thence generally North-Westerly along the outermost extremities of those waters to Latitude 28° 50′ 30″ South, Longitude 113° 46′ 45″ East; thence East to Longitude 113° 50′ 15″ East; thence South to the Northernmost extremity of the reefs surrounding the group and thence generally South-Easterly along the outer extremities of those reefs to the starting point.

2. All that portion of the Indian Ocean bounded by lines starting at a point on the Southernmost extremity of the outer reefs surrounding Rat Island in the Easter Group situate at approximate Latitude 28° 47′ 45″ South, Longitude 113° 45′ 00″ East and extending South to the outermost extremity of the Western Australian waters of that group situate at approximate Latitude 28° 50′ 30″ South; thence generally North-Westerly and North-Easterly along the outermost extremities of those waters to approximate Latitude 28° 36′ 15″ South, Longitude 113° 43′ 45″ East; thence South to the Northernmost extremity of the outer reefs and thence

generally South-Westerly and South-Easterly along the outer extremities of those reefs to the starting point.

3. All that portion of the Indian Ocean bounded by lines starting at a point on the Southernmost extremity of Evening Reef, situate South of West Wallabi Island in the Wallabi Group at approximate Latitude 28° 32′ 55″ South, Longitude 113° 41′ 45″ East and extending South to the outermost extremity of the Western Australian Waters of that group, situate at approximate Latitude 28° 35′ 29″ South; thence generally North-Westerly and Northerly along the outermost extremities of those waters to approximate Latitude 28° 15′ 34″ South, Longitude 113° 31′ 30″ East; thence East to the Northernmost extremity of the reef on the Northward of North Island at approximate Longitude 113° 35′ 20″ East and thence generally Southerly and South-Easterly along the outermost extremities of those reefs to the starting point.

WHEREAS by sections 223 and 225 of the Municipal Corporations Act, 1906-1953 (6 Edwardi, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a

public highway within the meaning of any law now or hereafter in force; and whereas the Muni-cipality of Albany has requested that certain land named and described in the Schedule hereunder which has been used for a street or way within the Municipality of Albany, be declared a public highway: Now therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be a public highway, and such land shall, from the date of this Proclamation, be absolutely dedicated to the public as a highway within the meaning of any law now or hereafter in force.

WHEREAS by section 166 of the Factories and Shops Act, 1920-1952, it is enacted that the Governor may by proclamation temporarily suspend the operations of the said Act, in so far as it applies to the closing time fixed or appointed for any shop or shops, either generally or in any specified locality or district: Now, therefore, I, the said Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, do by this proclamation temporarily suspend the operations of the Factories and Shops Act, 1920-1952, for the period the 12th day of April to the 15th day of April, 1954, inclusive, in so far as the said Act applies to the closing time of shops situated in those districts throughout the State which would normally observe the weekly half-holiday during that period between the usual hour of closing of such shops and 6 p.m. on the said days.

ORDER IN COUNCIL.

F.D. 1140/50.

WHEREAS by the Forests Act, 1918, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner:-

(a) The Governor shall cause to be laid on the Table of each House of Parliament a

proposal for such revocation.

(b) After such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall, by Order in Council, revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposals dated the 23rd day of November, 1950, for the revocation in part of the dedication of Crown lands as State Forest; and whereas after such proposals had been laid before Parliament a resolution was passed by both Houses rariament a resolution was passed by both Houses that such proposals should be carried out: Now, therefore, His Excellency the Governor with the advice and consent of the Executive Council doth hereby revoke in part the dedication of Crown lands as State Forest No. 20 by excising those portions of such State Forest as is described in the Schedule hereto.

March, 1954, and published in the Government Gazette on the 26th day of March, 1954, subject to the said works being commenced not later than the 1st day of January, 1955.

 - (a) The total liability for repayment of allowances received as Bursar shall be reduced by one twenty-fourth of the total for each complete calendar month spent in Teacher Training including the probationary period of six calendar months.
 - (b) If the student is judged unsuitable by the Director of Education during the first six calendar months of his course of Teacher Training he and his guarantor shall repay the balance of the allowances due under paragraph (a) of this clause but no claim will be made by the Minister for allowances received while undergoing Teacher Training.
 - (c) If the Student's course is terminated for any reason and at any time except death, disease or accident incapacitating the Student from teaching, or as provided for in paragraph (b) of this clause he is and his guarantor shall repay the balance of the allowances due under paragraph (a) of this clause together with the total of the allowances received by the student during his course of Teacher Training.

The resultant quotient shall be payable for each month of default.
- 6. The Student agrees to pay such fees as may be determined by the Director of Education for membership of clubs and societies associated with Teachers' College.
- 7. That if at the end of the course, in the opinion of the Principal of the Teachers' College, the Student is not competent to take up an appointment as a teacher, he may be informed that the Minister does not intend to offer him any appointment, whereupon this agreement shall determine and be of no force and effect and the determination of this agreement shall not give rise to any claims for damages, compensation or expenses or otherwise by or in respect to any of the parties hereto.
