WHEREAS section 74 of The Constitution Act, 1889, provides that the Governor in Council may vest in Heads of Departments, or other officers or persons within the State, power to make minor appointment of foreman and other persons employed at a daily rate of wage on works under the control of the Department of Public Works, and of Water Supply, Sewerage and Drainage (exclusive of the Metropolitan Water Supply, Sewerage and Drainage Department) should be vested in Hilton Keith Permain and any persons appointed to act temporarily in his place the appointment of foreman and other persons employed on such works at a daily rate of wages.

Public Works Act, 1902-1953. Donnybrook School Site Extension.

ORDER IN COUNCIL.

The Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 158/54.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend water works, sewerage works and stormwater drainage works, and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now therefore His Excellency the Governor, with the advice and consent of the executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.
Guildford District.
Pumping Station No. 1.
Supplementary Suction Tank.

A 50-ft. diameter reinforced concrete underground tank, with pipes connected to existing pumping station, and all other apparatus connected therewith as shown in red on Plan M.W.S. 7822.

This Order in Council shall take effect from the 23rd day of April, 1954.

Traffic Act, 1919-1953. Municipality of Bunbury.

ORDER IN COUNCIL.

L.G. 2254/52.

HIS Excellency the Governor acting by and with advice and consent of the Executive Council, hereby makes the following order under the authority of section 49 of the Traffic Act, 1919-1953, namely, that the Municipality of Bunbury is hereby empowered to make by-laws in pursuance of:—

- 1. Clause (zc) of paragraph (i) of subsection (1) of section 47 of the said Act prohibiting the use for heavy traffic of all roads within a defined area, except certain defined roads on which by such regulation heavy traffic is permitted, and the use on any road of a vehicle the weight of which exceeds a prescribed weight.
- 2. Clause (b) of paragraph (vii) of subsection (1) of section 47 of the said Act prohibiting the passage of heavy or obstructive traffic over any specified road, either generally or during certain months of the year.
- 3. Clause (c) of paragraph (vii) of subsection (1) of section 47 of the said Act prescribing the maximum weight which may be taken across any bridge or culvert.
- 4. Clause (k) of paragraph (vii) of subsection (1) of section 47 of the said Act regulating the maximum weight of the load that may be carried by any vehicle (inclusive of the weight of the vehicle) on roads other than such roads as are specifically prescribed in any prescribed area, and prohibiting the carriage of any such load exceeding the prescribed maximum weight.
- 5. Clause (1) of paragraph (vii) of subsection (1) of section 47 of the said Act prohibiting the carriage by a vehicle on any road of a load which (including the weight of the vehicle) exceeds the weight prescribed as the maximum load that may be lawfully carried on the road, notwithstanding the fact that there may have been issued a licence which authorises the carrying by the vehicle of a greater load.

Subject to the condition that no such by-law shall be valid and effectual unless it has, prior to notification of its making being published in the Government Gazette, been submitted to, and approved by the Governor.

Dumbleyung Road Board.

- (2) Clause (zl) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting or restricting the parking of vehicles of a specified class or classes in all roads or in specified roads or specified parts of roads, at all times or at specified times.

Subject to the condition that no such by-law shall be valid and effectual unless it has, prior to notification of its making being published in the Government Gazette, been submitted to, and approved by the Governor.

Road Districts Act, 1919-1951. Albany Road Board and Albany Municipal Council—Adjustment of Accounts, etc.

ORDER IN COUNCIL.

WHEREAS by an Order in Council made under section 8 of the Road Districts Act, 1919-1951, and published in the Government Gazette of the 31st day of July, 1953, at page 1441, portion of the Albany Road District, as described in the Schedule annexed to the said Order was severed from the Albany Road District and annexed to the Albany Municipal District; and whereas it is necessary that the assets and liabilities of the said Albany Road District should be apportioned and allocated in respect of the portion so severed and annexed; and whereas it is provided by section 10 of the said Act that the Governor may adjust and

finally determine all questions relating to any of the matters aforesaid: Now, therefore, for the purpose of apportioning and allocating the assets and liabilities of the Albany Road District and in exercise of the power conferred by the said section 10, His Excellency the Governor, acting by and with the advice and consent of the Executive Council, doth hereby order that the assets specified in the Schedule hereto shall be transferred from the Albany Road Board to the Municipality of Albany, and doth further order that (a) loan rates in respect of the loans raised by the Albany Road Board before the 1st day of July, 1953, shall be levied only upon the portion of the district which still remains therein and shall not apply to the portion of the district which was transferred to the Albany Municipal District on the 1st day of July, 1953, and (b) that in respect of loans raised by the Municipality of Albany before the 1st day of July, 1953, the land transferred from the Albany Road Districts on that date shall be exempt from loan rating.

Workers' Compensation Act, 1912-1952.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1952, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under

the said Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer from the operation of the said section; and whereas the Bank of New South Wales, of St. George's Terrace, Perth in the State of Western Australia, being an employer within the meaning of the said Act and having made application in accordance with the regulations made under the Act has proved to the satisfaction of the Minister that as such employer it has established a fund for insurance against its liability aforesaid and has deposited at the Treasury securities, to wit, a bond of five thousand pounds given by the Bank, charged with all payments to become due and payable by the Bank under its liability: Now therefore, His Excellency the Governor in Council, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby exempt the Bank of New South Wales as such employer aforesaid from the operation of section 13 of the Workers' Compensation Act, 1912-1952, for a period of two years computed from and including the 31st day of March, 1954.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1953, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under this Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability the Governor may by Order in Council exempt such employer from the operation of section 13; and whereas Amalgamated Collieries of W.A. Limited, of St. George's Terrace, Perth, is an employer within the meaning of the Act, and as such is subject to the provisions of section 13 and has made application duly in accordance with the Act and the regulations made thereunder for exemption from the operations of the section, and has satisfied the Minister that it has established a fund for insurance against its liability to pay compensation under the Act to all workers employed by it, and has deposited at the Treasury securities, to wit, a bond for the amount of £10,000 by the Bank of New South Wales of Perth, charged with all payments to become due by the company under the said liability: Now therefore His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred by section 13 of the Act. doth hereby exempt Amalgamated Collieries of W.A. Limited from the operation of section 13 of the Workers' Compensation Act, 1912-1953, for a period expiring on the 29th day of February, 1956.

Perth. being an employer within the Terrace, Perth, being an employer within the meaning of the Act and as such subject to the section and having made application in accordance with the Act and the regulations made thereunder for exemption from the operation of section 13, has satisfied the Minister that it has established a fund for insurance against its liability to pay compensation under the Act to all workers employed by it, and has deposited at the Treasury a security, to wit, Commonwealth Government Securities of the value of five thousand pounds (£5,000): Now therefore His Excellency the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers conferred by the Act, doth hereby exempt The Mutual Life and Citizens Assurance Company Limited from the operation of section 13 of the Workers' Compensation Act, 1912-1952, for a period ending on the 28th day of February, 1956. for exemption from the operation of section period ending on the 28th day of February, 1956.

Part I.—Insert after by-law 35, a new by-law to stand as by-law 35A as follows:—

Repairs to Dwelling Houses.

- 35A. The owner of every dwelling house shall maintain such dwelling house and any laundries, bathrooms, lavatories and privies attached to or used in connection therewith in good order and condition and properly repaired and fit for use and in particular shall—
- 1. Repair or replace any roof or part thereof which shall become in disrepair.
- 2. Repair any brick or stone work which shall show signs of fretting and treat or repair any walls which may become damp.
- 3. Replace all decayed or ant eaten timber therein.
- 4. Repair and replace with new material where necessary any verandah or the roof, floor supports or other parts thereof which may become in disrepair.
- 5. Repair and replace where necessary any steps or hand rails thereof which may become in disrepair.
- $6.\$ Repair or replace any flashings which may become in disrepair.
- 7. Replace any ant stops which shall be missing or in disrepair.
- 8. Repair or renew any ventilators which shall become in disrepair or be missing.
- 9. Keep all floors even in surface and free from cracks.
- 10. Replace or repair all skirtings, architraves and fixtures, which may become a harbourage for vermin.
- 11. Keep all walls and the plaster and wall paper thereon in good repair and repair any cracks and renew any plaster or wall paper which may become dilapidated or in disrepair.
- 12. Refit and repair any doors which may become in disrepair or which shall cease to fit properly.
- 13. Repair or replace with new, any window frames or sash cords which may become broken or in disrepair and re-glaze any windows which may become broken or cracked.

- 14. Keep all water service in such state of repair and condition as shall comply in all respects with all of the provisions of the Metropolitan Water Supply, Sewerage and Drainage Act and regulations and by-laws made thereunder.
- 15. Keep all electric wiring and fittings in such state of repair and condition as shall comply in all respects with all of the requirements of the Fire Underwriters' Association of W.A.
- 16. Retain all natural lighting free from any obstruction which would reduce the natural lighting below the ratio of one square foot of lighting to each 10 square feet of floor area.

By-law 19 of Part I is repealed and the following by-law substituted therefor:—

19.—Method of Disposal of Rubbish.

- (a) No rubbish shall be deposited on any of the lands under the control of the local authority except on such portion of the area known as "Eyre Park" being that portion of Albany Lot A14 bounded by Middleton Road, Beach Road and Garden Street, as the local authority may direct. The local authority shall define such area by sign boards.
- (b) All rubbish so deposited shall be such as is defined as "refuse" under clause 12 (b) hereof and such trade wastes as may be permitted by the local authority.
- (c) All rubbish shall be deposited on or beyond the edge of that previously deposited and levelled down so that no rubbish remains above the level of the dump.
- (d) No persons, unless authorised by the local authority, shall disturb, remove, set fire to or burn any rubbish, or damage, deface or remove any signs or other equipment within the area defined by the local authority for the dumping of rubbish.

Yarloop District Hospital Board-Resolution.

WHEREAS under the provisions of section 23 of the Hospitals Act, 1927, a Board may itself establish and manage a Medical Fund, the object of which shall be to secure for its subscribers medical attendance, hospital treatment, or other similar benefits; and may, by by-laws, provide for the regulation and control of such Funds; and whereas a Medical Fund has been established by the Board of Management of the Yarloop District Hospital: Now, therefore, the said Board of Management, acting pursuant to section 23 of the Hospitals Act, 1927-48, do hereby make by-laws for the regulation and control of the said Medical Fund in the manner set forth in the Schedule hereunder:—

Schedule.

By-laws of the Yarloop District Medical and Hospital Fund.

- 1. Repeal.—The by-laws heretofore made by the Yarloop Hospital Board and published in the Government Gazette on the 7th day of February, 1947, and the 16th day of April, 1948, are hereby repealed.
- 2. Name.—The Fund shall be known as the Yarloop District Medical and Hospital Fund. (Hereinafter called, for the purposes of these by-laws, the Medical Fund or the Hospital Fund as the context requires.)
- 3. Board of Management.—The administration of the Fund shall be vested in the Yarloop Hospital Board as constituted from time to time in accordance with the provisions of the Hospitals Act, 1927-48
- 4. Membership.—Any person may apply to become a subscriber to the Medical Fund and/or the Hospital Fund, but the Board reserves the right to accept or reject any application for membership at its absolute discretion, or to accept for membership subject to such terms and conditions as the Board may decide. No person shall be approved for membership of the Medical Fund unless approved by a Medical Officer of the Fund.
- 5. (a) The term "subscriber" shall mean any person male or female who is financial and has paid his or her subscription in accordance with these by-laws before seeking any benefits or privileges and shall include, so far as benefits are concerned, all dependants of the subscriber.
- (b) The word "dependant" shall mean the wife, parents and grandparents of a subscriber, the sons, daughters, brothers and sisters not over 16 years of age of a subscriber, who are actually residing with and are wholly dependant on him at the date of illness or accident which the Medical Officer is required to treat.
- (c) If the Medical Officer is not aware or is in doubt as to whether any person is or is not a dependant, he may refer the matter to the secretary and be guided by his decision.
- (d) Every subscriber to the Medical Fund, and his dependants shall, if required, submit to a medical examination by the Medical Officer of the Fund before he is accepted as a subscriber.
- 6. Subscriptions.—(a) The subscription rates shall be 16s. per calendar month for the Medical Fund and 8s. per calendar month for the Hospital Fund. The rates for members between the ages of 16 and 21 years shall be half the adult rate, if without dependants.
- (b) Any person who is a member of the Pensioners Medical Fund may be accepted at 10s. per calendar month.
- 7. Disability.—At the discretion of the Board a contributor or a dependant with an existing known disability may be admitted to membership and payment shall be made for any illness except the specified disability, but no person who may develop a chronic condition after acceptance as a member of the Fund shall be excluded from membership for that condition.
- 8. Alteration.—The Board may make any alteration of these by-laws provided that two weeks notice of such alterations shall be given to the subscribers and such alterations shall be submitted to the Governor in Council and to the Commonwealth Director of Health for their approval.

- 9. Benefits—Medical Fund.—(a) Every subscriber and dependant being a member of the Medical Fund, shall be entitled to medical and surgical treatment, free of charge, for all cases of sickness and accident, and including midwifery, while an inmate of a hospital attended by the Medical Officers of the Fund, subject to the limitations and conditions set forth in these by-laws.
- (b) Every subscriber and dependant, being a member of the Medical Fund, shall be entitled to medical treatment whilst being attended by a Fund Medical Officer as an out-patient within the Fund area, subject to the limitations and conditions set forth in these by-laws.
- 10. (a) If the Fund Medical Officer recommends the transfer of a subscriber or a dependant to another doctor for outpatient or inpatient treatment the Medical Fund shall, subject to the limitations and conditions set forth in these by-laws, pay the medical practitioners charges for such treatment as follows:—
 - (i) Specialist consultations or treatment to a maximum of £31 10s. in any one year, other than operations.
 - (ii) Surgical treatment to a maximum of £35 per operation, inclusive of Anaesthetic fees
- (b) If the Fund Medical Officer recommends the transfer of a subscriber or a dependant to the Royal Perth Hospital, Princess Margaret Hospital for Children, or the Fremantle Hospital for treatment, the cost of such treatment shall be paid by the Medical Fund to a maximum of £31 10s. in any one year including cost of transport.
- (c) Where is becomes necessary, owing to the seriousness of the condition of the subscriber or dependant, for the Fund Medical Officer to arrange for a consultant to travel from Perth for the purpose of consultation or treatment, the Medical Fund shall be liable for the payment of the consultant's fee to a maximum of £35.
- (d) Where in the opinion of the Medical Officer it is necessary for a guardian to accompany a minor, treatment for which minor is provided for under the preceding subclauses of this by-law, the Fund shall pay the cost of transport from and to the Fund area in respect to such guardian. Any payment made in this connection shall form part of the maximum liability of £35.
- 11. (a) The Board of Management shall have discretionary powers regarding payment for treatment incurred at any hospital by a subscriber or dependant when such subscriber or dependant becomes suddenly ill or meets with an accident while temporarily outside the Fund district and is unable to return for treatment by the Fund Medical Officer.
- (b) The Board of Management shall have discretionary powers regarding payment up to a maximum of £11 11s. for any one case in any one year, in respect of doctor's fees incurred by a subscriber or dependant when such subscriber or dependant becomes suddenly ill or meets with an accident while temporarily outside the district and is unable to return for treatment by the Fund Medical Officer. Provided that, before any claim shall be entertained under this by-law, a subscriber may be required to produce a certificate from the attending doctor to the effect that the condition for which treatment was given precluded his return for the purpose of treatment by the Fund Medical Officer.
- 12. (a) If a subscriber of dependant, on the recommendation of the Medical Officer, is required to travel for the purpose of consulting another doctor the Fund shall pay the cost of transport to a maximum payment of £1 10s. per visit.
- (b) If, owing to the condition of the subscriber or dependant, the Medical Officer recommends transport by ambulance or other vehicle the Fund shall pay the cost of such transport.
- (c) Cost of transport of members or dependants, being members of the Medical Fund, from outcentres approved by the Board for the purpose of consulting the Medical Officer in cases of emergency, may be paid by the Fund, provided that such journey is authorised by the Medical

Officer before the journey is undertaken. The rates of payment from such out-centres shall be fixed by the Board from time to time.

- 13. The Fund shall pay theatre charges at such rates as may be determined from time to time by the State Department of Health.
- 14. A maximum benefit of £5 5s. in any one year may be paid for x-ray services.
- 15. Payment for services rendered to subscribers or their dependants under the Commonwealth Health (Medical Benefits) regulations shall be made in accordance with the following scale:—

First Schedule.

Parts 1 and 5: Equal to Commonwealth Benefit plus $25\,$ per cent.

Parts 2, 3, 6, 7: Equal to Commonwealth Benefit plus 50 per cent.

Part 4: Equal to Commonwealth Benefit. Second Schedule.

All items: Equal to Commonwealth Benefit. This by-law shall apply only to those items of service which are rendered under a fee for service.

- 16. (a) Any sum paid by the Commonwealth by way of subsidy shall comprise part of the amount paid as benefit in each case but shall not be included in calculating the maximum benefit payable by the Medical Fund.
- (b) Where medical services are rendered on a fee-for-service basis, the total of Fund and Commonwealth benefits payable to or on behalf of a subscriber shall not exceed 90 per cent. of the total charge. If the combined Fund and Commonwealth benefit for any service would exceed 90 per cent. of the total charge then the Fund benefit shall be reduced by an amount equal to the difference between the total charge and 90 per cent. of that charge.
- 17. The Fund may make payment direct to the hospital or doctor concerned or to the subscriber on production of an account from the hospital or doctor duly receipted as being paid in full.
- 18. The Fund shall provide each out-centre with drugs and dressings for use in emergency.

Accounts.

- 19. Separate Accounts.—Separate accounts shall be maintained for the Medical and Hospital Funds and a statement of receipts and payments in respect to each fund shall be compiled quarterly. A balance sheet of each fund shall be published annually. The accounts shall be audited annually by an officer appointed by the Minister for Health under section 26 of the Hospitals Act, 1927.
- 20. The secretary as appointed from time to time to the Hospital Board shall be secretary of the Medical and Hospital Funds and shall keep the books and carry out all the duties required under the instructions of the Board. He shall also act as the Public Officer of the Funds to perform all acts required under the Commonwealth Hospitals and Medical Benefits regulations.
- 21. No payments shall be made from moneys received as subscriptions to the Hospital or Medical Fund except for the payment of benefits to subscribers or for the administration of the Funds. The cost of administration shall at no time exceed 15 per cent.
- 22. Hospital Fund—Benefits.—Every subscriber to the Hospital Fund and his dependants shall, after complying with the conditions set forth in these by-laws, be entitled to in-patient treatment in the local hospital specified by the Fund Medical Officer for which a payment of 10s. per day shall be made to that hospital.
- 23. Provided that if a bed is not available at a rate which will be fully met by the amount specified in by-law 22, the Board may make an additional payment to cover the increased cost, but such payment shall not be made if a bed at increased cost is requested by the subscriber or dependant.

- 24. A payment of 10s. per day shall be made for in-patient treatment at any other approved hospital. Payment in respect to other hospitals shall be limited to 70 days in any one year for each person entitled to benefit. Additional payment as set out in by-law 23 may also be made.
- 25. Qualifying Period—Accidents.—The subscriber shall be entitled to benefit from the Fund if he meets with an accident at any time after acceptance of membership.

Sickness.—Benefit will not be payable in respect of treatment for a disability of which the symptoms were apparent to the subscriber before the expiration of two (2) weeks after acceptance of membership.

Maternity.—Benefits for maternity will not be available to the subscriber until the expiration of a period of nine (9) months after acceptance of membership.

- 26. Forfeiture of Benefits.—A subscriber shall only be entitled to benefits for himself and dependants as long as he shall be a financial member of the Fund, and any subscriber who is four weeks in arrears may be deemed to be unfinancial and, if so deemed, shall forfeit all benefits from the Fund.
- 27. A subscriber who has been a member of the Fund for a longer period than twelve consecutive months may continue membership of the Fund although not residing within the Fund area and shall be entitled to those benefits given under a fee-for-service.
- 28. Limitation.—Benefits will not be payable in the following cases:—
- (a) For any condition covered by the Workers' Compensation Act.
- (b) Injuries or sickness covered by third party insurance, Repatriation Act, or Social Services Act, or under process of Common Law: Provided that failure on the part of the sick or injured person to recover damages or compensation shall not deprive such persons from medical services by the Fund.
 - (c) Examination for life insurance.
 - (d) Alcoholism.
 - (e) Venereal disease.
 - (f) Certifiable insanity after certification.
- (g) Tuberculosis after the date of positive diagnosis.
- 29. For the purposes of these by-laws the expression "in any one year" shall mean the period of 365 days immediately preceding each day for which a claim for benefit is made.

- (2) Every person who owns, manages, conducts, controls or is in charge of any factory or other works or undertakings, or of any work or operation carried on in any factory, works, or undertakings as aforesaid, shall take due precautions against the leakage from any vats, tanks, vessels, pits, conduits, or open channels of any poisonous or offensive water therefrom, and shall sufficiently fence off and protect from the public or from any stray stock all such vats, tanks, vessels, pits, conduits, or open channels containing any poisonous or offensive water, and every person who shall fail or neglect to so take precautions, or who shall neglect to so fence off and protect any such vat, tank, vessel, pit, conduit, or open channel, shall be guilty of an offence against this by-law and shall on conviction be liable to a penalty not exceeding ten pounds.
- ceeding ten pounds.

 (3) Every person who owns, manages, conducts, controls, or is in charge of any factory or other works or undertakings, or of any work or operation carried on in any factory, works, or undertakings as aforesaid, shall make due provision for the conveyance away from such factory or other works or undertakings of all offensive or waste waters or poisonous water derived from such factory or other works or undertakings, in properly constructed channels or water courses, or conduits, and shall make provision by means of culverts or bridges for the crossing over by the public of all such channels, water courses, or conduits. Such culverts or bridges or crossing places shall be constructed in such a manner as the Board directs, and shall at all times be kept and maintained in an efficient manner to the satisfaction of the Board. Any person offending against the provisions of this by-law shall be liable on conviction to a penalty not exceeding five pounds.
- (4) The word "person" where it is used in these by-laws, shall mean and include any person, firm, or body corporate, and shall also include any manager, servant, or employee of such person, firm or body corporate who does or permits to be done any act made punishable by these by-laws, or fails or neglects to do any act required to be done hereunder, whether such act or omission is done or omitted to be done hereunder, whether permission of any such person, firm, or corporation or not

- 2. Clause 65 is amended by adding before the word "Where" in line 1 thereof the words "Subject to clause 19 hereof"
- 3. Clause 89 is deleted and a new clause is substituted therefore as follows:-
 - 89. No sleep-out or enclosed verandah shall be constructed unless the following conditions are complied with:-
 - (a) No dado may exceed three feet six inches in height above the floor level.
 - (b) In the case of new buildings the dado must be constructed of brick or concrete if it faces any street.
 - (c) In the case of existing buildings:-
 - (i) If the enclosed space has a concrete floor or if it includes any newly added floor area the dado must be constructed of brick or concrete.
 - (ii) If the enclosed space has a wooden floor the dado may be constructed of any approved material except where the building is located on a lot at the investion of two streets in the junction of two streets in which case subclause (b) this clause shall apply as if the building were a new building.
 - (iii) If the building is itself of wood the dado may be constructed of any approved material.
 - (d) The enclosing walls above the top of the dado-
 - (i) shall consist of glass louvres capable of being opened extending to at least 40 per cent. of the length of the enclosing walls, the remainder of the enclosing walls being constructed of material similar to the dado, or
 - (ii) shall consist of glass louvres capable of being opened extending to at least 25 per cent. of the length of the enclosing walls, the remainder of the enclosing walls being constructed as windows,
 - (iii) provided that if the window of any room opens into the enclosed space the enclosing wall opposite thereto shall consist of glass louvres capable of being opened extending to at least the combined widths of all the combined widths of all rooms of which any window so opens or to at least 40 per cent. of the length of the enclosing walls, whichever is the greater.
