WHEREAS it is provided by section 241 of the Road Districts Act, 1919-1951, that rates through the district shall be uniform, except insofar as a board may fix the rate for any townsite or for any special area, defined for that purpose by proclamation, at a higher figure within the limits set forth in the said section; and whereas it is desirable to proclaim and declare that all those portions of the Kwinana Road District defined in the Schedule hereto shall be areas within which the Kwinana Road Board may rate at such higher figure: Now, therefore I, the said Governor, acting by and with the advice and consent of the Executive Council, do hereby proclaim and declare that all those portions of the Kwinana Road District defined in the Schedule hereto shall be areas within which the Kwinana Road Board may fix the rate at such higher figure as aforesaid, within the limits mentioned in section 241 of the Road Districts Act, 1919-1951.

Schedule.

Area A.

All that portion of land bounded by lines starting at the intersection of the low water mark of Cockburn Sound and the Northern boundary of lot 2 of Cockburn Sound Location 704 (portion of Commonwealth Reserve 255), as shown on Land Titles Office Diagram 17122, and extending Easterly and Southerly along boundaries of that lot to a point in prolongation Westerly of the Northern boundary of location 343; thence Easterly, Southerly, again Easterly, again Southerly and again Easterly to and along boundaries of locations 343, 323, 507 and 635 to the Western side of road No. 789; thence generally Southerly along that side to a

point in prolongation Westerly of the Northern boundary of Peel Estate Lot 1189; thence generally Easterly to and along that boundary and onwards to and along those of lot 1168 to the North-Eastern corner of the latter lot; thence generally South-Easterly along the Eastern boundaries of lots 1168, 1169, 1170, 1171 and 1172 to the South-Eastern corner of the latter lot; thence Westerly along its Southern boundary to the North-Eastern corner of lot 1173; thence Southerly along the Eastern boundary of that lot and onwards to the Northern boundary of lot 1180; thence Easterly, Southerly and Westerly along boundaries of that lot to the North-Western corner of lot 4; thence Southerly along the Western boundary of that lot and onwards to the Northern boundary of lot 99; thence Westerly and South-Westerly along boundaries of that lot to the North-Eastern side of road No. 313; thence generally North-Westerly along that side to the Eastern side of road No. 4029; thence Northerly along that side and onwards to the Northern side of road No. 3691; thence generally Westerly along that side and that of road No. 4851 to the South-Eastern corner of Cockburn Sound Location 146; thence Northerly along the Eastern boundaries of locations 146, 58 and 125 to the North-Eastern corner of the latter location; thence Westerly, Southerly and again Westerly along boundaries of locations 125 and 442 to the South-Western corner of the latter location; thence North-Westerly to and along the North-Eastern side of Gulf Street and onwards to the North-Western side of Rockingham Road (road No. 695); thence South-Westerly along that side of the Southernmost corner of location 704 aforesaid; thence North-Westerly along the South-Western boundary of that location to the low water mark of Cockburn Sound aforesaid, and thence generally Northerly along that low water mark to the starting point.

Area B.

All that portion of Cockburn Sound Location 244 bounded by lines starting at the intersection of the North-Western side of Rockingham Road (road No. 695) and the prolongation North-Westerly of the South-Western side of Ocean Street and extending South-Easterly to and along that side to the North-Western side of Pioneer Road; thence

South-Westerly along that side to the Northern side of Office Road (road No. 1771); thence West-erly along that side and onwards to the North-Western side of Rockingham Road aforesaid, and thence North-Easterly along that side to the starting point.

(b) A brick and tile pumping station and a reinforced concrete well, together with a 10in. diameter reinforced concrete rising main and all other apparatus connected therewith, as shown on Plan M.W.S.S. & D.D., W.A., No. 7860.

Municipal Corporations Act, 1906-1953.

Municipality of Kalgoorlie.

ORDER IN COUNCIL.

L.G. 2226/52.

WHEREAS it is provided by subsection (1) (b) (ii) of section 480 of the Municipal Corporations Act, 1906-1953, that a Council may with the approval of the Governor expend out of the ordinary revenue of the Municipality any sum or sums not exceeding the aggregate 10 per cent. of such ordinary revenue for subsidising the road board of any adjoining road district in respect to the expense to be incurred by the said road board in providing, constructing or maintaining any road within the said road district; and whereas the Council of the Municipality of Kalgoorlie is desirous of expending the sum of £167 from its ordinary revenue for subsidising the expense incurred by the Kalgoorlie Road Board on the Abattoirs Road: Now, therefore, His Excellency the Governor, acting by and with the advice and consent of the Executive Council and in exercise of the power vested in him in the said section of the said Act, doth hereby authorise the Council of the Municipality of Kalgoorlie to expend from its ordinary revenue the sum of £167 for subsidising the expense incurred by the Kalgoorlie Road Board.

Traffic Act, 1919-1953.

Preston Road Board.

ORDER IN COUNCIL.

L.G. 1898/52.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, hereby makes the following Order under the authority of section 49 of the Traffic Act, 1919-1953, namely, that the Preston Road Board is hereby empowered to make by-laws in pursuance of—

- (1) Clause (a) of paragraph (i) of subsection (1) of section 47 of the said Act, prescribing the rules to be observed in respect of any vehicle being driven or used on roads;
- (2) Clause (zd) of paragraph (i) of subsection (1) of section 47 of the said Act, appointing stands and parking places for different classes of vehicles and regulate the use thereof;
- (3) Clause (zl) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting or restricting the parking of vehicles of a specified class or classes in all roads or in specified roads or specified parts of roads, at all times or at specified times.

Subject to the condition that no such by-law shall be valid and effectual unless it has, prior to notification of its making being published in the *Government Gazette*, been submitted to and approved by the Governor.

CRIMINAL CODE ACT, 1913.

Criminal Practice Rules 1914.

IT is ordered by the Honourable Sir John Patrick Dwyer, K.C.M.G., Chief Justice of Western Australia and the Honourable Albert Asher Wolff, the Honourable James Leonard Walker, the Honourable Lawrence Walter Jackson and the Honourable John Evenden Virtue, Puisne Judges of the Supreme Court of Western Australia, acting in pursuance of the powers contained in the Supreme Court Act, 1935-1950, and of the Criminal Code and of every other power enabling them in that behalf as follows:—

The following amendments to the Criminal Practice Rules, 1914, shall come into operation upon publication thereof in the *Government Gazette*.

1. All references to the date, "1914" immediately following a reference to the "Criminal Practice Rules" are deleted, whenever occurring.

2. Order I Rule 1 is amended by substituting for the words, "The expression 'Respondent' means the person who has the duty of appearing for the Crown or who undertakes the defence of any appeal," the words, "The expression, 'Respondent' includes all persons entitled to appear other than the appellant."

3. Order I Rule 1 (c) is amended by substituting for the reference to, "The Interpretation Act, 1898," a reference to, "The Interpretation Act, 1918-1948."

4. Order II Rule 1 is amended by adding thereto the words, "or, in the case of an indictment presented in a Court of Session, 'Western Australia: In the Court of Session holden at B'."

5. Order IV Rule 4 is amended by adding thereto the words, "In this Rule the word 'appearance,' subject to the context, includes 'defence'."

6. Order IV Rule 5 is amended by substituting for the words, "If the defendant appears by solicitor, he may also plead by solicitor," in line one, the words "The defendant may plead by counsel or solicitor."

7. Order IV Rule 6 is amended by adding thereto the words, "In this Rule, the expression 'memorandum of appearance' includes 'defence'."

8. Order VI Rule 3 is amended by inserting after the word "sessions" in line three, the words "Court of Session."

9. Order IX Rule 10 is amended by deleting all words in the first four lines commencing with the words, "In respect of cases" and ending with the words, "such cases he is," and substituting therefor the words, "The Registrar, if."

10. Order IX Rule 16 is repealed and the following rule substituted:—

16. (1) Every notice of appeal on the part of the prosecution shall be by notice of motion filed in triplicate in the registry and may be according to the Form 8 in Part IV of the Schedule.
- (2) The Registrar shall ascertain the date of the sitting of the Court of Criminal Appeal at which the appeal may be heard, being a date not less than ten clear days after the day of such filing.
- (3) The Registrar shall endorse such date on two copies of the notice of appeal and shall return such copies to the appellant.
- (4) The appellant shall, not less than seven clear days before such date, serve one of the copies on the accused or his solicitor.

11. Order XIV Rule 1 is repealed.

12. Order XIV Rule 2 is amended by deleting the words, "with consecutive numbers," in line nine.

13. Order XIV Rule 3 is amended by inserting at the commencement thereof the words, "Exhibits shall be retained in the custody of an officer of the Court of Trial during the time limited for any appeal, and, where an appeal is lodged, then pending that appeal. Subject as aforesaid."

14. Order XVI Rule 2 is amended as follows:—

- (a) by inserting after the words, "shall be given" in line three the words in brackets, "(not being notices to which in his opinion section 701, subsection (2) of the Code applies)"; and
- (b) by deleting the words, "or whenever it appears to be necessary for the proper determination of any appeal or application, or for the due performance of the duties of the Court of Criminal Appeal under the said section, may," in lines 4, 5, 6 and 7.

15. Order XVI Rule 3 is amended by substituting for the word, "thereof" in line two, the words, "of the Supreme Court specifying what is to be furnished."

16. Order XVII is amended by inserting after Rule 3, a new Rule as follows:—

4. (i) The foregoing Rules of this Order do not apply in any case where the Crown or the Prosecutor is the appellant. In any such case the Registrar shall—

- (a) notify the accused or his counsel or solicitor of the appeal; and
- (b) where the appellant is a private prosecutor, notify the Crown Prosecutor of the appeal.

(ii) Where the appellant is a private prosecutor, the Court of Criminal Appeal may, at any stage of the proceedings, order that the Crown Prosecutor shall take over the defence of the appeal.

17. Order XVIII is amended by inserting after Rule 1 a new Rule as follows:—

1A. If it appears necessary or expedient for the proper determination of an appeal or application to the Court of Criminal Appeal, a Judge of the Supreme Court on application by any appellant or respondent prior to the hearing and after notice of such application to other parties concerned, may, by special order, grant leave to all or any parties to file affidavits relating to any ground of the appeal or application, and may direct what persons shall be competent to make any such affidavit or affidavits and within what time or times any such affidavit shall be filed.

18. Order XVIII Rule 3 is amended by substituting for the reference to "Supreme Court Act (Amendment), 1892," in the last line, a reference to the "Supreme Court Act, 1935-1950."

19. Order XIX Rule 11 is amended by inserting the word, "Criminal," after the words, "Court of," in line one.

20. Order XXII Rule 1 is amended by inserting after the word, "Peace" in line 2, the words, "or Court of Session."
21. Order XXII Rule 2 is amended by inserting after the word, "Peace" in line 2, the words, "or Court of Session."
22. Order XXII Rule 4 is amended as follows:—

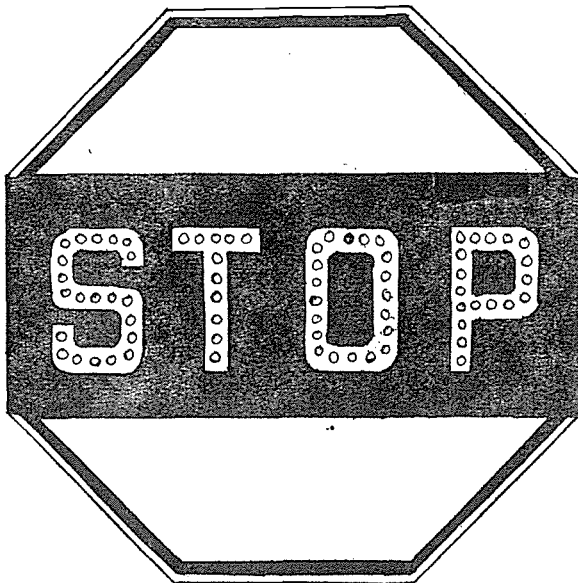

COAL MINES REGULATION ACT, 1946-1951.

Department of Mines,
Perth, 30th June, 1954.

HIS Excellency the Governor in Executive Council, under the 1954 provisions of the Coal Mines Regulation Act, 1946-1951, has been pleased to amend in the manner set forth in the Schedule hereunder the Regulations and General Rules made under the Act and published in the *Government Gazette* on the 19th day of September, 1947, and amended from time to time thereafter.

Schedule.

The abovementioned Regulations and General Rules are amended by deleting Division IV—Explosives—and substituting a new Division IV—Explosives—as follows:—

Division IV—Explosives.

38 (1) Explosives shall be stored in a main magazine or a distributing magazine.

(2) A main magazine may be either—

- (a) a building on the surface of the ground at a distance of not less than one hundred yards from any other buildings, works, or a public road, surrounded by substantial mounds of earth at least four feet in thickness to a height level with the eaves of the building; or
- (b) an excavation in the ground so arranged that the roof shall not be less than 15 feet below the surface of the ground; or
- (c) a drive or chamber in an upper level of the workings of the mine connected with the surface by an independent air pass; the passage connecting the magazine with the workings of the mine shall describe in its course at least one right angle, and the magazine shall be situated at a distance of 60 feet from any travelling road or underground thoroughfare, unless, in the opinion of the inspector, owing to the nature of the country, this distance may be reduced, but in no case shall the distance be less than 30 feet; or
- (d) a building approved by the Inspector of Explosives appointed pursuant to the provisions of the Explosives Act, 1895, and licensed under those provisions.

(3) The construction, lining and ventilation of every main magazine shall be approved by the inspector, and it shall be protected by doors so constructed and secured as to render it safe against unlawful entry.

(4) The quantity of explosives which may be stored in a main magazine constructed as provided in paragraph (a) of subregulation (2) of this regulation shall not exceed five hundred pounds, in paragraph (b) of subregulation (2) of this regulation shall not exceed two thousand pounds, and in paragraph (c) of subregulation (2) of this regulation, such quantity as is certified by the Inspector of Explosives, so appointed, not exceeding one day's supply, according to the requirements of the mine, together with such extra amount, not exceeding one thousand pounds, as he may certify to be reasonable to provide for emergencies, and in paragraph (d) of subregulation (2) of this regulation, such quantity as is approved by the Inspector of Explosives so appointed.

39 (1) Detonators shall not be stored in a magazine containing other explosives, nor shall they be carried or placed in a receptacle containing other explosives.

(2) The detonators in any place of storage as aforesaid shall be under the sole control of the manager or some one person specially authorised in writing by the manager to have such control in respect of that place of storage for the time being. But this regulation shall not apply to explosives and detonators when assembled in the surface magazine pending issue to the workers going on shift. The person having control of the surface magazine shall be appointed in writing by the Manager.

(3) The Manager or other person for the time being having control of detonators as aforesaid shall only issue detonators—

- (a) in mines to which this Act applies, to shotfirers appointed therein or contract miners;
- (b) to such officials of the mines, who shall be either firemen, examiners or deputies of the mine, or underground officials of the mine superior to the fireman, examiners or deputies, as are specially authorised in writing by the manager for that purpose.

(4) No person shall take into the mine, or shall have in his possession in the mine any detonators except in accordance with the foregoing provisions.

40. Magazines of a design approved by the Inspector of Explosives may be provided underground and the quantity of explosives stored in such magazine shall not exceed requirements for one day's operations.

41. No explosives shall be taken into a working face except in a securely covered case or canister of size and construction approved by the inspector.

42. Every person to whom detonators are issued shall keep them until they are about to be used for the charging of a shot-hole in a non-metallic case, provided by the owner and approved by the departmental inspector, which shall be kept securely fastened and separate from any other container of explosives. The persons provided with such cases shall be responsible for any loss or wilful damage.

43. Every charge shall be placed in a properly drilled and placed shot-hole, and shall have sufficient stemming and each charge shall consist of a cartridge or cartridges of not more than one description of explosive. It shall be the duty of the person firing the shot to satisfy himself that these requirements are fulfilled before he fires the shot.

44. (1) In charging holes for blasting no iron or steel tools shall be used in tamping or ramming, and an adequate supply of tools approved by the inspector for this purpose shall be provided.

(2) Dry coal or coal dust shall not be used for stemming in any gaseous, dry or dusty mine or part thereof.

45 (1) No explosive shall be forcibly pressed into a hole, and when a hole has been charged the explosive shall not be unrammed, nor shall any part of the stemming be removed, nor shall the detonator leads be pulled out save as provided in regulation 47 (2).

(2) No drill shall be used for the boring of a shot-hole unless it allows of a clearance of at least $\frac{1}{8}$ in. over the diameter of the cartridge which is intended to be used in the shot-hole and no person shall attempt to charge a shot-hole unless such clearance exists.

46. The person firing the shot or shots shall, after the shot has been fired, make a careful examination of the place to see that it is safe in all respects.

47. (1) Where a shot miss-fires the following provisions of this regulation shall be observed:—

- (a) The person firing the shot shall not approach or allow anyone to approach the shot-hole until an interval has elapsed of not less than 10 minutes.
- (b) The person firing the shot shall, before approaching or allowing anyone to approach the shot-hole, disconnect the cable from the firing apparatus and carry such apparatus himself until the cable has been disconnected from the shot.
- (c) If the person firing the shot has occasion to leave the place before the shot has exploded, he shall fence off the place before leaving, and shall affix a danger board or fence indicating the presence of a miss-fire shot.
- (d) Except where a miss-fire is due to a faulty cable or a faulty electrical connection, and the shot is fired as soon as practicable after the defect is remedied, another shot shall be fired in a fresh hole which shall be drilled not less than 12in. away from the hole in which the shot has missed fire, and shall, as far as practicable, be parallel with it.
- (e) A second charge shall not be placed in the same hole.
- (f) The person firing the second shot shall, before doing so, attach a string to the electric leads of the miss-fired shot, and secure it by attaching it to the cable or to a prop or otherwise.
- (g) After the second shot has been fired no person shall work in the place until the person firing the shot or an official of the mine has made a careful search for the detonator and charge of the miss-fired shot.

If the detonator and charge are not found, the stone or mineral shall be loaded under the supervision of the person firing the shot, or an official and sent to the surface in a skip or skips specially marked.

The search for the detonator and charge, and the loading of any stone or mineral which may contain a detonator, shall be carried out as far as possible without the use of tools.

- (h) Should the miss-fired shot not be dislodged by the second shot the person firing the shot shall report to the manager or other official, who shall take such action as he may deem desirable.
- (i) The person or persons firing the shots shall report the circumstances to the manager, under-manager, or deputy, and the number of cartridges, if any, which have not been found, and hand to him the detonator and charge, if found.

(2) The provisions of regulation 45 as to the pulling out of detonator leads shall not apply in cases in which an exemption is granted by the departmental inspector on the ground that water is used for stemming.

48. Shot-firers shall make daily and sign a record of the number of shots fired and the number of miss-fired shots (if any) in a book kept at the mine for the purpose.

49. No person firing a shot shall use a cable less than 40 yards in length.

50. Every electrical shot-firing apparatus shall be examined, cleaned and thoroughly overhauled at regular intervals either by the maker of the apparatus or by a competent person, and a record of such examination shall be kept at the mine.

51. No detonators other than electric detonators shall be used in any mine.

52. In any gaseous or dry and dusty mine no shot shall be fired except by or under the direction of a competent person appointed by the owner, agent, or manager of the mine; and such person shall not fire the shot nor allow it to be fired until he has examined both the place itself where the shot is to be fired and all contiguous accessible places of the same seam within a radius of 20 yards, and has found such place safe for firing.

53. If in any mine, inflammable gas was found and recorded in the last examination under regulation 126, no shots shall be fired—

- (a) unless a competent person appointed as aforesaid has examined the place where gas has been so reported to be present, and has found that such gas has been cleared away, and that there is not at or near such place sufficient gas issuing or accumulated to render it unsafe to fire the shot; or
- (b) unless the explosive employed in firing the shot is so used with water or other contrivance as to prevent it from inflaming gas, or is of such a nature that it cannot inflame gas.

54. If the place where a shot is to be fired is dry and dusty, then the shot shall not be fired unless one of the following conditions is observed, that is to say—

- (a) unless the place of firing and all contiguous accessible places within a radius of 20 yards therefrom are at the time of firing in a wet state from thorough watering or other treatment equivalent to watering, in all parts where dust is lodged, whether roof, floor, or sides; or
- (b) in the case of places in which watering would injure the roof or floor, unless the explosive is so used with water, or other contrivance, as to prevent it from inflaming gas or dust, or is of such a nature that it cannot inflame gas or dust.

55. If such dry and dusty place is part of a main haulage road, or a place contiguous thereto, and showing dust adhering to the roof and sides, no shot shall be fired there unless—

- (a) both the conditions mentioned in regulation 54 have been observed; or
- (b) such one of the conditions mentioned in regulation 54 as may be applicable to the particular place has been observed, and, moreover, all workmen have been removed from the seam in which the shot is to be fired, and from all seams communicating with the shaft on the same level except the men engaged in firing the shot, and such other persons, not exceeding 10, as are necessarily employed in attending to the ventilating appliances, engines, machinery, winding apparatus, signals, or horses, or in inspecting the mine.

56. Electricity from lighting or power cables shall not be used for firing shots.

57. When shot firing cables or wires are used in the vicinity of power or lighting cables, sufficient precautions shall be taken to prevent the shot firing cables or wires from coming into contact with the lighting or power cables.

58. Only competent persons who have been properly instructed in the work and duly authorised by the manager in writing shall be allowed to fire shots electrically in any part of a mine.

59. The exploder and shot-firing cable shall be of a type approved by the Electrical Inspector, and after firing the shots, if the cable is used in more than one place, it shall be rolled on to a reel provided for the purpose.

60. The exploder shall be in the charge of the shot-firer and shall be fitted with a handle or key which shall be detached when not required for firing and shall not, under any conditions, pass from the personal custody of the shot-firer whilst on duty, except when a primary or secondary battery is used for shot-firing.

61. The exploder shall not be connected to the shot-firing cable until all other steps preparatory to the firing of the shot have been completed and all persons have been removed to a place of safety.

62. Immediately after the firing of the shot, the firing cable shall be disconnected from the exploder.

63. (1) Every person firing any charge of explosives shall, immediately before doing so, make sure that all persons in dangerous proximity have been warned, and that all approaches to the explosion are guarded either by persons told off for that purpose or by warning obstacle and notices.

(2) All machinery in the immediate vicinity of shots being fired shall be stopped immediately before the shot is fired so that all persons can be adequately warned.

(3) If the person firing the shot has reason to believe that there is a possibility of the shot blowing through into an adjoining place he shall ascertain that all persons in that place have taken proper refuge before the shot is fired.

64. (1) When using explosives in any mine, the men charging and firing the explosives shall be jointly and severally responsible for the proper firing and handling thereof, and when relieved from duty shall forthwith report the position of any charged holes and misfires to the men relieving them or to the deputy, under-manager or manager.

(2) It shall be the sole responsibility of the person firing the shot to see that the provisions of this regulation are adhered to.

(3) Not more than six shots shall be fired simultaneously unless approved by the departmental inspector.

(ii) "Where an employee is required to work outside the normal hours of duty (8 a.m. to 3 p.m. day shift and 3 p.m. to 10 p.m. afternoon shift) or on night shift and has to provide his own conveyance, the employer shall pay such employee an amount equal to the liability of the employer in respect of each employee at the mine, living in the same locality, under the provisions of paragraph (1) of this subclause."

(iii) Any dispute as to the operation of this subclause shall be determined by the Board of Reference.

2. This amendment shall take effect as from the commencement of the first pay period following the 8th day of April, 1954.

THE Tribunal hereby awards, orders and prescribes that Award No. 4 of 1953 of the W.A. Coal Industry Tribunal, as amended, should be further amended in the following manner:—

1. Clause 20. Payment for wet work: Add the following new subclause:—

(f) Should a worker have to work for a shift on a pay Saturday in an excessively wet place, from which the water cannot reasonably be removed, five hours straight shift shall constitute a full day's work and the worker shall be paid a full shift's pay for the work so performed at the rate of time and a half.

For any time less than five (5) hours that a worker is required to work in such excessively wet place, he shall be paid an amount ascertained in accordance with the following formula:

$$\frac{\text{Time so worked}}{5 \text{ hours}} \times \text{Rate for the full shift} \times 1\frac{1}{2}$$

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the said reference of industrial dispute was remitted by the Court to the Conciliation Commissioner, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Conciliation Commissioner by their respective representatives and requested the Conciliation Commissioner to make the said Agreement an Award of the Court; Now therefore, the Conciliation Commissioner, pursuant to section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling him, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court.

Memorandum of Agreement.

(Note.—Wherever the word "Award" occurs herein, it shall be taken to mean and include "Agreement")

1.—Title.

This Award shall be known as the Brushmakers' Award and replaces Award No. 33 of 1949 (as amended).

3.—Scope.

This Award shall apply to the industry of broom and brushmaking and to all workers employed in the branches of the industry mentioned in the Schedule hereunder.

Industry—

Millet and/or grass mixture broom making in all its branches.
Brushmaking in all its branches, including pan work, wood machining, painting, varnishing or spraying.
Mop-making.
Firefighter-making.
Washboard-making.

Representative Employer—

W.A. Brushware Co. (1909) Limited.

4. Area.

This Award shall have effect over the area comprised within a radius of fifteen (15) miles from the General Post Office, Perth.

5.—Term.

The term of this Award shall be for a period of twelve (12) months from the beginning of the first pay period commencing after the date hereof.

6.—Hours.

(a) Forty (40) hours shall constitute a week's work, to be worked in five days.

(b) The ordinary weekly working hours shall be worked between 7.30 a.m. and 6 p.m., Monday to Friday inclusive.

(c) No day's work shall exceed eight (8) hours which shall be worked in a continuous shift.

(d) The actual time at which work is commenced shall be mutually agreed upon between the employer and the worker, and no alteration of these times shall be introduced until seven days shall have elapsed after the Union has been notified of such alteration.

(e) A notice shall be posted up in each factory, setting out the starting and finishing times in operation for the time being in each factory.

7.—Overtime.

(a) Overtime shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter, until the usual time of starting on the next ordinary working day.

(b) All work performed on Saturday after 12 noon or on Sunday shall be paid for at double time rates.

(c) All work performed outside the ordinary working hours on each day Monday to Friday inclusive and all work performed on Saturday before 12 noon shall be counted as overtime and paid for accordingly.

(d) Work performed by pieceworkers, beyond the ordinary hours of duty and all time worked on Saturday before 12 noon shall be paid for at the rate of 50 per cent. in addition to the ordinary piecework rates, for the first four hours, and at the rate of 100 per cent. in addition to ordinary piecework rates thereafter until the usual time of starting on the next ordinary working day.

Work performed by pieceworkers on Saturdays after 12 noon or on Sundays, shall be paid for at the rate of 100 per cent. in addition to ordinary piecework rates.

(e) As far as practicable, no junior worker shall be employed on overtime unless the proportion of adults to juniors as provided in this agreement is maintained whilst such overtime is worked.

(f) When a worker, without being notified on the previous day, is required to work after the usual knock-off time for more than one (1) hour, he shall be provided with any meal required, or shall be paid three shillings (3s.) in lieu thereof: Provided that such payment need not be paid to workers living in the same locality as their place of employment, who can reasonably return home for a meal.

(g) Notwithstanding anything contained herein:—

(i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) No organisation, party to this Award or worker or workers covered by this Award shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.

9.—Piecework.

(a) An employer may make a contract with any worker or group of workers for payment by results by piecework.

(b) The rate of payment shall be fixed on the basis that it shall be sufficient to yield to a worker of average capacity for a full week's work of ordinary hours at least the minimum time rate of pay as prescribed herein for such week's work: Provided that, where a worker works part of a full week at piecework rates and part at time rates, he shall be paid so much as he is entitled to receive under such piecework rates, plus the proportionate amount which he is entitled to receive under this Award at time rates of pay.

(c) A worker working under any system of payment by results shall receive at least the time rate of pay as prescribed herein.

(d) In the event of any dispute regarding piecework rates occurring and remaining unsettled between the employer and workers, the employer or the union may refer such dispute to the Board of Reference.

(e) If any increase or decrease in the basic wage as proclaimed from time to time is not included in the piecework rates, the worker's earnings shall be increased or decreased, as the case may be, in accordance with such increase or decrease in the basic wage.

10.—Mixed Functions.

Any worker carrying out work classified at a higher minimum than his usual rate shall be paid, whilst engaged on such work, at the rate prescribed therefor: Provided that, where no record of such work is kept the worker shall be paid at the higher rate for the whole of the day on which the work was performed. Any such record shall be signed daily only if correct by the worker, and shall be available for inspection at the factory office by the union representative during working hours.

11.—Contract of Service.

(a) The contract of service of every worker shall be a contract of hiring by the week. One week's definite notice shall be given on either side of the termination of the engagement: Provided that a worker may be summarily dismissed for misconduct or theft, in which case he shall be paid up to the time of dismissal only.

(b) All wages shall be paid in cash, on or before Friday, in each week, and shall be paid within ten (10) minutes of the usual time for finishing work.

(c) Except as provided in subclause (d) hereof, when the engagement of a worker is terminated he shall be paid all wages and holiday pay due to him within ten (10) minutes of the expiration of the engagement.

(d) When the engagement of a worker is terminated for misconduct, he shall be paid all wages due to him, within two (2) hours of the termination of his engagement.

12.—Breakdowns, etc.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the union, or the unions affiliated with it, or by any other association or union, or through the breakdown of the employer's machinery, or any stoppage of work by any cause which the employer cannot reasonably prevent.

13.—Holidays.

(a) Subject to subclause (b) hereof the following days or the days observed in lieu, shall be allowed as holidays without deduction of pay, namely:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day.

(b) All work performed on any of the foregoing days shall be paid for at the rate of double time.

All work performed by pieceworkers on such days shall be paid for at the rate of 100 per cent. in addition to ordinary piecework rates.

(c) On any public holiday not prescribed as a holiday under this Award the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

14.—Annual Leave.

(a) Except as hereinafter provided a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer.

(b) If any prescribed holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(c) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(d) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(e) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (c) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(f) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(g) The provisions of this clause shall not apply to casual workers.

15.—Absence Through Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12) of a week for each completed month of service: Provided that pay-

ment for absence through such ill-health shall be limited to one week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident, wherever sustained, arising out of his own wilful default, or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) Notwithstanding the provisions of subclause (c) hereof, a worker who has already been allowed paid sick leave on one occasion shall not be entitled to payment for any further absence in the same year, unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

(e) Sick leave shall accumulate from year to year so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year. Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

16.—Time and Wages Record.

The employer shall keep or cause to be kept a time and wages book, wherein shall be entered—

- (a) the name and sex of each worker, including piece-workers;
- (b) the nature of his or her employment;
- (c) the time he or she commences and finishes work each day;
- (d) the total hours worked each day and each week;
- (e) the wages and overtime (if any) received therefor;
- (f) the ages and sex of junior workers.

Such book shall be entered up each day in legible English characters and shall be signed weekly only if correct by each worker. Such book shall be open for inspection at the factory office by the union representative during working hours.

Any system of automatic recording by means of machines shall be deemed to comply with this provision to the extent of the information recorded.

17.—Employment of Females.

Female workers shall not be employed on the following work: Pan work, bottle-brush making (other than baby bottle-brush making), finishing, millet-broom making or on any work other than bench drawing, filling machine, automatic boring and filling machine, semi-automatic boring and filling machine, trimming machine and mixing machine.

Firefighters, mops and baby bottle-brushes may be made by females.

18.—Proportion of Juniors.

(a) Males.—Junior workers (male) shall be allowed in the proportion of one (1) junior to every three (3) or fraction of three (3) workers in receipt of the full adult male rate prescribed in this Award.

(b) Females.—Junior workers (female) shall be allowed in the proportion of one (1) junior to every two (2) or fraction of two (2) workers in receipt of the full adult female rate prescribed in this Award.

(c) Where no experienced adult male or female worker is available ready and willing to perform work under this Award, the employer may employ additional male or female junior workers in excess of the proportions prescribed in subclauses (a) and (b) of this clause.

(d) In the event of any adult male or female worker being dismissed for any reason other than misconduct, and such adult male or female worker is not replaced by another adult male or female worker, as the case may be, the proportion of junior male or female workers, as the case may be, prescribed in subclauses (a) and (b) of this clause shall immediately be effected.

(e) The proportions prescribed in subclause (a) and (b) of this clause shall at all time be strictly maintained; provided that nothing in this clause shall operate to cause the dismissal of any junior worker employed in the industry at the date of this Award. If any junior worker employed in the industry at the date of this Award shall cease to be employed in the industry through any cause whatsoever, his or her place may be filled by another junior worker; provided that the engagement of such junior worker shall not operate to cause the dismissal of any adult worker.

19.—Junior Worker's Certificate.

(a) Junior workers shall furnish the employer with a certificate showing the following particulars:—

- (i) Name in full.
- (ii) Age and date of birth.
- (iii) Name of each previous employer.
- (iv) Length of service with each previous employer.

(b) The certificate shall be signed by the worker and his or her legal guardian.

(c) No worker shall have any claim upon the employer for additional wages, in the event of his or her age or length of service with the previous employer being wrongly stated on the certificate.

(d) If any worker shall wilfully mis-state his or her age, he or she and the legal guardian alone shall be guilty of a breach of this Award.

20.—Under-rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the union and the employer.

(b) In the event of no agreement being arrived at the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker may be employed at the proposed lesser rate.

21.—Interviewing Workers.

The secretary or any duly authorised representative of the Union shall not be prevented from visiting or conversing with the members of the union in any shop during the meal hours.

22.—Posting of Award and Union Notices.

(a) A copy of this Award shall be placed in a suitable place agreed upon by the employer and the union.

(b) The accredited union representative shall not be prevented from posting any notice of the union not exceeding fourteen (14) inches by nine (9) inches, in a suitable place agreed upon between the employer and the union. Failing agreement in this connection the Board of Reference shall decide where the copy of the Award, or the said notices, shall be posted.

23.—Board of Reference.

(a) The Court appoints, for the purposes of the Award a Board or Boards of Reference. Each Board shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. There are assigned to each such Board in the event of no agreement being arrived at between the parties to the Award the functions of—

- (i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretation of the provisions of the Award or any of them;
- (ii) deciding any other matter that the Court may refer to such Board from time to time.

(b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1952, which for the purpose are embodied in this Award.

24.—Outdoor Work.

No work of any description or class covered by this Award shall be done or performed for any employer, except in the factory or workshop of any employer bound by this Award.

25.—General.

(i) Provision of materials and tools:—

- (a) The employer shall provide all materials and tools used by his employees.
- (b) No charge shall be made against a worker for the use of bench appliances or tools of trade supplied by the employer.

(ii) Clock:—

One reliable clock shall be installed in each factory, and the starting and finishing time of workers shall be taken from that clock.

26.—No Reduction.

This Award shall not in itself operate to reduce the wages of any worker who is at present receiving above the minimum rate prescribed for his or her class of work.

Between Western Australian Government Tramways, Motor Omnibusses, River Ferries and Fremantle Tramways Employees' Union of Workers, Applicant, and General Manager, Western Australian Government Tramways and Ferries, Respondent.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the said reference of industrial dispute was remitted by the Court to the Conciliation Commissioner, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Conciliation Commissioner by their respective representatives and requested the Conciliation Commissioner to make the said Agreement an Award of the Court: Now, therefore, the Conciliation Commissioner, pursuant

to section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling him, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court.

Memorandum of Agreement.

(Note—Wherever the word "Award" occurs herein, it shall be taken to mean and include "Agreement").

1.—Title.

This Award shall be known as the "Government Ferries, Workers' Award."

2.—Arrangement.

3.—Area and Scope.

This Award shall apply to workers described herein employed by the General Manager on the Western Australian Government ferries plying on the Swan River.

4.—Wages and Allowances.

(d) Deckhands and/or Junior Workers when required to collect fares and issue tickets shall be paid an additional amount of two (2) shillings per day or part of a day.

(e) Casual employees shall be paid ten per cent. (10%) in addition to the wage herein prescribed.

"Casual" means a worker engaged for less than one week continuously but does not include an employee who, when work is available, leaves his employment before the expiration of one week.

(f) Wages shall be paid weekly.

(g) Liberty to apply for variation of margins and/or Junior Workers' percentages is agreed to during the currency of the Award if the Court of Arbitration determines a general alteration to this standard.

5.—(1) Hours.

(a) A week's work shall consist of forty (40) hours worked in five (5) or six (6) shifts spread over seven (7) days.

(b) Each week shall commence and finish on Sunday at 12.45 a.m.

(c) The General Manager shall determine whether a week's work shall consist of five (5) or six (6) shifts, but each employee affected by any change in the weekly number of shifts shall be notified of such alteration at least one (1) week prior to its operation.

(d) The minimum time inclusive of preparation time to be paid for each day shall be six (6) hours forty (40) minutes to be worked consecutively insofar as it applies to staff employed in traffic on the normal ferry service. When employed ashore, the minimum time to be paid for each day shall be six (6) hours forty (40) minutes. The foregoing minimums may be reduced to three (3) hours twenty (20) minutes in respect to employment on charter cruises or any service other than the normal ferry service.

(e) As far as is practicable, no employee shall be booked up for duty until he has had ten (10) hours off duty, except to facilitate the rotations of shifts or on a public holiday, or the day following a public holiday. In all cases there shall be a minimum of eight (8) hours off duty.

5.—(2) Rosters.

(a) As far as is practicable, shifts shall be rostered to rotate weekly.

(b) Rosters shall be posted on the notice board one (1) clear week ahead, but shall be subject to alteration in the event of special circumstances arising which could not have been foreseen at the date of posting of roster.

(c) Employees shall be rostered to have at least one (1) day off in each week. If after posting the rostered weekly work as per subclause (b) of this clause an employee's day or days off is or are cancelled, he shall be paid a minimum including preparation allowances of six (6) hours forty (40) minutes at the rate applicable to the day, plus one-half: Provided that all time actually worked in excess of four (4) hours on such day shall be paid at the rate of double time. The penalty rate herein prescribed shall not in any instance exceed double time. Such time to stand alone and not be included in the week's work of forty (40) hours.

(d) If after posting of the rostered weekly work as per subclause (b) of this clause, an employee's day or days off is or are cancelled, but another day or days is or are substituted therefor, he shall be paid at the rate applicable to the day plus one-quarter for all time worked on his originally rostered day or days off.

(e) As far as is practicable, forty-eight (48) hours' notice of cancellation or alteration to day or days off shall be given.

(f) If after receiving notice of cancellation of day or days off, an employee is not given work, he shall be given an allowance of three (3) hours twenty (20) minutes at ordinary rates for each day involved.

6.—Overtime.

(a) Overtime shall mean all time worked in excess of eight (8) hours per day and/or forty (40) hours per week, and shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) The time on which penalty rate has been paid for at a daily basis will not be subject to the penalty rate on a weekly basis.

(c) Employees required to work on any day beyond the final rostered finishing times of shifts as posted or notified on the day previous, shall be paid for all such excess time at the rate prescribed in subclause (a) hereof.

(d) Time for which penalty rates have been prescribed shall not be included in the ordinary weeks' work.

(e) The overtime rates shall be computed on the rate applicable to the day on which the time is worked: Provided that double time, i.e., twice the ordinary rate, shall be the maximum.

(f) (i) The General Manager may require any worker to work reasonable overtime at overtime rates provided under this Award, and workers shall work overtime in accordance with such requirements.

(ii) No organisation party to the Award, worker, or workers covered by this Award, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements as shown in this subclause.

(iii) This subclause shall remain in operation only until otherwise determined by the Court.

7.—Work on Saturdays and Sundays.

(a) All time worked on Saturdays by shift workers shall be paid for at time and a half. Provided that this subclause shall not apply to employees who finish duty by 12.45 a.m. on Saturdays. For the purpose of this subclause, "shift worker" means workers other than workers who always commence and complete the ordinary hours of work during the period 7 a.m. to 5.30 p.m.

(b) Time worked on Sundays by employees rostered for shift work shall be included in the week's work of forty (40) hours and shall be paid for at the rate of time and a half, provided that this subclause shall not apply to employees who finished duty by 12.45 a.m. on Sundays.

8.—Contract of Service.

(a) No worker after six (6) months' continuous service shall leave the Department until the expiration of fourteen (14) days' written notice of his intention so to do, without the approval of the General Manager.

(b) Except in the case of summary dismissal for misconduct fourteen (14) days' written notice shall be given by the General Manager to any worker who has completed six (6) months' continuous service and whose services are no longer required and the reason for dismissal shall be stated on such notice.

(c) In the event of either the General Manager or the employee failing to give the prescribed notice, wages shall be paid or forfeited, as the case may be, to the extent by which the actual written notice given falls short of the fourteen (14) days' notice. Wages so forfeited by the employee may be deducted from any wages due to such employee at the time of his leaving the services of the General Manager. Provided that where both parties agree to the acceptance of notice of less than fourteen days (14), no penalty shall be imposed.

(d) (i) **Guaranteed Week.**—The General Manager shall normally guarantee to each employee, other than a casual, a full week's work, but if during any period by reason of any action on the part of any section of his workers or for any cause beyond his control, he finds himself unable to carry on either wholly or partially the complete running of ferry services, workshops or other normal operation, the General Manager shall be entitled notwithstanding any implication arising from the provisions of section 45 of the W.A. Government Tramways and Ferries Act, 1948, to employ only such employees (if any) as he considers can be usefully employed and for such hours only as he considers necessary, and during such period no employee shall be paid except for such time as shall be actually worked by him.

Provided that employees who are required to attend for work and do so attend on any day shall be paid a minimum of one day's pay at ordinary rates.

(ii) An employee stood down in accordance with the foregoing provision shall not lose any sick leave or other rights or privileges to which such employee would ordinarily be entitled, provided that this provision does not entitle an employee to payment for any public holiday falling during such period of stand-down.

(iii) The guaranteed period may be reduced in respect of any employee under suspension: Provided that any worker suspended on a charge which is not sustained shall be entitled to the benefit of the guarantee during the period of his suspension.

9.—(1) Annual Leave.

(a) After twelve (12) months' continuous service in the employ of the General Manager all workers shall be allowed two (2) weeks' leave which shall be paid for at the ordinary rate for eighty (80) hours.

(b) All workers, after one (1) month's continuous service, shall be entitled to the annual leave set out in the preceding subclause, in proportion as the length of service is to the full number of holidays for the twelve (12) months.

(c) Annual leave may, subject to the approval of the General Manager, be allowed to accumulate for two (2) years.

(d) Workers shall be paid for annual leave at their graded rates of pay when such annual leave is taken. Provided that if within two (2) weeks before such annual leave is taken the worker is acting in a higher capacity and has been so acting for a period of not less than two (2) months continuously, the annual leave shall be paid for at the rate applicable to such higher capacity position.

(e) Any worker who may resign or be dismissed from the service for any cause other than for peculation or theft shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service. Provided always that, if the worker has been dismissed for peculation or theft, no claims for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

9.—(2) Holidays.

(a) In addition to their annual leave all workers, other than casuals, shall be granted the following holidays: New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Queen's Birthday, Christmas Day, Boxing Day, and any other day proclaimed as a general public holiday.

(b) (i) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If an employee is required to work on a holiday he shall be paid for the time worked as if it were an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or be taken at some subsequent date where the worker so agrees.

(ii) If a worker is rostered for a short shift on a holiday, but is not required to work on that day he shall be paid for such rostered hours only.

(c) (i) When any holiday falls on a Sunday, workers shall not be granted a paid holiday except where that holiday is observed on the following Monday.

(ii) In the case of workers working a five-day week, no payment or day in lieu shall be granted for any holiday which falls outside his rostered working week of five (5) days.

(d) A holiday which falls on a day on which a worker is on paid annual leave shall be treated as if it fell on the worker's ordinary working day.

(e) (i) When a worker is off duty owing to leave without pay or sickness including accidents on or off duty, any holiday falling during such absence shall not be treated as a paid holiday. Where the worker, however, is available to resume his normal duties on a public holiday and whether he is given work or not on such holiday, he shall be entitled to a paid holiday for such holiday.

(ii) In accordance with the long service leave conditions as provided for in clause 10 of this Award, any holiday occurring during the period in which a worker is on long service leave shall be calculated as portion of the long service leave and extra days in lieu shall not be granted.

10.—Long Service Leave.

The conditions governing the granting of long service leave to full time Government wages employees generally shall apply to workers covered by this Award.

11.—Absence from Duty.

(a) Any employee, being unable to attend to his duty shall notify his officer-in-charge at least three (3) hours before the time he is booked for duty, and he shall also satisfy such officer that is unable to attend his duties.

(b) Any worker so absent shall not again be booked up for duty unless he notifies such officer not later than noon on the day previous that he is able to resume.

(c) Subject to the provision of clause 12 (Payment for Sickness) any worker losing time through sickness or special leave shall be reduced in wages only to the extent of the time actually lost through sickness or actually granted as special leave.

12.—Payment for Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health at the rate of one-twelfth (1/12) of the guaranteed week's work for each completed month of service: Provided that payment for such absence through such ill-health shall be limited to one (1) week in each calendar year, but the sick leave herein provided shall be allowed to accumulate and any portion unused in any year may be prevailed of in the next or any succeeding year. Payment hereunder may be adjusted at the end of each calendar year or at any time the worker leaves the service, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) No worker shall be entitled to the benefits of this clause unless he produces proof to the satisfaction of the General Manager, or his representative, of sickness, but the General Manager shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(c) No payment will be made for any absence due to a worker's own fault, neglect, or misconduct.

13.—Uniforms.

Should the General Manager require an employee to wear uniform, the uniform shall be supplied to the employee free of cost.

14.—Time and Wages Record.

The secretary of the union, a party to this Award, shall be entitled at all reasonable times to inspect the department's records of the hours worked by, and the amounts paid to, the various workers covered by this Award.

15.—Privileges.

(a) All existing privileges regarding free travel on buses or trams shall apply to all workers covered by this Award.

(b) Under no circumstances will a duplicate pass be issued in lieu of a pass during its term of currency, which has been lost or otherwise not accounted for.

16.—Operation of Award.

The term of this Award shall be for a period of three (3) years commencing as from and including the 30th May, 1954.
