PURSUANT to section 219 of the Road Districts Act, 1919-1951, I, the said Lieutenant-Governor and Administrator do hereby proclaim and declare that the Moora Road Board may adopt the system of valuation on the annual value on that portion of the district described in the Schedule hereto, and may impose rates on the rateable land within such area on the annual value thereof, in accordance with the relative provisions of the said Act, and any proclamation heretofore or hereafter issued hereunder, and for the time being in force.

Schedule.

All that portion of land bounded by lines starting at the intersection of the centre of Long Street and the centre of a one chain road passing along the Southern boundary of Moora Town Lot 224 and extending Easterly along that centre to the centre of Keane Street; thence Northerly along that centre to the centre of road No. 9237; thence Easterly along that centre and onwards to the centre of the Midland Railway Reserve; thence Southerly along that centre to a point in prolongation Westerly of the Northern boundary of lot 209 of Melbourne Location 908 as shown on Land Titles Office deposited Plan 3553; thence generally South-Easterly and generally North-Easterly to and along the Northern boundaries of lots 209, 221, 222, 165, 166, 167 and 168 of location 908 and onwards to the centre of Ranfurly Street; thence Southerly along that centre to the centre of Atbara Street; thence Westerly along that centre to the centre of a one chain road passing along the Western boundary of lot 18 of location 908 as shown on Land Titles Office deposited Plan 3223; thence Southerly and South-Easterly along that centre to the centre of a one chain road passing along the South-Eastern boundary of lot 27 of location 908; thence South-Westerly

along that centre to the centre of Government Road as shown on Land Titles Office deposited Plan 3166; thence North-Westerly along that centre to the centre of Perejuan Street as shown on Land Titles Office deposited Plan 3140; thence South-Westerly and Westerly along that centre to the centre of Findlater Street; thence Northerly along that centre to the centre of Atbara Street aforesaid; thence Westerly to and along the centre of Drummond Street to the centre of Long Street; thence Northerly along that centre to the centre of Dandaragan Street; thence North-Westerly along that centre to the centre of Moore Street; thence North-Easterly along that centre to the centre of Long Street aforesaid and thence generally Northerly along that centre to the starting point.

WHEREAS it is enacted by section 6 of the Plant Diseases Act, 1914-1952, that the Governor, *inter alia*, may revoke or vary any proclamation under that Act: Now therefore I, the Lieutenant Governor and Administrator acting with the advice and consent of the Executive Council do hereby revoke the Proclamation dated the 11th day of June, 1941, and published in the *Government Gazette* on the 13th day of June, 1941, whereby the Governor under the provision of section 5 of the Act prohibited the bringing into the State of Western Australia from any of the following States of the Commonwealth of Australia, that is to say, Victoria, New South Wales, South Australia, Queensland and

Tasmania of the plants or things mentioned in the schedule to that proclamation except in accordance with the relative regulations made and from time to time in force under the Act.

HIS Excellency the Lieutenant-Governor and Administrator acting by and with the advice and consent of the Executive Council, under the provisions of the Road Districts Act, 1919-1951, doth hereby alter the common boundary between the Upper Blackwood Road District and the Manjimup Road District by severing all that portion of the Upper Blackwood Road District described in the Schedule hereto and annexing it to the Manjimup Road District to form part of the Perup Ward thereof.

All that portion of Upper Blackwood Road District bounded by lines starting at the intersection of the prolongation Easterly of the Northern boundary of Nelson Location 3232 and the prolongation Southerly of the Western boundary of location 3537, a point on the present road district boundary, and extending Northerly to the South-Western corner of the latter location; thence Easterly and Northerly along boundaries of that location to the South-Western corner of location 1905; thence Easterly along the Southern boundaries of locations 1905 and 5613 to a point in prolongation Northerly of the Eastern boundary of location 1677; thence Southerly to and along that boundary to the North-Western corner of location 9282; thence Easterly, Southerly and Westerly along boundaries of that location to the Eastern boundary of location 1677 aforesaid; thence Southerly along that boundary to the North-Western corner of location 8535; thence Easterly and Southerly along boundaries of that location to the North-Western side of road No. 3080 at its South-Eastern corner; thence generally South-Westerly and generally South-Easterly along that side to its intersection with a line joining the North-Eastern corner of location 3461 and the South-Western corner of location 2302, a point on the road district boundary, and thence generally North-Westerly along that road district boundary to the starting point.

Water Boards Act, 1904-1953.

Brunswick Water Supply Catchment Area.

ORDER IN COUNCIL.

WHEREAS by section 36 of the Water Boards Act, 1904-1953, the Governor may, from time to time, by Order in Council, constitute any portion of the State a water reserve or catchment area, and define the boundaries thereof: Now, therefore, His Excellency the Lieutenant-Governor and Administrator by and with the advice of the Executive Council doth hereby constitute that portion of the State defined in the Schedule hereunder a catchment area and assign the name of "Brunswick Water Supply Catchment Area" thereto.

This Order in Council shall take effect on the 28th day of July, 1954.

HIS Excellency the Lieutenant-Governor and Administrator in Executive Council, under the provisions of the Physiotherapists Act, 1950-1952, has

been pleased to approve of the amendment in the manner mentioned in the Schedule hereunder, of the rules made by the Physiotherapists Registration Board pursuant to section 8 of the Act and published in the *Government Gazette* on the 27th day of June, 1952.

Schedule.

Whereas under the provisions of the Physiotherapists Act, 1950-1952, the Physiotherapists Registration Board may, with the approval of His Excellency the Governor in Council, make rules for the purposes mentioned in section 8 of the Act; and whereas pursuant thereto the rules made by the Board and approved by His Excellency the Governor in Council were published in the *Gazette* on the 27th day of June, 1952: Now, therefore, the Board doth hereby resolve to amend the said rules by adding the following after rule 46:—

Part IX.

Mature Age Students.

47. Every person who desires to be enrolled as a mature age student shall, within three months from the commencement of this rule or within such further time as the Board may in special circumstances allow, lodge an application in the form shown in Form 1 of the Appendix to the Regulations (which form may be modified to suit the circumstances), together with proof to the satisfaction of the Board that the applicant was *bona fide* engaged in the practice of physiotherapy in Western Australia prior to the commencement of the Act and with any other information which the Board may require.

48. The Board may accept or reject any application or require further evidence or information on any matter relating thereto.

49. If the Board accepts the application it shall issue to the applicant a certificate in the form of Form 9 (modified to suit the circumstances) in the Appendix to the Regulations.

50. The Board may require a student enrolled under this Part to take a preliminary examination to determine the extent and nature of the course required in his case.

51. The subjects to be studied by a student enrolled under this part shall be those specified in rule 40, provided, however, that the Board, having regard to the previous experience and knowledge of any particular student, may in its discretion in each case give credit for any subject or subjects without requiring the student to take the course and/or without requiring the student to attend the examination in the subject or subjects concerned and a student given a credit by the Board under this rule shall be deemed to have passed the subject concerned at the previous annual examinations, provided, further, that having regard to credits granted under this rule, the Board may in each case by written notice to the student concerned alter the order and the time within which the remaining subject shall be passed by a student enrolled under this Part, and such student shall comply with the terms of the said notice.

52. The Board either generally or in each particular case may require a student enrolled under this Part to attend the regular classes in the subjects specified in rule 40 and may specify the minimum percentage of classes to be attended in order to qualify for admission to the annual examinations.

53. An applicant under this Part shall complete the course of study and pass the examinations notified to him by the Board under rule 51 within 24 months from the date of notification, or within such further time as the Board, having regard to the circumstances, may allow in each particular case.

54. The tuition fees prescribed by rule 24 shall not apply to students enrolled under this Part and in lieu thereof the Board may fix the tuition fees to be paid by such students either generally or in each particular case and any fees so fixed shall be charged and shall be payable to the Registrar at such time or times and/or by such instalments as the Board shall determine, provided that in no case shall the tuition fees fixed by the Board under this rule exceed the tuition fees prescribed by rule 24.

55. Rules 35 (c), (d), (e), 39, 41, 42, 43, 44 and 45 shall also apply *mutatis mutandis* to students enrolled under this Part.

Adoption of By-laws.

WHEREAS under the Health Act, 1911-1952, the Governor may cause to be prepared Model By-laws for any of the purposes for which by-laws may be made by a local authority; and whereas Model By-laws described as Series "A" have been prepared and published in the *Government Gazette* on 4th December, 1944, and amended from time to time thereafter; and whereas a local authority may adopt the said Model By-laws with or without modification: Now, therefore I, Harry Lester McGuigan, being the Commissioner appointed by the Governor under section 4 of the Kwinana Road District Act, 1953, and in the exercise of the powers vested in me by that Act, do hereby adopt the aforesaid Model By-laws as published in the *Government Gazette* on 4th December, 1944, together with the amendments thereto published on 26/1/45, 30/11/45, 20/12/46, 10/2/50, 24/3/50, 29/12/50, 22/6/51, 17/8/51, 2/11/51, 16/5/52, 31/12/52, 6/2/53, 20/3/53 and 21/8/53, as the by-laws of the Kwinana Health District, with the modifications as follows:—

(1) Part I, By-law IA, Paragraph (2).

Delete all words after the word "case" in line one thereof and insert in lieu thereof the following words:—"of any house or public or private place in respect of which the requirements of more than two families, or more than 10 persons have to be provided for, at least two separate sanitary conveniences shall be provided. There shall be additional sanitary conveniences in the proportion of one for every 10 persons or portion of 10."

Provided that this requirement shall not apply to public buildings under Part VI of this Act, nor to licensed premises under the provisions of the Licensing Act, 1911-1953, nor to factories under the provisions of the Factories and Shops Act, 1920-1952."

(2) Part I, By-law 3.

Add after paragraph (b) a new paragraph (c) as follows:—

(c) The owner of any premises whereon there is a sanitary convenience, shall maintain such sanitary conveniences and the pedestal pan, cisterns and other parts thereof and the water service in good condition and properly repaired and fit for use.

(3) Part I—Insert after By-law 41 a New By-law (41A) as follows:—

41A. (1) Every house within the Kwinana Health District shall be provided with an adequate water supply by either—

- (a) connecting the house to an established water supply and reticulating the water supply to bathroom, kitchen and laundry; or
- (b) where no established water supply exists, then by the construction or provision of well or wells, properly and efficiently equipped and maintained with a pump or other equivalent and efficient device for raising water and the necessary pipes for reticulating the water to bathroom, kitchen and laundry; or
- (c) a water storage tank of not less than 1,000 gallons capacity with adequate catchment facilities connected thereto, together with pipes reticulating the water from the tank to bathroom, laundry and kitchen.

(2) The owner of any house aforesaid shall not use or occupy or permit, allow or suffer to be used or occupied any house unless and until an adequate supply as aforesaid has been provided and maintained.

(4) The following scale of fees is hereby prescribed as applied to Schedule "D" of Part IX of the adopted by-laws:—

By-laws Governing the Conditions of Long Service Leave to be granted to Employees of the Dundas Road Board.

PURSUANT to the powers conferred by the Road Districts Act, 1919-1951, and of other powers enabling it in that behalf the Dundas Road Board doth hereby make the following by-laws:—

1. In the interpretation of these by-laws the following words shall have the meaning assigned to them hereunder:—

(a) "Board" means the Dundas Road Board.

(b) "Continuous service" means service in the employment of the Board during which an employee has not been absent from such service for a continuous period of more than 2 days or an aggregate period of more than 10 days without leave of absence being granted by the Board.

2. All employees of the Board shall, after each period of 10 years continuous service as permanent full-time employees thereof commencing from the 1st day of January, 1946, be entitled to three months long service leave. Long service leave is to be taken at the convenience of the Board, which will, as far as possible, meet with the wishes of the employee, but the Board may require the employee to take his leave by giving not less than three months notice.

3. Absence on account of sickness shall not be deemed to be a break in the continuity of service, providing the period of absence shall not be longer than three months in any year, unless otherwise decided by the Board.

4. (a) Employees due to take long service leave shall be paid their salary or wages for the period thereof at the rate equivalent to the salary or wages paid in the week immediately preceding the taking of long service leave.

(b) The Board may, at its discretion, either—

- (i) pay to an employee his salary or wages periodically during long service leave, or
- (ii) pay to the employee in advance a sum representing the amount of his salary or wages for the period of his long service leave.

5. Employees shall not be entitled to long service leave until the completion of 10 years service. After the completion of the first 10 years, employees will be entitled to a *pro rata* payment if they leave the service of the Board before the next period is completed.

6. In the event of the resignation, retirement, or death of an employee the Board may pay to such employee (or in case of his death, to his personal representative or if there be none, to his dependants) a sum of money equal to his salary or wages for the period of long service leave which the Board was empowered under these by-laws to grant such employee at the date of his resignation, retirement, or death or if the Board after consideration of all the circumstances directs that the death of an employee to be presumed the Board may authorise the payment to the dependants of the employee a sum equivalent to the amount of salary or wages which would under this by-law have been granted to the employee immediately prior to the date of his death, such date to be determined by the Board.

7. An employee dismissed by the Board except in the matter of retrenchment shall not be paid any sum in pursuance of the preceding by-law.

8. Long service leave shall be considered as a special period of recuperation after a lengthy term of service, with a view to fitting the employee for a further term, and during such leave no employee shall undertake any form of employment for hire or reward, unless by special permission of the Board. Any contravention of this by-law shall entitle the Board to dismiss the employee concerned from its service and cease paying, or recover, any amounts paid in advance on account of long service leave.

(b) The Board shall not be in any way bound to make any payment under this by-law.

By-law for the Control of Caravan Parking
and/or Camping Parks.

THE Mandurah Road Board, under and by virtue of the powers conferred on it by virtue of the Road Districts Act, 1919-1951, section 201 (61) and all other powers enabling it in that behalf doth hereby make and publish the following additional by-law number 123A:—

1. This by-law shall apply to the district of the Mandurah Road Board and shall be read in conjunction with the General By-laws under the Road Districts Act promulgated as the Caravan Parking By-laws and the Caravan and Camping Regulations, 1949, as promulgated under the Health Act.

2. In these by-laws, subject to the context, "Park" shall mean an area designated and defined for the conduct and use of caravan parking and/or camping.

3. The Mandurah Road Board hereinafter referred to as "the Board" may grant a license for the establishment or conduct of a "Park" upon the following conditions:—

- (a) That if the area in respect of which an application for a license has been made is unfenced, it shall be fenced with a type of fence approved in writing, by the Board, within such time as is specified by the Board.
- (b) That where the main entrance to a "Park" is from a constructed public road, before a license is granted the owner or occupier of such "Park" area shall provide an approach from such road to the entrance gate constructed of road-making material to the satisfaction of the Board.
- (c) That any new "Park" to be established shall be of an area of not less than half an acre with a 16ft. wide carriage way from the "Park" to the adjoining public road and if at any time there is a residence on the area at least one-fifth of an acre shall be reserved for the exclusive use of each such residence.
- (d) That on the "Park" there is a potable water supply adequate for the convenient use of persons using such "Park."

- (e) That no permanent buildings shall be constructed or erected or altered before plans and specifications have been submitted to and approved by the Board.
- (f) That before consideration is given to granting a license detailed plans showing clearly the layout of the "Park" and amenities in relation to the boundaries of such "Park" have been submitted to and approved by the Board.
- (g) That any "Park" license issued shall not be transferable without the written permission of the Board.
- (h) That any "Park" license issued by the Board may be cancelled at any time if a nuisance within the meaning of the Health Act continues to exist or if any nuisance or annoyance is caused to owners or occupiers of property adjoining such "Park" or if the licensee fails to comply with the by-laws or regulations relating to such "Park" or if there is with the "Park" any conduct which in the opinion of the Board is of a disorderly nature.
- (i) That free access to the "Park" is afforded every authorised officer of the Board at all reasonable times for the purpose of inspection.

4. A "Park" license fee of 5s. per annum shall be paid to the Board by the applicant for a license at the time the license is issued. Such license shall be for the year commencing on 1st July and ending on 30th June next following unless previously cancelled. In addition to the foregoing fee the license fees imposed by the Caravan Parking By-laws, 1949, must be paid.

5. Any person who by act or omission shall commit a breach of any portion of these by-laws shall be guilty of an offence and on conviction be liable to a fine not exceeding £20.

DOG ACT, 1903-1948.

Kwinana Road Board—By-Law.

LG 117/54.

PURSUANT to an order in Council promulgated in the *Government Gazette* on the 23rd day of October, 1953, under section 35A of the Dog Act, 1903-1948, and in exercise of all other powers thereto enabling it, the Kwinana Road Board doth hereby make and publish the following by-laws for the establishment of a Dog Pound and the control of dogs within the area of the Kwinana Road Board.

1. In these by-laws the term "Board" shall mean the Kwinana Road Board.

2. The Board may establish and maintain a pound or pounds for the impounding of dogs seized pursuant to the provisions of the Dog Act, 1903-1948.

3. A dog seized by the police or by an officer authorised by the Board may be placed in a pound.

4. Where a dog has been seized or placed in a pound, the keeper of the pound or other officer authorised by the Board shall, if the owner or person usually in charge of the dog is known to him, forthwith notify such person that the dog has been impounded.

5. If the owner or person apparently acting on behalf of the owner of a dog seized or impounded shall claim such dog then upon payment of the fees specified in the schedule hereto the dog shall be released to such person.

6. The poundkeeper shall be in attendance at the pound for the release of dogs at such times and on such days of the week as shall from time to time be determined by the Board.

7. Any person applying for the release of a dog seized or impounded shall prove to the satisfaction of the poundkeeper or other officer authorised by the Board the ownership of the dog and his authority to take delivery of it. The poundkeeper or officer may accept such proof as he considers satisfactory and no person shall have any right of action against him or the Board in respect of the delivery of a dog in good faith.

8. If a dog shall not be claimed and the said fees paid within 48 hours of its being seized, or if a dog having a collar around its neck with a registration label for the current year affixed thereto shall not be claimed and the said fees paid within 48 hours of the service of a notice upon the registered owner, the poundkeeper or other officer authorised by the Board may sell such dog.

9. Upon the sale of a dog, the proceeds of sale shall be the property of the Board and may be disposed of in such manner as the Board thinks fit. The owner of a dog sold pursuant to these by-laws shall have no claim against the Board in respect to the proceeds thereof.

10. If within the times mentioned in by-law 8 hereof or at any time before the destruction of a dog the dog has not been claimed as aforesaid and the said fees paid, and if no offer has been received for its purchase, the dog may be destroyed.

11. Notwithstanding anything herein contained but subject to the provisions of section 19 of the Dog Act, 1903-1948, any dog seized or impounded may at any time be destroyed upon the authority of the secretary of the Board if, in the opinion of the secretary, the dog is too savage or noisy to be kept or is suffering from an injury, disease or sickness.

12. If the Board shall destroy a dog at the request of its owner, whether such dog shall have been seized or impounded or not, the owner shall pay to the Board the fee specified in the schedule hereto.

13. No person shall—

- (a) unless a poundkeeper or other officer of the Board duly authorised in that regard, release or attempt to release a dog from a pound;
- (b) destroy, break into, damage or in any way interfere with or render not dog-proof any pound;
- (c) destroy, break into, damage, or in any way interfere with or render not dog-proof any dog cart, vehicle or container used for the purpose of catching, holding or conveying dogs which have been seized.

14. The owner of a dog shall keep such dog chained or under effective control from sunset to sunrise.

15. The owner of a dog shall prevent that dog from entering or being in any of the following places:—

- (a) A public building.
- (b) A theatre or picture gardens.
- (c) A house of worship.
- (d) A shop or other public business premises.

16. The owner of a dog shall prevent that dog from entering or being in any of the following places unless on a leash held by a person:—

- (a) A sports ground.
- (b) An area set aside for public recreation.
- (c) A car park.
- (d) A school.
- (e) Any land vested in or under the control of the Board, other than a road.

17. No person shall obstruct or hinder an employee of the Board or member of the Police Force in the performance of anything authorised by the provisions of the Dog Act, 1903-1948, or the regulations made in pursuance of those provisions.

18. The payment of fees in respect of the seizure, care, detention or destruction of a dog shall not relieve the owner of it of liability to a penalty under any of the provisions of these by-laws.

19. Any person who shall commit a breach of these by-laws shall, upon conviction, be liable to a penalty not exceeding £5.
