WHEREAS by section 3 of the Perth Gas Company's Act, 1886-1937, it is enacted that the limits of the said Act shall extend to and include the City of Perth and every place being within a circle of five miles from the General Post Office in the City of Perth and every other place outside the circle of five miles to which the Governor may from time to time by proclamation declare that the Act shall extend: Provided that the Governor shall not make or issue any proclamation under this section to extend the limits of the Act to any place situated within the district of any municipal council or of any road board outside the said circle of five miles unless and until the municipal council or the road board concerned (as the case may be) has by resolution consented thereto; and whereas it is desirable to extend the limits of the Act to that portion of the Municipality of Claremont described in the schedule hereunder; and whereas the said Municipality of Claremont has by resolution passed

on the 12th day of October, 1936, consented thereto: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers aforesaid and of every other power in this behalf me enabling, do hereby proclaim and declare that the limits of the Act shall extend to and include that portion of the Municipality of Claremont described in the schedule hereunder which is outside the circle of five miles from the General Post office in the City of Perth.

The Schedule.

That area bounded on the West side by Queenslea Drive and its continuation South of the river, but including College Avenue; on the South side by Shenton Road; on the West side by Servetus Street; and on the North side by the Municipal boundary; both sides of the streets and roads forming the above boundaries to be included in the area of supply.

WHEREAS it is provided by regulation 2 of the Building Regulations contained in the Second Schedule to the Road Districts Act, 1919-1951, in reference to buildings on any block of land laid out for building, that the area allotted to any building, and the open space used in connection with such building shall together be not less than the area for the time being fixed by proclamation as the proper area to be allotted to such building; and whereas a proclamation was issued under the said Act and published in the *Government Gazette* on the 5th day of April, 1946, page 330, declaring that the minimum area to be allotted to every building intended to be or capable of being used as a dwelling house and the open space exclusively belonging thereto in the locality forming part of the Peppermint Grove Road District which is bounded on the North by the Southern alignment of Johnston Street from its intersection with Stirling Highway to the intersection of that alignment with the Western alignment of Palmerston Street proceeding in a Southerly direction along that alignment to the Southern boundary of the Peppermint Grove Road District, thence following the said Southern boundary in a Westerly direction to the intersection of that boundary with the Eastern alignment of Stirling Highway, thence proceeding in a Northerly direction along Stirling Highway to the starting point, which locality is referred to as Locality "A," shall be an area of not less than 3,648 square feet and that the minimum area to be allotted to every building intended to be or capable of being used as a dwelling house and of the open space exclusively belonging thereto in the locality of the Peppermint Grove Road District excluding therefrom the said locality "A" shall be an area of not less than 9,900 square feet; and whereas it is deemed expedient to vary the said proclamation and in lieu thereof to provide for the minimum area to be allotted to

every building intended to be or capable of being used as a dwelling house, and of the open space exclusively belonging thereto in the aforementioned locality "A," and to further provide for a different minimum area to be allotted to every building intended to be or capable of being used as a dwelling house and the open space exclusively belonging thereto in the locality of the Peppermint Grove Road District excluding the said locality "A," and being the remaining portion of the said road district: Now, therefore I, the said Governor, acting with the advice and consent of the Executive Council, do hereby revoke the said proclamation of the 5th day of April, 1946, and do hereby declare and proclaim (1) that the minimum area to be allotted to every building intended to be or capable of being used as a dwelling house and of the open space exclusively belonging thereto in the said locality "A" in the Peppermint Grove Road District shall be an area of not less than 3,648 square feet, and (2) that the minimum area to be allotted to every building intended to be or capable of being used as a dwelling house and of the open space exclusively belonging thereto in the locality of the Peppermint Grove Road District excluding therefrom the said locality "A" shall be an area of not less than 9,500 square feet.

WHEREAS it is enacted by section 5 of the Road Districts Act, 1919-1951, that for the purposes of the Act, the word "Town" or "townsite" means and includes, *inter alia*, any land (including privately owned subdivided land) which the Governor may seem fit, as he is hereby empowered, to declare by proclamation to be a town or townsite for the purposes of the Act; and whereas by proclamation dated the 21st day of February, 1945, and published in the *Government Gazette* on the 23rd day of March, 1945, the Governor declared that certain land situate within the Belmont Park Road District and more particularly described in the Schedule to that proclamation shall be a townsite to be known as "Belmont Park": Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the power conferred upon me by the Act, do hereby declare all that land situate within the boundaries of the Belmont Park Road District not already declared a townsite to be a townsite within the meaning and for the purposes of the Act, and to be added to and form part of the townsite of Belmont Park.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909.

ORDER IN COUNCIL.

M.W.S. 1564/54.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act, have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.

Sewage Treatment Works at location 3150 (714), Subiaco.

One reinforced concrete sludge digestion tank, and all other apparatus connected therewith as shown in red on Plan M.W.S.S. & D.D. W.A., No. 7699.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909, it is provided that, subject to the provisions of the Act, the Minister for Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct and extend Water Works, Sewerage Works and Stormwater Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor in Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.

Victoria Park District.

Reticulation Area No. 17, Part 2.

Nine-inch, six-inch and four-inch diameter reticulation pipe sewers with all manholes and other apparatus connected therewith, as shown in green on Plan M.W.S.S. & D.D., W.A., No. 7886.

Country Areas Water Supply Act, 1947-1951.

Kalamunda Rating Zone.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 10 of the Country Areas Water Supply Act, 1947-1951, that the Governor may by Order in Council constitute any number of rating zones in a country water area: Now therefore His Excellency the Governor by and with the consent of the Executive Council doth hereby constitute that portion of the Country Water Area defined in schedule hereunder to be a rating zone and assign the name of "Kalamunda Rating Zone" thereto.

This Order in Council shall take effect on the 7th day of October, 1954.

Schedule.

All that portion of land bounded by lines starting at a point on the Western boundary of location 2639 in prolongation Easterly of the Southern side of Jessie Road and extending Southerly along that boundary to the Northern side of Hill Street (road No. 10683); thence Easterly along that side to the Eastern boundary of that location; thence Southerly along boundaries of locations 2639 and 1473 and onwards to and along the Easternmost boundary of Kalamunda Town lot 419 (Reserve 23277) to the South-Eastern corner of that lot; thence South-Westerly to the Westernmost corner of town lot 361 (Reserve 19232); thence generally South-Easterly along the North-Eastern side of Byron Road and onwards to the Southern side of Howell Road; thence Easterly along the Northern boundaries of Canning Locations 395 and 563 to the North-Eastern corner of the latter location; thence Southerly along the Eastern boundary of that location and onwards to the North-Eastern side of the late Upper Darling Range Railway Reserve; thence generally South Easterly along that side and the South-Western side of road No. 6547 to a point situate North of the intersection of the Eastern side of Calandenia Road and the prolongation Easterly of the Northern side of Banksia Road; thence South to that intersection; thence Westerly to and along the Northern side of Banksia Road aforesaid and onwards to the North-Western side of Canning Road (road No. 1837); thence South-Westerly along that side to the Northern side of Glyde Road (road No. 6852); thence Westerly along that side and onwards to and along the Southern side of Glyde Road (road No. 7412) and again onwards to and along the Southern boundary of Kalamunda Town lot 360 to the South-Eastern corner of lot 176; thence Northerly, North-Easterly and Westerly along the boundaries of the latter lot; thence Northerly to and along the Western boundary of lot 177 and onwards to the Southern boundary of lot 180; thence Westerly along that boundary and to and along the Southern boundary of lot 179; thence Northerly along its Western boundary and onwards to the South-Eastern corner of lot 102 of Canning Location 579 (L.T.O. Plan 3609); thence Westerly and North-Easterly along boundaries of that lot to the South-Western corner of location 259; thence Northerly along the Western boundaries of locations 259, 80, 422, 929 and the prolongation Northerly of the last-mentioned boundary to the Southern boundary of location 244; thence Westerly, Northerly and Easterly along boundaries of that location to the South-Western corner of location 398; thence Northerly along the Easternmost boundary of Swan Location 1394, the Eastern boundary of lot 47, and to and along the Eastern boundary of lot 20 of Canning Location 437 (L.T.O. Plan 2551); thence Westerly to the South-Eastern corner of Swan Location 4141; thence Northerly and North-Westerly along the boundaries of that location to a point situate in prolongation Southerly of the Western boundary of lot 4 of location 1304 (L.T.O. Plan 2764); thence Northerly and Easterly to and along boundaries of that lot to a point situate in prolongation Southerly of the Western boundary of lot 23 of that location 1304; thence Northerly to and along the Western boundaries of lots 23, 22, 21, 20, 19 and 18

of that location 1304, the Western boundary of location 1378 and onwards to the Western corner of lot 19 of location 1763 (L.T.O. Plan 4551); thence North-Easterly along the North-Western boundary of that lot and those of lots 20 to 23 (inclusive), and their prolongation North-Easterly to a point situate West of the North-Western corner of lot 2 of Kalamunda lot 185 (L.T.O. Diagram 4676); thence East to the Western side of William Street; thence generally North-Easterly along that side and the Western side of Lascelles Parade to a point situate in prolongation Westerly of the Southern side of Jessie Road and thence Easterly to and along that side to the starting point, as shown in red on Plan P.W.D., W.A. No. 34338.

Dog Act, 1903-1948.

Municipality of Northam.

ORDER IN COUNCIL.

L.G. 1648/52.

WHEREAS by section 34a of the Dog Act, 1903-1948, it is provided that a local authority may, for the protection of owners of stock, make by-laws for (a) requiring dogs to be kept chained or otherwise under effective control from sunset to sunrise, and authorising the destruction of any dog not so kept under control and found wandering at large; (b) imposing a penalty not exceeding ten pounds for the breach of any such by-laws; and whereas it is further provided by section 36 of the said Act that section thirty-four A shall not have effect within any municipality outside the metropolitan area unless extended to such municipality outside the metropolitan area unless extended to such municipality by an Order in Council published in the *Gazette*; and whereas the Council of the Municipality of Northam desires to make a by-law under the provisions of the said section 34a and to that end it is desirable that the provisions of the section should be extended to the Municipality of Northam. Now, therefore, His Excellency the Governor with the advice and consent of the Executive Council does hereby extend the provisions of section 34a of the said Act to the Municipality of Northam in accordance with the provisions of section 36 of the said Act.

Description of District Boundaries and
Re-division into Wards.

ORDER IN COUNCIL.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, under the provisions of the Road Districts Act, 1919, doth hereby—

- (1) redescribe the boundaries of the Rockingham Road District as described in Schedule "A" hereto;
- (2) redivide the Rockingham Road District into three wards with names, boundaries and number of members as described in Schedule "B" hereto.

Schedule "A."

Rockingham Road District.

District Boundaries.

All that portion of land bounded by lines starting at the intersection of the low water mark of Mangles Bay (Cockburn Sound) and the South-Western boundary of Cockburn Sound Location 704 and extending South-Easterly along that boundary to the North-Western side of Rockingham Road (road No. 695); thence North-Easterly along that side to a point in prolongation Westerly of the Northern side of Office Road (road No. 1771); thence Easterly to and along that side to the Western side of road No. 1255; thence Northerly along that side to a point in prolongation Westerly of the Northern boundary of location 137 (reserve 3310); thence Easterly, Southerly and again Easterly to and along boundaries of location 138 to a point in prolongation Northerly of the Western boundary of location 17; thence Southerly to and along the Western boundaries of locations 17, 19, 20, 855 and 90 to the Northern boundary of location 189; thence Easterly and Southerly along boundaries of that location to its South-Eastern corner; thence South-Easterly to and along the North-Eastern side of a one-chain road, passing through portion of location 16 and onwards to the North-Eastern side of road No. 1607; thence generally South-Easterly and generally North-Easterly along that side to its junction with the Southern boundary of location 1724 (reserve 23793, late Rockingham Jarrah Timber Company's Railway) opposite the Northernmost corner of Peel Estate Lot 449; thence North to the Northern boundary of Cockburn Sound Location 1724 aforesaid; thence generally South-Easterly along that boundary to a point in prolongation Northerly of the Western boundary of Peel Estate Lot 1098; thence Southerly to the Northernmost corner of that lot; thence generally South-Easterly along the North-Eastern boundaries of that lot and onwards to the North-Western boundary of portion of Cockburn Sound Location 16, a point on the South-Eastern side of the Serpentine River Diversion Drain Reserve; thence generally South-West-erly along that side of that reserve to the South-Western corner of Peel Estate Lot 1090; thence Easterly and Northerly along boundaries of that lot to a point in prolongation Westerly of the Southern boundary of lot 804; thence Easterly to and along that boundary to a point in prolongation Northerly to the Western boundary of lot 79 of Cockburn Sound Location 16, as shown on Land Titles Office Deposited Plan 739A; thence Southerly to and along the Western boundaries of lots 79, 80 and 81 to the North-Eastern corner of portion of lot 3 of location 16, as shown on Land Titles Office Diagram 2909; thence Westerly, South-West-erly, North-West-erly, Southerly and again Westerly along boundaries of lot 3, as shown on that diagram and Land Titles Office Deposited Plan 3064, and onwards to the low water mark of the Indian Ocean, and thence generally Northerly along the low water mark of the Indian Ocean, Warnbro Sound, Shoalwater Bay and Mangles Bay to the starting point. Including Garden Island, Penguin Island and other adjacent islands. (Public Plans 341D/40 and 380A/40.)

Schedule "B."

Ward Boundaries.

Town Ward.

All that portion of Rockingham Road District bounded by lines starting from the intersection of the Southern boundary of Cockburn Sound Location 700 (portion of Commonwealth Reserve 255) and the low water mark of Shoalwater Bay, a point on the road district boundary, and extending generally North-West-erly and generally North-Easterly along that road district boundary to the South-Eastern side of Pioneer Road; thence South-West-erly, South-Easterly and again South-West-erly to and along boundaries of reserves 21018 and 7490, Rockingham Town Lots 268 (reserve 20226), 433 (reserve 22412) and again 268 to the South-Eastern

corner of the latter lot, and thence Westerly along the Southern boundary of that lot and onwards to and along the Southern boundaries of lot 146 (reserve 9458) and Cockburn Sound Location 700 aforesaid to the starting point. (Three members.) (Public Plan 341D/40 and Rockingham Townsite.)

Safety Bay Ward.

All that portion of Rockingham Road District bounded by lines starting at the intersection of the low water mark of Shoalwater Bay and the Southern boundary of Cockburn Sound Location 700 (portion of Commonwealth Reserve 255), a point on the Southern boundary of the Town Ward and extending Easterly along that boundary to the North-Eastern side of road No. 40; thence generally South-Easterly along that side to the North-Western corner of Peel Estate Lot 661; thence Westerly to and along the Northern side of a one-chain road passing along the Northern boundary of lot 600 and the Northern boundary of lot 584 and again onwards to the low water mark of Warnbro Sound, a point on the road district boundary, and thence generally North-Westerly along that road district boundary to the starting point. (Three members.) (Public Plan 341D/40.)

Rural Ward.

All that portion of Rockingham Road District situate East and South of the Eastern and Southern boundaries of the Town and Safety Bay Wards. (Three members.) (Public Plans 341D/40 and 380A/40.)

A By-law of the Municipality of East Fremantle made under Section 130 of the Municipal Corporations Act of 1906-1953, for Regulating the Granting of Long Service Leave to Employees.

IN pursuance of the powers conferred by the said Act the Mayor and Councillors of East Fremantle order as follows:—

1. In the interpretation of this by-law the following words shall have the meanings assigned to them hereunder:—

(a) "Council" means the Municipality of East Fremantle.

(b) "Employee" means and includes all persons employed in any capacity by the Council and who are in the regular and full-time employ of the Council.

(c) "Continuous service" means service in the employment of the Council during which an employee has not been absent from the service of the Council for a continuous period of more than two days or an aggregate period of more than 10 days without leave of absence being granted by the Council and has not been absent, without pay, for a period exceeding four weeks: Provided that an employee who was employed by the Council on a permanent basis immediately prior to entering a continuous full-time service with the Armed Forces of the Commonwealth of Australia, or who was directed by the Manpower Directorate to serve elsewhere between the 3rd day of September, 1939, and the 3rd day of March, 1947, shall have such service counted as continuous service with the Council, provided the requisite proof is produced.

2. All present and future employees of the Council shall, after each period of ten (10) years continuous service as permanent full-time employees, be entitled to three (3) months long service leave and no long service leave will be granted to any

employee without a qualifying period of ten (10) years being first completed. All employees who qualify for long service leave on the 31st day of October, 1948, shall be entitled thereto and all other employees shall be entitled thereto as from the commencing date of their employment with the Council.

3. (a) The Council may grant long service leave to an employee of the Council who has been granted long service leave for ten (10) years continuous service if, before a further period of ten (10) years continuous service is reached such employee retires from the Council's service owing to having reached the retiring age of sixty-five (65) years, or is retired on the grounds of ill-health, or dismissed through staff retrenchments, in which case the long service leave may be adjusted *pro rata*.

Provided that no such grant shall be made to an employee of the Council who prior to completing a further period of ten (10) years continuous service resigns his employment with the Council.

(b) The long service leave which may be granted under this by-law shall be for a period not exceeding one and three-tenths weeks for every completed year of service since the conclusion of the period of service which qualified the employee for his previous long service leave and shall be on full pay.

4. An employee dismissed by the Council for neglect of duty or for irregular practices shall not be paid any sum in pursuance of the preceding clause.

5. Long service leave shall be taken at the convenience of the Council, who will, as far as possible meet with the wishes of the employee, but the Council may require the employee to take leave by giving not less than three (3) months notice. Long service leave shall be taken in the first place in accordance with a roster prepared by the Town Clerk and prepared so far as possible to enable the employees to take long service leave in order of the length of their service with the Council.

6. In the event of the death of an employee who has served a period of at least two (2) years continuous service the Council may pay to his personal representatives, or if there be none, to his dependants a sum of money equal to his wages or salary for the period of long service leave which the Council would have been empowered under this by-law to grant to such employee at the date of his death, if he had retired after ten (10) years continuous service, or if the Council after consideration of all the circumstances, direct that the death of an employee be presumed, the Council may authorise the payment to the dependants of the employee a sum equivalent to the amount of wages or salary which would under this by-law have been granted the employee immediately prior to the date of his death, such date to be determined by the Council.

7. Absence on account of sickness shall not be deemed to be a break in the continuity of service, providing the period of absence shall not be longer than three months in any year, unless otherwise decided by the Council.

8. (a) Employees taking long service leave shall be paid their salary or wage for the period thereof at the rate equivalent to the permanent rate of pay excluding conditional margins or higher duty payments, equivalent to the salary or wage paid in the week immediately preceding the taking of long service leave.

(b) The Council shall pay to any employee his salary or wages during his period of long service leave weekly provided that it may at its discretion pay to the employee in advance a sum representing the amount of his salary or wages for the period of his long service leave upon written application being made to the Council for payment in such manner.

9. All annual leave to which an employee is entitled or will become entitled before the expiration of his long service leave shall be taken by the employee in conjunction with his long service leave but any public holidays which may occur during the taking of his long service leave are not to be paid for over and above the long service leave but are to form part of such long service leave.

10. Long service leave shall be considered as a special period of recuperation after a lengthy term of service, with a view to fitting the employee for a further term, and during such leave no employee shall undertake any form of employment for hire or reward, unless by special permission of the Council. Any contravention of this clause shall entitle the Council to dismiss the employee from its service and to cease paying or to recover any amounts paid in advance on account of long service leave.

INDUSTRIAL AGREEMENT.

No. 15 of 1954.

(Registered 4th October, 1954.)

This Agreement made in pursuance of the Industrial Arbitration Act, 1912-1952, this 30th day of September, 1954, between the Minister for Works, Minister for Water Supply, Sewerage and Drainage, Commissioner of Main Roads, and the Minister for Lands (hereinafter referred to as the "Minister") of the one part and the Australian Workers' Union, Westralian Branch Industrial Union of Workers (hereinafter referred to as the "Union") of the other part, witnesseth as follows:—

1.—Title.

This Agreement shall be known as the Australian Workers' Union Government Foremen's Agreement, and supersedes Agreement No. 11 of 1949.

2.—Arrangement.

3.—Area and Scope.

This Agreement shall apply to Foremen who are eligible for membership in the applicant Union and who are employed by the respondents throughout the State on the following classes of work. Provided it shall not apply to workers covered by any other Award of the Court of Arbitration or any Industrial Agreement registered under the Industrial Arbitration Act, 1912-1952.

(a) Roads and bridges construction and maintenance.

(b) Country water supply sewerage, drainage, and irrigation construction and maintenance, excepting any work comprised in or connected with the Mundaring-Kalgoorlie water supply undertaking, or the metropolitan water supply sewerage and drainage undertaking.

(c) Land clearing.

For the purpose of this clause, "land clearing" shall include clearing, fencing grading or levelling land for any purpose associated with work carried out by the respondents, including the construction of aerodrome runways.

4.—Term.

This Agreement shall have effect for one (1) year.

5.—Hours.

The hours of labour shall be those applying to other workers on the job.

6.—Overtime.

(a) Foremen and Sub-Foremen shall not be entitled to payment for overtime unless called on to work such overtime with other workers for more than an aggregate of two (2) hours in any week.

(b) When the aggregate overtime exceeds two (2) hours in any week the whole of such overtime shall be paid for at the rate of time and one half for the first four (4) hours and thereafter double time. Sunday time included in time for which overtime is paid shall be paid for at double time. In the calculation of overtime each day shall stand alone.

(c) Overtime shall not be construed as meaning the additional time usually and necessarily worked by Foremen and Sub-Foremen as part of their ordinary duties prior to and after the usual starting and finishing hours.

7.—Holidays.

(a) Except as hereinafter provided, each of the following days or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely: New Year's Day, Australia Day (26th January), Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day and Boxing Day.

(b) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it were an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(c) In the case of workers working a five-day week, no payment or a day in lieu shall be granted for any public holiday falling on a Saturday.

(d) Payment for holidays shall be in accordance with the usual hours of work.

(e) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday.

Where the worker is on duty or available on the whole of the working day immediately preceding a holiday, or resumes duty or is available on the whole of the working day immediately following a holiday, as prescribed in this clause, the worker shall be entitled to a paid holiday on all such holidays.

8.—Annual Leave.

(a) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.

(b) If any award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(c) A worker may be rostered off and granted annual leave with payment of ordinary wages as prescribed prior to his having completed a period of twelve (12) months' continuous service, in which case should the services of such worker terminate or be terminated prior to the completion of twelve (12) months' continuous service, the said worker shall refund to the employer the difference between the amount received by him for wages in respect of the period of his annual leave and the amount which would have accrued to him by reason of the length of his service up to the date of the termination of his services.

(d) (i) Subject to paragraph (ii) when computing the annual leave due under this clause no deduction shall be made from such leave in respect of the period that a worker is on annual leave and/or holidays. Provided that no deduction shall be made for any approved period a worker is absent from duty through sickness with or without pay unless the absence exceeds three (3) calendar months, in which case deduction may be made for such excess only.

(ii) Approved periods of absence from work caused through accident sustained in the course of employment shall not be considered breaks in continuity of service, but the first six (6) months only of any such period shall count as service for the purpose of computing annual leave,

(e) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled to such holidays on full pay as are proportionate to his length of service during that period with such employer.

(f) Any worker who may resign or be dismissed from the service for any cause, other than for peculation or theft shall be entitled to receive payment for any annual leave which may have been due up to the time of leaving the service; provided always that if the worker has been dismissed for peculation or theft no claim for annual leave shall be recognised. Misconduct herein referred to shall not affect accumulated annual leave or payment therefor.

(g) When work is closed down for the purpose of allowing annual leave to be taken, workers with less than a full year's service shall only be entitled to payment during such period for the number of days' leave due to them provided that nothing herein contained shall deprive the employer of his right to retain such workers during the close-down period as may be required.

(h) Workers regularly working for the Government north of south latitude 26 shall be allowed to accumulate annual leave for two (2) years, subject to the convenience of the Department. Such workers who proceed to Fremantle and Geraldton during the period of such leave shall be allowed once in each two (2) years reasonable travelling time on the forward and return journeys between the place of their employment and either of the said ports.

9.—Sick Leave.

An employee on production of an adequate medical certificate shall be granted sick leave on the following basis:—

(a) 1/6th of a week's pay for each completed month of service.

(b) The liability of the employer shall in no case exceed two (2) weeks' wages during each calendar year in respect of each worker, but any portion unused up to the period of one (1) week in any calendar year shall be allowed to accumulate and may be availed of in the next or any succeeding year.

(c) The privileges accrued by way of accumulation of sick leave prior to this amendment, or 15 working days whichever is the greater shall be credited to the worker concerned.

(d) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(e) Indisposition not necessitating confinement to the house shall not be regarded as illness in respect of which leave of absence may be granted under this Clause except under special circumstances as may be approved by the employer.

(f) Sick leave shall not be granted in respect of any absence due to an employee's own fault, neglect or misconduct.

(g) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act, 1912-1944.

10.—Camping Allowance.

(a) Foremen who in order to be available for their work have to live in a camp established whether by employers or employees for the purpose of enabling employees to be so available by living therein, shall be paid a camping allowance of 4s. for each day on which they are required to hold themselves and do hold themselves available in a camp throughout the said day, whether or not work is done on the said day, provided however, that the total amount payable under this provision shall not exceed twenty shillings (20s.) per week.

(b) Where a cook is provided each foreman shall be deducted two shillings (2s.) per working day from the camping allowance prescribed in sub-clause (a) of Clause 10; provided however, the amount payable under this provision shall not exceed ten shillings (10s.) per week.

(c) Stretchers, mattress, pillow and requisite cooking utensils shall be provided by the Department for employees who are obliged to camp at or near the works.

11.—Travelling Allowance.

When travelling on duty and out of pocket expenses for meals or bed are necessarily incurred, a reasonable allowance with a minimum of four shillings (4s.) per item shall be paid: Provided an employee who is notified or is aware on the previous day that he will be required to travel within his own district shall not be entitled to claim for lunch on the first day.

12.—District Allowance.

Foremen shall be paid the same district allowance as that paid to the men under their control.

13.—Long Service Leave.

Long service leave shall be granted in accordance with the conditions applying to Government full time Wages employees generally, as now in force, or as amended during the currency of this Agreement.

14.—Rail Passes.

At the Christmas vacation employees shall be granted free return rail passes from the work to place of engagement.

15.—Preference.

Preference of employment shall be given to financial members of the Australian Workers' Union.

16.—No Reduction.

Any employee who has been prior to the date of this Agreement in receipt of a higher rate of pay than that specified herein shall not suffer any reduction in such amount solely by reason of this Agreement. Provided, however, that on re-employment following any break of service the wage shall be governed by the terms of this Agreement.

17.—Contract of Service.

The engagement shall be terminable by one week's notice on either side. An employee may, however, be summarily dismissed for misconduct or dereliction of duty.

18.—Board of Reference.

In the event of a dispute arising upon any matter shown in this Agreement, the point in dispute shall be referred to a Board consisting of a representative of the department, a representative of the Union, and a Chairman to be mutually agreed upon by such representatives; failing their agreement, the Industrial Registrar of Western Australia shall be Chairman. The decision of the Board shall be final and binding.
