(8) repair or renew any ventilators which shall become in disrepair or be missing;
(9) keep all floors even in surface and free from cracks;

(10) replace or repair all skirtings, architraves and fixtures which may become a harbourage for vermin;

(11) keep all walls, ceilings and the plaster and wall paper thereon in good repair and repair any cracks and renew any plaster or wall paper which may become dilapi-dated or in disrepair;

(12) refit and repair any doors which may become in disrepair or which shall cease to

NURSES REGISTRATION ACT, 1921-1953.

Department of Public Health, Perth, 20th October, 1954.

HIS Excellency the Lieutenant-Governor and Administrator, under the provisions of the Nurses Registration Act, 1921-1953, has been pleased to amend in the manner mentioned in the Schedule hereunder, the Nurses Registration Regulations, 1946, published in the Government Gazette on the 10th day of February, 1947, and amended from time to time thereafter.

Schedule.

Nurses Registration Regulations, 1946, are amended by deleting Part VII (G.G. 1/5/53) and substituting a new Part VII as follows:—

Part VII.

Division 1-Nursing Aides' Training Schools.

- 1. An institution may be prescribed by the Board-
 - (a) as a complete nursing aides' training school, if it is capable of providing a complete training course of one year, exclusive of sick leave and leave other than ordinary leave.
 - (b) as a component school, if it is capable of providing part of such training as a component member of a group of schools providing a complete training course.

In approving a component school the Board shall decide the proportion of the period of training required under these regulations to be spent in such school and the proportion in the other school or schools of the group of which the component school forms a part.

- Before an institution can be approved as a training school for nursing aides it must fulfill the following conditions:-
 - (a) The matron is a registered nurse and approved by the Board for the purpose.
 - (b) The buildings, equipment, and other facilities provided in the institution are adequate for the training of nursing aides.(c) The daily average number of patients is at least twenty occupied
 - beds.
 - (d) The proportion of registered nurses to trainees is considered by the Board sufficient to ensure adequate supervision of the trainees' duties.
 - (e) Provision is made at the institution for trainees to receive practical instruction in the wards from the matron or other registered nurse,

- (f) Provision is made for systematic courses of instruction in theoretical and practical nursing during the period of training by the matron or other registered nurse or other lecturers, in accordance with the curriculum and syllabus in Appendix IX to these regulations.
- (g) Provision is made for the issue to trainees of certificates at the conclusion of their final course of lectures that they have attended the systematic courses of lectures and received practical instruction in accordance with the curriculum and syllabus prescribed, and have passed an examination therein.
- (h) The institution is being conducted and managed in an efficient manner.
- (i) The management undertakes to furnish annually to the Board a report in accordance with the Form No. 4 in the Appendix IX to these regulations, and also undertakes to furnish to the Board such information as it may at any time require regarding the trainees and their training.
- 3. If at any time in the opinion of the Board its requirements in regard to the training of nursing aides as prescribed in these regulations are not being complied with, the Board may after giving the Board of Management, proprietor, or other controlling authority not less than two months' notice of its intention so to do, remove the name of the institution from its list of training schools.
- 4. The following is a list of institutions prescribed by the Board for the time being at which the training of nursing aides may be undertaken:—

Royal Perth Hospital. District Hospital, Merredin. District Hospital, Busselton. Mt. Henry Women's Home.

Division 2—Qualifications for Trainees.

- 5. Applicants for admission as trainees into a training school shall be at least 17 years of age.
- 6. Application shall be made to the matron or, in the case of Government hospitals, to the principal matron.
- 7. The application shall be in the handwriting of the applicant and signed by the applicant and shall be accompanied by—
 - (a) the applicant's certificate of birth;
 - (b) three personal references;
 - (c) a certificate as to physical and mental fitness from a legally qualified medical practitioner, and
 - (d) a certificate showing that the applicant has obtained general education at least equal to a sixth standard certificate of the Education Department, or a certificate showing that she has passed an examination in general education conducted by the Board.
- 8. A trainee shall, before being accepted by an institution for training as a nursing aide, undergo a period of probation of two months' duration.
 - 9. (1) Training shall be continuous.
- (2) The period during which a trainee has broken her training owing to illness or for other reasons satisfactory to the Board, shall be made up so that she completes the full period of training as prescribed in these regulations.
- (3) Where the break is for a period exceeding one month, she shall in addition, undergo a further one week's training for each month or part thereof of the period of the break.
- 10. Where a trainee has ceased training at any one prescribed training school, whether of her own accord or through dismissal, the Board shall have power to determine whether she shall be permitted to enter another training school and to decide the period, if any, of the previous training that shall be credited to her.

Division 3—Examinations.

- 11. The Board shall hold an examination for enrolment three times yearly, in April, August, and December, unless otherwise arranged by the Board.
- 12. The examination shall be based on the subjects in the syllabus of training prescribed in Appendix IX to these regulations, and shall consist of—
 - (a) a simple written test, and
 - (b) a test of practical efficiency in the wards of the trainees' own training schools by examiners appointed by the Board.
- 13. A trainee shall not sit for an examination for enrolment until she has completed the prescribed course of training.
- 14. Trainees for admission to an examination for enrolment shall make application to the secretary of the Board on a form to be provided by the Board, not later than one month before the date of the examination.
- 15. The application shall be accompanied by the prescribed examination fee and a statement signed by the matron showing—
 - (a) the date on which training commenced;
 - (b) particulars of any period during which, apart from ordinary or holiday leave, the trainee was absent from duty;
 - (c) that the applicant has attended the course of lectures; received the practical instruction, and passed the examination referred to in regulation 2 (g) of these regulations,

16. A trainee who has failed to pass an examination for enrolment shall, unless she receives an exemption from the Board, sit for the next examination, and if she fails a second time may be called on to undergo such further training not exceeding a period of three months as the Board may approve before again presenting herself for examination, and in that case shall sit for the next examination after the end of the further period of training.

Division 4—Enrolment.

- 17. (I) A trainee who has passed the examination for enrolment and has otherwise complied with the requirements of these regulations, and
 - (II) a person who has completed not less than fifteen months' training, including experience in the nursing of sick children, in a general nurses' training hospital and who has passed the examination for enrolment.

shall, upon payment of the prescribed fee, receive a certificate signed by the chairman and secretary of the Board, and also, upon payment of the prescribed fee, the prescribed nursing aide's badge which shall be worn by her when on duty as a nursing aide.

- 18. A person who has passed the First Year Professional Examination conducted by the Board and who has completed not less than fifteen months' training, including experience in the nursing of sick children, in a training hospital for nurses, may make application to the Board in writing, supported by references from the matron of her training hospital and two other reputable persons, to be enrolled as a nursing aide.
- 19. A person applying for enrolment under section 5 (5e) of the Act, may be enrolled as a nursing aide if she can furnish to the satisfaction of the Board—
 - (a) evidence that she has had not less than two years' whole time experience in nursing under the supervision of a trained general nursing staff in an approved hospital or institution; or not less than three years' whole time bona fide practice in the nursing of the sick, including not less than six months' whole time training or experience under the supervision of a trained general nursing staff in an approved hospital or institution;
 - (b) evidence of good character.
- 20. A person enrolled under the provisions of regulation No. 18 or regulation No. 19 of these regulations shall, upon payment of the prescribed fee, receive a certificate signed by the chairman and secretary of the Board, and also, upon payment of the prescribed fee, a nursing aide's badge which shall be worn by her when on duty as a nursing aide.
- 21. Every enrolled nursing aide who desires to apply for re-enrolment under the provisions of section 11 (1) of the Act, shall make application to the Board on the prescribed form and lodge therewith the fee of one shilling.
- 22. A copy of a certificate of enrolment, or a duplicate nursing aide's badge, may be issued upon payment of the prescribed fee, if it is proved to the satisfaction of the Board that the original certificate or the original badge, as the case may be, has been lost or accidentally destroyed.

Penalties for Breaches of the Regulations.

23. A person contravening any of the provisions of these regulations shall be liable, unless otherwise provided for, to a penalty not exceeding ten pounds.

7.—Hours of Labour and Overtime.

The hours of labour shall be those applying to other workers on the job provided that:-

- (a) Foremen shall not be entitled to payment for overtime unless called on to work such overtime with other workers for more than an aggregate of two (2) hours per week.
- (b) Overtime shall not mean the additional time usually and necessarily worked by foremen as part of their ordinary duties prior to and after the usual starting and finishing time.
- (c) Subject to sub-clauses (a) and (b) hereof all time worked in excess of the ordinary daily hours shall be classed as overtime and paid as follows:—
 - (i) Time and a half for the first four hours after the usual stopping time and double time thereafter.
 - (ii) Where overtime is worked on any Saturday, time and a half for the first four hours and double time thereafter.
 - (iii) All time worked on Sunday shall be paid for at double time rates.

The overtime rate shall be computed on the rate applicable to the day on which the time is worked, provided that double time i.e. twice the ordinary rates shall be the maximum.

.8.—Preference.

Any worker engaged under this agreement who is not a member of the Australian Workers' Union is not a memoer of the Australian Workers Union shall make and complete an application for membership within fourteen (14) days of commencing employment under this Agreement. Provided that where such a worker is a financial member of another industrial Union, he shall on the expiration of his current membership with such other Union, within fourteen (14) days of such expiry, make and complete an application for membership with the Australian Workers' Union.

9.—Contract of Employment.

- (i) For the purpose of this Agreement, a Board of Reference is hereby appointed, which shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties.  - (a) Adjusting any matters of difference which may arise from time to time, except such as involve interpretation of the provisions of this Agreement or any of them.
