Minister for Lands has approved, pursuant to the powers contained in section 17 (3) of the Bush Fires Act, 1954, of the suspension until the 13th January, 1956, of the prohibited burning times declared for the Harvey Road District, so far as the declaration relates to the land within 2 chains on either side of the timber tramway running from Mornington Mill to Wokalup. Any burning carried out under the provisions of this suspension shall be subject to the following conditions:—
