NOTICE is hereby given, under section 98 of the Vermin Act, 1918-1953, that all owners and/or occupiers of all or any holdings, either owned, rented or leased, within the whole of the Nyabing-Pingrup Vermin District, shall, on the 27th day of February, 1956, commence the work of destroying rabbits upon such holdings and upon all the roads bounding and intersecting such holdings. Between Australian Workers' Union, Westralian Branch, Industrial Union of Workers, Applicant, and Co-operative Bulk Handling Limited, Respondent.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement an Award of the Court: Now, therefore, the Court, pursuant to section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court.

Memorandum of Agreement.

3.—Area and Scope.

This Award shall apply to workers engaged by the respondent at the Bulk Grain Silo and Gallery at Albany, in the State of Western Australia.

4.—Term.

The term of this Award shall be for a period of three (3) years commencing from date of issue.

5.—Hours.

Forty (40) hours shall constitute a week's work, to be worked between the hours of 8 a.m. and 5 p.m., Mondays to Fridays inclusive.

6.—Overtime.

(a) All time worked prior to the usual starting time or after the usual finishing time shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) All work performed on Sunday shall be paid for at the rate of double time.

(c) Notwithstanding anything contained in this Award—

- (i) an employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement;
- (ii) no organisation party to this Award, or worker or workers covered by this Award, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.

#### 7.—Wages.

(a) The minimum rates of wages payable to workers covered by this Award shall be as follows:—

(a) Basic Wage—South-West Land Division	....	....	....	....	12	11	8
(b) Margin per week	....	....	....	....	2	10	0

Liberty is reserved to either party to apply in respect of this margin.

(b) The rates herein specified provide for all disabilities associated with the job, such as dust, working in confined spaces, height, etc.

#### 8.—Casual Workers.

A casual worker shall—

- (i) mean a worker who is dismissed through no fault of his own within one week of engagement;
- (ii) be paid 10 per cent. in addition to the rates prescribed in clause 5;
- (iii) not be entitled to holidays, annual leave or sick pay.

#### 9.—Contract of Service.

(a) The contract of service other than for casual workers shall be by the week and shall be terminated by one week's notice on either side.

(b) The contract of service for casual workers shall be by the hour and shall be terminated by one hour notice on either side.

(c) Wages shall be paid weekly, on a day mutually agreed upon between the employer and the worker.

#### 10.—Breakdowns.

Notwithstanding anything contained in this Award, the employer shall be entitled to deduct payment for any day or portion of a day that the worker cannot be usefully employed because of any strike by the Union or Unions affiliated with it, or by any other Association or Union, or through the breakdown of the employer's machinery, or any stoppage of work by any cause that the employer cannot reasonably prevent.

#### 11.—Under-rate Workers.

(a) Any worker who, by reason of old age or infirmity, is unable to earn the minimum wage, may be paid such lesser wage as may from time to time be agreed upon in writing between the employer and the Union.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

#### 12.—Holidays.

(a) The following days, or the days observed in lieu shall, subject to subclause (b) hereof, be allowed as holidays without deduction of pay, namely, New Year's Day, Anniversary Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day.

(b) All work performed on the holidays prescribed herein shall be paid for at the rate of double time.

(c) (i) When a worker is off duty owing to leave without pay or sickness, including accidents on or off duty, except time for which he is entitled to claim sick pay, any holiday falling during such absence shall not be treated as a paid holiday.

(ii) Any worker absenting himself from work without due cause, proof of which will lie on him, on the working day preceding or on the working day succeeding a holiday provided for herein, shall not be entitled to payment for such holiday, providing that this subclause shall not be taken as a precedent for any other Award.

(d) On any public holidays not prescribed as a holiday under this Award, the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

(e) This clause shall not apply to casual workers.

#### 13.—Annual Leave.

(a) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.

(b) If any Award holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(c) A worker may be rostered off and granted annual leave with payment of ordinary wages as prescribed prior to his having completed a period of twelve (12) months' continuous service, in which case should the services of such worker terminate or be terminated prior to the completion of twelve (12) months' continuous service, the employer may deduct from any moneys due to such worker or the said worker shall refund to the employer the difference between the amount received by him for wages in respect of the period of his annual leave and the amount which would have accrued to him by reason of the length of his service up to the date of the termination of his services.

(d) If after one month's continuous service in any qualifying 12-monthly period, a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(e) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award, shall not count for the purpose of determining his right to annual leave.

(f) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (h) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers, he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(g) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(h) This clause shall not apply to casual workers.

#### 14.—Absence through Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one (1) week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the

sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident, wherever sustained, arising out of his own wilful default or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer or his representative on the job, of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) Sick leave shall accumulate from year to year so that any balance of the period in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year. Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

(e) Notwithstanding the provisions of subclause (c) hereof, a worker who has already been allowed paid sick leave on one occasion shall not be entitled to payment of any further absence in the same year, unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

(f) This clause shall not apply to casual workers.

#### 15.—Time and Wages Record.

(a) The employer shall keep, or cause to be kept, a record containing the following particulars:—  
(a) The name of the worker; (b) the class of work performed by him; (c) the starting and finishing time each day; (d) the wages and overtime (if any) paid to him each week.

(b) The time and wages record shall be open for inspection by a duly accredited official of the Union, during the usual office hours, at the employer's head office, and he shall be allowed to take extracts therefrom.

#### 16.—Inspection.

Any officer authorised by the Union may, on any day, for the purpose of investigating any alleged breaches of this Award, and after giving notice in writing to the company or its agent, enter the premises on which the operations covered by this Award are carried on and inspect such operations and speak to workers; provided that such permission shall not in any way be exercised so as to cause any delay in such operations.

#### 17.—Accommodation.

Suitable accommodation shall be provided for workers to change in. Hot and cold water showers shall be provided. A suitably furnished crib room shall also be provided.

#### 18.—First Aid.

A suitable first aid kit shall be provided and maintained by the employer.

#### 19.—Board of Reference.

(a) The Court hereby appoints, for the purpose of this Award, a Board of Reference. The Board shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties.

(b) There are assigned to the Board, in the event of no agreement being arrived at between the parties to the Award, the functions of—

(i) adjusting any matters of difference which may arise between the parties from time to time except such as involve interpretations of the provisions of the Award or any of them;

(ii) deciding any other matter that the Court may refer to the Board from time to time;

(iii) adjudicating on any claim made for handling excessively dusty wheat and fixing where considered necessary a penalty rate for such work.

An appeal shall lie from any decision of the Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

#### 20.—Preference.

Preference of engagement shall be given to members of the Australian Workers' Union competent to do the work. Providing that this clause shall not be taken as precedent for any other Award.

#### 21.—Meal Money.

Meal money of 4s. 6d. shall be paid to men ordered to resume work after 6 p.m. on week days and to men ordered to continue work after 1 p.m. and 6 p.m. on Saturdays, Sundays and holidays, provided—

- (a) they cannot conveniently return home for a meal;
- (b) they have not been notified on the previous day.

#### 22.—Smoke-ohs.

Breaks of 10 minutes shall be allowed from 10 a.m. to 10.10 a.m. and from 3 p.m. to 3.10 p.m.

#### 23.—Shift Workers.

(a) The employer may, if he so desires, work shifts outside the ordinary hours of employment.

(b) Rate of pay for shift work shall be ordinary rates plus 7½ per cent.

## 3.—Scope.

This Award shall apply to the workers classified in clause 9 hereof engaged in the industries carried on by the respondents.

## 4.—Area.

This Award shall operate over the area comprised within a radius of fifteen (15) miles from the General Post Office, Perth.

## 5.—Term.

The term of this Award shall be for a period of one (1) year from the beginning of the first pay period commencing after the date hereof.

## 6.—Definitions.

"Casual worker" shall mean a worker employed for less than one (1) week.

"Storeman" shall be taken to mean the second adult worker in the store.

## 7.—Hours.

Forty (40) hours shall constitute a week's work to be worked between the hours of 7.30 a.m. and 5.30 p.m. Monday to Friday inclusive: Provided that the actual times at which work is commenced or finished shall be mutually agreed upon and arranged between the employer and his workers.

## 8.—Overtime.

(a) All time worked outside the normal hours from Monday to Friday, inclusive, or on Saturday, shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) In the computation of overtime each day shall stand by itself.

(c) No worker shall be required to work on a Sunday.

(d) When a worker, without being notified on the previous day, is required to continue working after the usual knock-off time for more than one (1) hour he shall be provided with any meal required or shall be paid the sum of two shillings and sixpence (2s. 6d.) in lieu thereof. Provided that this clause shall not apply in the case of a worker living in the same locality as his place of employment who can reasonably return home for a meal.

(e) Notwithstanding anything contained in this Award—

- (i) an employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement;
- (ii) no organisation, party to this Award, or worker or workers covered by this Award, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.

## 9.—Wages.

The minimum rates of wages payable to workers covered by this Award shall be as follows:—

(d) Casual workers shall be paid ten per cent. (10%) in addition to the rates prescribed above.	

Liberty is reserved to the parties to this Award to apply to the Court of Arbitration for an amendment to this clause to insert rates for female workers should such workers be employed in the industry.

## 10.—Shift Work.

(a) An employer may, if he so desires, work his establishment on shifts, but before doing so shall give notice of his intention to the Union.

(b) Work other than day shift shall not be recognised as afternoon or night shift unless in either case five (5) consecutive afternoons or nights are worked, but shall be deemed to be overtime; on completion of the fifth (5th) consecutive afternoon's or night's work the worker shall be deemed to have been employed on afternoon or night shift, as the case may be, during the preceding four (4) afternoons or nights, and thereafter during any subsequent consecutive afternoons or nights he is so employed.

(c) Subject to weekly rotation, the loading on the ordinary rates of pay for shift work shall be five per cent. (5%).

(d) The sequence of shift work shall not be deemed to be broken under the preceding paragraphs (b) and (c) by reason of the fact that the works are closed on a Sunday or on any public holiday.

## 11.—Higher Duties.

Any worker carrying out work classified at a higher minimum than his usual rate shall be paid whilst so engaged on such work at the higher rate prescribed therefor.

## 12.—Contract of Service.

(a) The contract of hiring of every worker other than a casual worker shall be deemed to be a contract of hiring by the week. Provided that no termination of the contract of service shall become effective until at least one week's definite notice in writing to that effect has been given to or received by the worker or the employer concerned.

(b) Nothing in this clause shall deprive the right to the employer to summarily dismiss a worker for misconduct.

## 13.—Breakdowns, etc.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the Union or Unions affiliated with it, or by any other Association or Union, or through the breakdown of the employer's machinery, or any stoppage of work by any cause which the employer cannot reasonably prevent.

## 14.—Absence Through Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health at the rate of one-twelfth (1/12th) of a week's pay for each completed month of service: Provided that, subject to subclause (g) hereof, payment for absence through such ill-health shall be limited to one (1) week's pay in each calendar year.

(b) Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(c) This clause shall not apply when the worker is entitled to compensation under the Workers' Compensation Act.

(d) A worker shall not be entitled to receive any wages from his employer for any time lost through any accident not arising out of or in the course of his employment or for any accident wherever sustained arising out of his own wilful default or for sickness arising out of his own wilful default.

(e) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(f) Notwithstanding the provisions of subclause (e) hereof, a worker, who in any calendar year, has already been allowed paid sick leave on one occasion for one day only, or less, shall not be entitled to payment for any further absence of one day only or less, unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

(g) Sick leave shall accumulate from year to year so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year. Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

## 15.—Holidays.

(a) The following days, or the days observed in lieu thereof, shall, subject to subclause (b) hereof, be allowed as holidays without deduction of pay, namely:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Christmas Day, Boxing Day and Union Picnic Day: Provided that picnic day shall be held on the second Monday of September in each year.

(b) All time worked on the holidays prescribed in subclause (a) hereof shall be paid for at the rate of double time.

(c) On any public holiday not prescribed as a holiday under this Award the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done, ordinary rates of pay shall apply.

## 16.—Annual Leave.

(a) Except as hereinafter provided, a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer.

(b) If any prescribed holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(c) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(d) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award, shall not count for the purpose of determining his right to annual leave.

(e) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (c) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(f) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(g) The provisions of this clause shall not apply to casual workers.

## 17.—Young and Female Workers.

(a) No person under the age of seventeen years shall be employed in any cellar or room in which wines or spirits are drawn, broken down, or bottled.

(b) Females may only be employed capsuling, labelling, wiping, wrapping and packing into containers.

(c) No female shall be employed under subclause (b) of this clause to displace any adult male worker who is employed in the industry at the date of this Award.

## 18.—Record.

(a) Each employer shall keep or cause to be kept a time and wages record wherein shall be entered—

- (i) the name of each worker;
- (ii) the nature of his employment;
- (iii) the time he commences and finishes work each day;
- (iv) the total hours worked each day and each week;
- (v) the wages (and overtime, if any) received therefore;
- (vi) the ages of junior workers.

(b) Any system of automatic recording by means of machines shall be deemed a compliance with this clause to the extent of the information recorded.

(c) Such record shall be entered up each day in legible English characters and shall be signed weekly only if correct by each worker.

(d) The record shall be open for inspection by a duly accredited official of the Union at the employer's office during ordinary office hours.

## 19.—Under-rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

## 20.—Proportion of Male Junior Workers.

Junior workers seventeen years of age and under twenty-one years of age shall be allowed in the proportion of one (1) junior worker to every four (4) or fraction of four (4) adult male workers employed.

## 21.—Junior Worker's Certificate.

(a) Junior workers, upon being engaged, shall furnish the employer with a certificate from their parent, guardian or a responsible person, containing the following particulars:—

- (1) Name in full.
- (2) Age and date of birth.

(b) No worker shall have any claim upon an employer for additional pay in the event of the age of the worker being wrongly stated on the certificate. If any junior worker shall wilfully mis-state his age in the above certificate, he alone shall be guilty of a breach of this Award.

## 22.—Board of Reference.

(a) For the purposes of this Award, a Board of Reference is hereby appointed, which shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. The said Board shall have assigned to it in the event of no agreement being arrived at between the parties to the dispute, the functions of—

- (i) adjusting any matters of difference which may arise from time to time except such as involve interpretation of the provisions of the Award or any of them;
- (ii) dealing with any other matter which the Court may refer to the Board from time to time.

(b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.
