WHEREAS it is enacted, inter alia, by section 15 of the Wheat Products (Prices Fixation) Act, 1938-1939, that the Governor may from time to time, on the recommendation of the Wheat Products Prices Committee constituted pursuant to the Act,

by Proclamation fix the minimum and the maximum price at which substances included in the definition of wheat products may be sold in the State, or in any specified part of the State, by the manufacturer thereof or by any person, and that the Governor may from time to time revoke or vary any Proclamation under the section by a subsequent Proclamation; and whereas the Gover-nor by Proclamation dated the 21st day of December, 1955, and published in the Government Gazette on the 20th day of January, 1956, fixed the prices at which bread, being a wheat product within the meaning of the Act, may be sold by any person in the various parts of the State specified in that Proclamation; and whereas it is now considered necessary and expedient to vary that Proclamation so far as it concerns the Kalgoorlie-Boulder Area as therein defined: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and on the recommendation of the Wheat Products Prices Committee, and in exercise of the power in this behalf conferred upon me by the Act, do hereby vary the Proclamation dated the 21st day of December, 1955, made pursuant to that Act and published in the Government Gazette on the 20th day of January, 1956, by substituting for the Third Schedule to that Proclamation the following schedule:

AT a meeting of the Executive Council held in the Executive Council Chamber, at Perth, on the 13th day of March, 1956, the following Orders in Council were authorised to be issued:—

Workers' Compensation Act, 1912-1954. ORDER IN COUNCIL.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1954, that it shall be obligatory for every employer to obtain from an incorporated insurance office approved by the Minister a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer from the operation of the said section; and whereas the Bank of New South Wales of St. George's Terrace, Perth, in the State of Western Australia, being an employer within the meaning of the said Act and having made application in accordance with the regulations made meaning of the said Act and having made application in accordance with the regulations made under the Act, has proved to the satisfaction of the Minister that as such employer it has established a fund for insurance against its liability aforesaid and has deposited at the Treasury securities, to wit, a bond of five thousand pounds given by the Boak about the sale payments to become ties, to wit, a bond of five thousand pounds given by the Bank, charged with all payments to become due and payable by the Bank under its liability: Now, therefore, His Excellency the Governor in Council, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the Act, doth hereby exempt the Bank of New South Wales as such employer aforesaid from the operation of section 13 of the Workers' Compensation Act, 1912-1954, for a period of two years computed from and including the 31st day of March, 1956.

(Incorporated) to be held in trust for the aforesaid purpose, subject to the condition that the land shall not be leased or mortgaged in whole or in part without the consent of the Governor. part without the consent of the Governor.

Traffic Act, 1919-1954. Broome Road Board. ORDER IN COUNCIL.

HIS Excellency the Governor acting by and with the advice and consent of the Executive Council hereby makes the following order under section 49 of the Traffic Act, 1919-1954, namely that the Broome Road Board is hereby empowered to make by-laws in pursuance of:

- (1) Clause (a) of paragraph (i) of subsection (1) of section 47 of the said Act, prescribing the rules to be observed in respect of any vehicle being driven or used on roads.
- (2) Clause (u) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting the use of any specified road by any vehicle or by any person riding, driving, or in charge of any animal.
- (3) Clause (v) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting the use of any specified road by any vehicle or by any person riding, driving or in charge of any animal, except when proceeding in a prescribed direction.

- (4) Clause (w) of paragraph (i) of subsection (1) of section 47 of the said Act, prescribing the routes to be followed by all classes of traffic, or any particular class of traffic or vehicle, from one specified point to another, either generally or between any specified times.
- (5) Clause (y) of paragraph (i) of subsection (1) of section 47 of the said Act, providing for the placing, erection or installation on roads, or footpaths of traffic signs and directions, and for the marking on roads or footpaths of signs for the direction of traffic, both vehicular and pedestrian.
- Clause (zd) of paragraph (i) of subsection (1) of section 47 of the said Act, appointing stands and parking places for different classes of vehicles and regulate the use thereof.
- (7) Clauses (zl) and (zm) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting or restricting the parking of vehicles or vehicles of a specified class or classes in all roads or in specified roads, or specified parts of roads, at all times or at specified times, and prescribing a penalty for any breach thereof.

Subject to the condition that no such by-law shall be valid and effectual unless it has prior to notification of its making being published in the Government Gazette, been submitted to and approved by the Governor.
