## Native Welfare Act, 1905-1954. Native Institution. PROCLAMATION

By His Excellency Lieutenand-General Sir Charles Henry Gairdner, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Commander of the Most Excellent Order of the British Empire, Governon in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

WHEREAS under section 2 of the Native Welfare Act, 1905-1954, "Native Institution" means and includes any mission, reformatory, orphanage, school, home, station, reserve, or other institutions for the benefit, protection, or care of the native inhabitants of the State, declared by Proclamation to be a native institution for the purpose of this Act: Now, therefore I, the said Governor, hereby declare the United Aborigines Mission, Derby, to be an institution within the meaning of the said section.

## Spear-guns Control Act, 1955. PROCLAMATION

WESTERN AUSTRALIA, TO WIT, CHARLES HEMRY GAIRONER, Governor. [L.S.] By His Excellency Lieutenant-General Sir Charles Henry Gairdner, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Victorian Order, Companion of the Most Honourable Order of the Bath, Commander of the Most Excellent Order of the British Empire, Governor in and ever the State of Western Australia and its Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 5 of the Spearguns Control Act, 1955, that from time to time the Governor may by Proclamation declare areas to be prohibited areas within the meaning of that Act: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council and in exercise of the powers contained in the Spear-guns Control Act, 1955, hereby declare the areas comprising

- (a) that portion of the Swan River 100 yards wide measured from its left bank at high water mark and which portion is contiguous to the Belmont Park Road District;
- (b) that portion of the Swan River 100 yards wide measured from its right bank at high water mark and which portion is contiguous to the Peppermint Grove Road District;
- (c) those portions
  - (i) of the Canning and Swan Rivers 100 yards wide and
  - (ii) of Bull Creek (North of a prolongation of the Southern alignment of Bulls Creek Road) within a maximum of 100 yards in width measured from their left banks at high water mark and which portions are contiguous to the Melville Road District; and
- (d) that portion of the Moore River within the Gingin Road District between a prolongation of the Northern boundary of Swan Location 787 and the sea; and
- (e) that portion of the Guilderton To nsite within the Gingin Road District South of Swan Location 2948,

to be prohibited areas within the meaning of that Act.

WHEREAS by sections 223 and 225 of the Municipal Corporations Act, 1906-1943 (6 Edwardi, No. 32), it shall be lawful for the Governor, on request of the Council, by notice in the Government Gazette, to declare any land reserved, used, or by purchase or exchange acquired for a street or way, or any place, bridge, or thoroughfare, to be a public highway, and such land shall thereupon and thenceforth, from the date of such Proclamation, become and be absolutely dedicated to the public as a public highway within the meaning of any law now or hereafter in force; and whereas the Bunbury Municipal Council has requested that certain land named and described in the Schedule hereunder which has been reserved for a street or way within the Municipality of Bunbury, be declared a public inghway: Now, therefore I, the said Governor, by and with the advice and consent of the Executive Council, do by this my Proclamation declare the said land to be a public highway, and such land shall, from the date of this Proclamation, be absolutely dedicated to the public as a highway within the meaning of any law now or hereafter in force.

## ORDER IN COUNCIL.

F.D. 1368/54.

WHEREAS the enactment contained in section 74 of the Constitution Act, 1889, whereby the appointment of all public officers under the Government of the State is vested in the Governor in Council, does not apply to minor appointments which by Act of Legislature or by Order in Council may be vested in the heads of departments or other officers or persons within the State; and whereas it is desirable that the appointment of persons as employees of the Forests Department and its branches at a daily or weekly rate of wages should be vested in Philip Norman Shedley and Ian George Morison or any persons appointed to temporarily act in place of such officers: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, hereby vests in Philip Norman Shedley and Ian George Morison and any persons appointed to temporarily act in place of such officers the appointment of persons as employees of the Forests Department and its branches at a daily or weekly rate of wages.

Forests Act, 1918-1954.

ORDER IN COUNCIL.

F.D. 1079/53.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown land as a State Forest may be revoked in whole or in part in the following manner: —

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall, by Order in Council, revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposals dated the 23rd day of November, 1953, for the revocation in part of the dedication of Crown Lands as State Forest; and whereas after such proposals had been laid before Parliament, a resolution was passed by both Houses that such proposals should be carried out: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown Lands as State Forest No. 37 by excising that portion of such State Forest as is described in the Schedule hereto.

location 1760; thence Northerly along the Eastern boundary of that location and onwards to and along that of location 770 and again onwards to and along the Eastern boundary of location 1315 and again onwards to and along that of location 2933 and again onwards to a point situate West of the 82-Mile Post on the No. 1 Rabbit Proof Fence aforesaid; thence West to the Eastern shore of Lake Moore aforesaid; and thence generally North-North-Easterly along the Eastern shores of that lake to the starting point.
