AT a meeting of the Executive Council, held in the Executive Council Chamber, at Perth, on the 24th day of July, 1956, the following Orders in Council were authorised to be issued:—

##### ORDER IN COUNCIL.

Corres. No. 3412/49.

WHEREAS by section 33 of the Land Act, 1933-1954, it is, *inter alia*, made lawful for the Governor to direct that any land reserved pursuant to the provisions of the Act, shall be leased for the purpose for which the land is reserved as aforesaid, by Instrument of Lease in accordance with the form in the Fourth Schedule of the Act, to any person (as defined in the said section); and whereas it is deemed expedient that reserve No. 24434 (Perth Lot 765) shall be leased for a term of seven (7) years to the Western Australian Trotting Association to be held in trust for the purpose of a Trotting Racecourse, subject, however, to the following conditions:—

- (a) Filling to a reduced level of 9.00 feet to be completed within the subject land, and also to a reduced level of 6.00 feet for a width of 22 feet along the riverside boundary of the subject land from the point A to the point B on the Plan page 79 of Lands and Surveys File 3412/49.
- (b) Existing underground drainage to be extended under the additional filling referred to above to the satisfaction of the authorities concerned.
- (c) The external boundaries to be fenced to the satisfaction of the Perth City Council.
- (d) An easement on the area as shown on page 79 of Lands and Surveys File 3412/49 to be provided for the Metropolitan Water Supply, Sewerage and Drainage Department. No buildings or other structures to be erected on this area.
- (e) At any time after the completion of the required filling and other improvements, the Association, on application from it, to be issued a Crown Grant of the subject land in trust for Trotting Racing purposes.

Now, therefore, His Excellency the Lieutenant-Governor and Administrator, by and with the advice and consent of the Executive Council, doth hereby direct that the abovementioned reserve shall be leased for a term of seven (7) years to the aforesaid trustees to be held in trust for the purpose of a Trotting Racecourse, subject, however, to the conditions aforesaid.

Between Amalgamated Engineering Union of Workers, Kalgoorlie Branch; State Executive, Australasian Society of Engineers' Industrial Association of Workers; Electrical Trades Union of Workers of Australia (Western Australian Goldfields Sub-branch), Kalgoorlie, Applicants, and Australian Blue Asbestos Ltd., Respondent.

HAVING heard Mr. H. J. Symons on behalf of the applicants, and Mr. F. S. Cross on behalf of the respondent, and by consent, I, the undersigned, Conciliation Commissioner of the Court of Arbitration, in pursuance of a remission to me by the said Court and in pursuance of the powers contained in section 92 of the Industrial Arbitration Act, 1912-1952, do hereby order and declare that Award No. 2 of 1953 be and the same is hereby amended in the terms of the attached schedule.

This order shall take effect as from the beginning of the first pay period commencing after the date hereof.

Schedule.

Clause 13—Hours.

Delete existing subclause (a) and substitute in lieu thereof the following:—

(a) The ordinary working hours shall not exceed forty (40) in any one week, and shall not exceed eight (8) hours daily, to be worked between the hours of 7 a.m. and 5 p.m. from Monday to Friday inclusive.

Clause 14—Overtime (other than Continuous Process Workers).

Delete existing clause and substitute in lieu thereof the following:—

14—Overtime (other than Continuous Process Workers).

(a) For all work done beyond the hours of duty on any ordinary day, payment shall be at the rate of time and a half for the first two (2) hours and double time thereafter.

(b) For all work done on Saturdays payment shall be at the rate of time and a half for the first two (2) hours and double time thereafter.

(c) Repairs to the machinery of the employer which is broken down and has caused a stoppage of operations shall be paid for at the rate of time and a half on Saturdays, Sundays and holidays.

(d) Work done on Sundays and holidays shall be paid for at the rate of double time.

(e) When a worker is recalled to work after leaving the premises, he shall be paid for at least two (2) hours at overtime rates.

(f) When a worker without being notified on the previous day is required to continue working after the usual knock-off time for more than one (1) hour or (in the case of a day-worker) after 5.30 p.m. whichever is the later, he shall be provided with any meal required or shall be paid three shillings and sixpence (3s. 6d.) in lieu thereof.

(g) When a worker is required to hold himself in readiness for a call after ordinary hours, he shall be paid at ordinary rates for the time that he holds himself in readiness.

(h) When a worker is required for duty during any meal time, whereby his meal time is postponed for more than one hour, he shall be paid at overtime rates until he gets his meal.

(i) When computing overtime, any district allowance shall not be computed as an addition to the day's pay.

(j) (i) Within the limits prescribed by the Mines Regulation Act and the regulations made thereunder, an employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) No organisation party to this Award, or worker or workers covered by this Award, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.

Introduce a new clause 14A to read as follows:—

14A—Rest Period after Overtime.

(a) When overtime work is necessary, it shall whenever reasonably practicable be so arranged that workers have at least eight (8) consecutive hours off duty between the work of successive days.

(b) Where a worker (other than a casual worker) has not had at least eight (8) consecutive hours off duty between his usual finishing time on one day and his usual starting time on the next day, the following provisions shall apply:—

(i) He shall if he so desires, be entitled to have eight (8) consecutive hours off duty from the completion of his overtime work until he next commences work, but shall not be paid for such time off duty.

(ii) If on the instructions of the employer, he continues or resumes work at his ordinary starting time without having such eight (8) hours break, he shall be paid at overtime rates for the balance of the hours less than eight (8) which he has not had off duty. Hours of overtime actually worked since his last usual finishing time, shall be counted in computing the actual rate of overtime under this paragraph.

(iii) If a worker, of his own volition, continues or resumes work at his ordinary starting time without such break, he shall be paid at ordinary rates.

Clause 15—Continuous Process Workers.

Delete existing clause and substitute in lieu thereof the following:—

15—Continuous Process Workers.

(a) Forty (40) hours shall constitute a week's work to be worked in five (5) shifts of eight (8) hours each inclusive of crib time.

(b) A worker called upon to work a sixth shift in any week shall be paid at the rate of time and a half.

(c) For work done beyond the hours of duty on any day except holidays, payment shall be at the rate of time and a half for the first two (2) hours and double time thereafter.

(d) When computing overtime, the district allowances shall not be computed as an addition to the day's pay.

(e) These overtime rates shall not apply to excess time due to private arrangement between the workers themselves, or which is necessary for effecting periodical rotation of shifts, or which is owing to a relieving man not coming on at the appointed time. The time for which any worker may be paid at ordinary rates instead of overtime due to a relieving man not coming on at the proper time shall not exceed two (2) hours, after the expiration of which overtime rates shall apply for the whole shift.

(f) When a worker, without being notified on the previous day, is required to continue working after the usual knock-off time for more than one (1) hour, or (in the case of a day-worker), after 5.30 p.m., whichever is the later,

he shall be provided with any meal required or shall be paid three shillings and sixpence (3s. 6d.) in lieu thereof.

(g) Work done on Sundays during the ordinary hours of duty shall be paid for at the rate of time and a half.

(h) Work done on holidays shall be paid at double time, except work in connection with repairs to machinery which has broken down and has caused a stoppage of operations.

**Clause 16—Annual Leave and Holidays.**

Delete existing clause and substitute in lieu thereof the following:—

**16.—Annual Leave and Holidays.**

(a) Each worker shall be entitled to three (3) weeks' annual leave on full pay or, should the period of continuous employment be less than one year, the worker shall be paid a sum proportionate as his length of service is to the full year's employment. Annual leave shall be taken at a time suitable to the convenience of the employer; provided that, where a worker is dismissed for wilful misconduct, he will not be entitled to the benefits of this clause.

(b) Continuous process workers shall be granted one (1) week's leave on full pay, in addition to the leave prescribed in subclause (a) hereof. Workers who have worked as continuous process workers for less than two hundred and forty-one (241) shifts at ordinary rates of pay shall be granted the proportion of the additional week. The quantum of annual leave to be allowed to a worker shall for service prior to the 11th day of July, 1956, be calculated in accordance with the provisions of the Award applicable before that date, and for service subsequent to the 11th day of July, 1956, in accordance with the provisions of this subclause.

(c) The amounts to be paid under subclauses (a) and (b) shall be calculated at the rate prevailing at the time the payment is made.

(d) The provisions as to annual leave shall not apply to casual workers.

(e) Subject to clauses 14 (c) and (d) and 15 (h), the following shall be paid holidays:—Christmas Day, Easter Monday, Labour Day, and one additional day in each calendar year to be nominated by the employer. If Christmas Day falls on a Sunday, the following Monday shall be observed. Provided that any worker who does not present himself for work (if required) on the working day following any of the abovementioned holidays shall not be entitled to be paid for such holiday unless he produces proof satisfactory to the employer that he was prevented by sickness from presenting himself for work on any such day and that such sickness was not due to intemperance or misconduct.

(f) If any of the holidays prescribed in subclause (e) falls during a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, the worker shall be paid one extra day at ordinary rates for that day, or at his option, have one day on full pay added to that period for each such holiday.

**Clause 18—Payment for Sickness.**

Delete existing subclause (a) and substitute in lieu thereof the following:—

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for 1/10th of a week's pay at the Award rate for each 23.7 shifts actually worked, at ordinary rates of pay. Provided that payment for absence through such ill-health shall be limited to one week's pay in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Worker's Compensation Act.

**Clause 19.—Shifts.**

Delete existing clause and substitute in lieu thereof the following:—

**19.—Shifts.**

(a) Men working shifts not subject to weekly rotation shall be paid for each shift other than day shift at the rate of time and one-quarter. The roster known as the Great Boulder Roster and other accepted variations thereof, shall be deemed to be subject to weekly rotation.

(b) A worker employed on any shift other than day shift shall be paid five per cent (5%) in addition to his ordinary rate.

(c) Work other than day shift shall not be recognised as afternoon or night shift unless in either case five (5) consecutive afternoons or nights are worked, but shall be deemed to be overtime. On completion of the fifth consecutive afternoon's or night's work, the worker shall be deemed to have been employed on afternoon or night shift, as the case may be, during the preceding four (4) afternoons or nights, and thereafter during any subsequent consecutive afternoons or nights he is so employed.

**Clause 26.—Definitions.**

Delete existing subclause (h) and substitute in lieu thereof the following:—

(h) "Casual hand" means any worker who is dismissed through no fault of his own before the expiration of one week of his employment.

**Clause 31.—Apprentices.**

Delete existing subclause (b) and substitute in lieu thereof the following:—

(b) The maximum number of apprentices allowed to any employer shall be in the proportion of one (1) apprentice to every two (2) or fraction of two (2) journeymen employed by him in that branch; provided that the fraction of two (2) shall not be less than one.

Consequential amendment: Insert in Clause 2—Arrangement, after 14—Overtime, 14A—Rest Period after Overtime.

No. 47 of 1955.

Between the Metropolitan Wool Scouring and Fellmongery Employees' Industrial Union of Workers, Applicant, and Swan Wool Scouring Co. Pty. Ltd., and Jandakot Wool Scouring Co. Pty. Ltd., Respondents.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the said reference of industrial dispute was remitted by the Court to the Conciliation Commissioner, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Conciliation Commissioner by their respective representatives and requested the Conciliation Commissioner to make the said Agreement an Award of the Court: Now, therefore, the Conciliation Commissioner, pursuant to section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling him, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court.

**Memorandum of Agreement.**

(Note.—Wherever the word "Award" occurs herein, it shall be taken to mean and include "Agreement.")

## 1.—Title.

This Award shall be known as the Wool Scouring and Fellmongery Industry Award and replaces Award No. 45 of 1948 as amended.

## 3.—Area.

This Award shall operate over the area comprised within a radius of thirty (30) miles from the G.P.O., Perth.

## 4.—Scope.

This Award shall apply to the workers engaged in the Wool Scouring and Fellmongery Industry as carried on by the respondents.

## 5.—Term.

This Award shall operate for a period of three (3) years as from the beginning of the first pay period commencing after the date hereof.

## 6.—Holidays and Annual Leave.

(a) The following days or the days observed in lieu, shall, subject to clause 8 hereof, be allowed as holidays without deduction of pay, namely:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day.

(b) On any public holiday not prescribed as a holiday under this Agreement the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done ordinary rates of pay shall apply.

(c) Except as hereinafter provided a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve months' continuous service with such employer.

(d) If any prescribed holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(e) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service.

(f) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays

or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(g) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (e) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers, he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(h) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(i) The provisions of this clause shall not apply to casual workers.

## 7.—Overtime.

(a) All time worked by day workers, prior to the usual starting time or after the usual finishing time, and all time worked on Saturday shall be regarded as overtime and paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) All time worked by shift workers prior to the usual starting time or after the usual finishing time and all time worked after 11 a.m. on Saturday shall be regarded as overtime and paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(c) Notwithstanding anything contained in this Award:—

(i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) No organisation, party to this Award or worker or workers covered by this Award shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

## 8.—Sunday and Holiday Work.

All work performed on Sunday, or the holidays prescribed in clause 6 (a) hereof shall be paid for at the rate of double time.

## 9.—Proportion of Juniors.

The employer shall be entitled to employ one junior and, thereafter additional juniors may be employed in the proportion of one junior to every four (4) or fraction of four (4) workers in receipt of the full adult rate of pay.

## 10.—Higher Duties.

A worker required to do work which is entitled to a higher rate under this Award than that which he usually performs shall be entitled to payment at the higher rate whilst so employed.

## 11.—Time and Wages Record.

The employer shall keep and enter up, or cause to be kept and entered up, a record containing the following particulars:—

- (a) The name of the worker.
- (b) The class of work performed by each worker.
- (c) The wages and overtime (if any) paid to each worker.
- (d) The time during which the worker has been employed.
- (e) The ages of Junior workers.

Such record shall be open to inspection by a representative of the Union, not more than once weekly, during the business hours of 10 a.m. to 4 p.m.

## 12.—Under Rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage, as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

## 13.—Junior Workers Certificate.

Junior workers shall furnish the employer with a certificate showing the following particulars:—

(a) Name in full.

(b) Age and date of birth.

The certificate shall be signed by the worker.

No worker shall have any claim upon an employer for additional wages in the event of his age being wrongly stated on the certificate.

## 14.—Payment for Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill health for one-twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill health shall be limited to one week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment or for any accident wherever sustained, arising out of his own wilful default or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) Notwithstanding the provisions of subclause (c) hereof, a worker who has already been allowed paid sick leave shall not be entitled to payment for any further absence unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill health.

(e) Sick leave shall accumulate from year to year so that any balance of the period prescribed in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and subject to the conditions hereinbefore prescribed shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year: Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

## 15.—Board of Reference.

The Court appoints for the purpose of this Award, a Board of Reference. The Board shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. There are assigned to the Board in the event of no agreement being arrived at between the parties to this Award the functions of:—

(i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award or any of them;

(ii) deciding any other matter that the Court may refer to such Board from time to time.

An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

## 16.—Meal Money.

Where a worker without being notified on the previous day is required to continue working after his usual knock-off time for more than one hour, he shall be provided with any meal required or shall be paid three shillings (3s.) in lieu thereof: Provided that this clause shall not apply to a worker residing in the same locality as his place of employment who can reasonably return home for a meal.

## 17.—Notice Board.

An accredited representative of the Union shall not be prevented from posting a copy of this Award or any notice of the Union not exceeding fourteen (14) inches by nine (9) inches in a suitable place agreed upon between the employer and the Union. Failing agreement in this connection the Board of Reference shall decide where the copy of the Award or the said notice shall be posted.

## 18.—Breakdowns, etc.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the Union or the Unions affiliated with it or by any other association or Union or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.

## 19.—Shift Work.

Workers employed on afternoon shift shall be paid five per cent. (5%) extra. Workers employed on night shift shall be paid seven and half per cent. (7½%) extra.

## 20.—Definitions.

(a) "Casual hand" shall mean a worker engaged by the hour and who may be put off or leave the employer's service at any moment without notice. The minimum engagement for a casual hand shall be four (4) hours.

A casual hand engaged and not permitted to commence work shall receive two (2) hours' pay at the prescribed rate.

(b) "Weekly hand" shall mean a worker engaged by the week and whose employment shall be terminated by not less than one (1) week's notice on either side.

## 21.—Hours.

(a) Day Work: Forty (40) hours shall constitute a week's work to be worked eight (8) hours daily, between the hours of 7.30 a.m. and 5.30 p.m. Monday to Friday inclusive.

(b) Shift Work: Forty (40) hours shall constitute a week's work to be worked in five (5) shifts of eight (8) hours each to be paid for at ordinary rates. Whenever the shift commences at 11 p.m. on Sunday ordinary shift rates for the hour's work on Sunday shall be payable. All shifts payable at ordinary shift rates shall finish not later than 11 a.m. on Saturday. Crib time shall be taken in the employer's time, when shift work is worked.

## 22.—Special Provisions.

(a) Shift boss shall be paid three shillings (3s.) per shift extra.
