ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1954, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for the like or other public purposes to be specified in such order; and whereas it is deemed expedient as follows:—

Corr. No. 3310/20—That reserve No. 17525 (Maudiga Lot 33) should vest in and be held by the Mt. Marshall Road Board in trust for the purpose of Recreation.

Corr. No. 3380/21—That reserve No. A17768 should vest in and be held by the Cranbrook Road Board in trust for the purpose of Hallsite and Camping.

Corr. No. 1291/56—That reserves Nos. "A" 14398 and "A" 24556 should vest in and be held by the Fauna Protection Advisory Committee in trust for the purpose of Protection of Flora and Fauna.

ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1954, it is, *inter alia*, made lawful for the Governor by Order in Council to direct that any land reserved pursuant to the provisions of this Act shall be granted in fee simple to any person (as defined in the said section) subject to the condition that the person shall not lease or mortgage the whole or any part of the land without the consent of the Governor and subject to such other conditions and limitations as the Governor shall deem necessary to ensure that the land is used for the purpose for which the land is reserved as aforesaid; and whereas it is deemed expedient as follows:—

Corres. No. 3155/21—That reserve No. 19646 (Corrigin Lot 147) should be granted in fee simple to The Perth Diocesan Trustees to be held in trust for the purpose of a Church Site (Church of England).

Clause 5.—Overtime.

Delete the existing clause and insert in lieu thereof:—

(a) (i) All time worked in excess of the ordinary daily hours as rostered for any one shift shall be classed as overtime.

(ii) All overtime worked on any day other than a Sunday shall be paid for at one and one-half ( $1\frac{1}{2}$ ) times the ordinary rate for the first four hours, and at double the ordinary rate thereafter.

(iii) All overtime worked on Sundays shall be paid for at double the ordinary rate.

(iv) Week-end penalty rates shall not be deemed to be part of the ordinary rate for the calculation of overtime.

(b) The preceding provisions of this clause shall not apply at Greenplace or to Female Ward 7 at Claremont.

(c) (i) The Inspector General may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) The union or worker or workers covered by this Award shall not in any way whether directly or indirectly be party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

(iii) This subclause shall remain in operation until otherwise determined by the Court.

Clause 7.—Public Holidays.

Delete subclause (a) of existing clause and insert in lieu thereof:—

(a) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely: New Year's Day, Good Friday, Labour Day, Anzac Day, Christmas Day and Boxing Day.

Clause 9.—Sick Leave.

Delete the existing clause and insert in lieu thereof:—

(a) (i) Subject as hereinafter provided sick leave shall be granted on the basis of ten (10) working days on full pay for each year of service.

(ii) If, in any calendar year any absence through sickness exceeds the worker's current entitlement, and, by service subsequent to the sickness the worker becomes entitled to further sick leave with pay, payment may be adjusted at the end of that calendar year or at the time the worker leaves the service of the employer, whichever is the sooner.

(iii) Any unused portion of the sick leave herein prescribed up to a maximum of seven (7) working days in each year shall be allowed to accumulate and may be availed of in the next or any succeeding year.

(b) Workers in the employ of the Inspector General at the commencement of this clause, shall be allowed an initial credit on the following basis:—

(i) Where continuous service exceeds three (3) years—forty-five (45) working days less any sick leave taken during the preceding triennial period.

(ii) Where continuous service is less than three (3) years—an amount calculated on the entitlement provided for in subclause (a) hereto, less any sick leave taken from the commencement of service to the date this amendment comes into force.

(c) No sick leave with pay shall be granted without an adequate medical certificate, provided that if in any case it is not convenient for the employee to obtain a medical certificate, sick leave may be granted on other evidence satisfactory to the Inspector General, but such leave shall be limited to two (2) consecutive days in any one period and a total of 3 days in any calendar year.

(d) (i) The maximum period of sick leave allowable with pay in respect of any continuous absence shall not exceed 6 months.

(ii) A worker who has been granted 6 months continuous sick leave with pay shall not be entitled to receive further sick leave with pay until a period on duty of not less than 4 weeks has been completed.

(e) Any period during which a worker is absent on leave without pay shall not be included as part of such worker's period of continuous service for the purpose of this clause.

(f) A worker who is absent on approved annual leave, long service leave, or leave without pay, shall not be eligible for leave under this clause during the currency of such approved leave.

(g) No leave on account of illness or injury shall be granted with pay if the illness or injury has been caused by the worker's own fault, neglect or misconduct.

#### Clause 11.—Travelling Allowance.

Delete subclause (c) of the existing clause and insert in lieu thereof:—

(c) The maximum amount for conveyance of household effects shall be forty (40) pounds.

### INDUSTRIAL AGREEMENT.

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1952, this 28th day of August, 1956, between the W.A. Fire Brigades Board (hereinafter referred to as the "Board") of the one part and the Fire Brigade Employees Industrial Union of Workers (Coastal Districts) of Western Australia (hereinafter referred to as the "Union") of the other part, whereby the said parties mutually agree as follows:—

(c) Where less than a full week is worked, the worker shall be paid at the daily rate for a 5-day week.

#### 4.—Hours of Work.

(a) Forty hours shall constitute a week's work, worked from Monday to Friday inclusive.

(b) Such hours shall be worked between the hours of 8 a.m. and 5 p.m. with an interval of one hour for lunch between 1 p.m. and 2 p.m.

#### 5.—Overtime.

Liberty to apply is granted to either party to provide for overtime if circumstances warrant the employment of more than one watchroom attendant on day duty.

#### 6.—Holidays.

(a) A period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by the Board after a period of twelve (12) months' continuous service with such employer. Provided that no annual leave shall accrue to any worker until he has served three (3) complete months.

(b) For employment for portion of the year beyond three (3) months, the worker shall only be entitled to such holidays as are proportionate to his length of service.

(c) A worker who is dismissed for peculation or theft shall not be entitled to annual leave or payment therefor.

(d) Except as hereinafter provided, each of the following days, or the day observed in lieu thereof, shall be allowed as a holiday to all workers and be paid for, namely:—New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day, Sovereign's Birthday, Christmas Day and Boxing Day.

(e) Whenever any holiday falls on an employee's ordinary working day and the employee is not required to work on such day, he shall be paid for the ordinary hours he would have worked on such day if it had not been a holiday. If he is required to work on a holiday he shall be paid for the time worked as if it was an ordinary working day and shall, in addition, be allowed a day's leave with pay to be added to the annual leave or to be taken at some subsequent date if the worker so agrees.

(f) Payment for holidays shall be in accordance with the usual hours of work.

#### 7.—Watchroom Supervision.

Watchroom Attendants with two (2) or more years' service shall be in charge over firemen of any rank assisting on Watchroom duty.

#### 8.—Sick Leave.

(a) (i) A worker shall be entitled to payment for non-attendance on the ground of personal ill health for one-twelfth (1/12th) of a week's pay for each completed month of service.

(ii) The liability of the employer shall in no case exceed one (1) week's wages during each calendar year in respect of each worker but the sick leave herein provided shall be allowed to accumulate and any portion unused in any year may be availed of in the next or any succeeding year.

(iii) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act, 1912-1944.

(c) No worker shall be entitled to the benefit of this clause unless he produces proof satisfactory to his employer or his representative of sickness but the employer shall not be entitled to a medical certificate unless the absence is for more than one day.

(d) No payment shall be made for any absence due to the worker's own fault, neglect or misconduct, or where the worker does not notify his station of his sickness within four hours of commencing time.

## 9.—Accident Pay.

Full pay shall be paid for accidents while on duty.

## 10.—Uniforms.

All uniforms as determined by the Board shall be supplied to the employee.

## 11.—Watchroom Duty.

Watchroom duty shall be performed as required by the Chief Officer.

## 12.—Payment of Wages.

Wages shall be paid weekly.

## 13.—Membership of Union.

Every man employed as a permanent Watchroom Attendant must when assuming duty apply for membership in the applicant Union, and if elected remain a member of the Union whilst in the service of the Board.

## 14.—Term of Agreement.

Term of Agreement shall be one year from the date hereof.
