AT a meeting of the Executive Council held in the Executive Council Chamber on the 20th day of December, 1956, the following Orders in Council were issued:—

Water Boards Act, 1904-1954.

Lake Grace Water Area.

ORDER IN COUNCIL.

P.W.W.S. 649/56.

WHEREAS by the Water Boards Act, 1904-1954, and the Water Supply, Sewerage and Drainage Act, 1912, the Governor is empowered by Order in Council to constitute the district of a local authority or two or more local authorities, or any part or parts of such district or districts a water area, under such name as may be directed; and whereas, under the provisions of the said Acts, the Governor may authorise the Minister for Water Supply, Sewerage and Drainage to exercise, within a water area, all the functions of a water board: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby constitute an area, having the boundaries described in the Schedule hereunder, a water area for the purpose of the said Acts, under the name of the Lake Grace Water Area, and doth hereby appoint the Minister for Water Supply, Sewerage and Drainage to exercise all the functions of a water board under the Acts in such area.

Schedule.

All that portion of land bounded by lines starting at the South-Eastern corner of Williams Location 8986 (reserve 22716) and extending Northerly along its Eastern boundary and onwards to the South-Eastern side of the Kukerin-Lake Grace Railway

Reserve; thence North-Easterly and Easterly along the Southern sides of that railway reserve to a point situate in prolongation Southerly of the Eastern boundary of location 11879; thence Northerly to and along that boundary to the South-Western corner of location 10151; thence Easterly, North-Easterly and again Easterly along boundaries of that location and onwards to and along a Northern side of road No. 6130 and again onwards to the Western boundary of location 14092; thence Southerly along the Western boundaries of locations 14092 and 11841; thence Easterly along the Northern side of a two-chain road for a distance of 40 chains 40 and 8/10ths links; thence 179 deg. 56 min., 2 chains; thence 119 deg. 23 min., 25 chains 38 and 2/10ths links; thence 91 deg. 44 min., 12 chains 19 and 6/10ths links; thence 359 deg. 56 min., 53 chains 91 and 6/10ths links; thence 89 deg. 56 min., 70 chains; thence 179 deg. 56 min., 96 chains; thence 269 deg. 56 min., 70 chains; thence 359 deg. 56 min., 41 chains 58 and 3/10ths links; thence 271 deg. 44 min., 12 chains 33 and 5/10ths links; thence 299 deg. 23 min., 26 chains 39 links to the Northern boundary of location 14146; thence Westerly and Southerly along boundaries of that location to a point situate in prolongation Easterly of a Northern boundary of location 9747; thence Westerly, Southerly, again Westerly, Northerly, again Westerly and again Northerly to and along boundaries of that location and onwards to a point situate in prolongation Easterly of the Northern side of road No. 8424; and thence Westerly to and along that side to the starting point, all as shown in red on Plan P.W.D., W.A., 35454.

This Order in Council shall take effect on the 20th day of December, 1956.
