### Land Act, 1933-1956. PROCLAMATION

WHEREAS by section 31 of the Land Act, 1933-1956, the Governor may by Proclamation and subject to such conditions as may be expressed therein, classify as of Class "A" any lands of the Crown reserved to Her Majesty for any of the purposes specified in the said sections; and whereas it is deemed expedient as follows:—

\*Corres. No. 714/54—That the addition to reserve "A" 24033, "Public Utility," comprised in Beverley Lots 108 and 122 should be classified as of Class "A." (Plan Beverley Townsite.)

Corres. No. 1059/14—That the addition to reserve A14222, "Camping and Recreation," comprised in Denison Lots 27 and 28, should be classified as of Class "A." (Plan Denison Townsite.)

Now, therefore I, the Governor, with the advice of Executive Council, do by this my Proclamation classify as of Class "A" the additions to above reserves.

\* Area of this reserve increased to 17 acres 2 roods 12 perches.

Metropolitan Main Drainage. City of Perth Municipality. Victoria Park-Carlisle, Central Area.

- (a) Five (5) excavated drainage compensating basins numbered P1 to P5 inclusive.
- (b) Reinforced concrete pipe drains of 15in., 18in., 21in., 24in. and 30in. diameter.
  - (c) Four (4) stormwater pumping stations.
- (d) Reinforced concrete rising mains of 10in., 12in., 15in., 18in. and 24in. diameter.

The above works are shown on Plan M.W.S.S. & D.D., W.A., No. 8088.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956. Country Areas Water Supply Act, 1947-1951. ORDER IN COUNCIL.

M.W.S. 829/34.
WHEREAS by section 7 of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956, and by section 8 of the Country Areas Water Supply Act, 1947-1951, it is enacted that the Governor may by Order in Council from time to time alter the boundaries of the Metropolitan Water, Sewerage and Drainage Area, or of any district, and of a country water supply area; and whereas it is desirable to alter the boundaries of the said areas and of the Metropolitan Water and Sewerage District. of the Metropolitan Water and Sewerage District, as hereinafter described: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Acts, doth hereby order and declare as follows:—

That the boundaries of the Metropolitan Water, Sewerage and Drainage Area, and of the Metropolitan Water and Sewerage District, are hereby altered by deleting therefrom and that the boundaries of the Country Water Area formerly known as the Goldfields Water Supply Area are hereby altered by adding thereto the land described in the Schedule hereto.

All that portion of the Metropolitan Water Supply, Sewerage and Drainage Area bounded by lines starting at a point on the South-Western side of the Greenmount-Mundaring Railway Reserve situate in prolongation South-Westerly of the North-Western boundary of lot 293 of Helena Location 20b (L.T.O. Plan 4524) and extending generally South-Easterly and generally South-Westerly along boundaries of that drainage area to a point on the North-Western boundary of lot 233 situate 3 chains 40 and 9/10ths links South-Westerly from the Northernmost corner of that lot; thence North-Westerly to the South-Western corner of lot 227; thence North-North-Easterly along that boundary; thence North-Easterly to the South-Western corner of lot 3 (L.T.O.
