WHEREAS it is enacted by section 3 of the University Medical School, Teaching Hospitals Act, 1955, that where the Senate, within the meaning of that Act, is of the opinion that a public hospital is suitable for the teaching of medicine, the Senate may give written notification to that effect to the Minister who shall, as soon after receiving it as is practicable, present the notification to the Governor who may by proclamation declare the hospital to be a teaching hospital to which the provisions of the Act apply; and whereas the Senate is of opinion that the hospitals set out in the Schedule hereto are suitable for the teaching of medicine; and whereas the Senate has given written notification to that effect to the Minister who has duly presented the notification to the Governor: Now therefore I, the Governor, acting with the advice and consent of the Executive Council, do hereby declare the hospitals set out in the Schedule hereto to be teaching hospitals to which the provisions of that Act apply.
