### FREMANTLE HARBOUR TRUST ACT, 1902-1954.

Ex. Co. 951.

THE Fremantle Harbour Trust Commissioners, acting pursuant to the provisions of the Fremantle Harbour Trust Act, 1902-1954, do hereby make the regulations set out in the Schedule hereunder:—

#### Schedule. Regulations.

1. In these regulations the expression "principal regulations" means the regulations published in the *Government Gazette* on the 17th June, 1955, made by the Fremantle Harbour Trust Commissioners pursuant to the provisions of the Fremantle Harbour Trust Act, 1902-1954, as reprinted with all amendments to and including those appearing in the *Government Gazette* of the 16th November, 1956, and published as so reprinted, pursuant to the Reprinting of Regulations Act, 1954, in the *Government Gazette* of the 22nd March, 1957.

2. Regulation No. 31 of the principal regulations is amended—

- (a) by substituting for the word "Each" in line one the passage "With effect from the 1st March, 1957, each";
- (b) by substituting for the word "five" in line two the word "six";
- (c) by substituting for the word "three" in line two the word "four."

Regulations.

1. In these regulations the State Housing Act Regulations made under the State Housing Act, 1946, and published in the *Government Gazette* on the 12th August, 1949, and amended by notices published in the *Government Gazette* on the 4th August, 1950; 5th October, 1951; 25th July, 1952; 31st October, 1952; 21st November, 1952; 11th December, 1953; 16th May, 1956, and the 5th October, 1956, are referred to as the principal regulations.

2. Regulation 39 of the principal regulations is amended by substituting for the symbols and figures "£3 3s. 0d." wherever appearing in the regulation the symbols and figures "£4 4s. 0d."

## MUNICIPAL CORPORATIONS ACT, 1906-1956.

City of Fremantle.

By-law amending By-law No. 9 prescribing the conditions upon which Fruit, Fish, Meat, Poultry, Game, Vegetables and Articles of Merchandise may be Hawked and Prohibiting the Hawking of same in certain prescribed Streets, Ways and Public Places within the City of Fremantle.  
L.G. 917/53.

IN pursuance of the powers conferred by the said Act, the Mayor and Councilors of the Municipality of the City of Fremantle order as follows:—

By-law No. 9 published in the *Government Gazette* on the 9th day of February, 1934, prescribing the conditions upon which fruit, fish, meat, poultry, game, vegetables and articles of merchandise may be hawked and prohibiting the hawkking of same in certain prescribed streets, ways and public places within the City of Fremantle, is hereby amended as follows:—

Paragraph 6.—By deleting paragraph 6 and inserting in lieu thereof a new paragraph 6:—

(a) No person shall hawk any fruit, fish, meat, poultry, game, vegetables or articles of merchandise in the City of Fremantle without first obtaining a license from the Town Clerk.

(b) A licensed hawker shall not sell or offer for sale any wares in any manner other than from a basket or similar container and in any other place other than within the premises of a householder.

Passed by resolution of the City of Fremantle on the 18th day of March, 1957.

## TRAFFIC ACT, 1919-1956.

## Harvey Road Board.

## Heavy Traffic By-law.

L.G. 714/52.

THE Harvey Road Board pursuant to an order in Council under section 19 of the Traffic Act, 1919-1956, and in exercise of the power thereby conferred, doth hereby make the following by-law to have effect in the Harvey Road Board District:—

(a) A person shall not drive a vehicle on any of the roads specified in the Schedule hereto, during the period commencing on the 1st day of May and terminating on the 1st day of November in any year, if the gross weight of that vehicle, including the load carried and the tare, exceeds 75 per cent. of the gross load permissible for the class of vehicle under the provisions of the 10th Schedule to the Traffic Regulations 1954.

North Ward.—Johnston Road, West of Eckersley Road. Riverdale Road, West of Eckersley Road. Yarloop-Hoffman Road.

Central Ward.—Myalup Road, West of Government Road, Harvey-Quindanning Road. Mornington Mills Road.

South Ward.—Mornington Creek Road. Wellesley Road. Brunswick East Road to Beela. Mitchell Road, Benger. Seven Hills Road.

(b) Any person who shall commit a breach of this by-law shall be liable, on conviction, to a penalty not exceeding £20.

Previous heavy traffic by-laws as printed in the *Government Gazettes* of 16/10/36, page 1743; 11/10/46, page 1269; 14/7/50, page 1618 and 30/5/52, page 1361 are hereby repealed.

In these regulations, the Milk Act, 1946-1947, Regulations No. 4 published in the *Government Gazette* on the 15th October, 1948, as amended by the Milk Act, 1946-1948, Regulations No. 6 published in the *Government Gazette* on the 3rd June, 1949, and by notice published in the *Government Gazette* on the 13th June, 1952, are referred to as the principal regulations.

2. Regulation 63 of the principal regulations is amended—

- (a) by substituting for the word "Members" in line one the passage "With effect from the 1st March, 1957, members";
- (b) by substituting for the symbol and figures "£160" in line two the symbol and figures "£200."

## Schedule.

## Regulations.

1. In these regulations the regulations made under the provisions of the Dairy Products Marketing Regulation Act, 1934-1937, as reprinted and published in the *Government Gazette* on the 5th May, 1939, and amended from time to time thereafter, are referred to as the principal regulations.

2. Regulation 19 of the principal regulations is amended—

- (a) by substituting for the word "The" firstly appearing in line one, the passage "With effect from the 1st March, 1957, the";
- (b) by substituting for the passage "£3 3s. per day or part thereof for attendances at meetings of the Board" in lines one and two of subparagraph (a) of paragraph (1), the passage "£4 4s. for each meeting of the Board which he attends";
- (c) by substituting for the passage "£2 2s. per day or part thereof for attendances at meetings of the Board" in lines one and two of subparagraph (a) of paragraph (2), the passage "£3 3s. for each meeting of the Board which he attends";
- (d) by deleting paragraph (4).

## DRIED FRUITS ACT, 1947-1954.

Regulations.

1. In these regulations the Dried Fruits Regulations, 1956, published in the *Government Gazette* on the 23rd October, 1956, are referred to as the principal regulations.

2. The principal regulations are amended by substituting for paragraph (a) of regulation 12 the following paragraph:—

(a) Where a meeting of the Board or a conference of Dried Fruits Boards is, on or after the 1st March, 1957, held within this State or within any other State or territory of the Commonwealth, the Chairman shall be paid a fee of £4 4s. and a member shall be paid a fee of £3 3s. for each meeting or conference which the Chairman or member attends.

## PLANT DISEASES ACT, 1914-1956.

HIS Excellency the Governor in Executive Council has been pleased, under the provisions of the Plant Diseases Act, 1914-1956, to make the regulations set out in the Schedule hereunder.

Schedule.  
Regulations.

1. These regulations may be cited as the European Red Mite Regulations, 1957.

2. In these regulations, if not inconsistent with the context, the expression "the disease" means the disease known as, or caused by, the pest known as European Red Mite (*Paratetranychus pilosus*).

3. The object of these regulations is to prevent the introduction into, and the spread within this State of the disease.

4. (1) No person shall bring or cause to be brought into this State from any State or Territory of the Commonwealth specified in the Schedule to these regulations any kind of plants or fruits unless the plants or fruits are accompanied by a certificate issued by the Department of Agriculture of that State or Territory that the plants or fruits have been examined by an officer of that Department duly appointed for that purpose by the head of that Department and were found to be free from European Red Mite (*Paratetranychus pilosus*).

(2) Where it appears to an inspector that plants or fruits are brought into this State in contravention of subregulation (1) of this regulation, they shall be confiscated and destroyed by the inspector unless the person who

brought them or caused them to be so brought despatches them, at his own expense and in accordance with the directions of the inspector, to the State or Territory from which they were brought.

GOVERNMENT RAILWAYS ACT, 1904-1955.

By-laws.

1. The by-laws made pursuant to the Government Railways Act, 1904 (as amended), and published in the *Government Gazette* on the 29th October, 1920, as amended by the amendments thereto published in the *Government Gazette* from time to time thereafter are in these by-laws referred to as the principal by-laws.

2. By-law No. 41 of the principal by-laws is amended by substituting for the fourth paragraph the following paragraphs:—

Notwithstanding that a person has complied with the other requirements and conditions prescribed by these by-laws for the grant of a license he shall not be granted a license under this by-law except on the payment of a license fee in accordance with the provisions of by-law 41A of these by-laws shall terminate on the 30th June or the 31st December, as the case may be, next succeeding its date of issue but may at the discretion of the Commission be renewed for half-yearly periods expiring on those dates.

3. The principal by-laws are amended by inserting after by-law 41 a new by-law as follows:—

41A. A license fee referred to in by-law 41 of these by-laws shall be such amount, not less than ten shillings (10s.) for each half-yearly period or part thereof, as may from time to time be determined by the Commission with the approval of the Minister.

## THE UNIVERSITY OF WESTERN AUSTRALIA.

Amending Statute No. 1 of 1957.

Amendment to Statute No. 11—Academic Dress.

SECTION 2 is amended to read: The academic dress shall be for—

**Undergraduates.**—A plain black stuff gown of a pattern approved by the Professorial Board, with a band of silk half an inch wide of the colour appropriate to the Faculty placed horizontally on the breast of the gown at each side. Black cloth trencher cap.

**Scholars.**—Same as for other undergraduates, with the addition of a black velvet bar on the right shoulder of the gown.

**Bachelors.**—Black stuff or silk gown similar in shape to that worn by Bachelors of Arts of the University of Cambridge. Black silk hood of the simple plain cut shape similar to the hood worn by Bachelors of Arts of the University of Oxford, lined with silk of the colour appropriate to the Faculty and edged inside and outside with white silk to a depth of one inch. Black cloth trencher cap.

**Masters.**—Black stuff or silk gown similar in shape to that worn by Masters of Arts of the University of Cambridge. Hood as for Bachelors, but without the white edging. Black cloth trencher cap.

**Doctors of Philosophy.**—The silk M.A. gown but with a facing of scarlet cloth, four inches wide, the full length of the front. Hood as for Bachelors but without the white edging, lined with scarlet cloth. Black velvet trencher cap.

**Doctors (other than of Philosophy).**—Gown of scarlet cloth of the Cambridge Litt.D. pattern with facing four inches wide the full length of the front and fully lined sleeves of silk of the colour appropriate to the Faculty. Hood of scarlet cloth of the same shape as that prescribed for Bachelors lined with silk of the colour appropriate to the Faculty. Black velvet trencher cap.

The non-festal gown of Doctor shall be black and of the same shape as that prescribed for Masters.

**Faculty Colours.**—The following are the colours of the silk linings and facings of the dress for degrees in the several Faculties:—

Arts—Royal Blue.	Agriculture—Bronze.
Law—Royal Purple.	Dental Science—Silver Grey.
Education—Sky Blue.	Medicine—Ruby.
Economics—Flamingo.	Surgery—Ruby.
Science—Emerald Green.	Music—Peacock Blue.
Engineering—Gold.	

The Professorial Board has defined the colours mentioned in the Statute by reference to the British Colour Council Dictionary of Colour Standards (2nd Edition, 1951) as follows:—

Royal Blue (B.C.C.197).	Bronze (B.C.C.116).
Royal Purple (B.C.C.110).	Silver Grey (B.C.C.153).
Sky Blue (B.C.C.162).	Ruby (B.C.C.38).

Amending Statute No. 2 of 1957.

Amendment to Statute No. 18—Conditions of Awarding Hackett Bursaries and Hackett Studentships and Scholarships.

Subsection (2) of section 3 is amended to read:

(2) A Studentship awarded for tenure at an Australian University will be of the value of £550 per annum and in addition a travelling allowance of £25 per annum will be granted if a Studentship is taken at a University outside Western Australia.

Subsections (1) and (2) of section 4 are amended to read:

4. Hackett Scholarships shall be awarded under the following conditions:—

- (1) Postgraduate Scholarships hereinafter described as the Scholarships shall be open to graduates of the University of Western Australia and to students of that University who have satisfied the requirements of a pass degree. The Scholarships, which shall normally be tenable at the University of Western Australia but may in exceptional circumstances and with the approval of the Professorial Board be held at any other University or recognised institution in Australia,
  - (a) if awarded to a graduate, shall be of a value not exceeding £450 per annum if held at the University of Western Australia or £500 per annum if held at any other University or recognised institution within Australia and
  - (b) if awarded to a student who has satisfied the requirements of a pass degree, shall be of a value not exceeding £250 per annum for one year only.
- (2) Scholarships will normally be awarded for one year only but if held by a graduate may be renewed by the Professorial Board for a second year.

Amending Statute No. 3 of 1957.

Amendment to Statute No. 19—Professorial Board.

Section 4 is amended to read—

4. The Board, after receiving report from the Faculty or Faculties concerned, shall make all necessary arrangements for giving effect to the Statutes and regulations relating to matriculation and the various courses of study.

The Board may delegate to a Committee of its own members, to be known as the Ph.D. Committee, all or such matters relating to the degree of Doctor of Philosophy as it thinks fit.

Section 10 is amended to read:

10. Subject to any conditions laid down by the founders and accepted by the Senate, the Board shall determine the time and method of awarding Fellowships, Studentships and Scholarships, Exhibitions and Prizes, and except as may be otherwise provided by the Statutes and the regulations, shall from time to time make the awards thereof.

Subject to the foregoing provisions, the Board may delegate to a committee of its own members or to appropriate Faculties and Boards of Examiners the power to award such Scholarships, Exhibitions and Prizes as are specified in the regulations in accordance with conditions prescribed therein.

Amending Statute No. 4 of 1957.

Amendment to Statute No. 7—Matriculation or Admission to the University.

Section 2 is amended to read:

2 (1) The Professorial Board may admit to matriculant status in the University of Western Australia persons who have gained educational qualifications outside Western Australia and may from time to time delegate its authority hereunder to a committee appointed by it.

(2) Every applicant for matriculant status under clause 2 (1) above shall be required to produce satisfactory documentary evidence of his qualifications and to prove his identity with the person named in such documents.

The Common Seal of the University of Western Australia has been affixed in pursuance of an order of the Senate by the undersigned being legally entitled to the custody thereof as the Chancellor of the said body Corporate.
