ORDER IN COUNCIL.

1. Land Tax—Notice to Make Returns.

NOTICE is hereby given that every person who was at noon on the 30th day of June, 1957, the owner within the meaning of the said Act, of any land whatsoever in Western Australia and who is liable to land tax, is hereby required to make and furnish to me at the office of the Commissioner of Taxation, Perth, on or before the 31st day of August, 1957, a land tax return in the prescribed form.
