### ORDER IN COUNCIL.

WHEREAS by section 33 of the Land Act, 1933-1956, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of subleasing; and whereas it is deemed expedient as follows:—

Corr. No. 3674/55—That reserve A.24309 (Cockburn Sound Location 1746) should vest in and be held by the Cockburn Road Board, in trust for the purpose of Recreation and Camping.

Corr. No. 2497/57—That reserve 24750 (Karlgarin lot 37) should vest in and be held by the Kondinin Road Board, in trust for the purpose of Recreation.

Corr. No. 2782/55—That reserve 24738 should vest in and be held by the Upper Chapman Road Board, in trust for the purpose of a Beach Camping Resort.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall vest in and be held by the above road boards, in trust for the abovementioned purposes with power to the said road boards (subject to the approval in writing of the Minister for Lands in the case of reserves A24309 and 24750) to lease the whole or any portion of the said reserves for any term not exceeding 21 years from the date of the lease.

### Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956.

Enlargement of existing Detritus Tanks; conversion of old Septic Tanks to Pre-Aeration Tanks and Pilot Activated Sludge Plant; diversion of Shenton Park Main Drain to the Ocean Outfall; one Primary Sedimentation Tank; one Aeration Tank; two Final Sedimentation Tanks; two Sludge Thickening Tanks; one Primary Digester; one Gas Holder; additional Sludge Drying Beds; Machinery House; Workshops and Administration Building; together with all other apparatus connected therewith.

to an East boundary of Pastoral Lease 394/768; thence North, West and South along boundaries of that pastoral lease the aforesaid East-West line; thence West to a point situate South of the East-ernmost boundary of Pastoral Lease 394/765; thence North and West to and along boundaries of that pastoral lease to its Northernmost North-West corner; thence Westerly to and along the South boundary of late Pastoral Lease 3393/96 to the Easternmost boundary of Pastoral Lease 394/766; thence North along that boundary and the East boundary of Pastoral Lease 394/455 to the South-ernmost South-West corner of late Pastoral Lease 2175/96; thence East along the Southernmost boun-dary of that late pastoral lease to the East boun-dary of that late pastoral lease to the East boun-dary of Pastoral Lease 394/1241; thence North along that boundary; thence East, North and West along boundaries of Pastoral Lease 394/1115 to the thence West to a point situate South of the Eastalong boundaries of Pastoral Lease 394/1115 to the South-East corner of late Pastoral Lease 334/1113 to the thence North along the East boundary of that late pastoral lease to the Northernmost boundary of Pastoral Lease 394/1432; thence West and South along boundaries of that pastoral lease to the North-ernmost boundary of late Pastoral Lease 2175/96 aforesaid; thence West along that boundary to the East boundary of Pastoral Lease 394/458; thence North, West, again North, again West, again North and again West along boundaries of Pastoral Leases 394/458 and 394/456 to the South-East corner of Pastoral Lease 394/460; thence North and West along boundaries of that pastoral lease to the left bank of the Hardey River; thence generally North-Easterly, upwards, along that bank to a line joining the summit of Mount Lionel and the North-West corner of late Pastoral Lease 1757/96; thence Northerly along that line to the summit of Mount Lionel aforesaid; thence North-Westerly along a line joining the lastmentioned point and survey mark ¥13 to the Southernmost boundary of Pas-toral Lease 394/1283; thence West, North and again Wort close boundary of the moutanel the survey for West along boundaries of that pastoral lease to a point situate South of an East boundary of that pastoral lease; thence North to and along that boundary and onwards to a line joining survey mark Y13 aforesaid and the survey mark on Mount Pira: thence Wort, North Westorly along that line Riga; thence West-North-Westerly along that line to the North-South line passing through the survey mark on Mount Elvire aforesaid; thence North to a point situate East of the Southernmost boundary of Pastoral Lease 394/978; thence West, North, East, again North, again East and again North to and along boundaries of that pastoral lease to the South-West corner of Pastoral Lease 394/1312; thence East, North and again East along boundaries of Pastoral Leases 394/1312 and 394/978 aforesaid to the North-South line aforesaid; and thence North along that line to the starting point. (Public Plans 91/300, 92/300, 96/300, 97/300, 98/300, 110/300 and 111/300.)

### Schedule B. Ward Boundaries. Town Ward.

All that portion of the Tableland Road District bounded by lines starting at a point situate 204 deg. 31 min., 23 chains 50 links and 294 deg. 31 min., 24 chains 25 links from the Western corner of Wittenoom Gorge Town Lot 44 and extending 24 deg. 31 min. to the South-Western boundary of town lot 359 (reserve 23864); thence North-Westerly, North-Easterly and South-Easterly along boundaries of that lot to a point situate in prolongation South-Westerly of the North-Western boundary of town lot 357 (reserve 23863); thence North-Easterly and South-Easterly to and along the North-Western and North-Eastern boundaries of that lot and onwards for a distance of 30 links to the North-Westerly along that side for a distance of 5 chains 50 links; thence 114 deg. 31 min., 70 chains 75 links; thence 204 deg. 31 min., 80 chains; and thence 294 deg. 31 min., 80 chains to the starting point. (Public Plans Wittenoom Gorge Townsite and 97/300.) (Two members.)

All that portion of the Tableland Road District bounded by lines starting at the intersection of an Eastern boundary of that road district and the

Provided however, that nothing herein contained shall be deemed to reduce the rates now paid to any junior worker employed at the date of the Award.

(d) Notwithstanding that the rates above are expressed in weekly amounts, it is hereby declared that the contract of service is a daily contract subject to clause 24.

#### 6.—Allowance.

In addition to the basic wage and the margin mentioned in clause 5, each of the adult workers employed in any portion of the employer's operations conducted at a distance of ten (10) miles or more from the Kalgoorlie Post Office shall be entitled to an allowance at the rate of eight shillings (8s.) per week, payable for each day upon which the worker is so employed or is available and willing to work. This allowance shall also apply to pieceworkers.

#### 7.-Tool Allowance.

Where a woodcutter (including a pieceworker) is required to supply his own tools, a tool allowance at the rate of ten shillings (10s.) per week shall be paid.

### 8.—Hours of Duty.

Forty (40) hours shall constitute a week's work to be worked in five days of eight (8) hours each Monday to Friday inclusive except in the case of quad drivers, who shall work the forty (40) hours to suit the requirements of the employer's business. But in no case shall such quad driver be required to be on duty for more than twelve (12) hours on any day without payment for overtime for such day: Provided further, however, that overtime shall not be cumulative.

#### 9.—Overtime.

(a) Subject to subclause (c) and clause 15 hereof, all work performed beyond the specified hours of duty on any ordinary day and on Saturday, shall be paid for at the rate of time and a half for the first two (2) hours and double time thereafter. Work done on Sundays and holidays shall be paid for at the rate of double time.

(b) When computing overtime the district allowance shall not be computed as an addition to the day's pay.

(c) When work is done in connection with repairs to machinery necessary to enable work to be safely resumed, workers acting as assistants to the fitter, or fitters engaged on the work, shall be entitled to the margin usually paid to a fitter's assistant, but the rate for overtime shall be the same as that prescribed in the Engineering Award for work done in such circumstances.

(d) When a worker is recalled to work after leaving the job, he shall be paid for at least two (2) hours at overtime rates.

(e) When a worker is required for duty during any meal time, whereby his meal time is postponed for more than one (1) hour, he shall be paid at overtime rates until he gets his meal.

(f) When a worker employed at the Lakewood Depot, without being notified on the previous day, is required to continue working after the usual knock-off time for more than one (1) hour or (in the case of a day worker) after 6 p.m., whichever is the later, he shall be provided with any meal required or shall be paid three shillings and sixpence (3s. 6d.) in lieu thereof. Provided that this subclause shall not apply to any worker who can reasonably return home for a meal.

(g) Notwithstanding anything contained in this Award—

- (i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.
- (ii) No organisation, party to this Award, or worker or workers covered by this Award shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

### 10.—Rest Period After Overtime.

(a) When overtime work is necessary, it shall, whenever reasonably practicable, be so arranged that workers have at least eight (8) consecutive hours off duty between the work of successive days.

(b) When a worker (other than a casual worker) has not had at least eight (8) consecutive hours off duty between his usual finishing time on one day and his usual starting time on the next day the following provisions shall apply:—

- (i) He shall if he so desires, be entitled to have eight (8) consecutive hours off duty from the completion of his overtime work until he next commences work, but shall not be paid for such time off duty.
- (ii) If on the instructions of the employer, he continues or resumes work at his ordinary starting time without having such eight
  (8) hours break, he shall be paid at overtime rates for the balance of the hours less than eight (8) which he has not had off duty. Hours of overtime actually worked since his last usual finishing time, shall be counted in computing the actual rate of overtime under this paragraph.
- (iii) If a worker of his own volition, continues or resumes work at his ordinary starting time without such break, he shall be paid at ordinary rates.

### 11.—Holidays.

(a) Subject to clause 9 hereof, the following days, cr the days observed in lieu, shall be holidays without deduction of pay, namely:—Christmas Day, Labour Day, Easter Monday, and one other day to be nominated by the employer.

(b) Liberty is reserved to the Union to apply for an additional holiday and to the respondents to apply to amend this clause.

### 12.—Annual Leave.

(a) Subject to the proviso herein, three (3) weeks' holiday on full pay shall be granted once in each year to every worker: Provided he has worked two hundred and forty two (242) working days at ordinary rates of pay. Should he have worked on less than two hundred and forty-two (242) working days, when the said holiday is taken, or at the termination of his employment, he shall be paid for or allowed a proportionate number of holidays. Payment for the said holidays shall be at the rate of pay the worker is receiving immediately before the holiday is taken or employment terminated.

(b)Pieceworkers shall be entitled to be paid, when on holiday, the minimum rate for their grade.

(c) Any worker who has taken part in a strike (including a slow strike) or a general or sectional stoppage of work unauthorised by the employer during the period of service in respect of which the abovementioned annual holidays are granted, shall forfeit one day of such annual holidays for every day or part of a day during which he takes part in a strike, or in such unauthorised stoppage of work.

(d) Where a worker is dismissed for wilful misconduct, he will not be entitled to the benefits of this clause.

(e) If any of the holidays prescribed in clause 11 of this Award falls during a worker's period of annual leave, and is observed on a day which in the case of that worker would have been an ordinary working day, the worker shall be paid one extra day at ordinary rates for that day or at his option have one day on full pay added to that period for each such holiday.

(f) This clause shall not apply to casual workers.

#### 13.—Absence Through Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week for each completed month of service: Provided that, subject to subclause (g) hereof, payment for absence thorugh such ill-health shall be limited to one (1) week in each calendar year.

(b) Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(c) This clause shall not apply when the worker is entitled to compensation under the Workers' Compensation Act.

(d) A worker shall not be entitled to receive any wages from his employer for any time lost through any accident not arising out of or in the course of his employment or for any accident wherever sustained arising out of his own wilful default or for sickness arising out of his own wilful default.

(e) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(f) Notwithstanding the provisions of subclause (e) hereof, a worker who in any calendar year has already been allowed paid sick leave shall not be entitled to payment for any further absence unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

(g) Sick leave shall accumlate from year to year so that any balance of the period specified in subclause (a) of this clause which has not been allowed in any year to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year. Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

(h) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to payment under this clause.

#### 14.—Wet Pay.

Any worker on day work required to work in wet places shall be paid one shilling and fourpence (1s. 4d.) per shift extra.

Wet places shall mean places where the water is over the worker's boots.

### 15.—Shifting Camps.

(a) When for the purposes of the employer's operations workers are required to shift their own camps, they shall be entitled to an allowance for the time necessarily occupied in dismantling, loading, travelling, unloading and re-erecting their camps, not exceeding one half  $(\frac{1}{2})$  day's pay, at their prescribed ordinary day work rates.

(b) If required to shift camps and/or equipment other than their own, they shall be entitled to payment at their prescribed ordinary time rate for such time as they are so engaged; provided that on Saturdays and Sundays the rate payable shall be as prescribed in clause 9 hereof.

#### 16.—Subcontracting.

(a) All the terms and conditions hereinafter set forth, as far as applicable to them respectively, shall be observed and carried out by the employer itself, and by its subcontractors, and also by the workers, anything which herein may be read to the contrary notwithstanding.

(b) For the more effectively securing the due observances and performances of the last preceding clause, and the carrying out of the terms and conditions hereinafter mentioned, the employer, so far as concerns its own acts, and so far as permitted by law, agrees that no subcontractors under it shall be allowed to operate on or use the lines, lands, and/or places under the control of the employer for the purpose of supplying firewood without such person or company first having agreed in writing to the terms and conditions of this Award. (c) Before any subcontractor shall be allowed to commence operations on or use any of the said lines, lands and/or places controlled by the employer, he shall notify in writing the secretary of the Union whose members are affected that such subcontractor has agreed in writing to the terms and conditions of this Award.

#### 17.—Stores and Supplies.

(a) The employer shall sell stores and supplies to the workers at Kalgoorlie cash prices.

(b) The employer shall deliver all stores required at least three (3) times per week. Present arrangements for delivery to camps shall continue. In any place where stores are left at or near the railway line, to be taken delivery of by the workers, a suitable safe or other receptacle protected from weather and sun shall be provided by the employer for the reception and protection of such stores.

(c) In the case of goods delivered from the employer's bush stores other than by train, the employer shall provide some person to distribute the goods to the men's camps.

### 18.---Water.

(a) Good drinking water shall be supplied free to all workers, and, in the case of bush workers, shall be delivered into tanks along the line where the men are working, and in no case shall the distance between the tanks be more than half  $(\frac{1}{2})$ a mile.

(b) If required and as soon as practicable tanks shall be fitted with taps.

### 19.—Mixed Functions.

Any worker carrying out work classified at a higher minimum than his ordinary rate shall be paid at the rate of such work for the whole of that shift.

### 20.—Casual Workers.

Any worker dismissed through no fault of his own before the expiration of one week of his employment shall be considered casual and shall receive ten per cent. (10%) above the rate specified for the work performed. This clause shall not apply to pieceworkers.

### 21.—Weighing of Wood.

Wagons shall be taken across the weighbridge and weighed in the presence of the workers' representative. The weight then ascertained shall be taken as final. Delivery between the cutters and the employer shall be completed when the wood has passed the weighbridge and the weight has been ascertained unless otherwise agreed to.

#### 22.—Mining and Sawmill Timber.

Cutting of mining or sawmill timber may be done by day workers at a margin rate of one pound twelve shillings and sixpence (£1 12s. 6d.) per week, if done by piecework, the piecework rates shall be such as may be mutually agreed upon. Should a difference arise on this question the matter shall be determined as provided by clause 30 of this Award.

### 23.—Existing Customs.

All existing customs and conditions prevailing at the time of this Award and not altered by this Award shall not be varied, unless by mutual consent of the parties thereto, and the workers and the employer shall not be deprived of any privileges or rights hitherto enjoyed, nor shall any new conditions detrimental to the interests of either of the parties be imposed unless specifically mentioned herein.

### 24.—Full Payment for Shift.

(a) After beginning a shift a worker shall not be paid for less than a full shift, unless he leaves work of his own accord, or is dismissed for misconduct. This shall not apply in matters beyond the control of the management.

(b) If before a worker leaves the works at the end of his shift he is not informed that his services are not required, and because he is not so informed he attends at the next shift willing to work it, and there is not suitable work which he is allowed to perform, he shall be paid the wages he would have been entitled to as if he had worked the shift he was willing to work.

(c) This clause shall not apply in matters beyond the control of the management.

#### 25.—Record.

The employer shall keep or cause to be kept a record showing the names of each worker, the shifts worked and the wages and allowances paid. Such record shall be open for inspection to a duly accredited representative of the Union, during the usual office hours, at the employer's head office or other convenient place, and he shall be allowed to take extracts therefrom.

#### 26.—First-aid.

(a) The employer shall provide at the Lakewood Depot, and the bush terminal, first-aid equipment fully and efficiently supplied. A first-aid box shall be supplied at each fettling gang camp.

(b) If no person possessed of recognised first-aid qualifications is at present employed at each camp at or in the vicinity of which upwards of fifty (50) of the employer's workers are engaged, the employer shall, when engaging workers, give preference to at least one worker so qualified, if he is competent to perform the service required by the employer.

(c) Any first-aid man appointed by the employer to perform first-aid duties shall be paid an allowance of two shillings and sixpence (2s. 6d.) per shift in addition to his ordinary rate of pay.

#### 27.—Payment of Wages.

(a) Pay day shall be at least once every month, not later than the second Friday of the month, provided that workers employed at the Lakewood Depot shall be paid in two instalments in each month.

(b) Any worker leaving or being discharged shall be paid the full amount of wages due to him within one (1) hour from the time of his application at the employer's office during office hours.

#### 28.—Travelling Accommodation.

When the employer supplies a motor quad or a kalamazoo to convey navvies to and from their working place, they shall travel one way in their own time and one way in the employer's time.

### 29.—Preference.

(1) Preference of employment shall be given to financial members of the Australian Workers' Union or to persons who give to the employer an undertaking in writing to make application to join such Union within one month of accepting employment. Provided that—

- (a) there are members of the said Union or intending members applying as aforesaid, equally qualified with other workers offering their services to perform the particular work required to be done and ready and willing to undertake the same; and
- (b) the rules of the Union shall permit any worker of good character coming within the scope of this Award to become a member of the Union upon payment of the subscription and/or entrance fee prescribed by the registered rules.

(2) Where a worker, not having been a member of the said Union at the time of his engagement, applies for membership of the Union within one month after his engagement, it shall be deemed that no question of preference has arisen unless and until his application is rejected for good cause.

(3) If during the continuance of this Award anything in the nature of a strike occurs in the industry hereby regulated, or if there is any restriction in output by the workers or any section thereof acting in concert, the benefit of this clause shall thereupon cease and determine. For further assurance and without modification of or prejudice to the foregoing provisions of this sub-clause, the employer may at any time apply to the Court, upon giving seven (7) days' notice to the Union, for a declaration hereunder and the consequential cancellation of this clause, and the Court, upon cause being shown, shall make a declaration and order accordingly.

(4) The provisions of this clause shall not apply to junior workers or apprentices.

### 30.—Board of Reference.

(a) The Court hereby appoints, for the purposes of the Award, a Board of Reference.

(b) The Board shall consist of a chairman who, failing agreement between the parties, shall be appointed by the Court, and two (2) other representatives, one to be nominated by each of the parties.

(c) There shall be assigned to such Board the functions of:—

- (i) deciding matters specifically referred to in the Award as being the subject matter of a decision of the Board;
- (ii) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award, or any of them;
- (iii) deciding all matters and questions referred to in the Award as being the subject of mutual agreement, if not agreed upon;
- (iv) deciding any other matter that the Court may refer to such Board from time to time.

(d) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in and form part of this Award (Regulation 106).

(e) There shall be no cessation of work pending the reference to and the settlement of any dispute by the Board.

### 31.—Sanitary Arrangements.

The employer shall provide sufficient sanitary conveniences of an approved type for the use of his workers.

### 32.—General Conditions of Piece Work.

(a) Except in the case of wheel or curve blocks, the minimum frontage shall be two (2) chains for each man in any one party, with a maximum frontage of six (6) chains, irrespective of the number of men in the party. In the case of double banking, the original cutter shall have the choice of ends.

(b) Cutting or splitting shall be left to the option of the cutters so that they shall not be idle whilst firewood is being carted from the back of their blocks.

(c) If two (2) or more parties of cutters require blocks at the same time, they shall draw lots for precedence, and the bush boss shall conduct the drawing and measure out the blocks and distribute them between the cutters. Subject to the order of drawing, cutters shall be supplied with new blocks as soon as they have cut out their old blocks: Provided their services be required. No cutter shall take a block on his own authority.

(d) In the event of trees being unsuitable to cutters, such trees need not be felled. If a dispute arises as to what constitutes unsuitable trees, the bush boss and the workers' representative shall decide the question. If they cannot agree, the trees in dispute shall be felled and cut and loaded by the cutter at the time rate of pay.

(e) Camps shall be placed so that cutters shall not have to walk more than a mile to the front of the block where they are working.

(f) Wood shall be railed within three (3) weeks from the time the blocks are cleaned up, and, so far as possible, in the order in which it is carted.

(g) Blocks shall be cleaned up at least once per month.

(h) Wood burnt on rail trucks shall be paid for at tonnage rates, based on the average weight of the rake. (i) Wood belonging to each cutter or party to be loaded into rail trucks separately as far as practicable, except when cleaning up the line.

(j) Cutters shall peg their blocks from a point to a line as directed by the bush boss and the employer shall clear the tip.

(k) Cutters who are desirous of leaving their blocks shall give the employer notice, and their wood shall be trucked and paid for within twentyfour (24) hours after carting, and payment forwarded, when necessary, by registered letter to any address left by the worker. This shall also apply to cutters who have severed their connection with the employer.

(1) Cutters may obtain advances in cash or stores from the employer up to seventy-five per cent. (75%) of the estimated value of the sum coming to them for wood or timber lying out on their blocks, or on the line; the value of such stores or supplies to be taken as payment or part payment for any such wood or timber.

(m) (i) The wood shall be cut in accordance with the following extracts from the mine specifications, viz.: The employer shall supply firewood of locally grown timber other than black oak, in lengths of five (5) feet, with a diameter, if unsplit, of not more than ten (10) inches nor less than three (3) inches at either end, but, if the firewood exceeds ten (10) inches at both ends but does not exceed twelve (12) inches at both ends, the same shall be split in half, and, should the firewood exceed twelve (12) inches at both ends, shall be split in four (4) pieces.

(ii) All cutting shall be done in a face either from the back of block inwards or from the front outwards. All suitable timber shall be cut into firewood lengths and sizes as specified herein.

(iii) In the event of the cutter having unsplittable logs on hand, the price for same shall be arranged between the bush boss and the workers' representative, who shall decide, if necessary, the question of whether any log is unsplittable or not.

(n) Motor trucks shall be supplied to clean up blocks as soon as possible after they have been cut cut. If cutters are idle for more than one day whilst waiting for motor trucks, or to shift camp, the employer shall find work for such cutters, for which they shall be paid at the rates prescribed in clause 5 hereof for the class of work performed.

(o) Cutters called out by the employer to load on Saturdays shall be paid wages at the rate of time and a half for the first two (2) hours and double time thereafter and on Sundays at the rate of double time.

(p) (i) The term "culled bush" shall be deemed to mean a block from which firewood or mining timber has previously been removed, to such an extent as to leave the block so deficinet in firewood as to militate against the average firewood cutter's ability to produce approximately his normal output. The amount of extra payment to which a cutter shall be entitled under this clause for cutting in "culled bush" shall be determined in accordance with the formula laid down by the Chairman of the Board of Reference on 7th January, 1946.

(ii) A firewood cutter required to work in culled bush shall be paid at the rate of not less than threepence (3d.) per ton extra. Any dispute arising out of the application of this portion of the subclause shall be determined in accordance with the provisions of clause 30 of this Award.

(q) The cutter shall place his wood in heaps convenient for the driver.

#### 33.—Piecework.

(a) An employer may make a contract with a worker or group of workers for payment by results by piecework.

(b) All disputes between the employer and workers, or groups of workers, or between the employer and the Union, concerning any matter relating to piecework rates shall, in default of agreement, be referred to a Board of Reference for determination. (c) All contracts for piecework shall be fixed on the basis that they shall be sufficient to yield to a worker of average capacity over a period of three (3) months, using reasonable effort during the whole of the prescribed working day or week, the time worker's rate plus at least ten per centum (10%).

(d) A worker working under any system of payment on piecework shall receive at least the time rates of pay which he would have been entitled to under a contract of daily service (overtime, if any, not included) at the rates prescribed herein. For the purpose of ascertaining whether a pieceworker is receiving less than the minimum rate under this subclause, the total earnings of such pieceworker for the period of the last preceding one (1) month shall be averaged. The figure of nine shillings (9s.) per ton for five (5) foot greenwood on a basic wage of five pounds seven shillings and fivepence (£5 7s. 5d.) to be used as a basis for calculations and adjustments.

(e) In the case of a worker who has not had three (3) months' experience the minimum rate guaranteed under the preceding subclause hereof shall be such as may be mutually agreed upon between the representatives of the Union and the bush boss in each case and, in the event of their disagreement, may be referred to the Board of Reference for final determination. Each such inexperienced worker shall during this term be deemed to be an apprentice. At the end of each period of six (6) months the employer shall furnish the Registrar with a return showing the number of workers employed under this subclause and the wages and/or other payments made to each.

(f) Notwithstanding any alteration in the basic wage, the piecework rates shall remain constant until reviewed in accordance with the provisions of this clause. Until new piecework rates are fixed, any increase or decrease in the basic wage since the piecework rates were last fixed, shall be added to or deducted from the worker's earnings respectively.

(g) Junior workers over the age of fifteen (15) years may be employed at piecework at the rates as set out in this clause: Provided that any such junior worker is the son (natural or adopted) of a person employed by the employer and that the worker is with his father or guardian or some other worker approved by his father or guardian and employed by the employer. The employer shall not be liable to pay to any such junior worker the amounts required by this clause for the purpose of basic wage adjustments, except to the extent that such increases bear to the junior workers' rates on a pro rata basis; nor to make up the earnings to the minimum time rate of pay as prescribed by clause 15 hereof.

### 34.-Under Rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.

(c) Pending the Board's decision, the worker shall be entitled to work for or be employed at the proposed lesser rate.

(d) The wages of under-rate workers shall rise or fall on a pro rata basis, in conformity with the rise or fall in the basic wage.

#### 35.—Junior Worker's Certificate.

Junior workers, upon being engaged, shall, if required, furnish the employer with a certificate containing the following particulars:—

(1) Name in full.

(2) Age and date of birth.

No worker shall have any claim upon an employer for additional pay, in the event of the age of the worker being wrongly stated on the certificate. If any worker shall wilfully misstate his age in the above certificate, he alone shall be guilty of a breach of this Award.

#### 36.—Change Rooms.

(a) A suitable change room shall be provided at the Lakewood Depot for enabling the persons employed to conveniently dry and change their clothes. Hot and cold water shall be supplied in such change room.

(b) Suitable shower facilities shall be provided at all bush camps.

### 37.—Accidents and Transportation.

In the case of a worker suffering from a serious injury sustained on the job, an attendant shall accompany the sick or injured person to the nearest doctor or hospital. The employer shall provide transport to the nearest doctor or hospital and shall also pay wages to the attendant for the actual time occupied in such travelling.

#### 38.—Re-Employment After Accident.

Any worker who, as a result of his employment, suffers an accident, and following treatment is certified by his doctor as fit to resume work, shall, if and when practicable, be re-employed.

I certify pursuant to section 65 of the Industrial Arbitration Act, 1912-1952, that the foregoing is a copy of the agreement arrived at between the parties mentioned above.

### INDUSTRIAL AGREEMENT No. 4 of 1957. (Registered 19th June, 1957.)

THIS Agreement made in pursuance of the Industrial Arbitration Act, 1912-1952, this 4th day of June, One thousand nine hundred and fifty-seven between the Swan Brewery Company Limited; the Emu Brewery Limited; and the West Australian Glass Manufacturers Limited; and Union Maltings Proprietary Limited, all of Perth and Fremantle (hereinafter in these presents called "the Employers") of the one part, and the Breweries and Bottle Yards Employees Industrial Union of Workers, of Western Australia, of Perth being an industrial union of workers registered under the provisions of the Industrial Arbitration Act, 1912-1952 (hereinafter in these presents called "the Eunion") of the other part; whereby it is mutually agreed by and between the parties hereto that the several stipulations, conditions and provisions set out herein shall, in all cases, be binding upon and shall be faithfully and promptly carried out, observed, performed and complied with according to the true intent and meaning thereof by the parties hereto and it is also hereby mutually agreed by and between the parties hereto that this Agreement shall apply to the whole of the employees embraced in the Schedule herein contained.

#### 1.—Interpretation.

For the purpose of this Agreement-

- (a) "Casual hand" shall mean any person who is not employed continually for more than 40 ordinary working hours 7.30 a.m. to 5.30 p.m.
- (b) "Cylinder man" whenever used in this Agreement shall mean a worker who is generally employed at a majority of the undermentioned occupations, namely, filling, preparing, carbonating and racking beer from a chilling cylinder, but shall not mean any employee who is casually employed in any of the last-mentioned processes.
- (c) "Bottle-washer" shall mean any person employed washing bottles by hand or machinery.

- (d) "Fireman" shall mean a person employed in a stokehold attending a steam boiler or gas-producing plant.
- (e) "Nightcellarman and nightmalsters" shall apply only to cellarmen and malsters who are employed on night duties.
- (f) "Leading hands" are employees who are in charge of and responsible for the work of others.
- (g) "Month" shall mean calendar month.

#### 2.—Wages Schedule.

The parties to this Agreement mutually agree that the minimum rate of wages that shall be paid by the employers respectively to the persons employed by such employers in the capacities undermentioned is as follows:—

(a) Basic Wage: Within a radius of 15 miles from the G.P.O., Perth—

Workers in cold rooms or cellars with a temperature of less than 45deg. Fah. shall be paid 5s. per week in addition to the minimum rate.

Malsters working on permanent night duties at the Swan Malt House shall be paid an allowance of sixteen shillings (16s.) per week in addition to the ordinary rate of pay. Boiler cleaning which shall include scraping, cleaning and painting cylinders. For all time which they may be employed at this class of work, workers shall be entitled to be paid at the rate of one shilling (1s.) per hour in addition to the rates prescribed herein for their ordinary classification.

Ammonia Coils.—For all time which they may be employed chipping, cleaning, scraping, or painting ammonia coils workers shall be entitled to be paid at the rate of one shilling (1s.) per hour in addition to the rates prescribed herein for their ordinary classification, and whilst so engaged shall be supplied free with goggles, pullovers and respirators and allowed reasonable time before the end of each shift to cleanse themselves.

Coal Handling .--- Workers employed on breaking, crushing, and handling coal in bunkers or bins shall, for all time whilst so engaged be entitled to be paid at the rate of 6d. per hour in addition to the rates prescribed herein for their ordinary classifications. Boots: The employers agree to supply boots to those workers employed at bottle washing on the tanks, at the tubs, at the filters, at the cask-washing shed, and at the bottlers, to be worn during working hours, same to be supplied free of cost by the employers. Oilers and aprons: The employers agree to provide oilskin coats and leather aprons for carters, to be used whilst the employer's work is being done only. Overalls: The employers will provide overalls for those employees engaged in clearing boilers or economisers whilst so engaged. The overalls will remain the property of the employers and will be retained after com-pletion of the tasks. They will then be cleaned for future re-issue and use for the same purposes. In the case of the employers the Swan Brewery Company Limited, the Emu Brewery Limited and West Australian Glass Manufacturers Limited the abovementioned minimum rate of wages shall be deemed to have been payable by such employers in respect of all time worked on and after the fourteenth day of December, One thousand nine hundred and fifty-six and in the case of the employer Union Maltings Proprietary Limited such minimum rate of wages shall be deemed to have been payable by it in respect of all time worked on and after the 12th day of December, One thousand nine hundred and fifty-five.

#### 3.—Hours.

Forty hours shall constitute an ordinary week's work for all workers. Such hours shall (except as to shift workers) be worked on the following basis:---

- (a) All workers other than those mentioned in sub-clauses (b) and (c) hereunder:
   Five-day week, Mondays to Fridays inclusive, 8 hours per day, to be worked within a spread of hours of 7.30 a.m. to 5.30 p.m. with one hour for lunch.
- (b) Firemen: Five-day week, Mondays to Fridays inclusive, eight hours per day, starting time not before 5 a.m. on any day. The employer may require any fireman to start work at any time after 5 a.m.
- (c) Night cellarmen and night maltsters: Fiveday week, Mondays to Fridays inclusive, eight hours per day, starting time not before 4.30 p.m. nor after 2 a.m. on any ordinary working day.

#### 4.—Shift Work.

(a) Workers may be employed:-

- (i) On "regular shift work" that is in regular rotation from week to week on two or three shifts spread over 16 or 24 hours respectively day shift to be worked from 7.30 a.m. to not later than 3.30 p.m. afternoon shift from 3.30 p.m. to not later than 11.30 p.m. and night shift from 11.30 p.m. to not later than 7.30 a.m.
- (ii) On "casual shift work" that is on one weekly shift only worked in any department, casual, day, afternoon, and night shifts to start and finish at the times respectively referred to in the preceding paragraph.

(b) In the case of both regular and casual shift work the first shift of the week will begin on Sunday at 11.30 p.m. and the last shift of the week shall finish at 11.30 p.m. on Friday. Duty rosters shall be posted on Friday in each week and shall show the starting and finishing times of each worker during each week. Particulars relating to starting and finishing times shall be rigidly adhered to.

(c) The provisions contained in the previous sub-clauses of this clause may be varied by mutual agreement between any employer and the Union.

(d) All workers employed on regular afternoon and night shift work shall be paid an allowance equal to 10 per cent. of their ordinary weekly rate of pay.

(e) All workers employed on casual night shift work shall be paid an allowance equal to  $12\frac{1}{2}$  per cent. of their ordinary weekly rate of pay.

(f) A crib time of 30 minutes shall be allowed to the permanent night maltsters employed at the Swan Malt House and to all workers whether on regular or casual shift. Crib time shall be included in the working time.

(g) The additional allowances mentioned in subclauses (d) and (e) hereof shall be taken into consideration in calculating overtime rate for any overtime for work done beyond eight hours per day on Mondays to Fridays inclusive. Except as aforesaid the above allowances shall not be included for purpose of calculating any other penalty rates under this Agreement.

#### 5.—Overtime.

(a) The following overtime shall be paid for at the rate of time and a half:—All time up to four hours worked:—

- (i) Over eight hours per day on Mondays to Fridays inclusive.
- (ii) Outside the starting and finishing times mentioned in clause 3 (a) and before the starting time of 5 a.m. and 4.30 p.m. mentioned in clauses 3 (b) and (c) respectively.
- (iii) In the case of shift workers outside rostered starting and finishing times.
- (iv) On Saturday.

(b) All overtime in excess of four hours worked during the periods referred to in sub-clause (a) shall be paid for at the rate of double time.

(c) Subject to any alteration by mutual arrangement, all workers on day work engaged in or about a brewery or bottling works shall if required to work more than one hour's overtime, after the usual finishing time be entitled to knock off for one hour after the usual finishing time for refreshments in which event, if notice of overtime has not been given at least 24 hours previously, tea money shall be paid at the rate of six shillings (6s.) but where food is provided by the employer tea money shall be reduced by the cost of the food provided. If notice of overtime has been given at least 24 hours previously tea money shall be paid at the rate of four shillings (4s.) and where food is provided by the employer tea money shall be reduced by the cost of the food provided.

### 6.—Lunch Intervals.

The lunch intervals of 60 minutes shall be taken between 12 o'clock noon and 1 p.m. or between 1 p.m. and 2 p.m.

#### 7.—Smoke-o.

Ten minutes shall be allowed at 10 o'clock a.m. and again at 3 o'clock p.m. This concession however, does not apply to men working on shifts.

#### 8.—Casual Hands.

Casual hands shall be paid by the hour at the rate of ordinary pay plus two shillings (2s.) per day.

#### 9.—Record.

Each employer shall keep a record of the name of each worker except stablemen, the time he starts and finishes each day, total number of hours worked, overtime worked, and wages paid to each worker, and such record shall be open to the inspection of the secretary of or any other person appointed by the Union during working hours. Each worker shall sign the record kept for all moneys received by him.

#### 10.—Sundays.

All work performed by workers in any department on Sunday and Easter Saturday shall be paid for at the rate of double time. All workers required to work on Sundays shall be allowed one Sunday off per fortnight: Provided that the employer may, in an emergency, require such workers to work on consecutive Sundays.

#### 11.—Holidays.

All work performed by workers in any department on the undermentioned holidays shall be paid for on an hourly basis at a rate equal to one and one half  $(1\frac{1}{2})$  times the ordinary rate of pay per hour with a minimum of four (4) hours' pay and in addition such workers shall be paid one (1) day's pay for the holiday. All holiday shifts shall rotate. One ordinary day's pay shall be paid for the undermentioned holidays to workers who do not work that day.

The days to be observed as holidays according to the provisions of this Agreement are Christmas Day, Boxing Day, New Year's Day, Anniversary Day (in January), Annual Picnic Day, Good Friday, Easter Monday, Anzac Day, Labour Day, Foundation Day (in June), Show Day, and Sovereign's Birthday. In case any of the above holidays falls on a Saturday or a Sunday the following Monday shall be observed in lieu thereof.

#### 12.—Annual Leave.

(a) An employer shall grant an employee who completes twelve (12) months' service three (3) weeks' annual leave; such leave to be taken at times to be mutually agreed upon between the employees and their respective employers. The annual leave shall be in addition to the holidays mentioned in clause 11 hereof.

An employer shall pay to an employee who has been continuously employed for more than one (1) month but less than three (3) months an amount equivalent to one and one quarter  $(1\frac{1}{4})$  day's pay in respect of each completed month of service; and to an employee who has been continuously employed for more than three (3) months an amount equivalent to two and one twelfth (2.1/12th) days' pay in respect of each completed month of service. The said payments shall be made to an employee entitled thereto:—

- (a) on the termination of his service if such termination occurs before he takes his annual leave; or
- (b) on the taking of his annual leave if he remains in the service of his employer.

An employer shall set aside and/or credit to an employee's account from time to time sufficient money to cover the said payments so that unless that employee's service is terminated earlier there will be available for him at the time he takes his annual leave a sum equivalent to two (2) weeks' double pay and one (1) week's single pay and apart from paying the money so set aside an employer shall not be obliged to make any payments to an employee in respect of his annual leave or in respect of the period during which such leave is actually taken.

(b) It shall be a condition of every worker taking annual leave that he—

- (i) Shall not under any circumstances be engaged in any gainful employment while on such leave.
- (ii) Shall return to the active service of the employer forthwith at the expiration of leave, and
- (iii) Shall not draw any sick or accident pay simultaneously with annual leave.

A breach of condition (1) above will result in immediate discharge from the employer's service accompanied by forfeiture of all rights (if any) to retiring allowance or other similar payments or benefits.

A breach of condition (ii) (except as on the grounds of illness necessitating retirement or additional leave on the advice of a medical officer) will result in forfeiture of all rights (if any) to retiring allowance or other similar benefits or payments.

#### 13.—Annual Bonus.

The employer shall pay such employee receiving wages under this Award, a week's pay by way of bonus in the last week in December in each year. Any employee leaving the employer's service for reasons other than misconduct, dishonesty or neglect of duty before the payment of such bonus in any year shall, when leaving be paid a pro rata payment in lieu thereof; any employee who shall not have been in the employ of the employer for a year in the first week in December shall receive a part of his week's pay bearing the same proportion to a week's pay as the period of his service bears to a year.

### 14.—Long Service Leave.

(a) All workers who from time to time shall complete 25 years of continuous service with an employer shall be given long service leave. Such long service leave shall be taken at the conclusion of 25 years of continuous service and shall comprise 13 weeks' leave of absence for recreational purposes. (b) Should a worker who has completed 15 years of continuous service be retired compulsorily on medical grounds on the advice of a Medical Officer appointed by the employer or by reason of being over the employer's retiring age or die before completing 25 years' continuous service, there shall be paid by the employer to such worker or to his dependants as the case may require a sum of money bearing the same relation to 13 weeks' pay at his rate as his service with the employer bears to 25 years. "Dependant" shall mean the widow and/or children under the age of 16 years, or any child in fact dependent on any worker and, in the case of a single worker shall mean such dependent (if any) as such single worker may in writing notify to the employer during his lifetime, accompanied by proper proof of actual dependency.

(c) Continuous service shall include any interval spent on Service with Her Majesty's Armed Forces during the duration of any war on which Her Majesty may be engaged, and shall also include any interval spent during the duration of any war on which Her Majesty may be engaged with any National Service into which a worker is compulsorily drafted for defence purposes.

(d) Unless otherwise agreed in individual cases, long service leave shall be taken at such period as shall be mutually agreed upon within two years of it becoming due. In default of agreement it shall be taken at such time within such period of two years as the employer shall determine.

(e) Except in the cases of a worker who, at the time he becomes eligible for long service leave, is of an age exceeding 60 all long service leave shall be taken by way of actual holiday and not by way of payment in lieu thereof on retirement. A worker who at the time he becomes eligible for long service leave is beyond 60 years of age shall have the option of taking actual holiday under this scheme or of receiving payment in lieu thereof on retirement. Such option shall be exercised by a notice in writing addressed to the employer at the time of becoming eligible for long service leave.

(f) Workers on long service leave shall, while on such leave, continue to be paid at the actual rate (exclusive of overtime or other allowance) enjoyed by them at the commencement of such leave. Except in special circumstances payment shall be at the same times as during normal employment but may be made by cheque by mutual arrangement.

(g) It shall be a condition of every worker's taking long service leave that he (or she):—

- (i) Shall not under any circumstances be engaged in any gainful employment while on such leave;
- (ii) Shall return to the active service of the employer forthwith at the expiration of the leave; and
- (iii) Shall not draw any sick or accident pay simultaneously with long service leave pay.

A breach of condition (i) above will result in immediate discharge from the employer's\_service accompanied by forfeiture of all rights (if any) to retiring allowance, or other similar payments or benefits. A breach of conditions (ii) above (except as on the grounds of illness necessitating retirement or additional leave on the advice of a Medical Officer appointed by the employer) will result in forfeiture of all rights (if any) to retiring allowance or other similar benefits or payments.

(h) The employer shall have the right in cases of emergency to recall any worker from long service leave, in which case the unexpired leave shall be made up on some mutually convenient date.

(i) In order to avoid confusion and embarrassment workers whilst on long service leave shall not, without the prior permission of the officer in charge of the particular establishment, visit any of the premises of the employer except for the purpose of collecting pay or transacting genuine business with the employer's officers. Social visits shall not be induged in. "Establishment" means any brewery, co-operage, or workshop, but does not include hotels or annual picnics or sports or usual weekly competitive sporting activities. (j) The benefits of long service leave shall be in addition to all benefits at present or hereafter to be enjoyed by workers.

(k) In the event of any governmental or similar long service leave scheme being introduced for industry as a whole, the parties concerned shall meet to consider alterations necessary in order to adjust the scheme to such new conditions.

(1) Notwithstanding anything in this clause contained no worker nor his legal personal representative shall be entitled to any of the benefits by this clause conferred in any of the following circumstances:—

- (i) When, in the opinion of the directors of an employer a worker has committed fraud upon the employer or any defalcation in relation to the employer or breach of trust or similar act prejudicially affecting or likely to so affect business or interests of the employer and is dismissed.
- (ii) If the worker shall become a bankrupt or insolvent debtor within the meaning of any Act of the Parliament of the Commonwealth of Australia or of the State of Western Australia or shall assign, alienate or charge his benefits hereunder or any part thereof or attempt to do so or if through his own act or default or by operation or process of law the same shall become vested in or payable to some other person, firm or company.

#### 15.—Under-Rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage, may be paid such lesser wage as may from time to time be agreed upon in writing between the Union and the employer.

(b) In the event of no agreement being arrived at the matter may be referred to the board of reference for determination.

(c) After application has been made to the board, and pending the board's decision, the worker shall be entitled to work for or be employed at the proposed lesser rate.

(d) The provisions of regulation 92 of the regulations made under the Industrial Arbitration Act, 1912-1952, shall be deemed to apply to any board of reference appointed hereunder.

### 16.—Engagement.

The engagement between employer and worker, except casual hands, shall be weekly, and may be terminated by a week's notice from either party, except in the case of the worker absenting himself without leave, not obeying lawful commands, or being guilty of other misconduct, or of the works of the employer being stopped, through fire or tempest, when such engagement may be terminated immediately.

### 17.—Absence Through Sickness.

(a) A worker who is unable through sickness or accident to attend his duties, shall notify the employer not later than 10 a.m. on the day he first absents himself from duty

(b) A worker shall be entitled to sick pay in respect of any period of absence on account of sickness after the first day of January, 1948, on the basis of one half day's pay for each completed month served with the employer between the said 1st day of January, 1948, and the date of the commencement of such absence provided that in calculating the amount due to a worker in respect of any particular period of absence through sickness there shall be deducted therefrom any sum or sums previously paid to him hereunder.

(c) The term "sickness" shall not include any case where the worker is entitled to compensation under the Workers' Compensation Act. (d) No worker shall be entitled to the benefits of this clause unless he produces proof of his sickness satisfactory to the employer This proof shall be in the form of a medical certificate if the absence is for three days or more The employer shall have the right at any time to have the worker examined by a doctor on behalf of the employer.

(e) Except as aforesaid, a worker shall not be entitled to payment for time lost through sickness or accident.

### 18.—Contractors.

All work of any employee in the capacity as mentioned in this Agreement in or about a brewery or bottling works or in connection with the business of brewing or bottling beer shall be carried out departmentally by bona fide brewery employees engaged and paid direct by the brewery proprietors and not by agents or contractors. This clause shall not apply to contractors erecting, repairing or making alterations to buildings or machinery or to carriers being engaged for the delivery of goods other than beer as has been the practice or custom prior to this date. But when contractors are employed delivering beer the brewery company shall undertake to see that whilst employed on such work the contractors pay to both the drivers and offsiders the same wages and work under the same conditions as is provided in this Agreement.

#### 19.—Area.

This Agreement shall apply to the area comprised within a radius of fifteen (15) miles from the General Post Office, Perth.

#### 20.—Term.

This Agreement shall be for a term of twelve (12) months from the 12th day of December, One thousand nine hundred and fifty-six.
