WHEREAS by section 28A of the Main Roads Act, 1930-1955, it is provided that where the Commissioner is of opinion that a controlled access road should be provided and should be entered and departed from at specified places only, he shall make

a recommendation to the Lieutenant-Governor accordingly and that if of opinion that the recommendation should be given effect the Lieutenant-Governor may, by proclamation, proclaim the controlled access road and the places only; and whereas the Commissioner is of opinion that a controlled access road should be provided as herein-after described to form part of the controlled access road referred to in the Proclamation made pursuant to section 28A of the Main Roads Act, 1930-1955, on the 6th day of August, 1957, and published in the *Government Gazette* of the 9th day of August, 1957, and has made a recommendation to the Lieutenant-Governor accordingly; and whereas I the Lieutenant-Governor of the said State am of opinion that such recommendation should be given effect; Now therefore I, the said Lieutenant-Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Act, do hereby proclaim that the parcels of land coloured green in Plan P.W. W.A. 35795 (L.T.O. Plan 6978) which together are more particularly described in Schedule hereunder shall be a Controlled Access Road and I do hereby confirm the Proclamation made pursuant to section 28A of the Main Roads Act, 1930-1955, on the 6th day of August, 1957, and published in the *Government Gazette* on the 9th day of August, 1957.

Bruce Rock Road Board.

Town Planning Scheme No. 1.

Preliminary.

1. This Scheme is made in pursuance of section 7 of the Town Planning and Development Act, 1928-1956, for the purpose of:—

- (a) Classifying the Bruce Rock Townsite into zones for various building and land uses to ensure the proper and orderly development of the town.
- (b) Carrying out such works as may be necessary from time to time to implement the scheme.

Zoning.

1. The gazetted Bruce Rock Townsite is hereby classified into zones as follows:—

- (a) Business Zones (comprising all lands coloured blue on Scheme Map 2).

No person shall use any land or erect or use any building or structure in the Business Zone except for one or more of the following purposes:—

Shops, shops and dwellings combined but not dwellings alone, offices, showrooms, service stations and garages, hotels, cinemas, theatres, dance halls, and workrooms or storerooms in connection with a business where not

more than 50% of the buildings are so occupied, churches, road board buildings and other works depots and other public and institutional buildings.

- (b) Residential Zones (comprising all lands within the areas edged brown on the Scheme Map 2).

No person shall use any land or erect or use any building or structure in the Residential Zone except for one or more of the following purposes:—

Residences, hostels, tenements and flats, boarding houses, churches, schools, Road Board buildings other than works depots, and other public institutional buildings with the approval of the responsible authority by resolution, but shall not include any industry, trade, manufactory or business.

- (c) Industrial Zone (comprising all lands within the area edged purple on Scheme Map 2).

No person shall use any land or erect or use any building or structure in the Industrial Zone except for one or more of the following purposes:—

An industry, industrial purposes, factory manufactory, warehouse, or depot (not including an offensive industry or trade as defined in the Public Health Act). A dwelling on land forming part of or adjoining a factory and occupied by a caretaker or employee of the factory exclusively and so approved by the responsible authority.

- (d) Special Zones (comprising all lands within the areas hatched green and edged red on the Scheme Map 2).

No person shall use any land or erect or use any building or structure in these Special Zones except for the special purpose indicated on the Scheme Map 2 or for any of the uses permitted within the Residential Zone.

- (e) Rural Zone (comprising all the land within the Bruce Rock Townsite which is not included within any of the forementioned zones (a) to (d) and which is shown uncoloured on Scheme Map 2).

No person shall use any land or erect or use any building or structure in the Rural Zone except for one or more of the following purposes:—

Any purpose permitted in the Residential Zone. Agriculture, horticulture, forestry and the keeping of poultry and livestock other than swine. Noxious or offensive trades as defined in the Public Health Act may be permitted in this Zone and in no other, subject to the health by-laws of the responsible authority.

Existing Uses.

3. (1) If at the date of approval of the Scheme in the *Government Gazette* any land, building or structure is being lawfully used for a purpose or built on in a manner not permitted by the Scheme, such land, building or structure may continue to be used for that purpose or in that manner, but no such building or structure shall be added to or altered unless special permission to do so is granted by the responsible authority.

(2) If at the date of approval of the Scheme in the *Government Gazette* any land, building or structure is being used for a purpose or built on in a manner not permitted by this Scheme and such use or purpose is afterwards discontinued or changed or the buildings removed so that it conforms with the Scheme, no person shall thereafter use such land, building or structure for any purpose or in any manner not permitted by the Scheme.

(3) If any building or structure is at the date of the approval of the Scheme in the *Government Gazette* being used for a purpose or constructed in a manner not permitted by the Scheme and is subsequently destroyed or damaged by fire or otherwise to the extent of more than seventy-five (75) per cent. of its value, it shall not thereafter be repaired, rebuilt, altered or added to for the purpose of being used for any purpose not permitted by the Scheme, or in a manner not permitted by the Scheme, unless special permission to do so is granted by the responsible authority.

General Provisions.

4. The minimum area of a lot on which a dwelling or a shop and attached dwelling may be erected is 6,000 square feet. On any given lot a second dwelling may not be erected until such time as a subdivision has been approved by the Town Planning Board so that each dwelling shall stand on a separate lot.

5. Within the Business Zone no building or portion of a building shall be erected within 30 feet of any street frontage unless it shall have walls of brick, reinforced concrete, stone or cement brick, in accordance with the Building By-laws of the responsible authority.

6. The erection and maintenance of any advertising device, advertisement hoarding or structure for advertising purposes is prohibited in the Residential, Business and Special Zones except in the case of signs indicating professions, names, trades or calling exhibited on the land or buildings on or in which such profession, trade or calling is conducted and subject to the approval of the responsible authority by resolution.

Administration.

7. The area to which this Scheme shall apply is the area of the Bruce Rock Townsite as defined in the *Government Gazette* dated the 27th June, 1913.

8. The local authority responsible for implementing the Scheme and for enforcing its observance is the Bruce Rock Road Board (referred to in the Scheme as the responsible authority).

9. The provisions of section 10 of the Town Planning and Development Act, 1928-1956, shall apply to this Scheme and the period of notice required under subsection (1) of that section is one calendar month.

10. Any claims for compensation in respect of the coming into operation of this Scheme shall be made to the responsible authority not later than six months from the date the approval of this Scheme is notified in the *Government Gazette*.

Between Fire Brigade Employees' Industrial Union of Workers (Coastal Districts) of Western Australia, Applicant, and the Western Australian Fire Brigades Board, Respondent.

WHEREAS an industrial dispute existed between the abovenamed parties and whereas the said dispute was referred into Court for the purpose of hearing and determination and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement an Award of the Court.

Now therefore, the Court pursuant to Section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court:—

Memorandum of Agreement.

(Note.—Wherever the word "Award" occurs herein, it shall be taken to mean and include "Agreement.")

1.—Title.

This Award shall be known as the Fire Brigade Employees' Award and replaces Award No. 43 of 1948.

(c) Workers shall be eligible to progress to second class after completion of ten months' service as third class, and from second class to first class after twelve months' service as second class. Provided that no fireman eligible by length of service to the higher class shall be passed to the higher class by the Board unless he be certified as competent by the Chief Officer and recommended for such promotion.

(d) Where less than a full week is worked, workers shall be paid at per daily rate of wages for seven days a week.

(e) The margins shown in clause 3 (b) shall be payable while 56 hours per week are worked and the parties agree that in the event of any reduction in working hours the margins shall revert to the amounts shown in brackets against the respective classifications.

4.—Service Allowance.

(Additional to items in Clause 3)

After five (5) years' service workers shall be paid a long service allowance of five shillings (5s.) per week; after ten (10) years' service an additional allowance of two shillings and sixpence (2s. 6d.) per week, and after fifteen (15) years' service a further two shillings and sixpence (2s. 6d.) per week and after twenty (20) years' service a further additional allowance of two shillings and sixpence (2s. 6d.) shall be paid.

5.—Emergency Calls.

Any worker while off duty who is called upon to work outside his platoon hours shall be paid at the rate of time and one half per hour or part thereof. Time to commence when the call is received, provided he reports for duty within thirty (30) minutes after the receipt of such call until the signing off at the station. The minimum payment under this clause shall be for one hour at rates as specified in clause 13.

6.—Driving Allowance.

(a) Workers who are rostered or called upon to drive running fire appliances at any of the Board's stations shall be paid one shilling per shift in addition to their ordinary rate of pay.

(b) Workers whilst engaged in driving on journeys extending beyond 24 hours shall be paid twenty shillings (20s.) per day in addition to their ordinary rate of pay and in such cases no overtime shall be paid. Such workers shall be entitled to the travelling allowance under clause 9 hereof.

7.—Relieving.

(a) Any worker stationed in the metropolitan area and required to take up duty outside such area for a period of less than three (3) months shall be regarded as "relieving" and shall be entitled to the allowance provided in clause nine (9).

(b) Relieving shall be spread over as many of the staff as possible.

8.—Relieving an Officer.

In addition to the ordinary rates of pay a flat rate of 10s. per week shall be paid to the senior worker on each shift provided that he be in charge of and responsible for the shift during the officer's absence. Provided that no payment shall be made where each shift is manned by an officer.

9.—Travelling or Relieving Allowance.

All workers actually travelling or relieving beyond the metropolitan area shall be paid an allowance of 20s. per day.

10.—Meal Allowance.

A worker relieving away from his home station, unless notified on the previous day shall be allowed three shillings and sixpence (3s. 6d.) for each meal necessarily incurred; provided that no allowance shall be paid where the worker receives an allowance under clause nine (9) of this Award.

Provided further that in no case shall the worker be entitled to the allowance as aforesaid for more than the first day of any period of relieving.

11.—Goldfields Allowance.

Workers employed at Kalgoorlie and Boulder shall receive an allowance of two shillings and fourpence (2s. 4d.) per week.

12.—Hours of Duty.

(a) The hours of duty shall be worked on a system of three shifts by workers known as the "A" platoon, the "B" platoon, and the "C" platoon and each platoon shall perform an average weekly tour of duty of 56 hours over a period or cycle of six weeks. Provided that a probationary fireman shall not be drafted to a platoon nor be called upon to attend at the station on Saturdays, Sundays, and gazetted public holidays.

(b) The 24-hour daily tour of duty shall be performed by two of the three platoons, as under:—

Day Shift—8 a.m. to 6 p.m. on the same day.

Night Shift—6 p.m. to 8 a.m. on the following day.

The platoon rostered for duty on the day shift shall assume duty on the station at 8 a.m. and remain on duty until 6 p.m. on the same day, and the platoon rostered for duty on the night shift shall assume duty on the station at 6 p.m. and remain on duty until 8 a.m. on the following morning.

Each platoon shall, in rotation, work two consecutive day shifts and two consecutive night shifts in a period or cycle of six days.

Each platoon shall, in rotation, be off duty except as provided in clauses 5 and 13 for 24 hours between the conclusion of the second day shift, and the commencement of the first night shift and, except as provided in clauses 5 and 13, for 48 hours between the conclusion of the second night shift and the commencement of first day shift of the second six-day cycle.

(c) Notwithstanding anything contained in the foregoing it is provided that a worker may, for the efficient working of the service, be required to change from one platoon to another.

(d) Day Shift—All routine duties and drills, except as hereinafter provided, shall be performed between the hours of 8 a.m. and 4 p.m. and the platoon shall stand by on the station for fire calls from 4 p.m. to 6 p.m.

Night Shift—The platoon shall stand by on the station for fire calls from 6 p.m. to 8 a.m. on the following morning. The bells shall be rung at 7.15 a.m.

(e) Notwithstanding anything contained in the foregoing, it is provided that a worker, while on duty at the station, may be called upon to perform any of the following duties:—

(i) Watchroom duty;

(ii) any work incidental to a fire call or emergency call for special services ordinarily performed by firemen;

(iii) station domestic work;

(iv) the manning and driving of any of the Fire Brigade Board's motor vehicles;

(v) work of an urgent nature incidental to a breakdown of fire alarms, fire appliances or equipment; provided that if work of this nature extends beyond one hour, a penalty rate of two shillings (2s.) an hour in addition to the worker's ordinary rate shall be paid.

(vi) Drill under night conditions for an aggregate period of not more than six (6) hours per year.

13.—Overtime.

Any work done outside the platoon hours including travelling within the metropolitan area, shall be paid for at the rate of time and a half, except as otherwise herein provided. For this purpose overtime shall be calculated on the basis of forty-eight hours per week.

14.—Meal Hour.

One hour shall be allowed for each meal which shall be taken on the home station. Where a worker is on out-duty the meal hour, as far as is practicable, shall be taken on the home station between 11.30 a.m. and 2.30 p.m.

15.—Sick Leave.

(a) (i) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for one-twelfth (1/12th) of a week's pay for each complete month of service.

(ii) The liability of the employer shall in no case exceed one (1) week's wages during each calendar year in respect of each worker but the sick leave herein provided shall be allowed to accumulate and any portion unused in any year may be availed of in the next or any succeeding year.

(iii) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(b) This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act, 1912-1952.

(c) No worker shall be entitled to the benefit of this clause unless he produces proof satisfactory to his employer or his representative of sickness but the employer shall not be entitled to a medical certificate unless the absence is for more than one rostered shift.

(d) No payment shall be made for any absence due to the worker's own fault, neglect or misconduct, or where the worker does not notify his station of his sickness within four hours of the commencing time of his shift.

16.—Accident Pay.

Full pay shall be paid for accidents on duty whether occasioned incidental to a fire call or not.

17.—Uniforms.

All uniforms, as required, shall be supplied by the Board.

18.—Watchroom Duty.

Watchroom duty shall be performed as required by the Chief Officer.

19.—Residence.

No restriction shall be placed on men who are off duty as to place of residence, duty, or otherwise except as provided in clause five (5) (Emergency Calls).

20.—Salvage Duties.

Where possible, opportunity shall be given to workers to change into dry clothing where their uniforms have become wet.

21.—Annual Leave.

After the expiration of one (1) year's service, workers shall be entitled to twenty-eight (28) days' annual leave on full pay and thereafter a pro rata allowance. Provided that no leave shall accrue to any worker until he has served three (3) complete months.

22.—Payment of Wages.

Wages shall be paid weekly.

23.—Vacancies.

When a vacancy occurs in a rank higher than first class, applications shall be invited by the Chief Officer from qualified men in the classes below that in which the vacancy occurs, and all things being equal, a selection shall be made from such applicants for the vacancy.

24.—Transfers.

When transferring from one station to another, a worker shall be granted all reasonable expenses including second class rail fares and sleepers, if applicable, for himself, his wife and for all children under 16 years of age, irrespective of his mode of transport. Provided that the Board shall not be liable for and shall be indemnified against any claims for accidents in the case of a cash payment and the travel being by private transport. Provided also that this clause shall not apply in cases where a worker is transferred from one station to another as a punishment.

25.—Cleaning after Fires.

Reasonable time not exceeding thirty minutes shall be allowed for changing and cleaning after completion of duties on return from a fire and prior to leaving the Station. Provided that the worker shall see that the time of his departure from the Station is recorded in the Occurrence Book, and submits a claim on the form provided for the purpose.

26.—Charges against Employees.

When a worker is suspended and is summoned to appear before an officer of the Fire Brigades Board to answer a charge he shall be informed of the particular charge at least forty-eight hours before the hearing thereof, and shall have access to all reports which are put in as evidence against him. He shall have an advocate from the union to assist him. He shall be allowed to call evidence on his behalf, and to hear all evidence against him.

27.—Appeal Board.

Every worker shall have the right of appeal from a decision of the Fire Brigades Board affecting his employment, to an appeal board constituted of one representative of the Fire Brigades Board, one representative of the union and a stipendiary magistrate (or some other person appointed by the Court) as chairman.

28.—Membership of the Union.

Every man employed as a permanent or probationary fireman must when assuming duty apply for membership in the Western Australian Fire Brigades Employees' Industrial Union of Workers (Coastal Districts) and, if elected, remain a member of the union whilst in the service of the Board.

29.—Definition.

In the construction of these presents the term "worker" shall apply to and include the several classes of workers specified in clause 3.

30.—Bedding.

All beds and bedding requirements, including mattress covers, shall be provided by the Fire Brigades Board, and replacements due to fair wear and tear shall also be provided by the Board.

31.—Holidays.

On Saturdays after 12 noon, on Sundays, and on all gazetted public holidays, firemen shall not engage on work other than that specified in clause 12, sub-clause (e) (i), (ii), (iii), (iv) and (v).

32.—Seniority.

Seniority shall rank in the following order:—

1. Senior Fireman.
2. First Class Fireman.
3. Second Class Fireman.
4. Third Class Fireman.

33.—Application of Award.

Nothing herein contained shall apply to auxiliary firemen who may be employed under the conditions laid down from time to time in the rules and regulations issued under the provisions of the Fire Brigades Act.

34.—Board of Reference.

A Board of Reference is hereby appointed for the purpose of this Award. Such Board shall consist of a chairman and two other representatives, one to be nominated by each of the parties; the chairman shall be mutually selected by the parties, failing their agreement the Industrial Registrar shall act as chairman.

Such Board shall have assigned to it, in the event of no agreement being arrived at between the parties to the dispute, the functions of—

- (a) adjusting any matters of difference which may arise between the parties from time to time except such as involve interpretation of the provisions of the Award or any of them;
- (b) deciding any other matters that the Court may refer to the Board from time to time.

An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in this Award.

35.—Term of Award.

The term of this Award shall be three (3) years from the 20th day of May, 1957; provided that at any time after the expiration of twelve (12) months from that date, application may be made to the Court of Arbitration to alter, amend or vary the same, in accordance with the provisions of the Industrial Arbitration Act, 1912-1952.
