WHEREAS by section 46 of the Health Act, 1911-1956, it is provided, *inter alia*, that a local authority, in exercise of the powers conferred by Part III of the Act, may make and levy rates of different amounts in respect of different portions of its district, defined for that purpose by proclamation; and whereas the Gosnells Road Board, being the local authority for the Gosnells Road District, intends to make and levy rates of different amounts in respect of different portions of its district; and whereas the different portions of its district are so required to be defined for that purpose by proclamation: Now, therefore I, the Lieutenant-Governor, with the advice and consent of the Executive Council, do by this proclamation define those portions of the Gosnells Road District as follows:—

- (a) Canning Vale Ward of the District, as described in the Government Gazette on 21st December, 1923, and amended by notices published in the Gazette on 27th May, 1932; 6th December, 1935, and 25th February, 1938.
- (b) The remaining portion of the District.

- (c) (i) The maximum period of sick leave allowable with pay in respect of any continuous absence shall not exceed 6 months.
- (ii) A worker who has been granted 6 months continuous sick leave with pay shall not be entitled to receive further sick leave with pay until a period on duty of not less than 4 weeks has been completed.

- (a) No sick leave with pay shall be granted without an adequate medical certificate, provided that if in any case it is not convenient for the employee to obtain a medical certificate, sick leave may be granted on other evidence satisfactory to the employer, but such leave shall be limited to two (2) consecutive days in any one period and a total of 3 days in any calendar year.
