IN pursuance of the provisions of section 9 of the Fisheries Act, 1905-1956, I, the Governor of the State of Western Australia, by and with the advice and consent of the Executive Council, do hereby prohibit the taking of the fish known as or called "crayfish" by means of craypots, cribs, traps or any fixed engine in all that portion of Western Australian waters specified in the Schedule hereto from 15th January to 15th November of every year.

five miles north of Green Head and extending generally south-south-easterly and southerly to an east-west line situate 22 miles south of Cape Boulevard.

Forests Act, 1918-1954.

ORDER IN COUNCIL.

F.D. 1587/54.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown Land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament, the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall, by Order in Council, revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposals dated the 24th day of November, 1954, for the revocation in part of the dedication of Crown Lands as State Forest: And whereas after such proposals had been laid before Parliament a resolution was passed by both Houses that such proposals should be carried out: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, do hereby revoke in part the dedication of Crown Lands as State Forest No. 33 by excising that portion of such State Forest as is described in the Schedule hereto.

WHEREAS by the Forests Act, 1918-1954, it is provided that a dedication under the said Act of Crown Land as a State Forest may be revoked in whole or in part in the following manner:—

- (a) The Governor shall cause to be laid on the Table of each House of Parliament a proposal for such revocation.
- (b) After such proposal has been laid before Parliament the Governor, on a resolution being passed by both Houses that such proposal be carried out, shall, by Order in Council, revoke such dedication.

And whereas His Excellency the Governor did cause to be laid on the Table of each House of Parliament his proposal dated the 10th day of November, 1955, for the revocation in part of the dedication of Crown lands as State Forest; and whereas after such proposal had been laid before Parliament a resolution was passed by both Houses that such proposal should be carried out; and whereas, pursuant to that resolution, His Excellency the Governor did authorise the issue of an Order in Council on the 16th day of October, 1957, revoking such dedication, but that Order in Council contained a clerical error which renders the Order ineffective; and whereas it is, in the circumstances, necessary to cancel the said order and issue an Order in Council afresh pursuant to that resolution: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby revoke in part the dedication of Crown lands as State Forest Nos. 29 and 53 by excising that portion of such State Forest as is described in the Schedule hereto.

Water Boards Act, 1904-1954, and Country Areas Water Supply Act, 1947-1954.

ORDER IN COUNCIL.

1. UNDER section 4 (6) of the Water Boards Act, 1904-1954, each of the several Water Areas constituted, defined and now subsisting as Water Areas under and for the purposes of that Act under the names or designations shown in the Schedule to this Order (and within which the Minister for Works is authorised under section 161 of the said Act or under section 4 of Act No. 67 of 1912 to exercise powers conferred on a Water Board), is hereby abolished; and, under section 3 of Act No. 67 of 1912, any existing Water Board constituted for any such Water Area is hereby dissolved.

2. Under section 8 of the Country Areas Water Supply Act, 1947-1954, and for the purposes of that Act, each portion of the State comprised as at the date hereof within a Water Area referred to in paragraph 1 of this Order is hereby separately constituted a Country Water Area under the same name or designation as, at the date hereof, such portion had borne as a Water Area under and for the purposes of the Water Boards Act, 1904-1954 (and as respectively appears in the said Schedule) but with the insertion, in each case, of the word "Country" before the words "Water Area."

3. Under section 10 of the Country Water Supply Act, 1947-1954, and for the purposes of that Act, the whole of each of the Country Water Areas constituted by or under paragraph 2 of this Order is hereby separately constituted a Rating Zone under the name or designation respectively directed by paragraph 2 of this Order, but in each case with the substitution of the words "Rating Zone" for the words "Country Water Area."

4. This Order in Council shall take effect on the 1st day of January, 1958.

Between the West Australian Chemical and Allied Trades Industrial Union of Workers, Applicant, and Cuming Smith & Mount Lyell Farmers Fertilisers Limited, and Cresco Fertilisers (W.A.) Limited, Respondents.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement an Award of the Court: Now, therefore, the Court pursuant to section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court:—

Memorandum of Agreement.

(Note.—Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement".)

1.—Title.

This Award shall be known as the "Superphosphate Workers Award" and replaces Award No. 19 of 1953.

3.—Scope.

This Award shall apply to all classes of workers referred to in Clause 9 hereof engaged in the manufacture of superphosphate.

4.—Area.

This Award shall operate over the area comprised in the South-West Land Division of the State of Western Australia.

5.—Term.

This Award shall operate for a period of three (3) years as from the beginning of the first pay period to commence after the date hereof.

6.—Hours.

(a) Day Workers: Forty (40) hours shall constitute a week's work, to be worked in five (5) days, Monday to Friday, inclusive.

(b) Shift Workers: The ordinary hours of shift workers, inclusive of twenty (20) minutes crib time (which shall be taken at such a time, when possible, as to avoid a stoppage of work) shall not exceed—

- (i) Forty (40) hours in any one (1) week, or
- (ii) eighty (80) hours in two (2) weeks, at the option of the employer, to be worked in rotating shifts not exceeding eight (8) hours each day.

(c) Watchman's Hours: Watchman's hours shall not exceed forty-eight (48) per week, but he shall be allowed one day off for each four (4) weeks without deduction of pay.

Shift Work.

7. (a) Continuous process may be worked, and shift shall rotate weekly, so that, as far as practicable all workers shall have a fair share of day shifts.

(b) Where a worker is called on to work a quick shift he shall be paid at the rate of time and a quarter for such quick shift. A "quick shift" shall mean a shift where a worker is brought on to work a full shift without having had at least eight (8) hours off.

(c) Shift workers other than those on day shift shall be paid five per cent. (5%) extra for afternoon shift and ten per cent. (10%) extra for night shift.

(d) Continuous shift workers shall be paid time and a quarter for Saturday work.

8.—Overtime.

(a) Overtime shall be paid for work done before the recognised time for starting work and after the recognised time for ceasing work in each factory.

Each day shall be reckoned by itself.

This subclause shall not apply to men working on shifts.

Overtime for work done by workers (other than those on continuous shifts) on any day other than specified holidays or Sundays shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(b) Overtime for work done by men working on continuous shifts shall be paid for at the rate of double time (i.e., time in addition to ordinary time) for all time worked in excess of eight (8) hours in any one day of twenty-four (24) hours or on any rostered day off, except so far as the excess is, owing to arrangements between the workers themselves, or is necessary for effecting periodical rotation of shifts, or is owing to the relieving man not coming on duty and relieving at the appointed time, in which latter case the overtime rate shall be paid when the period exceeds one (1) hour.

(c) Any worker who is required to work on Sunday shall be paid a minimum of two (2) hours at the rate applicable for that day.

(d) Where a worker, without being notified on the previous day, has to continue working after the usual knock off time for more than one (1) hour, he shall be provided with any meal required or shall be paid three shillings and sixpence (3s. 6d.) in lieu thereof.

Provided that this subclause shall not apply to a worker residing in the same locality as his place of employment who can reasonably return home for a meal.

(e) Notwithstanding anything contained in this Award—

(i) an employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement;

(ii) no organisation party to this Award, or worker or workers covered by this Award, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

Call Back.—When a worker is recalled to work after leaving the job he shall be paid for at least two (2) hours at overtime rates.

(d) For the purpose of convenience, the wages prescribed above are expressed in weekly amounts. The provisions of clause 13, Contract of Hiring, shall be read in conjunction with this clause.

No junior worker less than seventeen (17) years of age shall be employed in wheeling bags of superphosphate or other similar material up an inclined ramp or board. No boy of less than eighteen (18) years of age shall be employed on night shift.

(e) Casual Workers.—Any worker employed for less than one (1) week shall be entitled to two shillings (2s.) per day, in addition to the ordinary rates prescribed for the particular class of work in which he is employed.

10.—Extra Rates and General Conditions.

(i) Except where specifically prescribed elsewhere in this clause, the method of calculating the extra rates provided in this clause shall be as follows:—

Any worker carrying out the special duties mentioned in this clause for less than half (½) of one (1) day or shift shall be paid the extra allowance on a pro rata basis for the time actually employed on such work.

Where such worker performs the work for half (½) or more of one (1) day or shift, he shall be paid the extra allowance for the whole of such day or shift.

(ii) One shilling (1s.) per day over the minimum rate prescribed herein shall be paid to men employed—

- (a) Stacking bales of bags two (2) tiers high or over, but where mechanical means are employed for lifting, this allowance shall not apply unless in the opinion of the Board of Reference the extra exertion is still required.
- (b) Lifting or carrying bags of nitrate of soda.
- (c) Stacking bags of raw materials over twelve (12) bags high and where no mechanical appliances are in use.
- (d) Working with tar or using mephalt.
- (e) Mixing concrete.
- (f) Using explosives.

(iii) One shilling and sixpence (1s. 6d.) per day over the minimum rates prescribed herein shall be paid to men employed—

- (a) Cleaning aerator from outside.
- (b) Working on a scaffold fifteen (15) feet or more above ground or floor level.

(iv) Two shillings (2s.) per day over the minimum rate prescribed herein shall be paid to men employed—

- (a) As splicers and riggers.
- (b) As hammer and gadmen.

(v) Two shillings and sixpence (2s. 6d.) per day over the minimum rate prescribed herein shall be paid to men employed cleaning out aerator from inside.

(vi) Five shillings (5s.) over the minimum rate prescribed herein shall be paid per day or part of a day to men employed cleaning out or assisting to clean out septic tanks.

(vii) Work done in the meal time or any portion thereof shall be paid for at the rate of time and a half, but this shall not apply to cases involving completion of work commenced before such meal time, and not occupying more than fifteen (15) minutes from the commencement thereof, in which case the meal time will be extended by such period beyond the ordinary time.

(viii) Any worker placed by the employer in charge of three (3) or more other workers shall be paid fifteen shillings (15s.) per week, or if placed in charge of less than three (3) other workers shall be paid eight shillings (8s.) per week, in addition to the margin prescribed for the work being performed. The extra allowance prescribed in this subclause shall not apply to any worker who is receiving an extra allowance for his particular class of work.

(ix) In addition to the rates of wages prescribed in clause 9 hereof, the following special rates shall be paid:—

11.—Protective Clothing.

(i) Dust glasses or goggles shall, where necessary, be supplied to workers.

(ii) Rubber gloves and either knee or ankle rubber boots shall, when required, be provided for the use of men who work in or about acid plants.

(iii) Loaders out and baggers shall be provided with leather aprons.

(iv) One pair of boots per annum shall be provided for bin excavator men.

(v) Workers having completed 12 months' continuous service with an employer shall be entitled to receive free of cost from the employer—

- (a) in the case of acid plant workers, two issues of working clothes per annum, and
- (b) in the case of all other workers, one suit of working clothes per annum.

12.—Mixed Functions.

Any worker engaged on duties carrying a higher rate than his ordinary classification for less than half ($\frac{1}{2}$) of one (1) day or shift shall be paid the higher rate for the time actually employed on such work.

Where a worker performs duties carrying a higher rate than his ordinary classification for half ($\frac{1}{2}$) or more of one (1) day or shift he shall be paid the higher rate for the whole of such day or shift.

13.—Contract of Hiring.

(a) The contract of hiring of every worker, except juniors, watchmen, despatch clerks, tally clerks and storemen, shall be deemed to be a contract of hiring by the day, terminable by one day's notice on either side given at any time.

Provided that the contract of hiring of any worker with 12 months' service or more shall be deemed to be a contract of hiring by the week, terminable by one week's notice on either side given at any time.

(b) The contract of hiring of juniors, watchmen, despatch clerks, tally clerks and storemen, shall be deemed to be a contract of hiring by the week, terminable by one week's notice on either side given at any time.

(c) The termination of the contract of service of any worker deemed to be on a contract of hiring by the week may take effect by payment or forfeiture (as the case may be) of a week's wages.

(d) Nothing herein shall derogate from the employer's right at common law to dismiss a worker without notice for misconduct or other sufficient cause.

14.—Breakdowns.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the union or unions affiliated with it, or by any other association or union, or through the breakdown of the employer's machinery, or any stoppage of work by any cause which the employer cannot reasonably prevent, except such stoppage is due to shortage of railway trucks.

15.—Under-Rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

16.—Time and Wages Record.

Each employer shall keep or cause to be kept at his usual place of business, or at each of them, if more than one, a book containing a record of the names of all workers employed by him at the particular factory, the class of work performed by each worker, the wages paid to each such worker, the starting and finishing time on each day, and the amount of overtime, if any. Such book shall be open to inspection by the Secretary, or such person as may be appointed by the Union, on any day during working hours.

17.—Holidays and Annual Leave.

(a) The following days, or the days observed in lieu shall, subject to subclause (c) hereof, be allowed as holidays without deduction of pay, namely:—New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day.

(b) On any public holiday not prescribed as a holiday under this agreement, the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty and payment may be deducted, but if work be done, ordinary rates of pay shall apply.

(c) All work done on any of the holidays specified in subclause (a) hereof (except Christmas Day, Good Friday, or Labour Day) shall be paid for at the rate of double time. All work done on Christmas Day, Good Friday or Labour Day shall be paid for at the rate of treble time.

(d) All work done on Sundays (except by shiftmen and watchmen) shall be paid for at the rate of double time. All work done on Sundays by shiftmen shall be paid for at the rate of time and a half. All work done on Sundays by watchmen shall be paid for at the rate of ordinary time.

(e) Except as hereinafter provided, a period of two consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of 12 months' continuous service with such employer.

(f) In addition to the leave prescribed in subclause (e) hereof, seven-day shift workers, that is shift workers who are rostered to work regularly on Sundays and holidays, shall be allowed one week's leave. Where a worker with 12 months' continuous service is engaged for part of the qualifying 12-monthly period as a seven-day shift worker, he shall be entitled to have the period of two consecutive weeks' annual leave prescribed in subclause (e) hereof increased by one-twelfth of a week for each month he is continuously engaged as aforesaid.

(g) If any prescribed holiday falls within a worker's period of annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(h) If after one month's continuous service in any qualifying 12-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a week's pay at his ordinary rate of wage in respect of each completed month of continuous service, or in the case of a worker referred to in subclause (f) hereof, such payment shall be one-quarter of a week's pay at his ordinary rate of wage.

(i) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim sick pay or time spent on holidays or annual leave, as prescribed by this Award, shall not count for the purpose of determining his right to annual leave.

(j) In the event of a worker being employed by an employer for portion of a year, he shall only be entitled, subject to subclause (h) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(k) A worker who is dismissed for misconduct or who illegally severs his contract of service, shall not be entitled to the benefit of the provisions of this clause.

(l) The provisions of this clause shall not apply to casual workers.

18.—Sick Pay.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health at the rate of one-twelfth (1/12th) of a week's pay for each completed month of service: Provided that, subject to subclause (g) hereof, payment for absence through such ill-health shall be limited to one (1) week's pay in each calendar year.

(b) Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(c) This clause shall not apply when the worker is entitled to compensation under the Workers' Compensation Act.

(d) A worker shall not be entitled to receive any wages from his employer for any time lost through any accident not arising out of or in the course of his employment, or for any accident, wherever sustained, arising out of his own wilful default, or for sickness arising out of his own wilful default.

(e) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(f) Notwithstanding the provisions of subclause (e) hereof, a worker who has already been allowed paid sick leave on one occasion shall not be entitled to payment for any further absence in the same year, unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health.

(g) Sick leave shall accumulate from year to year, so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year: Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of two (2) years but no longer from the end of the year in which it accrues.

19.—Junior Worker's Certificate.

(a) Junior workers, upon being engaged, shall furnish the employer with a certificate showing the following particulars:—

- (i) Name in full.
- (ii) Age and date of birth.

(b) The certificate shall be signed by the worker.

(c) No worker shall have any claim upon the employer for additional wages, in the event of his age being wrongly stated on his certificate, nor shall the employer in such case be deemed guilty of a breach of any of the provisions of the Award founded upon an age limitation, except in the case of collusion.

(d) If any worker shall wilfully mis-state his age in the above certificate, he shall be guilty of a breach of this Award.

20.—Board of Reference.

The Court may order, for the purposes of the said Award, the appointment of a Board or Boards of Reference and assign to such Board or Boards the following functions and powers arising under or out of the said Award, namely—

- (i) to adjust any matters of difference which may arise between the parties from time to time;
- (ii) to decide or report to the Court upon any other matter which the Court may from time to time refer to any such Board.

Separate Boards of Reference may be appointed, where deemed necessary or advisable for different localities.

Each Board shall consist of a chairman and two (2) representatives, one representative to be nominated by each party.

Save as herein provided, the provisions of regulation 92 shall apply.

21.—No Discrimination.

No employer shall, in the employment or dismissal of his workers, discriminate in any way against the members of the Union, nor shall they, in the conduct of their business, do anything with a view to directly or indirectly injuring the Union.

INDUSTRIAL AGREEMENT.

No. 11 of 1957.

Registered 22nd October, 1957.

THIS Agreement, made in pursuance of the Industrial Arbitration Act, 1912-1952, this 16th day of October, 1957, between the Australian Workers' Union, Westralian Branch, Industrial Union of Workers (hereinafter called "the Union") of the one part, and Dansk Aktieselskab Christiani & Nielsen and Clough Construction Co. Pty. Ltd., trading as Christiani & Nielsen (Australia) (hereinafter called "the employer") of the other part, witnesseth that, for the considerations hereinafter appearing, the parties hereto mutually covenant and agree the one with the other as follows:—

1.—Title.

This Agreement shall be known as the "Bridge Building Workers' Agreement, 1957."

2.—Arrangement.

3.—Area and Scope.

This Agreement shall operate over the areas actually occupied and controlled by the employer and shall apply to all workers employed in the classifications referred to herein.

4.—Term.

This Agreement shall operate for a period of two (2) years as from the beginning of the first pay period commencing after the date hereof.

5.—Contract of Service.

One (1) week's notice on either side shall be necessary to terminate the contract of service of any worker, other than a casual worker (where the notice shall be one (1) hour). If the required notice is not given, one (1) week's (or one (1) hour's, in the case of a casual worker) pay shall be paid or forfeited as the case may be.

6.—Breakdowns, Etc.

The employer shall be entitled to deduct payment for any day upon which the worker cannot be usefully employed because of any strike by the Union or Unions affiliated with it or by any other association or union, or through any breakdown of the employer's machinery, or from any other cause for which the employer is not responsible, with the exception of wet weather, in which case the decision as to whether it is too wet to work shall rest with the engineer in charge, if available, and, in his absence, the foreman.

7.—Casual Workers.

A worker engaged for less than one (1) week (except a worker who is dismissed for inefficiency or misconduct or who leaves the service of the employer of his own volition) shall be deemed a casual hand and whilst engaged as such shall be entitled to receive ten per cent. (10%) in addition to the minimum rate herein prescribed.

8.—Higher Duties.

Any worker carrying out work classified at a higher minimum than his ordinary work for two (2) hours in any shift shall be paid at the minimum rate for such work for the whole of that shift. Provided that such minimum is not lower than such worker's regular rate of pay. If he be employed for less than two (2) hours at work classified at a higher minimum than his ordinary rate, he shall be paid his ordinary rate for the whole shift.

9.—Hours.

(a) For all workers other than watchmen, forty (40) hours shall constitute a week's work and shall be worked from Monday to Friday (inclusive) each week.

(b) For watchmen, forty (40) hours shall constitute a week's work.

10.—Shift Work.

If shifts are worked, workers employed on afternoon shifts shall be paid an additional five per cent. (5%) and if on night shifts, shall be paid an additional seven and a half per cent. (7½%).

A worker employed on shift work, who is not allowed to rotate day shift with afternoon and/or night shift, shall be paid a loading of twenty-five per cent. (25%) on the ordinary rates of pay for such work performed on afternoon and/or night shift. Provided that this provision shall not apply where the period for which afternoon and/or night shift is worked without rotation with day shift does not exceed two (2) weeks.

Any shift commencing before 6 a.m. or after 10 p.m. shall be deemed to be afternoon or night shift.

This clause shall not apply to watchmen.

11.—Overtime.

(a) For all workers other than watchmen—

(i) all work performed beyond eight (8) hours in any day or on Saturdays shall be deemed overtime and shall be paid for at the rate of one and a half times for the first two (2) hours and double time thereafter;

(ii) all time worked on Sundays or on the holidays referred to in subclause 13 (a) hereof shall be paid for at the rate of double time.

(b) All work performed by watchmen in excess of eight (8) hours per day or beyond forty (40) hours per week, exclusive of Sundays, shall be paid for at the rate of time and one-quarter. All work performed on Sundays shall be paid for at the rate of time and one-half.

(c) (i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) No organisation party to this Agreement, or worker or workers covered by this Agreement, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the requirements of this subclause.

12.—Meal Money.

When a worker is required for overtime without having been notified on the previous day, he shall be supplied with a meal or be paid three shillings (3s.) for a meal. Provided no such meal or payment is due unless the worker works more than one hour after the usual knock-off time. Provided that a worker who is allowed not less than one hour and a half in which to get a meal before resuming work, and facilities for obtaining a meal are available, shall not be entitled to meal money or a meal under this clause.

13.—Holidays.

(a) The following days, or the days observed in lieu thereof, shall be observed as holidays without deduction of pay:—New Year's Day, Australia Day, Labour Day, Anzac Day, Good Friday, Easter Monday, State Foundation Day, Christmas Day, Boxing Day and Building Trades Picnic Day.

(b) On any public holiday not prescribed as a holiday under this Agreement, the employer's establishment or place of business may be closed, in which case a worker need not present himself for duty, and payment may be deducted, but if work be done, ordinary rates of pay shall apply.

(c) Except as hereinafter provided, a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker by his employer after a period of twelve (12) months' continuous service with such employer.

(d) If after one (1) week's continuous service in any qualifying 12-monthly period, a worker lawfully leaves his employment, or his employment is terminated by the employer, through no fault of the worker, the worker shall be paid one-twenty-sixth (1/26th) of a week's pay at his ordinary rate of wage in respect of each completed week of continuous service.

(e) Any time in respect of which a worker is absent from work, except time spent on holidays or annual leave as prescribed by this Agreement, shall not count for the purpose of determining his right to annual leave.

(f) In the event of a worker being employed by an employer for portion only of a year, he shall only be entitled, subject to subclause (d) of this clause, to such leave on full pay as is proportionate to his length of service during that period with such employer, and if such leave is not equal to the leave given to the other workers, he shall not be entitled to work or pay whilst the other workers of such employer are on leave on full pay.

(g) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(h) With the exceptions of subclauses (a) and (b) hereof the provisions of this clause shall not apply to casual workers.

14.—Board of Reference.

(1) For the purpose of this Agreement, a Board of Reference is hereby appointed, which shall consist of a chairman and two (2) other representatives, one to be nominated by each of the parties. The said Board shall have assigned to it, in the event of no agreement being arrived at between the parties to the dispute, the functions of—

(a) adjusting any matters of difference which may arise from time to time, except such as involve interpretation of the provisions of this Agreement, or any of them;

(b) dealing with any other matter which the Court may refer to the Board from time to time.

(2) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Industrial Arbitration Act, 1921-1952, which for this purpose are embodied in this Agreement.

15.—Record.

(a) Each employer shall keep a time and wages book showing the name of each worker, and the nature of his work, and hours worked each day, and the wages and allowances paid each week. Any system of automatic recording by means of machines shall be deemed to comply with this provision to the extent of the information recorded.

(b) The time and wages record shall be open for inspection by a duly accredited official of the Union, during the usual office hours, at the employer's office or other convenient place, and he shall be allowed to take extracts therefrom.

16.—Payment of Wages.

Wages shall be paid at least once weekly within fifteen (15) minutes of the worker's knock-off time.

The employer shall not keep more than two days' pay in hand.

The employer shall provide a suitable change room where the workers may change their clothes.

18.—First Aid.

An adequate first aid kit, maintained by the employer, shall be provided on the site.

19.—Special Rates.

(a) Dirt Money.

A dirt allowance of twopence (2d.) per hour shall be payable in connection with work deemed to be more than ordinarily dirty; cases of dispute to be determined by the Board of Reference.

(b) Wet Work.

(i) Any worker working in water or "wet places" shall be paid an extra allowance of one shilling and fourpence (1s. 4d.) per day or part of a day.

(ii) "Wet places" shall mean places where, in the performance of the work the splashing of water and mud saturate the worker's clothing or where protection is not provided to prevent splashing or drippings sufficient to saturate his clothing, and shall include wet material or wet ground in which it is impracticable for the worker wearing ordinary working boots to work without getting wet feet. Provided that this clause shall not apply to men working on natural surfaces made wet by rain.

(iii) In exceptional cases where the work is excessively wet and which are not covered by subclause (ii) hereof, an extra allowance may be agreed upon or, failing agreement, determined by the Board of Reference.

(iv) Subject to subclause (iii) the engineer in charge or the foreman shall decide whether any allowance is payable under this clause.

(v) Workers called upon to work overtime in water or in wet places shall receive an extra one shilling and four pence (1s. 4d.) or the appropriate allowance fixed by the Board of Reference for each eight (8) hours or portion thereof, of overtime worked, and such allowance shall be treated as portion of the wage for the calculation of overtime. For all other purposes, the extra payment shall be deemed an allowance.

20.—Maximum Rate.

The highest rate to which a worker employed subject to this Agreement shall be entitled is twice the ordinary rate of pay.

21.—Special Conditions.

(a) Except as provided in this Agreement, the employer shall be entitled to deduct payment for any day or portion of day when a worker fails to report for duty.

(b) (i) If a worker is not notified before he leave the job at the end of the day or shift that his services will not be required on the next day or shift, and such worker presents himself for work at the appointed starting time, he shall be paid for that day: Provided, however, that if the unemployment is on account of causes beyond the control of the management he shall be entitled to only two (2) hours' pay and be notified of the cause why he cannot be employed: Provided, further, that when the worker lives or resides in such close proximity to the work that he is under no necessity

to incur any extra expense by a delayed notification of his services not being required, then such notice shall be deemed sufficient if given at least one (1) hour before the usual starting time.

(ii) Employees not required to commence work on Saturdays or Sundays after having been directed to report for work on such days shall be paid two (2) hours at the appropriate rate applicable for such day and shall be paid all fares actually and necessarily incurred in travelling to and from the job.

22.—Oilskins.

The employer will supply oilskins free of charge to all workers required by the employer to work in the rain or in exposed positions, as approved by the engineer in charge.

23.—Payment for Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health at the rate of one-twelfth (1/12th) of a week's pay for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one (1) week's pay in each calendar year.

(b) Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred.

(c) This clause shall not apply when the worker is entitled to compensation under the Workers' Compensation Act.

(d) A worker shall not be entitled to receive any wages from his employer for any time lost through any accident not arising out of or in the course of his employment or for any accident wherever sustained arising out of his own wilful default, or for sickness arising out of his own wilful default.

(e) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.
