WHEREAS by clause 14 of the Letters Patent passed under the Great Seal of the United Kingdom constituting the office of Governor of the State of Western Australia and its Dependencies, bearing date the 29th October, 1900, it is provided that in the event of the Governor having occasion to be temporarily absent from the seat of Government or from the State, he may in every such case, by an instrument under the Public Seal of the State, constitute and appoint the Lieutenant-Governor to be his deputy during such absence, and in that capacity to exercise, perform and execute, for and on behalf of the Governor, during such absence but no longer, all such powers and authorities vested in the Governor by such Letters Patent as shall in and by such instrument be specified; and whereas I, the said Governor, propose to absent

myself temporarily from the State; Now, therefore I, the said Governor, by virtue and in exercise of the powers vested in me as aforesaid, do by this instrument under the Public Seal of the State constitute and appoint you the said Sir John Patrick Dwyer as from the date of my departure upon the said absence from the State and during such absence to be my deputy, and in that capacity to exercise, perform and execute, for and on my behalf, as such Governor, all the powers and authorities vested in me by the said Letters Patent.

WHEREAS it is provided by subsection (1) of section 165 of the Factories and Shops Act, 1920-1956, that the Governor may from time to time, by Proclamation, exempt any portion of the State from the operation of the Act, or any Part thereof: Now therefore I, the Governor of Western Australia, do, by this Proclamation, exempt that portion of the State which is comprised within the limits of the Royal Agricultural Society Showgrounds at Claremont established by the Royal Agricultural Society Act, 1926, as amended, from the provisions of the Factories and Shops Act, 1920-1956, except the provisions relating to industrial awards and agreements and to the duties of industrial inspectors,

for the periods from the 6th to the 8th March, 1958, inclusive, and the 10th to the 15th March, 1958, inclusive.

At a meeting of the Executive Council held in the Executive Council Chamber at Perth on the 5th day of December, 1957, the following Orders in Council were authorised to be issued.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956.

ORDER IN COUNCIL.

WHEREAS by section 72 (h) of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956, it is provided that all land shall be rateable land within the meaning of the Act, save and except land declared by the Governor to be exempt from rates under the Act: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby declare that the land contained in west part lot 16, North Street, Bassendean, shall be exempt from sewerage rates under the Act.

Land Drainage Act, 1925.

Osborne Park Drainage District.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 3 of the Water Supply, Sewerage and Drainage Act, 1912, that, *inter alia*, the Governor may in his discretion, revoke any Order in Council, made before or after the commencement of that Act, for the constitution of any Board constituted under any of the

Acts, including the Land Drainage Act, 1900, referred to in subsection (1) of the said section 3, and may dissolve the Board constituted pursuant to any order so revoked; and whereas by Order in Council dated the 11th day of June, 1937, made pursuant to the Land Drainage Act, 1925, and published in the *Government Gazette* of the 18th day of June, 1937, the Board for the Osborne Park Drainage District was constituted; and whereas the Land Drainage Act, 1900, was repealed by the Land Drainage Act, 1925, under section 5 of which the Osborne Park Drainage Board subsisted and enured as if it had originated by Order in Council under section 15 thereof; and whereas it is enacted by section 11 of the Land Drainage Act, 1925, that the Governor may, by Order in Council, abolish any district constituted under that Act; and whereas the Njookenbooroo Drainage District was constituted by Order in Council dated the 19th day of December, 1911, made pursuant to the Land Drainage Act, 1900, and published in the *Government Gazette* dated the 29th day of December, 1911; and whereas the Land Drainage Act, 1900, was repealed by the Land Drainage Act, 1925, under section 5 of which the Njookenbooroo Drainage District subsisted and enured as if it had originated by Order in Council under section 11 thereof; and whereas the boundaries of the Njookenbooroo Drainage District were amended by Orders in Council made pursuant to the Land Drainage Act, 1925, and dated the 17th day of August, 1927, the 11th day of January, 1928, and the 30th day of June, 1931, and published in the *Government Gazettes* of the 26th day of August, 1927, the 27th day of January, 1928, and the 10th day of July, 1931, respectively; and whereas pursuant to section 12 of the Land Drainage Act, 1925, the name of the Njookenbooroo Drainage District was altered to the Osborne Park Drainage District by Order in Council dated the 28th day of December, 1934, and published in the *Government Gazette* of the 25th day of January, 1935; and whereas the boundaries of the Osborne Park Drainage District were amended by Order in Council dated the 29th day of May, 1935, and published in the *Government Gazette* dated 7th day of June, 1935: Now therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, doth hereby revoke the Order in Council for the constitution of the Osborne Park Drainage Board and dissolve the Osborne Park Drainage Board and abolish the Osborne Park Drainage District.

This Order in Council shall take effect on the 1st day of January, 1958.

Bunbury Water Board.

ORDER IN COUNCIL.

P.W.W.S. 939/56.

WHEREAS by the Water Boards Act, 1904-1954, it is provided that before undertaking the construction of works in the Water Area the Minister shall submit plans, descriptions, books of reference, and estimates of the proposed works to the Governor for approval; and if they are approved by the Governor he may forthwith make an Order empowering the Water Board to undertake the construction of the works: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, hereby approves of the Bunbury Water Board Plan No. 126, description, books of reference and estimates for the laying of new mains, together with the necessary valves, fittings and hydrants, within the Bunbury Water Area, which were duly submitted for approval, and hereby empowers the Bunbury Water Board to undertake the construction of the said works.

Country Areas Water Supply Act, 1947-1954.

Country Water Area and Rating Zone.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 8 of the Country Areas Water Supply Act, 1947-1954, that the Governor may, by Order in Council, constitute a Country Water Area; and whereas by section 10 of the said Act it is further provided that the Governor may, by Order in Council, constitute any number of Rating Zones in a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby constitute the Perenjori Country Water Area as defined in the Schedule hereunder and doth also hereby constitute the whole of the said area to be a rating zone and to assign the name of "Perenjori Rating Zone" thereto.

This Order in Council shall take effect on the 5th day of December, 1957.

Schedule.

All that portion of land bounded by lines starting at the north-eastern corner of the southern severance of Victoria Location 4738, a point on the southern side of Wongan Hills Railway Reserve, and extending south-easterly along that side to a point situate in prolongation westerly of the northernmost boundary of Perenjori Townsite; thence easterly to and along that boundary to the north-western corner of Victoria Location 6678 (reserve No. 15854); thence southerly and easterly along boundaries of Perenjori Townsite and onwards to the eastern side of North Street; thence southerly along that side and onwards to a point on the northern boundary of location 4768; thence south-westerly along that boundary to a point in prolongation southerly of the western boundary of lot 1 of location 4794, as shown on Lands Titles Office deposited diagram 19702; thence northerly to and along that boundary to the north-western corner of that lot; thence westerly and northerly along southern and western boundaries of part reserve 18848 to the starting point.

ORDER IN COUNCIL.

Great Southern Towns Country Water Area—
Extension.

Constitution of Pingelly Rating Zone.

1. UNDER section 4 (6) of the Water Boards Act, 1904-1954, the Pingelly Water Area as constituted and defined by Order in Council published in the *Government Gazette* dated 8th September, 1911 (and within which area the Minister for Works is authorised under section 161 of the said Act or under section 4 of Act No. 67 of 1912 to exercise powers conferred on a Water Board) is hereby abolished, and under section 3 of Act No. 67 of 1912, any existing Water Board constituted for such Water Area is hereby dissolved.

2. Under section 8 of the Country Areas Water Supply Act, 1947-1957, and for the purposes of that Act the boundaries of the "Great Southern Towns Country Water Area" as constituted and defined

by Order in Council published in the *Government Gazette* dated 14th June, 1957, are extended to include all that land

- (a) being the strip of land comprised within 50 links on either side of the water pipeline already constructed and now laid down by the said Minister in or over the land referred to in subparagraph (b) of this paragraph and up to the points at which the said water pipeline meets the boundaries of each of the areas described in subparagraphs (c) to (g) of this paragraph; and
- (b) being the land delineated and coloured red on the plan being Department of Lands and Surveys registered plan Miscellaneous Plan 208, sheets 1-3 inclusive, and Department of Public Works Plan P.W.D., W.A. No. 35957, sheets 1-3 inclusive; and
- (c) all that portion of land bounded by lines commencing at a point on an eastern boundary of Narrogin Agricultural Area lot 6 situate in prolongation westerly of the southern boundary of Williams Location 1393, and extending northerly and north-westerly along the eastern boundaries of Narrogin Agricultural Area lots 6, 9, 10 and 13 to a point situate in prolongation westerly of the northern boundary of Williams Location 1393; thence easterly to and along that boundary to the north-eastern corner of that location thence southerly and westerly along eastern and southern boundaries of that location to its south-western corner and onwards to the starting point.

being the land delineated and bordered yellow on sheet 1 of the said plan Lands and Surveys Miscellaneous Plan 208 and on sheet 1 of the said Plan P.W.D., W.A., No. 35957; and

- (d) all that portion of land contained within the boundaries of Cuballing Townsite—

being the land delineated and bordered grey on sheets 1 and 2 of the said plan Lands and Surveys Miscellaneous Plan 208 and on sheets 1 and 2 of the said Plan P.W.D., W.A., No. 35957; and

- (e) all that portion of land bounded by lines commencing at the south-eastern corner of Williams location 10427 (part reserve 15925) and extending northerly along the eastern boundary of that location to the north-west corner of reserve 6593; thence easterly along the northern boundary of that reserve and onwards to a point on the eastern side of reserve 16969 (Railway reserve); thence generally southerly along that side to a point situate in prolongation easterly of the southern boundary of reserve 4698; thence westerly to and along that boundary to the starting point

being the land delineated and coloured brown on sheet 2 of the said plan Lands and Surveys Miscellaneous Plan 208 and on sheet 2 of the said Plan P.W.D., W.A., No. 35957; and

- (f) all that portion of land contained within the boundaries of Popanyinning Townsite

being the land delineated and coloured green on sheet 2 of the said plan Lands and Surveys Miscellaneous Plan 208 and on sheet 2 of the said Plan P.W.D., W.A., No. 35957; and

- (g) all that portion of land bounded by lines commencing at the south-eastern corner of the northern severance of Avon Location 6355 and extending northerly along an eastern boundary of that severance and onwards to the south-eastern corner of the western severance of location 5595; thence generally north-westerly along the southern boundaries of that severance and onwards to the south-eastern corner of location 4242; thence northerly and westerly along western and northern boundaries of that location and onwards to a point on an eastern boundary of location 4634;

thence northerly, easterly, again northerly, westerly and again northerly along boundaries of that location and onwards to a point situate 15 and two-tenths links west of the south-western corner of location 3630; thence easterly 15 and two-tenths links to the south-western corner of that location; thence northerly along the western boundary of that location to the south-eastern corner of location 3456; thence northerly along the eastern boundaries of locations 3456, 2690, 2689, 2930 and 2365 to the north-western corner of Pingelly Townsite; thence easterly and southerly along northern and eastern boundaries of that Townsite to the northern side of road number 1998; thence south-easterly, southerly and again south-easterly along that side to a point in prolongation northerly of the western boundary of location 5625; thence southerly to and along that boundary to the south-western corner of that location; thence easterly to the north-western corner of location 5811 and southerly along the western boundary of that location to its south-western corner; thence westerly and southerly along northern and western boundaries of location 5843 to the south-western corner of that location; thence easterly along a southern boundary of that location and onwards to the western boundary of location 5715; thence southerly along that boundary to the south-western corner of that location; thence westerly and southerly along northern and western boundaries of location 5415 to the south-western corner of that location; thence southerly across the Hotham River (North Branch) to the north-eastern corner of Williams Location 6595; thence southerly along the eastern boundary of that location and onwards to and along the eastern boundary of the eastern severance of Avon Location 10421 to the south-eastern corner of that severance; thence westerly along the southern boundary of location 10421 and onwards to the starting point

being the land delineated and bordered pink on sheet 3 of the said plan Lands and Surveys Miscellaneous Plan 208 and on sheet 3 of the said Plan P.W.D., W.A., No. 35957.

3. Under section 10 of the Country Areas Water Supply Act, 1947-1957, and for the purposes of that Act the following land is constituted the Pingelly Rating Zone within the Great Southern Towns Country Water Area

all that land contained within the boundaries of the northern portion of Pingelly Townsite as shown bordered blue on sheet 3 of the said plan Lands and Surveys Miscellaneous Plan 208 and on sheet 3 of the said Plan P.W.D., W.A., No. 35957.

(Public Plan—Pingelly Townsite.)

This Order in Council shall take effect on the 1st day of January, 1958.

Between Western Australian Amalgamated Society of Carpenters and Joiners' Industrial Union of Workers, Applicant, and Australian Blue Asbestos Ltd., Respondent.

THE Conciliation Commissioner in pursuance of the powers and duties conferred upon him by Section 108B of the Industrial Arbitration Act, 1912-1952,

and in pursuance of a remission made to him by the Court of Arbitration, doth hereby make the following Award in connection with the industrial dispute between the abovenamed parties.

1.—Scope.

This Award shall apply to the workers classified in Clause 5 hereof employed by the employer in connection with the production of blue asbestos.

2.—Term.

The term of this Award shall be for a period of three (3) years and shall take effect from the commencement of the first pay period next following the date hereof.

3.—Area.

This Award shall have effect over the area covered by Mineral Claim 54 West Pilbara and the locality within a radius of fifty (50) miles thereof.

4.—Definitions.

(a) "Carpenter and Joiner" means a worker engaged upon the erection, repair or ornamentation of work, in wood, or of any form of constructional work in wood, as well as the making, preparing and fixing of all necessary woodwork and fittings in connection therewith including:—Metal ceilings, the fixing of the following asbestos products—corrugated sheets, gutters, down pipes, ridging, rain heads, ventilators and skylights, fascia and barge boards.

(b) "Casual worker" means any worker who is dismissed through no fault of his own before the expiration of one (1) week of his employment.

5.—Wages.

(a) Basic wage at the rate of £13 6s. 7d. per week.

(d) Tool Allowance.—In addition to the above, an allowance at the rate of five shillings (5s.) per week shall be paid as a tool allowance to a carpenter and joiner and a 3rd, 4th and 5th year apprentice.

(e) Casual Workers.—Casual workers shall be paid ordinary rates, plus ten per cent. (10%).

(f) Leading Hand.—Leading hands in charge of not less than three (3) and not more than ten (10) workers shall be paid at the rate of three shillings (3s.) per day extra; more than ten (10) and not more than twenty (20) workers, six shillings (6s.) per day extra; more than twenty (20) workers, nine shillings (9s.) per day extra.

(g) Wet and Dusty Places.—In dust bins or places where the atmosphere is similarly dust-laden, or where water is continuously dripping so that the clothing or feet become wet, one shilling and fourpence (1s. 4d.) per day or shift, or fraction of one shilling and fourpence (1s. 4d.) in proportion to the time worked in such place, shall be paid in addition to the rates prescribed in sub-clause (b).

(h) A disabilities allowance of two shillings and sixpence (2s. 6d.) per week shall be paid to all carpenters and joiners employed on construction work. This allowance shall not apply to carpenters and joiners employed in joiner shops.

(i) Dirt Money.—Workers employed on dirty work shall be paid fourpence (4d.) per hour extra. In case of a dispute as to whether the work is or is not dirty it shall be referred to the Board of Reference whose decision shall be final.

(j) Confined Space.—Workers employed in confined spaces as hereinafter defined, shall be paid sixpence (6d.) per hour extra.

"Confined Space" means a working space the dimensions of which necessitates a worker working continuously in a stooped or otherwise cramped position, or without proper ventilation, or where confinement within a limited space is productive of unusual discomfort.

(k) In respect to subclauses (g), (i) and (j) hereof, where more than one of the disabilities entitling a worker to extra rates exist on the same job, the employer shall be bound to pay only one rate, namely, the highest, for the disabilities so prevailing.

6.—District Allowance.

A district allowance of forty-five shillings (45s.) per week shall be paid to all adult workers employed under this Award.

7.—Hours.

(a) The ordinary working hours shall not exceed forty (40) in any one week and shall not exceed eight (8) hours daily, to be worked from Monday to Friday inclusive and, except in the case of shift workers, to be worked between the hours of 7 a.m. and 5 p.m.

(b) Lunch interval shall not exceed one (1) hour.

(c) Workers working underground for more than two (2) hours on any one (1) day or shift shall work the hours provided in the Award governing members of the Australian Workers' Union.

8.—Overtime.

(a) For all work done beyond the hours of duty on any ordinary day, payment shall be at the rate of time and a half for the first two (2) hours and double time thereafter.

(b) All work done on Saturdays shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter.

(c) Repairs to the machinery of the employer which is broken down and has caused a stoppage of operations shall be paid for at time and a half for Saturdays, Sundays and holidays.

(d) Work done on Sundays or on holidays shall be paid for at double time.

(e) When a worker is recalled to work after leaving the premises he shall be paid for at least two (2) hours at overtime rates.

(f) When a worker, without being notified on the previous day is required to continue working after the usual knock-off time for more than one (1) hour or (in the case of a day-worker) after 5.30 p.m. whichever is the later, he shall be provided with any meal required or shall be paid three shillings and sixpence (3s. 6d.) in lieu thereof.

(g) When a worker is required to hold himself in readiness for a call after ordinary hours, he shall be paid at ordinary rates for the time that he holds himself in readiness.

(h) When a worker is required for duty during any meal time whereby his meal time is postponed for more than one (1) hour, he shall be paid at overtime rates until he gets his meal.

(i) When computing overtime, any district allowance shall not be computed as an addition to the day's pay.

(j) (i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work overtime in accordance with such requirement.

(ii) No organisation, party to this Award, or worker or workers covered by this Award, shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation or restriction upon the working of overtime in accordance with the requirements of this subclause.

(k) A worker failing to take up his rostered or appointed shift unless such is due to illness or other just cause shall pay the employer for any extra payment incurred thereby through another worker being called upon to work the shift.

9.—Holidays.

(a) Each worker shall be entitled to three (3) weeks' annual leave on full pay, or should the period of continuous employment be less than one year, the worker shall be paid holiday pay in proportion as his length of service is to the full year's employment. Annual leave shall be taken at a time suitable to the convenience of the employer; provided that, where a worker is dismissed for wilful misconduct, he will not be entitled to the benefits of this clause; provided further, that by agreement between the employer and the worker, leave may be allowed to accumulate for two (2) years.

(b) The amounts to be paid under subclause (a) shall be calculated at the rate prevailing at the time the payment is made.

(c) Subject to subclauses 8 (c) and (d), the following shall be paid holidays:—

Christmas Day, Good Friday, Easter Monday, Labour Day and one (1) additional day in each calendar year to be nominated by the employer. If Christmas Day falls on a Sunday, the following Monday shall be observed. Provided that any worker who does not present himself for work (if required) on the working day following any of the abovementioned holidays shall not be entitled to be paid for such holiday unless he produces proof satisfactory to the employer that he was prevented by sickness from presenting himself for work on any such day and that such sickness was not due to intemperance or misconduct.

(d) The provisions as to annual leave shall not apply to casual workers.

(e) Any worker who has taken part in a strike (including a slow strike) or a general or sectional stoppage of work unauthorised by the employer, during the period of service in respect of which the abovementioned annual holidays are granted, shall forfeit one day of such annual holidays for every day or part of a day during which he takes part in a strike, or in such unauthorised stoppage of work, including a stoppage because of a fatal accident in the mine, except in the case of those workers working in the same shift and the same level as the deceased who desire to attend the funeral and so notify the employer.

10.—Weekly Hiring.

(a) A week's notice of intention to terminate the employment shall be given on either side, except in the case of casual workers.

(b) The employer shall be under no obligation to pay for any day not worked upon which the worker is required to present himself for duty, except such absence from work is due to illness and comes within the provisions of Clause 11 or such absence is on account of holidays to which by service subsequent to the sickness to a greater the worker is entitled under the provisions of the Award.

(c) This clause does not affect the right to dismiss for misconduct, and in such case wages shall be paid up to the time of dismissal only.

(d) The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the Union or Unions affiliated with it, or by any other association or union, or through the breakdown of the employer's machinery, or any stoppage of work by any cause which the employer cannot reasonably prevent.

11.—Payment for Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal ill-health for 1/10th of a week's pay at the Award rate for each 23.7 shifts actually worked, at ordinary rates of pay: Provided that, subject to subclause (d) hereof, payment for absence through such ill-health shall be limited to one week's pay in each calendar year. Payment hereunder may be adjusted at the end of each calendar year, or at the time the worker leaves the service of the employer in the event of the worker being entitled

allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to compensation under the Workers' Compensation Act.

(b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment, or for any accident wherever sustained, arising out of his own wilful default or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three days or more.

(d) Sick leave shall accumulate from year to year so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and, subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year.

(e) Any time in respect of which a worker is absent from work, except time for which he is entitled to claim for sick pay under the preceding provision shall not count for the purpose of determining his right to holidays.

12.—Shifts.

Men working shifts not subject to weekly rotation shall be paid for each shift other than day shift at the rate of time and one-quarter. The roster known as the Great Boulder Roster and other accepted variations thereof, shall be deemed to be subject to weekly rotation.

13.—Payment of Wages.

Pay day shall be in accordance with Section 55 of the Mines Regulation Act. Any worker leaving or being discharged shall be paid the full amount of wages due to him within one (1) hour of ceasing work, or within one hour of the opening of the office, if such office was closed at the time of his ceasing work, whenever same is practicable.

14.—Record Book.

A time and wages book shall be kept by each employer, in which shall be entered the name of each worker, the nature of the work he is doing, the hours worked each day, and the amount of wages received by him each week. The employer shall be responsible for the proper posting of the book each week; the said book shall be open to the authorised representative of the Union at any time during working hours, and he shall be allowed to take necessary extracts therefrom.

Provided that any system of automatic recording by means of machines shall be deemed a compliance with this provision to the extent of the information recorded.

15.—Representative Interviewing Workers.

In the case of a disagreement existing or anticipated concerning any of the provisions of this Award, an accredited representative of the Union shall be permitted to interview workers during the recognised meal hour, or at some other period convenient to the employer, on the business premises of the employer, but this permission shall not be exercised without the consent of the employer more than once in any one week.

16.—No Reduction.

Nothing herein shall in itself operate to reduce the wage of any worker below the rate actually received by him at the date hereof.

17.—Provision of Appliances.

(a) Carpenters and Joiners: The employer shall provide the following tools when they are required on the job—dogs and cramps of all sizes, bits not ordinarily used in a brace, hack saws, all hammers

except claw hammers, glue pots and brushes, dowel plates, trammels, hand and thumb screws, soldering irons and spanners from three-quarters of an inch upwards.

(b) The employer shall provide on all jobs suitable sanitary conveniences and boiling water ready for meal times, where it is necessary.

(c) First Aid—

- (i) A First-Aid outfit shall be provided by the employer at a convenient suitable place.
- (ii) Each shift boss and/or foreman shall have ready and available for use on his person a small emergency supply of bandages and padding or similar requisites.
- (iii) Any First-Aid man appointed by the employer to perform first aid duties shall be paid an allowance of two shillings and sixpence (2s. 6d.) per shift in addition to his ordinary rate of pay.

18.—Under Rate Workers.

(a) Any worker who by reason of old age or infirmity is unable to earn the minimum wage may be paid such lesser wage as may from time to time be agreed upon in writing between the union and the employer.

(b) In the event of no agreement being arrived at, the matter may be referred to the Board of Reference for determination.

(c) After application has been made to the Board, and pending the Board's decision, the worker shall be entitled to work for and be employed at the proposed lesser rate.

19.—Piecework.

(a) Subject to the minimum wage rates and other conditions herein prescribed, an employer may remunerate any of his workers under any system of payment by results.

(b) The union may during the currency of the Award apply to the Court for the correction or regulation of any piecework rate, time bonus rate, task rate or any other system of payment by results.

20.—Tool Lock-up.

A secure and weatherproof place shall be provided by the employer where the carpenter's tools may be locked up apart from the employer's plant or material.

21.—Grinding Time.

Employers shall provide sandstone grindstones. Carpenters shall be allowed to maintain their tools in proper working conditions in working hours.

When a carpenter who has been employed for five (5) consecutive working days is discharged, he shall be allowed two (2) hours for grinding tools or two (2) hours' pay in lieu thereof.

22.—University Students.

Provision may be made by agreement between an employer and University or School of Mines or Technical College students as to terms and conditions of employment. Any such agreement shall be submitted to the Court for approval within one (1) month after the making thereof. Provided always that this clause shall only apply in the case of a day time student who has not completed his course at the University or School of Mines or Technical College and where such employment is for the purpose of giving him practical experience and/or assisting the student to complete his course of study.

23.—Apprentices.

(a) The provisions of the Apprenticeship Regulations, 1953, subject to any modifications or alterations contained in this clause, are hereby embodied in and form part of this Award.

(b) The maximum number of apprentices allowed to any employer shall be in the proportion of one (1) apprentice to every two (2) or fraction of two (2) journeymen employed by him in that branch; provided that the fraction of two (2) shall not be less than one (1).

(c) If the apprentice be employed on a mine and the mine ceases any operations in which the apprentice is engaged, the apprenticeship may be terminated in which case the apprentice shall be given a certificate to show the time he has served, and the employer shall endeavour to find him another employer willing to complete the term. Should the apprentice desire to complete his apprenticeship with another employer, the certificate he has received from the former employer shall be prima facie evidence of the wages he is entitled to receive and the period necessary to complete his apprenticeship.

(d) If the apprentice shall at any time during the said term be wilfully disobedient to the lawful orders of the employer, his managers, foremen, or other servants having authority over the apprentice, or be slothful or negligent or disobedient, or shall otherwise grossly misbehave himself, or shall not conduct himself as a good and faithful apprentice should do, or should not faithfully observe and keep his part of his agreement then it shall be lawful for the employer with the consent of the Court to discharge the apprentice from his service.

(e) The Court may in its discretion for any cause which it may deem sufficient on the application of any party to an apprenticeship agreement, abrogate or cancel the agreement, either unconditionally, or subject to such terms and conditions as it may deem advisable.

24.—Board of Reference.

(a) The Court hereby appoints, for the purposes of the Award, a Board of Reference for each mine.

(b) The Board shall consist of a Chairman, who, failing agreement between the parties, shall be appointed by the Court, and two (2) other representatives, one to be nominated by each of the parties.

(c) There shall be assigned to each such Board the functions of:—

- (i) Deciding matters specifically referred to in the Award as being the subject matter of a decision of the Board;
- (ii) Adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of the Award, or any of them;
- (iii) Deciding all matters and questions referred to in the Award as being the subject of mutual agreements, if not agreed upon;
- (iv) Deciding any other matter that the Court may refer to such Board from time to time.

(d) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the regulations to the Industrial Arbitration Act, 1912-1952, which for this purpose are embodied in and form part of this Award. (Regulation 106.)

(e) There shall be no cessation of work pending the reference to and the settlement of any dispute by the Board.

25.—Transport.

(a) When a worker is engaged at Perth or at any town or city within the State of Western Australia north thereof the employer shall provide transport from such place of engagement to the place of employment, the cost of same to be deducted from the subsequent earnings of the worker in such manner as is agreed upon in writing by the parties. Provided that if the worker completes six (6) months' continuous service with the employer, the cost of such transport not exceeding the equivalent of a Perth-Wittenoom air fare will be refunded by the employer, and in addition such worker shall be paid an amount equivalent to four (4) hours' pay as compensation for travelling time.

(b) The foregoing provision shall apply to all periods of annual leave in respect to the return transport to Wittenoom as though such worker on returning from leave had been re-engaged. Provided that such worker returns from annual leave at the correct date to recommence work, or at any time approved by the employer as an extension of time.

26.—Dust Allowance.

A dust allowance, in addition to the margins provided by this Award, shall be paid if, and when so decided by a Board of Reference.

27.—Accident Pay.

In the event of a worker meeting with an accident during the shift, or being required to attend to one who has met with an accident, he shall be deemed to have rendered duty during the whole of the shift, and be paid accordingly.

28.—Drinking Water.

(a) In all districts where free water is supplied by the employer single men shall get three (3) gallons and married men six (6) gallons per day.

(b) Where practicable, and if required, hot points shall be provided at all crib rooms for the purpose of heating water or, alternatively, if required, the employer shall supply hot water to workers at all crib rooms.

HAVING heard Mr. H. Cant on behalf of the applicant and Mr. F. J. Darling on behalf of the respondent, and by consent, I, the undersigned, Conciliation Commissioner of the Court of Arbitration, in pursuance of a remission to me by the said Court and in pursuance of the powers contained in Section 92 of the Industrial Arbitration Act, 1912-1952, do hereby order and declare that Award No. 21 of 1954, as amended, be and the same is hereby further amended in the following manner:—

Delete Clause 24 and insert in lieu thereof the following:—

Clause 24—Interviewing Workers.

Subject to the observance of the security and safety regulations in force from time to time at the Cement Works, the Secretary or other full time Representative of the Union, duly authorised in writing by the President or Secretary of the Union, shall be allowed to enter the Cement Works by prior appointment not more than once in any week for the purpose of inspecting working places and shall be permitted to interview workers in the Canteen during the recognised meal period.

Between the Western Australian Amalgamated Society of Carpenters and Joiners' Industrial Union of Workers, Applicant, and Greenhalgh and Hewitt, Respondents.

HAVING heard Mr. R. Clohessy on behalf of the Applicant Union and Mr. G. Martin on behalf of the Respondents on the application herein for interpretation of Clause 18 of Award No. 63 of 1951 (Building Trades Award) the Court in pursuance of the powers contained in Section 90 of the Industrial Arbitration Act, 1912-1952, in order to remedy a defect in the said Award and for the purpose of giving fuller effect thereto doth hereby order and declare that the said Award, as amended, be and the same is hereby further amended in the following terms:—

Clause 18.—Fares and Travelling Time.

Delete subclause (a) of this clause and insert in lieu thereof:—

(a) For all workers required on any day to report directly to the job, the following allowance shall be paid to workers and apprentices to compensate for excess fares and travelling time from the worker's home to his place of work and return.

- (i) On places of work within a radius of two (2) miles from the G.P.O., Perth—nil.
- (ii) On places of work beyond a radius of two (2) miles and within a radius of twelve (12) miles from the G.P.O., Perth—4s. per day.
- (iii) For each additional mile up to 30 miles—4d. per mile.
- (iv) Subject to subclause (v) hereof, work performed at places beyond thirty (30) miles from the G.P.O., Perth, shall be deemed to be distant work unless the employer and the workers with the consent of the Union agree in any particular case that the travelling allowance for such work shall be paid under this clause, in which case an additional allowance of sixpence (6d.) per mile shall be paid for each mile in excess of thirty (30) miles.
- (v) In respect to work carried out from an employer's depot situated more than thirty (30) miles from the G.P.O., Perth, the Post Office nearest to such depot shall be substituted as the centre for the purpose of this clause.
- (vi) Apprentices shall be paid three-quarters ($\frac{3}{4}$) of the above rates.
- (vii) Where transport to and from the job is provided by the employer from and to his depot or such other place as is mutually agreed between the employer and worker, half the above rates shall be paid.
- (viii) When a conveyance is regularly provided by the employer to transport workers to and from work, such conveyance shall be provided with suitable seating accommodation and weatherproof covering.

Clause 19.—Country Work.

Amend the heading of this clause to "Distant Work".

Clause 2.—Arrangement.

Delete "19. Country Work" and insert in lieu thereof "19. Distant Work."

WHEREAS an industrial dispute existed between the abovenamed parties; and whereas the said dispute was referred into Court for the purpose of hearing and determination; and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference; and whereas the parties have this day appeared before the Court by their respective representatives and requested the Court to make the said agreement an Award of the Court: Now, therefore, the Court, pursuant to Section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling it, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court:—

Memorandum of Agreement.

(Note: Wherever the word "Award" occurs herein it shall be taken to mean and include "Agreement.")

1.—Title.

This Award shall be known as the Perth Road Board Officers' Award, 1956.

2.—Arrangement.

3.—Scope.

This Award shall apply to all officers in the employ of the Perth Road Board, excepting Health Inspectors.

4.—Area.

This Award shall have effect over the area comprised within the boundaries of the Perth Road Board, and the area comprised in any office or land upon which any undertaking of that Road Board is being carried on.

5.—Term.

The term of this Award shall be for a period of three (3) years from the date hereof.

6.—Definitions.

(a) "Board" shall mean the Perth Road Board.

(b) "Engineering assistant" shall mean an officer classified as such and qualified by training or experience to work under the direction of the Engineer or Assistant Engineer on surveys, town planning, draughting and/or design or works, structures and/or general routine work of the Engineering Department, but excluding a fourth-year University Engineering Student.

(c) "Executive Officer" shall mean and include the Secretary, Engineer-Building Surveyor, Assistant Secretary, Accountant and Assistant Engineer.

(d) "Temporary Officer" shall mean one who is engaged for less than one week.

(e) "Union" shall mean the Western Australian Local Government Officers' Association.

(f) "Year" shall mean from the 1st July to the 30th June next ensuing.

7.—Hours of Duty.

(a) Except as hereinafter provided, the ordinary hours of duty of officers shall be thirty-eight (38) per week to be worked between the hours of 8.30 a.m. to 5.30 p.m., Monday to Friday inclusive, with a break of not less than forty-five (45) minutes for lunch between noon and 2 p.m.

(b) The hours mentioned in subclause (a) hereof may be varied by agreement between the Board and its officer or officers and, where the duties appertaining to any office cannot be efficiently carried out within the prescribed hours, then in default of such agreement the hours of work shall be determined by the Board of Reference.

Provided, however, that the officer or officers concerned shall not be required to work (except subject to the provisions of the next following clause) a greater number of hours than those specified in subclause (a) hereof.

(c) The hours of duty of foremen and other officers who exercise control over non-clerical workers shall be the same as those of the men over whom they exercise control. Provided that such hours shall not exceed forty (40) per week.

8.—Overtime.

(a) All work done outside the hours specified in clause 7 hereof shall be paid, subject to subclause (b) hereof, at the rate of time and a half for the first four (4) hours and double time thereafter each day, or on Sundays at the rate of double time, or alternatively, time off during working hours may be allowed equivalent to the time worked outside the ordinary hours, or such time may be allowed to accumulate and may be added to the period of annual leave hereinafter prescribed.

(b) Executive officers shall not be entitled to claim payment or time off during working hours for time worked outside the hours prescribed in clause 7 hereof, unless the Board otherwise directs.

(c) No officer shall be entitled to claim payment or time off during working hours for overtime unless such overtime worked has been authorised beforehand by an Executive Officer.

(d) A statement of the overtime worked shall be submitted at each meeting of the Board containing particulars of all overtime alleged to have been worked since the expiration of the preceding meeting, by any officer. No claim for overtime shall be payable or other allowance made thereunder, after three (3) months from the expiration of the time when the overtime is alleged to have been worked unless the statement relating thereto hereinbefore referred to has been furnished to the Local Authority.

(e) Where an officer is required to work on after the usual time for ceasing duty, he shall, where such additional duty necessitates taking a meal away from the usual place of residence, be reimbursed for each meal at the rate of four shillings and sixpence (4s. 6d.) and shall be reimbursed the cost of each meal necessarily taken away from the usual place of residence on Saturdays, Sundays and public holidays at the rate of four shillings and sixpence (4s. 6d.) for each meal. Provided that in each case the overtime worked before and after a meal break totals not less than two (2) hours.

9.—Higher Duties.

(a) Where any adult officer performs the duty of a position higher than that in which he is usually employed for a period exceeding one month, he shall be paid while performing any such duty, at a rate not less than the minimum salary payable to the officer relieved.

(b) Where any officer regularly carries out the duties, or occupies a dual office, he shall be paid the salary pertaining to the higher office.

10.—Resignations or Dismissals.

Subject to the provisions of the Road Districts Act or Acts for the time being in force, the following provisions shall apply:—

(a) No Executive Officer, or Assistant to the Building Surveyor or Building Inspector or any Engineering Assistant shall leave his position until the expiration of one month's notice in writing of his intention so to do without the approval of the Board.

(b) One month's notice shall be given by the Board to any officer coming within the provision of subclause (a) hereof whose services are no longer required; provided that this subclause shall not apply to cases of summary dismissal for misconduct.

(c) In the case of officers not included in (a) and (b) hereof, one week's notice on either side shall be deemed sufficient notice to terminate the contract of employment; provided that after ten (10) years' service in the employment of the Board, one month's notice on either side shall be required to terminate the contract of employment of an officer; provided further that this subclause shall not apply to cases of summary dismissal for misconduct.

(d) One (1) day's notice on either side shall be deemed sufficient to terminate the contract of employment of temporary workers.

11.—Holidays.

(a) The following days, or the days observed in lieu, shall be granted as holidays and paid for, namely: New Year's Day, Australia Day, Good Friday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Queen's Birthday, Christmas Day and Boxing Day, and any other day or days which may be proclaimed as a public holiday under the Public Service Act as a holiday for persons employed in the Public Service of the Government of Western Australia.

(b) Where an officer is required to be on duty on any of the abovementioned holidays, he shall be allowed equivalent time off duty or an equivalent number of days may be added to his annual leave.

12.—Annual Leave.

(a) All officers shall be entitled to two (2) weeks' annual recreation leave (exclusive of intervening holidays) on full pay. The leave shall be taken at a time mutually convenient to the officer and the Board, at any time within six months of its becoming due.

(b) By agreement between the Board and any of its officers, leave may be allowed to accumulate up to and including a period not exceeding that allowed for three years' service.

(c) An officer not completing one year's service shall be granted pay in lieu of annual leave in proportion to his or her length of service.

(d) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(e) The provisions of this clause shall not apply to temporary workers.

13.—Sick Leave.

(a) No worker shall be entitled to payment of salary or wages on the grounds of ill-health except on the following terms and conditions:—

(i) On production of a medical certificate satisfactory to the employer or other evidence of a satisfactory nature, an officer shall be entitled to sick leave on the following scale:—

(a) First eighteen months' continuous service, up to a total of three weeks on full pay.

(b) Over eighteen months' continuous service and up to three years; three weeks on full pay and three weeks on half pay.

(c) Over three years' continuous service and within each subsequent triennial period from the expiration of the first three years; three months on full pay.

(ii) When an officer is in receipt of payment under the Workers' Compensation Act and is entitled to payment under the preceding subclause, the obligation of the employer hereunder shall be deemed to be discharged upon the payment of the difference.

(b) When an officer absents himself from duty without reasonable cause or in excess of the allowance herein provided for, the employer may deduct from his pay a sum proportionate to his time of absence.

14.—Record.

(a) A readily intelligible record shall be kept by the Board containing the following particulars:—

(i) The name of each officer.

(ii) The class of work upon which the officer is engaged.

(iii) The hours worked each day.

(iv) The salary (and overtime, if any) paid to each officer.

(b) Such record shall be signed by the officer and shall be open for inspection, during office hours, by the Secretary or an accredited representative of the Union, and such person may take extracts therefrom.

15.—Instruments.

The Board shall provide and maintain all instruments and equipment.

16.—Board of Reference.

(a) The Court may appoint, for the purpose of this Award a Board or Boards of Reference. The Board shall consist of a Chairman and two (2) other representatives, one to be nominated by each of the parties hereto as prescribed by the Regulations to the "Industrial Arbitration Act, 1912-1952." There are assigned to the Board in the event of no agreement being arrived at between the parties to this Award the functions of—

(i) adjusting any matters of difference which may arise between the parties from time to time, except such as involve interpretations of the provisions of this Award or any of them;

(ii) deciding any other matter that the Court may refer to such Board from time to time;

(b) An appeal shall lie from any decision of such Board in the manner and subject to the conditions prescribed in the Regulations to the "Industrial Arbitration Act, 1912-1952."

17.—Financial Statements.

The Financial Statements of the Board shall be made available to the inspection of the Secretary of the Union and a copy shall be supplied to the Union upon request.

18.—No Reduction.

No officer who at the date of this Award is in receipt of a higher rate of pay than is herein provided shall have his or her pay reduced as a consequence of this Award.

19.—Salaries.

The minimum salaries payable under this award shall be as set out hereunder:—

Adult female clerical officers (and who are not in classified positions) when performing work as a stenographer, comptometer or calculating or ledger machine operator shall receive six shillings (6s.) per week in addition to the above rates.

(f) For the purposes of adjustment and payment, the weekly salary shall be calculated as one fifty-second (1/52nd) of the annual salary.

(g) Any officer who at the date of commencement of this Award has been employed in the classified position in which he is the present occupant for at least two years shall be entitled to the rate applicable to the third year. Any such officer who has been employed in such position for at least one year shall be entitled to the rate applicable to the second year. Any such officer who has been employed in such position for less than one year shall be entitled to the rate applicable to the first year.

(i) Temporary workers shall be paid at the rate of ten per cent. (10%) in addition to the rates prescribed herein.
