
By-laws Amending By-laws Establishing Building Lines.



THE Perth Road Board, under and by virtue of the powers conferred on it in that behalf by the Road Districts Act, 1919-1954, the Second Schedule thereof, the Town Planning and Development Act, 1928-1955, and all other powers enabling it, doth hereby make and publish the following by-laws:—

The by-laws of the Perth Road Board, establishing building lines, passed at an ordinary meeting of the Perth Road Board on the 12th day of June, 1956, and published in the *Government Gazette* of the 12th day of September, 1956, are hereby amended in the following manner:—

HIS Excellency the Governor in Executive Council has been pleased to approve of the by-laws made by the Minister for Water Supply, Sewerage and Drainage under and for the purposes of the Country Areas Water Supply Act, 1947-1954, as set out in the Schedule hereunder.

Schedule.

By-laws.

1. In these by-laws the by-laws made by the Minister for Water Supply, Sewerage and Drainage under and for the purpose of the Country Areas Water Supply Act, 1947-1954, and published in the *Government Gazette* on the 20th June, 1957, as amended by by-laws amending the same published in the *Government Gazette* on the 30th September, 1957, are referred to as the principal by-laws.

2. The principal by-laws are amended by substituting for by-law 81 the following by-law:—

81. (1) The Minister shall nominate such day or days, in each financial year, on which meter readings shall be taken in the various rating zones.

(2) When a day on which meter readings shall be taken in a zone has been so nominated, meters in that zone shall be read at any time within the period commencing 20 days before and ending 20 days after that day and the quantity of water registered by the meter at the time of the reading shall for the purpose of these by-laws in the absence of proof to the contrary, be deemed to be the quantity of water registered by that meter as on the day so nominated.

3. Subparagraph (1) of paragraph (e) of by-law 89 of the principal by-laws is amended by adding after the passage "Williams;" in line four the passage "Big Bell; Carnarvon; Cue-Day Dawn; Denham; Derby; Dumbleyung; Geraldton; Lake Grace; Leonora; Meekatharra; Mount Magnet; Onslow; Pingelly; Port Hedland; Roebourne; Wittenoom; Yarloop;".

4. By-law 103 of the principal by-laws is amended by adding after the passage "mining," in line one the passage "watering of stock,".

5. The Schedule to the principal by-laws is amended by adding after the table "(50) Wongan Hills Rating Zone" the following tables:—

TRAFFIC ACT, 1919 (AS AMENDED).

HIS Excellency the Lieutenant-Governor in Executive Council, acting pursuant to the powers conferred by the Traffic Act, 1919 (as amended) has been pleased to make the regulations set out in the Schedule hereunder.

Principal Regs. 1. In these regulations the Traffic Regulations, 1954, published in the Government Gazette on the 15th December, 1954, as amended by the regulations amending the same published in the Gazette on the 9th February, 1955, 1st April, 1955, 11th May, 1955, 17th June, 1955, 9th August, 1955, 30th September, 1955, 30th December, 1955, 24th April, 1956, 23rd October, 1956, 16th November, 1956, 23rd November, 1956, 21st December, 1956, 22nd February, 1957, 8th March, 1957, 1st April, 1957, 26th April, 1957, 17th May, 1957, 1st July, 1957, 30th August, 1957, 25th September, 1957, and 5th November, 1957, are referred to as the principal regulations.

Schedule. Regulations.

Reg. 64A amended. Regulation 64A of the principal regulations is amended—

 (a) by substituting for the figures "30" in line two of paragraph (b) of subregulation (2) the figures "60";

- (b) by substituting for the passage "subparagraph (i)" in line six of subregulation (5) the passage "subregulation (ii)"; and
- (c) by adding after the word "efficiently" in the last line of subregulation (5) the passage "and each lamp mounted on the fore part of the vehicle is, when lighted, plainly visible to a person on the road, whether from the front or rear of the vehicle, or from that side of the vehicle on which it is mounted.

The principal regulations are amended by adding after Reg. 93A added. 3. regulation 93 a regulation as follows:-

93A. The driver of a vehicle equipped with a stop lamp or stop lamps in accordance with the provisions of regulation 93 of these regulations may, in lieu of giving by hand the required codified signal that he is stopping or slowing down, signify his intention to do so by lighting signals. the stop lamp or lamps by applying the service brake or other braking system of the vehicle designed to decelerate the vehicle or bring it to a standstill.

4. Regulation 193 of the principal regulations is amended-(a) by substituting for the word "The" in line one of sub-

regulation (1), the following passage-

Except in accordance with the provisions of sub-regulation (2) or (3) of this regulation, the;

(b) by deleting the words "except at such places where guide lines are marked on such roads by the local authority" in lines five and six of subregulation (1);

(c) by adding a subregulation as follow

(3) Where a member of the police force or a traffic inspector is controlling or directing traffic at a junction or an intersection, the driver of any vehicle or animal, if making a right hand turn from one road into another road at the junc-tion or intersection, shall, unless otherwise directed by the member of the police force or inspector, make the turn before reaching the middle of the road into which he is turning by passing either to the front or to the rear of the member of the police force or inspector, as the case requires.

5. Regulation 352A of the principal regulations is amended by Reg. 352A amended. revoking subregulation (3).

6. Item 14 of Table A of the Eleventh Schedule to the principal regulations is amended by adding after the word "day" being the last word of the parking restriction relating to sub-item Item 14 of Table A of 11th Schedule (da) in Column 2 the following passageamended.

> excepting Saturdays and Sundays, and between 8 a.m. and 9.30 a.m. on Saturdays.

7. Table A of the Eleventh Schedule to the principal regulations is amended by deleting item 17.
