WHEREAS it is enacted by section 5 of the Road Districts Act, 1919-1956, that for the purposes of the Act the word "Town" or "Townsite" means and includes *inter alia* any land (including privately owned subdivided land) which the Governor may see fit as he is thereby empowered to declare by Proclamation, to be a town or townsite for the purposes of the Act; and whereas all that land situated within the Wanneroo Road District, more particularly described in the Schedule hereunder, is land which the Governor may by virtue of section 5 of the Act declare by Proclamation to be a town or townsite for the purposes of the Act: Now, therefore I, the Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred upon me by the Road Districts Act, 1919-1956, and of all other powers in this behalf enabling me, do hereby declare that all that land situated within the Wanneroo Road District, more particularly described in the Schedule hereto, shall be a townsite, to be known as "Wanneroo Townsite" within the meaning and for the purposes of the Road Districts Act, 1919-1956.

Health Act, 1911-1957.

ORDER IN COUNCIL.

P.H.D. 684/48, Ex. Co. No. 339.

WHEREAS it is provided in section 161 (C) of the Health Act, 1911-1957, that the provisions of Division 3 of Part V of the said Act shall operate in certain districts which the Governor may declare by Order in Council to be districts within which the provisions of the said Division 3 of Part V shall

apply: Now, therefore, His Excellency the Governor, with the advice of Executive Council, hereby declares that the provisions of Division 3 of Part V of the Health Act, 1911-1957, shall operate and have effect in the Katanning Road Board Health District.

Traffic Act, 1919-1957.

Northampton Road Board.

ORDER IN COUNCIL.

L.G. 1924/52.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, hereby makes the following Order under section 49 of the Traffic Act, 1919-1957, namely, that the Northampton Road Board is hereby empowered to make by-laws in pursuance of—

- (1) clause (a) of paragraph (vii) of subsection (1) of section 47 of the said Act, defining what shall be deemed heavy traffic for the purpose of this Act;
- (2) clause (b) of paragraph (vii) of subsection (1) of section 47 of the said Act, prohibiting the passage of heavy or obstructive traffic over any specified road, either generally or during certain months of the year;
- (3) clause (1) of paragraph (vii) of subsection (1) of section 47 of the said Act, prohibiting the carriage by a vehicle on any road of a load which (including the weight of the vehicle) exceeds the weight prescribed as the maximum load that may be lawfully carried on the road, notwithstanding the fact that there may have been issued a license which authorises the carrying by the vehicle of a greater load;

subject to the condition that no such by-law shall be valid and effectual unless it has, prior to notification of its making being published in the *Government Gazette*, been submitted to and approved by the Governor.

Traffic Act, 1919-1957.

Tableland Road Board.

ORDER IN COUNCIL.

L.G. 1924/52.

HIS Excellency the Governor, acting by and with the advice and consent of the Executive Council, hereby makes the following Order under section 49 of the Traffic Act, 1919-1957, namely that the Tableland Road Board is hereby empowered to make by-laws in pursuance of—

- (1) clause (v) of paragraph (i) of subsection (1) of section 47 of the said Act, prohibiting the use of any specified road by any vehicle or by any person riding, driving, or in charge of any animal, except when proceeding in a prescribed direction;
- (2) clause (w) of paragraph (i) of subsection (1) of section 47 of the said Act, prescribing the routes to be followed by all classes of traffic, or any particular class of traffic or vehicle, from one specified point to another, either generally or between any specified times;

subject to the condition that no such by-law shall be valid and effectual unless it has, prior to notification of its making, being published in the *Government Gazette* been submitted to and approved by the Governor.

Country Towns Sewerage Act, 1948-1954.

Collie Sewerage Area.

ORDER IN COUNCIL.

WHEREAS by section 4 (b) of the Country Towns Sewerage Act, 1948-1954, the Governor may, by Order in Council, constitute sewerage districts by dividing any sewerage area into sewerage districts under such names as may be directed: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, doth hereby divide the Collie Sewerage Area into two sewerage districts, namely—

(a) Collie No. 1 Sewerage District; and

(b) Collie No. 2 Sewerage District,

defined in the First and Second Schedules respectively hereunder.

First Schedule.

Collie No. 1 Sewerage District.

All that area of the Collie sewerage area contained within a circle having a radius of two and a half miles, with its centre at the south-western corner of Collie Townsite Lot 1186 (reserve No. 14146), and shown blue on Plan P.W.D., W.A., 36078.

Second Schedule.

Collie No. 2 Sewerage District.

All that area of the Collie sewerage area, excluding that portion described as the Collie No. 1 Sewerage District, and shown yellow on Plan P.W.D., W.A., 36078.

Country Water Area.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 8 of the Country Areas Water Supply Act, 1947-1954, that the Governor may, by Order in Council, alter or extend the boundaries of a Country Water Area; and whereas by section 10 of the said Act it is further provided that the Governor may, by Order in Council, alter or extend a Rating Zone in a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby alter and extend the boundaries of the Bridgetown Country Water Area by altering thereto the area as defined in the Schedule hereunder and doth also hereby alter the Bridgetown Rating Zone.

thence generally northerly, easterly, southerly and westerly along boundaries of that reserve to the north-eastern corner of location 762; thence southerly along eastern boundaries of that location and location 3071 to the south-eastern corner of the latter location; thence westerly, southerly and easterly along boundaries of location 1046 to a point in prolongation northerly of the western boundary of location 664; thence southerly to and along that boundary to the south-western corner of that location; thence easterly along the southern boundaries of that location and location 663 to the north-eastern corner of location 662; thence southerly along the eastern boundary of that location to a north-eastern corner of Bridgetown Townsite; thence generally southerly and north-westerly along boundaries of that townsite to the north-eastern corner of location 6362; thence generally north-westerly and south-westerly along northern boundaries of that location and locations 6361 and 8443 to a point in prolongation easterly of the northernmost boundary of location 488; thence westerly to and along that boundary to a point on the eastern boundary of location 8471; thence northerly along that boundary and onwards to a point on a southern boundary of location 607; thence generally north-westerly and northerly along boundaries of that location to the south-eastern corner of the northern severance of location 12029; thence generally north-westerly along southern and western boundaries of that severance to the south-western corner of location 877, a point on the easternmost boundary of location 826; thence northerly, westerly, again northerly and again westerly along boundaries of that location to its north-western corner; thence westerly, northerly and again westerly along boundaries of location 882 to the south-western corner of location 883; thence northerly, westerly, southerly, again westerly and again northerly along boundaries of location 1299 to a point in prolongation easterly of the southern boundary of location 946; thence easterly to and along that boundary and southern boundaries of locations 1244, 1339 and 2347 to a point on the eastern boundary of location 1734; thence northerly and westerly along eastern and northern boundaries of that location to the south-western corner of location 944; thence northerly along the western boundary of that location to its north-western corner; thence south-westerly to the five-mile peg on an eastern boundary of late Timber Lease 61/11 as shown on Lands and Surveys Original Plan B598; thence northerly along that boundary and onwards to a point situate in prolongation westerly of the northern boundary of location 1371; thence easterly to and along that boundary and the northern boundary of location 5623 and onwards to a point on the eastern boundary of location 5255; thence southerly along that boundary to the south-eastern corner of that location; thence southerly to the north-western corner of location 5630; thence easterly along northern boundaries of that location and location 48 and onwards to a point on a western boundary of part location 1598; thence generally south-easterly along boundaries adjacent to the Blackwood River of that location and locations part 1599, 1641, 1765, 1783, 747, 745, 1191, 684, 633, 640, 639, 638 and 636 to a point in prolongation northerly of the eastern boundary of location 884; thence southerly to and along that boundary to the south-western corner of location 8427; thence southerly to the westernmost corner of location 9525; thence generally south-easterly along boundaries adjacent to the Blackwood River of that location and locations 497, 8441, 6368, 7545 (reserve 16918) and again 6363 to the south-western corner of that location; thence easterly, northerly and again easterly along boundaries of location 8479 to the south-western corner of location 1471; thence northerly along western boundaries of that location and locations 11302 and 11802 (reserve 2724) to the north-western corner of the latter location; thence easterly, northerly and again easterly to the south-western corner of location 495 and onwards along the southern boundary of that location to a point on the western boundary of Bridgetown Townsite; thence northerly and generally south-easterly along boundaries of that townsite to the starting point; being the land shown bordered green on sheets 1 to 3 inclusive of Lands and Surveys Miscellaneous Plan 211 and on Plan P.W.D., W.A., 36039.

Country Areas Water Supply Act, 1947-1954.

Lake Grace Country Water Area.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 8 of the Country Areas Water Supply Act, 1947-1954, that the Governor may, by Order in Council, extend the boundaries of a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby extend the boundaries of the Lake Grace Country Water Area by adding thereto the area as defined in the Schedule hereunder.

This Order in Council shall take effect on the 5th day of March, 1958.

Country Areas Water Supply Act, 1947-1954.

Country Water Area.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 8 of the Country Areas Water Supply Act, 1947-1954, that the Governor may, by Order in Council, constitute a Country Water Area; and whereas by section 10 of the said Act it is further provided that the Governor may, by Order in Council, constitute any number of Rating Zones in a Country Water Area: Now, therefore, His Excellency the Governor, by and with the consent of the Executive Council, doth hereby constitute the Northampton Country Water Area as defined in the Schedule hereunder and doth also hereby constitute the whole of the said area to be a Rating Zone and to assign the name of "Northampton Rating Zone" thereto.

This Order in Council shall take effect on the 24th day of February, 1958.

All that portion of land bounded by lines starting from a point on the northern side of the Northampton-Geraldton Railway Reserve situate in prolongation southerly of the western boundary of Northampton Townsite Lot 341, a point on the

Workers' Compensation Act, 1912-1956.

ORDER IN COUNCIL.

WHEREAS it is enacted by section 13 of the Workers' Compensation Act, 1912-1956, *inter alia*, that it shall be obligatory for every employer to obtain from an incorporated insurance office, approved by the Minister, a policy of insurance for the full amount of the liability to pay compensation under the said Act to all workers employed by him, but that if an employer proves to the satisfaction of the Minister that such employer has established a fund for insurance against such liability and has deposited at the Treasury securities charged with all payments to become due under such liability, the Governor may, by Order in Council, exempt such employer from the operation of the said section 13; and whereas The National Bank of Australasia Limited, of St. George's Terrace, Perth, being an employer within the meaning of the section has duly, in accordance with the Act and the regulations made thereunder, made application for exemption from the operation of the section, and has satisfied the Minister that it has established a fund for insurance against the said liability, and has deposited at the Treasury a security, to wit, a bond for £5,000, charged with all payments to become due under the said liability: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council, and in exercise of the powers conferred by the Act, doth hereby exempt The National Bank of Australasia Limited, of St. George's Terrace, Perth, from the operation of section 13 of the Workers' Compensation Act, 1912-1956, for a period expiring on the 31st day of December, 1959.
