Schedule.

Regulations.

1. In these regulations the regulations made under the Land Act, 1933-1956, published in the *Government Gazette* on the 16th December, 1949, and amended from time to time thereafter by notices published in the *Government Gazette* are referred to as the principal regulations.

2. The principal regulations are amended by substituting for the First Schedule, Second Schedule, Third Schedule, Fourth Schedule, Fifth Schedule, Sixth Schedule and Seventh Schedule the following Schedules :--

ROAD DISTRICTS ACT, 1919-1956.

TOWN PLANNING AND DEVELOPMENT ACT, 1928-1956.

Perth Road Board By-laws Amending By-laws Classifying Scarborough, Hamersley, Osborne, Inglewood and Maylands Wards.

L.G. 539/57.

THE Perth Road Board, under and by virtue of the powers conferred on it in that behalf by the Road Districts Act, 1919-1956, the Second Schedule thereof, the Town Planning and Development Act, 1928-1956, and all other powers enabling it, doth hereby make and publish the following by-laws:—

The by-laws of the Perth Road Board classifying Scarborough, Hamersley, Osborne, Inglewood and Maylands Wards passed at an ordinary meeting of the Perth Road Board on the 5th day of April, 1955, and published in the *Government Gazette* on the 3rd day of May, 1955, are hereby amended in the following manner:—

1. By-law No. 1 is amended by the insertion after the definition of "Residential and Flat Zone" of the following definition:—

"Rural Zone" means a rural zone as classified by these by-laws.

2. After by-law 10G the following new by-laws are inserted:-

Rural Zones.

10I. Area.—Those portions of the Perth Road District as shown contained within a black border on the map comprising the Ninth Schedule hereto are hereby classified as rural zones.


10J. Uses.—No person shall use any land or any building or structure in a Rural Zone except for one or more of the following purposes:—


- (a) Any purpose permitted in a Residential Zone.
- (b) Agriculture, horticulture, forestry or pasture.
- (c) Poultry farming.
- (d) Woodyard.
- (e) The treating, processing and packing of primary products grown in the locality.
- (f) The servicing of agricultural implements, plant and machinery.
- (g) A blacksmith's shop.
- (h) a cartage and carrying business if such bt liness is connected with a rural activity.
- (i) Public or private recreation.

And except for the following purposes, if special permission to do so is given by the Perth Road Board in each particular case:—

(j) Excavating for gravel, sand, stone or brickmaking or pottery clay.

10K. Subdivisions.—No person shall subdivide any land in a Rural Zone into allotments of an area of less than five acres each.
