PROCLAMATION

WESTERN AUSTRALIA, TO WIT, CHARLES HENRY GAIRDNER, CLL.S.] By His Excellency Lieutenant-General Sir Charles Henry Gairdner, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Knight Commander of the Royal Vic-torian Order, Companion of the Most Honour-able Order of the Bath, Commander of the Most Excellent Order of the British Empire, Governor in and over the State of Western Australia and its Dependencies in the Commonwealth of Australia.

WHEREAS by section 5 of the Plant Diseases Act, 1914-1956, it is provided that the Governor may, by Proclamation prohibit either absolutely or exby Proclamation prohibit either absolutely or ex-bept in accordance with regulations the bringing into the State of Western Australia either gener-ally or from any specified State, country, or place of any specified kind of plant, fruit, or other thing which would in his opinion be likely to introduce any disease into the State of Western Australia; and whereas by section 6 of the Act it is provided, *inter alia*, that the Governor may, by Proclama-ion, revoke or vary any Proclamation made under the Act: and whereas by a Proclamation dated the tion, revoke or vary any Proclamation made under the Act; and whereas by a Proclamation dated the 18th August, 1947, the Governor prohibited the pringing into the State of Western Australia from any of the following States of the Commonwealth of Australia, that is to say, Victoria, New South Males, South Australia and Queensland of all orded bananas during the period May to September of any year except in accordance with the regulations specified in that Proclamation; and whereas it is now deemed advisable and expedient that the pro-hibited period in respect of bananas imported from those States be prescribed from time to time by regulation: Now, therefore I, the Governor, acting with the advice and consent of the Executive Coun-cli and in exercise of the powers conferred upon me by the Act, do hereby-

- (a) revoke the proclamation dated the 28th August, 1947; and
- (b) prohibit the bringing into the State of Western Australia of all bananas from western Australia of all bananas from any of the following States of the Com-monwealth of Australia, that is to say, Victoria, New South Wales, South Austra-lia and Queensland, except in accordance with the regulations made pursuant to the Plant Diseases Act, 1914-1956.
