TRAFFIC ACT, 1919-1957.

Regulations.

1. In these regulations the Traffic Regulations, 1954, published in the *Government Gazette* on the 15th December, 1954, as amended by regulations amending the same published in the *Gazette* on the 9th February, 1955, the 1st April, 1955, the 11th May, 1955, the 17th June, 1955, the 9th August, 1955, the 30th September, 1955, the 30th December, 1955, the 24th April, 1956, the 23rd October, 1956, the 16th November, 1956, the 23rd November, 1956, the 21st December, 1956, the 22nd February, 1957, the 8th March, 1957, the 1st April, 1957, the 26th April, 1957, the 17th May, 1957, the 1st July, 1957, the 30th August, 1957, the 25th September, 1957, the 5th November, 1957, the 23rd December, 1957, the 24th January, 1958, the 19th February, 1958, the 17th April, 1958, the 29th April, 1958, the 13th May, 1958, the 5th June, 1958, the 25th June, 1958, the 15th July, 1958 and the 18th July, 1958, are referred to as the principal regulations.

2. Paragraph (d) of regulation 156 of the principal regulations is amended by substituting for the passage commencing with the word, "upon" in line two and ending with the last word "owner," the passage, "in that portion of the omnibus behind the two front rows of seats in the omnibus." Reg. 156

3. Regulation 159 of the principal regulations is amended by substituting for the passage in the proviso to subregulation (2) commencing with the word, "whilst" and ending with the last word, "seats," the passage, "who are in that portion of the omnibus behind the two front rows of seats in the omnibus." 4. Regulation 180 of the principal regulations is amended by adding after the passage, "194" in line one the passage, "and the provisions of Division (2) of this Part."

5. Regulation 238 of the principal regulations is amended—
(a) by adding after paragraph (b) of subregulation (3) the following paragraph:—

(c) Where two of the three traffic lanes referred to in paragraph (a) of this subregulation are allocated for the exclusive use of traffic proceeding in one direction, a person driving a vehicle in that direction at a speed greater than the speed of vehicles being driven in the lane on the left hand side of the road may continue to drive the vehicle in the middle lane. ;

(b) by adding before the word, "placed" in line two of subregulation (4), the passage, ",", or two lines one of which is continuous, and the other broken or dotted,";

(c) by adding after the word, "four" in line four, and again after the word, "two" in line four of subregulation (5), the words, "or more";

(d) by substituting for the passage, "the inner lane (nearest the double line)" in lines three and four of subparagraph (1) of the proviso to subregulation (5), the passage, "an inner lane—that is a lane nearer or nearest to the double line—";

(e) by substituting for the word, "the" in line one of subparagraph (ii) of subregulation (5), the word, "an"; and

(f) by adding after subregulation (5) a subregulation as follows:—

(6) Notwithstanding any other provision of these regulations, where a road is divided into two or more traffic lanes for the exclusive use of drivers of vehicles proceeding in one direction, a driver driving a vehicle in that direction may, if it is safe to do so in all the circumstances of the case, drive his vehicle and overtake and pass on the left hand side of another vehicle proceeding in the same direction.

6. The principal regulations are amended by adding after regulation 238 a regulation as follows:—

238A. Where a road is divided into two or more traffic lanes in the manner provided by regulation 238 a driver of a vehicle shall drive his vehicle so that the whole of the vehicle is within the limits of the traffic lane except that, when it is safe to do so, he may drive his vehicle into another lane in accordance with the provisions of regulation 238.

7. Regulation 260 of the principal regulations is amended by substituting for the words, "mallee roots" in line five of subregulation (2), the passage, "the roots of trees, or other vegetation."

8. The principal regulations are amended by adding after regulation 349AA a regulation as follows:—

349AB. No person shall drive a vehicle on Rason Parade, Edward Street, or Helen Street, within the Midland Junction Municipal District if the gross weight, calculated in accordance with the regulations, of the vehicle on any axle exceeds five tons.
