Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956.

Country Areas Water Supply Act, 1947-1954.

ORDER IN COUNCIL.

WHEREAS by section 7 of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956, and by section 8 of the Country Areas Water Supply Act, 1947-1954, it is enacted that the Governor may, by Order in Council, from time to time alter the boundaries of the Metropolitan Water, Sewerage, and Drainage Area or of any district or Metropolitan Main Drainage District, and of a Country Water Area; and whereas it is desirable to alter the boundaries of the said areas and of the Metropolitan Water and Sewerage District, as hereinafter described: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, and in exercise of the powers conferred by the said Acts, doth hereby order and declare as follows:—

That the boundaries of the Metropolitan Water, Sewerage, and Drainage Area, and of the Metropolitan Water and Sewerage District are hereby altered by deleting therefrom, and that the boundaries of the Goldfields and Agricultural Country Water Area and the Kalamunda Rating Zone are hereby altered by adding thereto, the land described in the Schedule hereto.
