WHEREAS it is provided by subsection 1 (b) (iii) of section 480 of the Municipal Corporations Act, 1906-1956, that a Council may, with the approval of the Governor, expend out of the ordinary revenue of the municipality any sum or sums not exceeding in the aggregate 10 per cent, of such ordinary revenue for providing all forms of tourist propaganda both within the district and elsewhere in connection with or in relation to any tourist resort within the district of the Council; and whereas the Municipality of Bunbury is desirous of expending the sum of £530 from its ordinary revenue for tourist propaganda purposes: Now, therefore, His Excellency the Lieutenant-Governor and Administrator, acting by and with the advice and consent of the Executive Council and in exercise of the power vested in him in the said section of the said Act, doth hereby authorise the Municipality of Bunbury to expend from its ordinary revenue the sum of £530 for tourist propaganda purposes.
