Land Act, 1933-1958.

ORDER IN COUNCIL.

Corr. No. 1486/30.

WHEREAS by section 33 of the Land Act, 1933-1958, it is made lawful for the Governor to direct that any reserve shall vest in and be held by any municipality, road board, or other person or persons to be named in the order, in trust for any of the purposes set forth in section 29 of the said Act, or for the like or other public purposes to be specified in such order, and with power of sub-leasing; and whereas it is deemed expedient that reserve 25300 should vest in and be held by the Minister for Works in trust for Harbour Works: Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserve shall vest in and be held by the Minister for Works in trust for Harbour Works, with power to the said Minister for Works, subject to the approval in writing of the Minister for Lands first obtained, to lease the whole or any portion of the said reserve for any term not exceeding 50 years from the date of the lease.

(a) Subject to clause 9 hereof the following day or days observed in lieu shall be holidays without deduction of pay, namely:—Christmas Day, Labour Day, Good Friday, Easter Monday and one other day to be nominated by the employer.

3.—Area and Scope.

This Agreement shall apply to all officers employed under the provisions of the Public Service Act, 1904-1956, whose maximum margins over the basic rate are less than £1,293 per annum: Provided that persons temporarily employed shall be subject to the rates of pay and to the exclusions referred to in clause 24 of this Agreement.

4.—Basic Rate: Interpretation.

(a) In this Agreement, the term "basic rate" means in the case of—

- (i) male officers employed in the metropolitan area—

the nearest pound (£) to the result obtained by multiplying the male basic wage for that area as declared from time to time by the Court of Arbitration of Western Australia, by 52 1/6th;

(e) A female professional division officer who occupies one of the following positions or such other position as the Commissioner may determine from time to time shall be paid the same margin as that prescribed for a male professional division officer occupying an identical position, provided that—

- (i) such female officer possesses the academic qualifications as described herein; and
- (ii) the duties and responsibilities of her position are the same as for the related male position.

(b) Classes and grades beyond a margin of £189 per annum shall be those set out in schedule B to this agreement.

(c) An officer who is over the age of 21 years on appointment may be appointed at a minimum rate of pay based on years of service and not on age.

(d) An officer classified in the automatic range shall be paid an allowance of £25 per annum provided that—

- (i) in the case of a typist or clerk-typist she passes an efficiency examination in shorthand writing at a speed of 100 words per minute and typewriting at 50 words per minute;
- (ii) in the case of a machinist she passes an examination in typewriting at a speed of 35 words per minute and in the operation of accounting and listing machines; and
- (iii) such allowance shall cease on the promotion of the officer to a higher position or should the officer refuse to accept promotion.

(e) An officer classified in the automatic range who has passed either of the examinations referred to in subclause (d) and has completed at least two years' continuous service on a margin of £189 per annum exclusive of allowance, shall be paid an allowance of £48 per annum, inclusive of the allowance under subclause (d). Thereafter the allowance shall be increased to

- (i) £71 per annum when the officer has been in receipt of the allowance of £48 per annum for a period of 12 months; and to

(g) An officer classified in the automatic range who has not passed either of the examinations referred to in subclause (d) shall be paid—

- (i) an allowance of £25 per annum on completion of five years' continuous service on a margin of £189 per annum provided the Permanent Head certifies that the officer is eligible and would be recommended for promotion on the grounds of efficiency and good conduct; such allowance to cease on promotion to a higher position or should the officer refuse to accept promotion; and
- (ii) an allowance of £30 per annum on completion of not less than 20 years of continuous permanent service, provided the Permanent Head certifies as to the good conduct, diligence and efficiency of the officer.

16.—Female Officers: Laboratory Assistants and Technical Assistants.

(a) The rates of pay for female laboratory assistants and technical assistants shall be as follows:—

17.—Female Officers: Telephonists, Assistants and Laboratory Attendants.

(a) The rates of pay for female telephonists, assistants and laboratory attendants shall be as follows:—

(c) An officer who has completed not less than 20 years of continuous permanent service shall be paid an allowance of £30 per annum, provided the Permanent Head certifies as to the good conduct, diligence and efficiency of the officer.

19.—Qualifications Allowance: Male Clerical Division Officers.

(a) Diplomates:

A male adult clerk who holds—
the diploma in Commerce of the University of Western Australia; or
the diploma in Public Administration of the Perth Technical College;

or passes the final examinations in all subjects in the syllabus of—

an Institute of Accountants, Secretaries or Cost Accountants approved by the Commissioner; or

the Commonwealth Institute of Valuers; or the Australian Insurance Institute;

or passes—

in five units (including English I) of a degree course in Arts, Science, Economics or Law at the University of Western Australia; or the examination in Law prescribed under section 25 of the Public Service Act, 1904-1956;

or holds or passes—

a qualification or examination which, in the opinion of the Commissioner, is equivalent to any of the aforesaid,

and who is in receipt of a margin which is expressed in column (a) of Schedule C to this Agreement, shall be paid qualifications allowance at the rate expressed in column (b) of that Schedule immediately adjacent to the officer's margin.

(b) Graduates:

A male adult clerk who holds—

a degree in Arts, Science, Economics or Law of the University of Western Australia; or

who holds or passes—

a qualification or examination which, in the opinion of the Commissioner, is equivalent to any of the aforesaid,

and who is in receipt of a margin which is expressed in column (a) of Schedule C to this Agreement, shall be paid qualifications allowance at the rate expressed in column (c) of that Schedule immediately adjacent to the officer's margin.

(c) Payment of an allowance under the provisions of this clause shall cease—

either

(i) as a result of the officer becoming entitled to a margin for which no qualifications allowance is provided,

or

(ii) by the effluxion of a period of 10 years from the date on which the officer first became entitled to payment of an allowance under this clause,

whichever occurs first:

Provided that in the event of (ii) hereof, payment of the allowance shall not cease before the 30th June, 1965.

20.—Fundamental Basis for Determination of Rates of Pay.

The fundamental basis for the determination of the rates of pay expressed in this Agreement is the rate payable under the provisions of subclause (a) of clause 9 to a male clerical division officer at the age of 27 years or during the seventh year of adult service. This rate was determined on the 1st January, 1959, at a margin of £317 per annum over the basic rate.

21.—Adjustment of Rates of Pay.

(a) Whenever necessary and in the manner prescribed in this clause the rates of pay contained in this Agreement shall be adjusted half-yearly as from the commencement of the first pay period in the months of July and January in each year.

(b) The amount of any adjustment shall be:—

(i) Male officers in receipt of a margin of £317 per annum and above—the difference between

(a) the average to the nearest pound (£) of the margin in each case between the gross annual salary rate paid to an officer on the maximum grade or at age 27 years (whichever occurs first) in the incremental scale of the male clerical automatic ranges of the Public Services of Queensland, New South Wales, Victoria, South Australia and Tasmania and the respective annual equivalent of the State basic wage for the capital city of each of the aforesaid States, or such other rate as may be used in the determination of cost of living adjustments for any of the foregoing Public Services, whichever may apply; and

(b) the margin of £317 per annum payable to an officer on the maximum of the male clerical automatic range as prescribed in subclause (a) of clause 9:

Provided that if the amount determined would result in an adjustment of less than £5 per annum from the current adjustment, if any, no variation shall be made.

(ii) Male officers in receipt of rates of pay below a margin of £317 per annum—

that proportion, to the nearest (£) of the adjustment applicable to male officers on a margin of £317 per annum, which the appropriate gross rate of pay (margin plus basic rate or percentage of basic rate) bears to the gross rate of pay (margin plus basic rate) payable in the metropolitan area to a male clerical officer on the maximum of the automatic range.

(iii) Female officers in receipt of a margin of £189 per annum and above—

Seventy-five per cent. to the nearest (£), of the adjustment applicable to male officers on a margin of £317 per annum, provided that female professional officers who are paid the same margins as those prescribed for male professional officers in accordance with the provisions of subclause (e) of clause 14, shall be subject to the same adjustments as apply to male officers on a margin of £317 per annum.

(iv) Female officers in receipt of rates of pay below a margin of £189 per annum—

Seventy-five per cent. to the nearest (£), of the adjustment applicable to male officers on the basis of the following table—

(c) Any adjustment to the rates of pay expressed in this agreement which may be necessary in accordance with the provisions of this clause shall be made only as the result of a review of margins actually paid by each of the State Public Services on the 1st July and the 1st January each year and no effect shall be given to any retrospective application of revised salary rates which may be determined at subsequent dates.

(d) Officers whose headquarters are in an area for which an independent basic wage is declared shall, for the purpose of this clause only, be deemed to be employed in the metropolitan area.

(e) No adjustment shall be made under the provisions of this clause before the commencement of the first pay period in the month of July, 1959.

22.—Annual Increments.

Subject to the receipt by the Commissioner of a report from the Permanent Head regarding good conduct, diligence and efficiency an officer shall proceed from the minimum to the maximum of his classification by annual increments according to the grades of such classification.

23.—Maintenance of Rights of Appeal.

Notwithstanding anything to the contrary herein contained or implied, the rights of officers in respect of all appeals under the Public Service Appeal Board Act, 1920-1950, shall be preserved and maintained, subject to any legal rights which the Commissioner or any other respondent may have in relation thereto.

24.—Temporary Employees.

A person employed in a temporary capacity under the provisions of section 31 of the Public Service Act, 1904-1956, shall be paid at a daily or weekly rate of pay equivalent to the annual rate that would be payable under the provisions of this agreement to a permanent officer engaged on duties of a similar nature and of equal responsibility, except that—

(a) a male employed in a temporary capacity as a clerk or as a laboratory assistant shall be paid in accordance with the following scale of rates:—

- (iii) is educationally qualified for appointment to the permanent staff.

the Commissioner, on the recommendation of the permanent head, approves payment of the same rate of pay as would be received by a permanent officer of the same age and years of service in the same capacity; and

(b) in no case shall the provisions of clauses 7 (a) provisos (i) and (ii), 7 (b), proviso to 8 (a), clauses 8 (b), 9 (d), 9 (e), 10 (d), 11 (c), 12 (c), 14 (d), 15 (d), 15 (e), 15 (g), 16 (c), 17 (c), 17 (d), 18 (c), 19 and 23 of this agreement apply in respect of a person temporarily employed.

25.—Term of Agreement.

This agreement which replaces and supersedes the agreements referred to in clause 1, shall operate as from and including the first day of January, 1959, and shall remain in force for a period of

five years as from that date, provided that either of the parties may after the 31st day of December, 1959, negotiate with the other party to amend or add to this agreement or approach the Court for an amendment to this agreement.
