#### ORDER-IN-COUNCIL.

WHEREAS it is enacted by section 18 of the Health Act 1911-57, that every municipal district shall be a health district within the meaning of the Act, and the municipal council thereof shall be the local authority for the district; and whereas it is enacted by section 22 of the Act that the Governor may place any area of land outside a municipal district, and whether actually adjoining or not, under the jurisdiction of the council of such muni-cipal district for the purpose of the Act and and cipal district, for the purpose of the Act, and such area shall for all the purposes of the Act be deemed within the municipal district while so placed under that jurisdiction; Now therefore, His Ex-cellency the Governor, acting with the advice and consent of the Executive Council, and in the exer-cise of the powers conferred by section 22 of the Act, doth hereby place the areas of land specified

#### Land Act, 1933-1958. ORDERS IN COUNCIL.
