Between: The Federated Engine Drivers and Firemen's Union of Workers of Western Aus-tralia, Applicant, and Municipality of Geraldton, Respondent.

WHEREAS an industrial dispute existed between the abovenamed parties, and whereas the said dispute was referred into Court for the purpose of hearing and determination, and whereas the said reference of industrial dispute was remitted by the Court to the Conciliation Commissioner, and whereas the parties subsequently met and conferred and have arrived at agreement on all matters in difference, and whereas the parties have this day appeared before the Conciliation Com-missioner by their respective representatives and requested the Conciliation Commissioner to make the said Agreement an Award of the Court: Now. the said Agreement an Award of the Court: Now, therefore, the Conciliation Commissioner, pursuant to Section 65 of the Industrial Arbitration Act, 1912-1952, and all other powers therein enabling him, hereby declares the memorandum hereunder written to have the same effect as and be deemed an Award of the Court.

Memorandum of Agreement.

(Note:---Wherever the word "Award" occurs herein, it shall be taken to mean and include 'Agreement".)

1. Title.

This Award shall be known as the Engine Drivers' (Municipality of Geraldton) Award and shall replace Award No. 78 of 1948 as amended.

3.—Scope.

This Award shall apply to all workers engaged as engine drivers in the Industry of Refrigeration, the supply of electricity and the production of gas.

4.—Area.

This Award shall operate within the area com-prised in the works of the Respondent.

5.—Term. The Term of this Award shall be for a period of three (3) years from the date hereof.

6.-Wages.

The minimum rate of wages payable under the provisions of this Award shall be:-

(c) The margins prescribed in the foregoing include allowances for dynamos, compressors and all work being performed by the workers concerned at the date hereof.

7.—No Reduction.

Nothing in this Award shall in itself operate to reduce the wage of any worker below the rate actually received by him at the date hereof.

8.—Hours.

The ordinary working hours shall not exceed forty (40) per week to be worked in five (5) shifts of eight (8) hours inclusive of crib time. Provided that this clause shall be deemed to have been com-plied with if the ordinary working hours do not exceed eighty (80) hours per fortnight.

9.-Overtime.

(a) All time worked in excess of eight (8) hours in any one working day or any time worked on the rostered day off shall be deemed overtime and shall be paid for at the rate of time and a half for the first four (4) hours and double time thereafter,

(b) All time worked outside the ordinary hours on Sunday shall be paid for at the rate of double time.

(c) Work done on the days observed as New Year's Day, Australia Day, Good Friday, Easter Saturday, Easter Monday, Anzac Day, Labour Day, State Foundation Day, Christmas Day and Boxing Day shall be paid for at double time rate, except in connection with version to the completence in connection with repairs to the employer's machinery which has broken down and has caused a stoppage of operations when the rate of time and a half shall apply to the work done on such days: Provided that the employer may pay for work done on the abovementioned days at ordin-ary time rate and add one day (or in connection with repairs aforesaid, half a day) to the worker's annual leave for each day so worked.

(d) These overtime rates shall not apply to excess time due to private an angement between the workers themselves, or which is necessary for effecting periodical rotation of shifts, or which is owing to a relieving man not coming on at the appointed time. The time for which any worker may be paid at ordinary rates instead of overtime due to a relieving man not coming on at the proper time shall not exceed two (2) hours, after the expiration of which overtime rates shall apply for the whole shift for the whole shift.

(e) Notwithstanding anything contained in this Award-

- (i) An employer may require any worker to work reasonable overtime at overtime rates and such worker shall work over-time in accordance with such requirement.
- (ii) No organisation, party to this Award, or worker or workers covered by this Award shall in any way, whether directly or indirectly, be a party to or concerned in any ban, limitation, or restriction upon the working of overtime in accordance with the veryimments of this gubeluge the requirements of this subclause.

10 .-- Shift Work.

(a) A worker employed on any shift other than day shift shall be paid for afternoon shift five per cent (5%) and for night shift ten per cent (10%) in addition to his ordinary rate. These rates shall be replaced by those specified in sub-clause 9 (c) and subclause (c) hereof where work is done during ordinary working hours on Satur-days Sundays and holidays days, Sundays and holidays.

(b) Where an employee works afternoon or night shift only, or afternoon and night shifts in rota-tion, but does not work day shift at least one week out of three, he shall receive one shilling per shift in addition to the rates set out above.

(c) Work required to be performed on Saturdays or Sundays as part of the ordinary working hours shall be paid for at the rate of time and a half.

11 --- Casual Workers.

(a) A casual worker shall mean and include an to do who is, without any fault of his own, dis-missed or refused work (as it is hereby agreed he may be) before the expiration of one (1) week from and including the date he starts work.

(b) Casual workers shall be paid ten per cent (10%) in addition to the rates set out above.

12.—Contract of Service.

Except as provided by clause 11 all employment shall be by the week.

13.—Annual Leave.

(a) Except as hereinafter provided a period of two (2) consecutive weeks' leave with payment of ordinary wages as prescribed shall be allowed annually to a worker, by his employer after a period of twelve (12) months' continuous service with such employer.

(b) Seven-day shift workers, that is shift workers who are rostered to work regularly on Sundays and holidays, shall be allowed one weeks' leave in addition to the leave prescribed in subclause (a) hereof. Where a worker with twelve months' continuous service is engaged for part of a qualifying twelve monthly period as a seven-day shift worker, he shall be entitled to have the period of two consecutive weeks' annual leave prescribed in subclause (a) hereof increased by one twelfth of a week for each month he is continuously engaged as aforesaid.

(c) If any prescribed holidays fall within a worker's period of Annual leave and is observed on a day which in the case of that worker would have been an ordinary working day, there shall be added to that period one day being an ordinary working day for each such holiday observed as aforesaid.

(d) If after one month's continuous service in any qualifying twelve-monthly period a worker lawfully leaves his employment, or his employment is terminated by the employer through no fault of the worker, the worker shall be paid one-sixth of a weeks' pay at his ordinary rate of wage in respect of each completed month of continuous service, or in the case of a worker referred to in subclause (b) hereof, such payment shall be one-quarter of a week's pay at his ordinary rate of wage in respect of each such month he is so engaged.

(e) Any time in respect of which a worker is absent from work except time for which he is entitled to claim sick pay or time spent on holidays or annual leave as prescribed by this Award shall not count for the purpose of determining his right to annual leave.

(f) A worker who is dismissed for misconduct or who illegally severs his contract of service shall not be entitled to the benefit of the provisions of this clause.

(g) The provisions of this clause shall not apply to casual workers.

14.—Absence Through Sickness.

(a) A worker shall be entitled to payment for non-attendance on the ground of personal illhealth, for one-twelfth (1/12th) of a week for each completed month of service: Provided that payment for absence through such ill-health shall be limited to one (1) week in each calendar year. Payment hereunder may be adjusted at the end of each calendar year or at the time the worker leaves the service of the employer, in the event of the worker being entitled by service subsequent to the sickness to a greater allowance than that made at the time the sickness occurred. This clause shall not apply where the worker is entitled to Compensation under the Worker's compensation Act.

(b) A worker shall not be entitled to receive any wages from his employer for any time lost through the result of an accident not arising out of or in the course of his employment or for any accident, wherever sustained arising out of his own wilful default or for sickness arising out of his own wilful default.

(c) No worker shall be entitled to the benefits of this clause unless he produces proof satisfactory to his employer of sickness, but the employer shall not be entitled to a medical certificate unless the absence is for three (3) days or more.

(d) Sick leave shall accumulate from year to year so that any balance of the period specified in subclause (a) of this clause which has in any year not been allowed to any worker by his employer as paid sick leave may be claimed by the worker and subject to the conditions hereinbefore prescribed, shall be allowed by his employer in any subsequent year without diminution of the sick leave prescribed in respect of that year: Provided that sick leave which accumulates pursuant to this subclause shall be available to the worker for a period of three (3) years but no longer from the end of the year in which it accrues.

the end of the year in which it accrues. (e) Notwithstanding the provisions of subclause (c) hereof, a worker, who in any calendar year has already been allowed paid sick leave, shall not be entitled to payment for any further absence, unless he produces to the employer a medical certificate stating that he was unable to attend for duty on account of personal ill-health, if such certificate is demanded by the employer.

15.-Time and Wages Record.

A time record shall be kept by each employer in which shall be entered the name of each worker, the nature of the work he is doing, the hours worked each day, and the amount of wages received by him each week; the said record shall be open to the inspection of the accredited representative of the Union at any time during the ordinary office hours and he shall be allowed to take necessary extracts therefrom.

16.-Meal Allowance.

Where a worker, without being notified on the previous day is required to continue working after the usual knock-off time for more than one (1) hour, or (in the case of a day worker) after 5.30 p.m., he shall be provided with any meal required, or shall be paid three shillings and sixpence (3s. 6d.) in lieu thereof. Provided that this clause shall not apply to a worker who can conveniently return home for a meal.

17.-Posting of Award.

The employer shall keep any copy of the Award supplied by the Union posted in a conspicuous place in the engine room.

18.---Maximum Rate.

Notwithstanding anything contained elsewhere in this Award, no time of duty shall be required to be paid for at more than double time rate.

19.-Breakdowns.

The employer shall be entitled to deduct payment for any day or portion of a day upon which the worker cannot be usefully employed because of any strike by the Union or Unions affiliated with it, or by any other Association or Union or through the breakdown of the employer's machinery or any stoppage of work by any cause which the employer cannot reasonably prevent.

20.-Board of Reference.

(a) The Court hereby appoints, for the purpose of this Award, a Board of Reference.

(b) The Board shall consist of a chairman, and two (2) other representatives, one (1) to be nominated by each of the parties.

(c) There are assigned to such Board in the event of no agreement being arrived at between the parties to this Award the functions of:—

- (i) adjusting any matters of difference which may arise between the parties from time to time except such as involve interpretations of the provisions of the award or any of them;
- (ii) deciding any other matter that the Court may refer to the Board from time to time.

(d) The provisions of regulation 92 of the Industrial Arbitration Act, 1912-1952, shall be deemed to apply to any Board of Reference appointed hereunder.

21.-Long Service Leave.

(a) Right to Leave.

A worker shall as herein provided be entitled to leave with pay in respect of long service.

(b) Long Service.

(1) The Long Service which shall entitle a worker to such leave shall, subject as herein provided, be continuous service with one and the same employer.

(2) Such service shall include service prior to the coming into operation hereof if it continued until such time but only to the extent of the last 20 completed years of continuous service.

(3) (i) Where a business has, whether before or after the coming into operation hereof, been transmitted from an employer (herein called "the transmittor") to another employer (herein called "the transmittee") and a worker who at the time of such transmission was an employee of the transmittor in that business becomes an employee of the transmittee—the period of the continuous service which the worker has had with the transmittor (including any such service with any prior transmittor) shall be deemed to be service of the worker with the transmittee.

(ii) In this subclause "transmission" includes transfer, conveyance, assignment or succession whether voluntary or by agreement or by operation of law and "transmitted" has a corresponding meaning.

(4) Such service shall include-

- (a) Any period of absence from duty on any annual leave or long service leave.
- (b) Any period of absence from duty necessitated by sickness of or injury to the worker but only to the extent of fifteen working days in any year of his employment.
- (c) Any period following any termination of the employment by the employer if such termination has been made merely with the intention of avoiding obligations hereunder in respect of long service leave or obligations under any award in respect of annual leave.
- (d) Any period during which the service of the worker was or is interrupted by service—
 - (i) as a member of the Naval, Military or Air Forces of the Commonwealth of Australia other than as a member of the British Commonwealth Occupation Forces in Japan and other than as a member of the Permanent Forces of the Commonwealth of Australia except in the circumstances referred to in section 31 (2) of the Defence Act, 1903-1956. and except in Korea or Malaya after June 26, 1950;
 - (ii) as a member of the Civil Construction Corps established under the National Security Act. 1939-1946;
 - (iii) in any of the Armed Forces under the National Service Act, 1951 (as amended).

Provided that the worker as soon as reasonably practicable on the completion of any such service resumed or resumes employment with the employer by whom he was employed immediately before the commencement of such service.

(5) Service shall be deemed to be continuous notwithstanding—

- (a) the transmission of a business as referred to in paragraph (3) hereof;
- (b) any interruption of a class referred to in paragraph (4) hereof irrespective of the duration thereof;
- (c) any absence from duty authorised by the employer;
- (d) any standing-down of a worker in accordance with the provisions of an Award, Industrial Agreement, Order or Determination under either Commonwealth or State law;
- (e) any absence from duty arising directly or indirectly from an industrial dispute if the worker returns to work in accordance with the terms of setlement of the dispute;

- (f) any termination of the employment by the employer on any ground other than slackness of trade if the worker be re-employed by the same employer within a period not exceeding two months from the date of such termination;
- (g) any termination of the employment by the employer on the ground of slackness of trade if the worker is re-employed by the same employer within a period not exceeding six months from the date of such termination;
- (h) any reasonable absence of the worker on legitimate union business in respect of which he has requested and been refused leave;
- (i) any absence from duty after the coming into operation of this clause by reason of any cause not specified in this clause unless the employer during the absence or within fourteen days of the termination of the absence notifies the worker in writing that such absence will be regarded as having broken the continuity of service, which notice may be given by delivery to the worker personally or by posting it by registered mail to his last recorded address, in which case it shall be deemed to have reached him in due course of post

Provided that the period of any absence from duty or the period of any interruption referred to in placita (c) to (i) inclusive of this paragraph shall not (except as set out in paragraph (4) hereof) count as service.

(c) Period of Leave.

(1) The leave to which a worker shall be entitled or deemed to be entitled shall be as provided in this subclause.

(2) Where a worker has completed at least 20 years' service the amount of leave shall be—

- (a) in respect of 20 years' service so completed—13 weeks' leave.
- (b) in respect of each 10 years' service completed after such 20 years—six and a half weeks' leave.

(3) Where a worker has completed at least 15 years' service since its commencement and his employment is terminated—

- (a) by his death;
- (b) in any circumstances otherwise than by the employer for serious misconduct;

the amount of leave shall be-

- (i) if such determination takes place before the worker has become entitled to leave under placitum (a) of paragraph (2) hereof such proportion of 13 weeks' leave as the number of completed years of such service bears to 20 years;
- (ii) if such termination takes place after the worker has become entitled to leave under placitum (a) of paragraph (2) hereof the leave due under such placitum and in addition such proportion of 13 weeks' leave as the number of completed years of such service after the accrual of such entitlement bears to 20 years.

(4) Where a worker has completed at least 10 years' service but less than 15 years' service since its commencement and his employment is terminated—

- (i) by his death; or
- (ii) by the employer for any reason other than serious misconduct; or
- (iii) by the worker on account of sickness of or injury to the worker or domestic or other pressing necessity where such sickness or injury or necessity is of such a nature as to justify or in the event of a dispute is, in the opinion of the Special Board of Reference, of such a nature as to justify such termination;

the amount of the leave shall be such proportion of 13 weeks' leave as the number of completed years of such service bears to 20 years. (5) In the cases to which paragraphs (3) and (4) hereof apply the worker shall be deemed to have been entitled to and to have commenced leave immediately prior to such termination.

(d) Payment for Period of Leave.

(1) A worker shall subject to paragraph (3) hereof, be entitled to be paid for each week of leave to which he has become entitled or is deemed to have become entitled the ordinary time rate of pay applicable to him at the date he commences such leave;

(2) Such ordinary time rate of pay shall be the rate applicable to him for the standard weekly hours which are prescribed by this Award (or agreement), but in the case of casuals and parttime workers shall be the ordinary time rate for the number of hours usually worked up to but not exceeding the prescribed standard;

(3) Where by agreement between the employer and the worker the commencement of the leave to which the worker is entitled or any portion thereof is postponed to meet the convenience of the worker, the rate of payment for such leave shall be at the ordinary time rate of pay applicable to him at the date of accrual or, if so agreed, at the ordinary time rate of pay applicable at the date he commences such leave;

(4) The ordinary time rate of pay-

- (a) shall include any deductions from wages for board and/or lodging or the like which is not provided and taken during the period of leave;
- (b) shall not include shift premiums, overtime, penalty rates, commissions, bonuses, allowances or the like.

(5) In the case of workers employed on piece or bonus work or any other system of payment by results payment shall be at ordinary time rates.

(e) Taking Leave.

(1) In a case to which paragraph (2) of subclause (c) applies—

- (a) Leave shall be granted and taken as soon as reasonably practicable after the right thereto accrues due or at such time or times as may be agreed between the employer and the worker or in the absence of such agreement at such time or times as may be determined by the Special Board of Reference, having regard to the needs of the employer's establishment and the worker's circumstances.
- (b) Except where the time for taking leave is agreed to by the employer and the worker or determined by the Special Board of Reference the employer shall give to a worker at least one month's notice of the date from which his leave is to be taken.
- (c) Leave may be granted and taken in one continuous period or if the employer and the worker so agree in not more than three separate periods in respect of the first 13 weeks' entitlement and in not more than two separate periods in respect of any subsequent period of entitlement.
- (d) Any leave shall be inclusive of any public holidays specified in this Award (or agreement) occurring during the period when the leave is taken but shall not be inclusive of any annual leave.
- (e) Payment shall be made in one of the following ways-
 - (i) in full before the worker goes on leave;
 - (ii) at the same time as his wages would have been paid to him if the worker had remained at work, in which case payment shall, if the worker in writing so requires, be made by cheque posted to an address specified by the worker; or
 - (iii) in any other way agreed between the employer and the worker.

(f) No worker shall, during any period when he is on leave, engage in any employment for hire or reward in substitution for the employment from which he is on leave, and if a worker breaches this provision he shall thereupon forfeit his right to leave hereunder in respect of the unexpired period of leave upon which he has entered, and the employer shall be entitled to withhold any further payment in respect of the period and to reclaim any payments already made on account of such period of leave.

(2) In a case to which paragraph (3) or paragraph (4) of subclause (c) applies and in any case in which the employment of the worker who has become entitled to leave hereunder is terminated before such leave is taken or fully taken the employer shall, upon termination of his employment otherwise than by death pay to the worker, and upon termination of employment by death pay to the personal representative of the worker upon request by the personal representative, a sum equivalent to the amount which would have been payable in respect of the period of leave to which he is entitled or deemed to have been entitled and which would have been taken but for such termination. Such payment shall be deemed to have satisfied the obligation of the employer in respect of leave hereunder

(f) Granting Leave in Advance and Benefits to be Brought into Account.

(1) Any employer may by agreement with a worker allow leave to such a worker before the right thereto has accrued due, but where leave is taken in such a case the worker shall not become entitled to any further leave hereunder in respect of any period until after the expiration of the period in respect of which such leave had been taken before it accrued due.

(2) Where leave has been granted to a worker pursuant to the preceding paragraph before the right thereto has accrued due, and the employment subsequently is terminated, the employer may deduct from whatever remuneration is payable upon the termination of the employment a proportionate amount on the basis of 13 weeks for twenty years' service in respect of any period for which the worker has been granted long service leave to which he was not at the date of termination of his employment or prior thereto entitled.

(3) Any leave in the nature of long service leave or payment in lieu thereof under a State law or a long service leave scheme not under the provisions hereof granted to a worker by his employer in respect of any period of service with the employer shall be taken into account whether the same is granted before or after the coming into operation hereof and shall be deemed to have been leave taken and granted hereunder in the case of leave with pay to the extent of the period of such leave and in the case of payment in lieu thereof to the extent of a period of leave with pay equivalent to the amount of the payment and to be satisfaction to the extent thereof of the entitlement of the worker hereunder.

(4) An employer shall be entitled to offset any payment in respect of leave hereunder against any payment by him to any long service leave scheme, superannuation scheme, pension scheme, retiring allowance scheme, provident fund, or the like or under any combination thereof operative at the first day of April, 1958.

(g) Records to be Kept.

(1) Each employer shall during the employment and for a period of 12 months thereafter, or in the case of termination by death of the worker a period of three years thereafter, keep a record from which can be readily ascertained the name of each worker and his occupation, the date of the commencement of his employment and his entitlement to long service leave and any leave which may have been granted to him or in respect of which payment may have been made hereunder.

(2) Such record shall be open for inspection in the manner and circumstances prescribed by this award (or agreement) with respect to the time and wages record.

(h) Special Board of Reference.

(1) There shall be constituted a Special Board of Reference for the purpose hereof to which all disputes and matters arising hereunder shall be referred and the Board shall determine all such disputes and matters.

(2) There shall be assigned to such Board the functions of-

- (a) the settlement of disputes on any matters arising hereunder;
- (b) the determination of such matters as are specifically assigned to it hereunder.

(3) The Board of Reference shall consist of one representative or substitute therefore nominated from time to time by the Western Australian Em-ployers' Federation (Incorporated) and one repre-sentative or substitute nominated from time to time by the West Australian Trade Unions Indus-trial Council (A.L.P.) together with a chairman to be mutually agreed upon by the organisations named in this paragraph.

(i) State Law.

(1) The provisions of any State law to the extent to which they have before the coming into operato which they have before the coming into opera-tion hereof conferred an accrued right on a worker to be granted a period of long service leave in respect of a completed period of 20 or more years' service or employment or an accrued right on a worker or his personal representative to payment in respect of long service leave shall not be affected beacher and other works and the service leave shall not be affected with the provisions hereof.

(2) The entitlement of any such worker to leave in respect of a period of service with the employer completed after the period in respect of which the long service leave referred to in paragraph (1) hereof accrued due shall be in accordance herewith.

(3) Subject to paragraphs (1) and (2) hereof, the entitlement to leave hereunder shall be in substitution for and satisfaction of any long ser-vice leave to which the worker may be entitled in respect of employment of the worker by the employer.

(4) An employer who under any State law with regard to long service leave is exempted from the provisions of that law as at the first day of April, 1958, shall in respect of the workers covered by such exemption be exempt from the provisions hereof.

(j) Exemptions.

The Special Board of Reference may subject to such conditions as it thinks fit exempt any employer from the provisions hereof in respect of its em-ployees where there is an existing or prospective long service leave scheme which, in its opinion is, viewed as a whole, more favourable for the whole of the employees of that employer than the provisions hereof.

(k) Liberty to Apply.

(1) Liberty is granted to any party to this Award to apply to the Court at any time for an appro-priate variation of this clause if any of the terms and conditions operating under the code of Long Service Leave being negotiated between the Aus-tralian Council of Trade Unions and Federal Em-ployers' Organisations is varied in any way.

(2) Liberty is reserved to either party to apply to amend in respect to the date of operation of this clause.

Faulds on behalf of Fremantle Harbour Trust Commissioners, I, the under-signed, Conciliation Commissioner of the Court of Arbitration, in pursuance of a remission to me by the said Court and in pursuance of the powers contained in Section 92 of the Industrial Arbi-tration Act, 1912-1952, do hereby order and de-clare that Award No. 7A of 1956 be and the same is hereby amended in the following manner.

Clause 3—Area and Scope.—Delete this clause and insert in lieu:—

3.—Area and Scope.

3.—Area and Scope. This Award shall apply to permanent ship painters and dockers employed by the Minis-ter for Works on the North and South slip-ways, the Minister for the North-West in re-spect of workers employed in the State Ship-ping Service Maintenance Workshop and on State vessels and in respect of workers em-ployed in the Harbour and Light Workshop and by the Fremantle Harbour Trust Com-missioners missioners.

Provided that this Award shall not apply to workers covered by any other Award or Industrial Agreement of the State Arbitration Court.

Clause 6.-Work During Meal Hours.-Delete this clause and insert in lieu:-

6.-Work During Meal Hours.

So far as is possible and expedient, work shall not be performed during prescribed meal times. If, however, workers are required to work during prescribed meal times, the fol-lowing rates of pay shall apply and continue to apply until the worker is knocked off for the full period for a meal:— Breakfort Time and a helt

Breakfast-Two and a half times the ordinary rate.

Dinner—Double ordinary rates. Tea—Double ordinary rates Supper—Two and a half times the ordinary rate.

Saturdays, Sundays and Holidays.—When work is required to be done through any meal time payment at the ordinary rate additional to the payment for that day.

Clause 7-Meal Money.-Delete this clause and insert in lieu:-

7.-Meal Money.

(a) Workers required to work overtime in excess of two (2) hours, unless the necessary meals are provided by the employer, shall, not less than three (3) hours before the com-mencement of work on the day upon which such overtime is to be worked, be given notice of the employer's intention to work overtime. If such notice is not given, or if the overtime of which notice has been given is not worked, each worker concerned shall be paid five shilleach worker concerned shall be paid five shill-ings (5s.) for each meal occurring in such overtime hours.

If the amount of overtime required to be worked necessitates a second or subsequent meal, the employer shall, unless he has noti-fied the workers concerned not less than three (3) hours before the commencement of work on the day the overtime is to be worked that such second or subsequent meal will also be re-quired, provide such meals or pay an amount of three shillings and four pence (3s. 4d.) for each such second or subsequent meal.

Workers working in the stream shall also, in their own time, if adequate meals are not provided, be provided with transport to and from the ferry landing.

(b) When workers are ordered in to dock or shift a vessel at 7 a.m. they shall not be entitled to a break for a meal before noon, but if they are ordered in at any time before 7 a.m. they shall have an hour for breakfast not later than 8 a.m.

Clause 9-Rates of Pay.-Add the following to this clause:

Liberty is reserved to all parties to apply to amend this clause at any time.

-Delete subclauses (a) Clause 10--Special Rates.and (b) of this clause and insert in lieu:-

(a) (i) Work in bilges, fuel or oil tanks, molasses tanks, or sanitary tanks—1s. 6d. per hour.

(ii) Work in smokeboxes, boilers, bunkers, furnaces, uptakes, inside the casing of internal combustion engines, under boilers or under tunnels—1s. 6d. per hour.

(b) (i) Work in peaks, ballast tanks, fresh water tanks, air tight compartments, refrigerating chambers when at a temperature of 32°F. or less, between boilers and ship's side, in tunnels except that portion of a tunnel used as a workshop, limbers, chain lockers, coffer dams, caissons or in any compartment or space, access to which is through a manhole or similar opening including work on stokehold or engine room tank tops-1s. 0d. per hour.

(ii) Carrying ashes on ships, removing comor repairing insulation—1s. 0d. per hour.

Clause 13-Overtime .-- Delete this clause and insert in lieu:-

13.—Overtime.

(a) (i) Except as prescribed in paragraph (ii) of this subclause and clause 14 of this Award, overtime shall mean all time worked before or after the usual starting or finishing time of the day and shall be paid for at the rate of time and one half for the first four (4) hours and double time thereafter, such double time to continue until the completion of the work.

(ii) A worker required to commence work at or after midnight and before 7.0 a.m. on any day other than a Sunday shall be paid at the rate of double time from the time of actual commencement until 7.0 a.m. and thereafter at overtime rates or ordinary rates in accordance with paragraph (i) of this subclause and clause 4 of this Award.

(b) Broken time. In the calculation of any working time, any portion of a half hour shall be paid as for a half hour.

Clause 14—Saturday and Sunday Work.—Delete this clause and insert in lieu:—

14 .- Saturday and Sunday Work.

14.—Saturday and Sunday Work. (a) Except as prescribed in paragraph (ii) of subclause (a) of clause 13, time worked on a Saturday shall be paid for at the rate of time and one half for the first two (2) hours and thereafter at the rate of double time. Except for the purpose of completing a job and then only for a limit of two (2) hours, no work shall be performed between noon on Saturday and midnight on Saturday, unless expressly required to work in conjunction with tradesmen, as crane attendants, or to clear a ship. ship.

(b) All work done on Sunday shall be paid at the rate of double time.

Clause 15-Rest Periods.-Delete this clause and insert in lieu:-

15.—Rest Periods.

(a) Subject to a period of at least sixty minutes total of actual work prior to the time mentioned and that the period calculated from

the actual time of commencement or on resumption of work after any meal break to the next meal break or anticipated time of cessation of work is at least three (3) hours-

10.0 a.m. to 10.15 a.m.; 3.0 p.m. to 3.15 p.m.; 8.0 p.m. to 8.15 p.m.; 10.0 p.m. to 10.15 p.m.; 3.0 a.m. to 3.15 a.m.; 5.0 a.m. to 5.15 a.m.

Provided that where the worker is to continue working without a meal hour break until 5.0 p.m. or 8.0 p.m. a rest period to be given between 5.0 p.m. and 5.20 p.m.

(b) In lieu of the foregoing workers em-ployed by the Fremantle Harbour Trust Com-missioners shall be granted rest periods in accordance with the following provisions:---

(i) Subject to the provisions hereinafter contained, a rest period of seven (7) minutes from the time of ceasing to the time of resumption of work shall be allowed each morning.

This interval shall be counted as time off duty without deduction of pay and shall be arranged at a time and in a manner to suit the convenience of the employer. Morning tea may be taken by workers during this in-terval but the period of seven (7) minutes shall not be exceeded under any circumstances. Upon proof of breach by a worker of any provision hereinbefore expressed or implied, the Court may grant the employer con-cerned exemption from liability to allow the rest period aforesaid.

- (ii) Workers engaged on essential emergency work or on some process in course (e.g. concreting) may be required to take the prescribed tea break at such time and in such a manner as considered necessary by the officer in charge of the job, or in his absence, by the foreman.
- (iii) Liberty is reserved to all parties to apply to amend this provision.
