Land Act, 1933-1958.

Corr. No. 2149/59.—That reserve No. 25405 should vest in and be held by the Carnarvon Municipal Council in trust for the purpose of a Hall Site.

Corr. No. 326/58.—That reserve No. 25408 should vest in and be held by the Minister for Works in trust for the purpose of Government Requirements (P.W.D. Quarters).

Corr. No. 2309/59.—That reserve No. 25411 should vest in and be held by the Gnowangerup Road Board in trust for the purpose of Road Board Requirements.

Now, therefore, His Excellency the Governor, by and with the advice and consent of the Executive Council, doth hereby direct that the beforementioned reserves shall vest in and be held by the abovementioned bodies in trust for the purposes aforesaid, subject nevertheless to the powers reserved to him by section 37 of the said Act.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956.

Metropolitan Main Drainage District No. 1.
South Belmont Extension.

ORDER IN COUNCIL.

M.W.S. 1335/57.

WHEREAS by section 7 (a) of the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956, it is provided that the Governor may, by Order in Council, alter or extend the boundaries of the Metropolitan Water, Sewerage and Drainage Area, or of any district, or Metropolitan Main Drainage District; and whereas it is desirable that the boundaries of Metropolitan Main Drainage District No. 1 as at present defined should be altered: Now, therefore I, the Governor, acting by and with the advice of the Executive Council, do hereby extend the boundaries of Metropolitan Main Drainage District No. 1 and declare that the said boundaries, as shown on Plan M.W.S.S. & D.D., W.A. No. 7087, and as described in Order in Council of 19th June, 1957, shall be extended in the following manner by adding the area described in the Schedule hereunder and including it in Metropolitan Main Drainage District No. 1.

Schedule.

All that portion of land, bounded by lines commencing at the intersection of Cleaver Terrace and Belmont Avenue, Belmont, and proceeding in a south-easterly direction along the centre of Belmont Avenue to the north-western boundary of lot 29, Belmont Avenue; thence north-easterly along the north-western boundaries of the said lot 29 and lot 26, Robinson Avenue, to the centre of Robinson Avenue; thence south-easterly along the centre of Robinson Avenue and onwards across Francisco Street, to the prolongation of the north-western boundary of lot 124, Robinson Avenue;

thence proceeding along the north-western boundary of the said lot 124 and south-easterly along the north-eastern boundaries of lots 124, 125 and partially along lot 126, Robinson Avenue, to the western corner of lot 144, Faulkner Avenue; thence north-easterly along the north-western boundaries of lots 144, 143, 142, Faulkner Avenue; thence south-easterly along the north-eastern boundary of the said lot 142 to the centre of Faulkner Avenue; thence north-easterly along Faulkner Avenue to the centre of Abernethy Road; thence south-easterly along Abernethy Road to the prolongation of the north-western boundary of lot 261, Abernethy Road; thence north-easterly along the north-western boundary of the said lot 261 and south-easterly along the north-eastern boundaries of lots 261, 260, Abernethy Road, and a right-of-way adjoining lots 1 to 5 inclusive, Abernethy Road; thence proceeding south-westerly along the south-eastern boundary of the said lot 5 to the centre of Abernethy Road; thence north-westerly along Abernethy Road to the prolongation of the south-eastern boundary of lot 3, Abernethy Road; and south-westerly along the south-eastern boundaries of the said lot 3 and lot 9, Robinson Avenue, to the centre of Robinson Avenue; thence south-easterly along Robinson Avenue and across Esther Street to the intersection of Robinson Avenue and Alexander Street; thence proceeding north-easterly along the centre of Alexander Street to the intersection of Alexander Street and Abernethy Road; thence south-easterly along the centre of Abernethy Road to the intersection of Abernethy Road and Sydenham Street; thence proceeding north-easterly along the centre of Sydenham Street, Cloverdale, to the prolongation of the north-eastern boundary of lot 255, Sydenham Street; and south-easterly along the north-eastern boundary of the said lot 255 to the centre of Wright Street; thence south-westerly along Wright Street to and across Abernethy Road to the intersection of Wright Street and Robinson Avenue; thence north-westerly along the centre of Robinson Avenue to the intersection of Robinson Avenue and Elizabeth Street; thence south-westerly along the centre of Elizabeth Street, to and across Belmont Avenue to the prolongation of the north-eastern boundary of lot 33, Elizabeth Street, Kewdale; thence south-easterly along the north-eastern boundary of the said lot 33 and onwards along a right-of-way situated on the north-eastern boundary of lot 39, Ross Street; thence to and across Ross Street and along the north-eastern boundary of lot 65, Ross Street, and onwards along a right-of-way situated on the north-eastern boundary of lot 71, Laurie Street; thence to and across Laurie Street and along the north-eastern boundary of lot 97, Laurie Street, and onwards along a right-of-way situated on the north-eastern boundary of lot 103, Wright Street, to the centre of Wright Street; thence proceeding north-easterly along Wright Street to the intersection of Wright Street and Belmont Avenue, Cloverdale; thence proceeding south-easterly along the centre of Belmont Avenue to and across Fulham Street to the prolongation of the north-western boundary of lot 42, Belmont Avenue, and north-easterly along the north-western boundary of the said lot 42 to the centre of Robinson Avenue; thence south-easterly along Robinson Avenue to and across Gabriel Street to the prolongation of the south-eastern boundary of lot 2 of lot 47, Robinson Avenue, and south-westerly along the south-eastern boundary of the said lot 2 to the north-eastern boundary of a right-of-way; thence south-easterly along the north-eastern boundary of the said right-of-way and part of the north-eastern boundary of lot 4 of lot 47, Belmont Avenue; thence south-westerly along the south-eastern boundary of the said lot 4 to the centre of Belmont Avenue; thence south-easterly along Belmont Avenue to the intersection of Belmont Avenue and Keane Street; thence proceeding south-westerly along the centre of Keane Street, Kewdale, to the intersection of Keane Street and Dixon Avenue; thence south-easterly along Dixon Avenue to a right-of-way situated on the south-eastern boundary of lot 406, Keane Street; thence proceeding south-westerly along the said right-of-way to the intersection of the said right-of-way

and a right-of-way situated on the north-eastern boundary of lot 428, Arthur Street; thence proceeding south-easterly along the right-of-way to the prolongation of the south-eastern boundary of lot 424, Arthur Street; thence south-westerly along the south-eastern boundary of the said lot 424 to the centre of Arthur Street; thence south-easterly along Arthur Street to the prolongation of the south-eastern boundary of lot 376, Arthur Street, and south-westerly along the south-eastern boundary of the said lot 376 to a right-of-way; thence south-easterly along the right-of-way to the centre of Briggs Street; thence south-westerly along Briggs Street to the intersection of Briggs Street and Knutsford Avenue, and south-easterly along the centre of Knutsford Avenue to the prolongation of the south-eastern boundary of lot 8, Knutsford Avenue; thence south-westerly along the south-eastern boundary of the said lot 8 and the south-eastern boundary of lot 22, Peachey Avenue, to the centre of Peachey Avenue; thence north-westerly along Peachey Avenue to the prolongation of the south-eastern boundary of lot 37, Peachey Avenue; thence south-westerly along the south-eastern boundary of the said lot 37 and the south-eastern boundary of lot 53, Acton Avenue, to the centre of Acton Avenue; thence north-westerly to the intersection of Acton Avenue and Briggs Street; thence south-westerly along the centre of Briggs Street to the prolongation of the north-eastern boundary of lot 316, Briggs Street, and south-easterly along the north-eastern boundary of the said lot 316; thence south-westerly along the south-eastern boundary of the said lot 316; thence south-easterly along the north-eastern boundary of lot 312, President Street, to and across President Street and along the north-eastern boundary of lot 294, President Street, and along the north-eastern boundary of lot 4, Kew Street, to the centre of Kew Street; thence south-westerly along Kew Street to the intersection of Kew Street and Paterson Road; thence north-westerly along the centre of Paterson Road to the prolongation of the south-eastern boundary of lot 264, Paterson Road, and south-westerly along the south-eastern boundary of the said lot 264 and along the south-eastern boundaries of lots 277, 276 and 275, President Street, and through the centre of lot 69, Surrey Road, to and across Surrey Road and along the south-eastern boundaries of part lot 274 and lots 273, 272, President Street, to the centre of Hillcrest Road; thence north-westerly along Hillcrest Road to the intersection of Hillcrest Road and President Street and south-westerly along the centre of President Street to the intersection of President Street and Orrong Road; thence north-westerly along the centre of Orrong Road, to and across Briggs Street, to and across Cohn Street to the prolongation of the north-western boundary of lot 36, Orrong Road; thence north-easterly along the north-western boundaries of the said lot 36 and lot 30, Hockin Place, to the centre of Hockin Place; thence south-easterly along Hockin Place to the prolongation of the north-western boundary of lot 26, Hockin Place; thence north-easterly along the north-western boundaries of the said lot 26 and lot 25, Cohn Street; thence north-westerly along the south-western boundary of lot 14, Cohn Street, and north-easterly along the north-western boundaries of the said lot 14 and lots 15 and 16, Cohn Street, to the centre of Surrey Road; thence north-westerly along Surrey Road to the intersection of Surrey Road and Oats Street, and north-easterly along the centre of Oats Street to the intersection of Oats Street and Paterson Road; thence north-westerly along the centre of Paterson Road to the prolongation of the north-western boundary of lot 12, Paterson Road, and north-easterly along the north-western boundaries of the said lot 12, and lots 9 and 8, Oats Street, and lot 5, Armadale Road, to the centre of Armadale Road; thence proceeding north-westerly along the centre of Armadale Road, to and across Fulham Street to the intersection of Armadale Road and Wright Street; thence south-westerly along the centre of Wright Street to the intersection of Wright Street and Kooyong Road; thence proceeding north-westerly along the centre of Kooyong Road to the intersection of Kooyong Road and Sydenham Street and

south-westerly along the centre of Sydenham Street to the intersection of Sydenham Street and Surrey Road; thence north-westerly along the centre of Surrey Road, Rivervale, to the prolongation of the north-western boundary of lot 1, Surrey Road, and north-easterly along the north-western boundary of the said lot 1; thence north-westerly along part of the south-western boundary of lot 8, Sydenham Street; thence north-easterly along the north-western boundary of the said lot 8 to the western corner of lot 1228, Sydenham Street, and north-westerly along the centre of a right-of-way and along the south-western boundaries of lots 4 and 3, Kooyong Road, and the south-western boundary of a right-of-way; thence north-easterly along part of the north-western boundary of lot 13, Kooyong Road; thence north-westerly along the south-western boundary of lot 1237, Alexander Street, to and across Alexander Street and along the south-western boundaries of lot 9, Alexander Street, and lots 7 and 8, Kooyong Road; thence south-westerly along part of the south-eastern boundary of lot 1245, Kooyong Road, and north-westerly along the south-western boundary of the said lot 1245 and a right-of-way, to the prolongation of the north-western boundary of lot 18, Kooyong Road; thence north-easterly along part of the north-western boundary of the said lot 18 and north-westerly along the south-western boundaries of lots 2 and 1, Kooyong Road, to the centre of Roberts Road; thence north-easterly along the centre of Roberts Road to and across Kooyong road to the intersection of Roberts Road and Fitzroy Road; thence north-westerly along the centre of Fitzroy Road to the prolongation of the north-western boundary of lot 165, Fitzroy Road; thence north-easterly along the north-western boundary of the said lot 165 and north-westerly along the south-western boundary of lot 155, Armadale Road, and north-easterly along the north-western boundary of the said lot 155 to the centre of Armadale Road; thence north-westerly along the centre of Armadale Road to the prolongation of the north-western boundary of lot 87, Armadale Road, and north-easterly along the north-western boundary of the said lot 87 and north-westerly along the south-western boundaries of lots 107 and 108, Toorak Road, and north-easterly along the north-western boundary of the said lot 108 to the centre of Toorak Road; thence north-westerly along the centre of Toorak Road to the intersection of Toorak Road and Campbell Street; thence north-easterly along the centre of Campbell Street to the prolongation of the south-western boundary of lot 99, St. Kilda Road; thence north-westerly along the south-western boundaries of lots 99 to 104, inclusive, St. Kilda Road, and north-easterly along the north-western boundary of the said lot 104 to the centre of St. Kilda Road; thence north-westerly along St. Kilda Road to the prolongation of the north-western boundary of lot 7, St. Kilda Road, and north-easterly along the north-western boundary of the said lot 7, and north-westerly along the south-western boundaries of lots 71 to 76, inclusive, Acton Avenue, to the centre of Francisco Street; thence north-easterly along Francisco Street to the intersection of Francisco Street and Acton Avenue; thence north-westerly along the centre of Acton Avenue to the prolongation of the north-western boundary of lot 15, Acton Avenue; thence north-easterly along the north-western boundary of the said lot 15 and north-westerly along the south-western boundaries of lots 23 and 24, Martin Avenue, and north-easterly along the north-western boundary of the said lot 24 to the centre of Martin Avenue; thence north-westerly along Martin Avenue to the prolongation of the north-western boundary of lot 78, Martin Avenue, and north-easterly along the north-western boundary of the said lot 78, and north-westerly along the south-western boundary of lot 50, Cleaver Terrace, to the centre of Cleaver Terrace; thence north-easterly along Cleaver Terrace to the point of commencement, as shown in colour on Plan M.W.S.S. & D.D., W.A. No. 7087.

Bunbury Water Board—Proposed Loan of £9,000.

ORDER IN COUNCIL.

P.W.W.S. 317/53.

WHEREAS by the Water Boards Act, 1904-1954, a water board may, with the approval of the Governor, borrow money for the construction of works for the storage, distribution and supply of water: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, hereby approves, under the provisions of section 113 of the Water Boards Act, 1904-1954, of the Bunbury Water Board borrowing the sum of nine thousand pounds (£9,000) from the Bank of New South Wales, and repayable with interest by thirty (30) equal half-yearly instalments over a period of fifteen (15) years with interest at the rate of five pounds ten shillings (£5 10s.) per annum for the purpose of financing the works referred to on Bunbury Water Board Plan No. 131 and approved by Order in Council dated the 22nd day of July, 1959, and published in the *Government Gazette* on the 31st day of July, 1959, subject to the said work being commenced not later than the 1st day of February, 1960.
