# Coal Mining Industry Long Service Leave Act, 1950-1951.

#### PROCLAMATION

WESTERN AUSTRALIA, TO WIT, CHARLES HENRY GAIRONER, Governor. IL.S.J By His Excellency Lieutenant-General Sir Charles Henry Gairdner, Knight Commander of the Most torian Order, Companion of the Most Honour-able Order of the Bath, Commander of the Most Excellent Order of the British Empire, Governor in and over the State of Western Australia and ts Dependencies in the Commonwealth of Australia.

WHEREAS it is enacted by section 2 subsection (1) of the Coal Mining Industry Long Service Leave Act, 1950-1951, that the interpretation of "award" includes, *inter alia*, such awards, varia-tions of awards and orders made and interpreta-tions given on or after the 18th day of April, 1951, as are declared by Proclamation to be included within the interpretation: Now, therefore I, the Governor acting with the advice and consent of the Executive Council do hereby declare and pro-claim the following awards shall be included in the interpretation of "award" under the said Act:—

At a meeting of the Executive Council held in the Executive Council Chamber, at Perth, on the 13th day of April, 1960, the following Orders in Council were authorised to be issued:—

# Fire Brigades Act, 1942-1959.

## ORDER IN COUNCIL.

WHEREAS it is enacted, *inter alia*, by subsection (2) of section 5 of the Fire Brigades Act, 1942-1959, that for the purposes of the Act the Governor may from time to time, by Order in Council, constitute as a fire district any portion of a district of a local authority which after the coming into operation of the Fire Brigades Act Amendment Act, 1959, is not a fire district, assign a name to a fire district, and include the name of a fire district in Part IV of the Second Schedule to the Act: Now, therefore, His Excellency the Governor, acting with the advice and consent of the Executive Council doth hereby

- (a) constitute that portion of the Road Dis-trict of Harvey more particularly de-scribed in the schedule hereunder a fire district;
- (b) assign the name of Brunswick Junction Fire District to that district; and
- (c) include in column one of Part IV of the Second Schedule to the Act "Brunswick Junction Fire District" and in column two opposite Brunswick Junction Fire District, "Road District of Harvey".

#### Schedule.

All that portion of land bounded by lines starting from the intersection of the western side of the South-Western Highway and the left bank of the Brunswick River and extending generally easterly along that bank to the western side of

the South-Western Railway; thence south-southwesterly along that side to a point situate in prolongation north-westerly of the north-eastern boundary of lot 1 of Wellington Location 1 as shown on Land Titles Office Deposited Diagram 575; thence south-easterly and southerly to and along boundaries of that lot to the northern side of Clifton Road; thence north-easterly along that side to a point situate in prolongation northerly of the eastern side of Brunswick Road (road numof the eastern side of Brunswick Road Groad num-ber 5331); thence southerly along that prolonga-tion to the southern side of Clifton Road afore-said; thence generally north-easterly along that side to the northern corner of lot 167 of location 1 as shown on Land Titles Office Deposited Plan 3020; thence southerly along eastern boundaries of that lot and of lot 166 to the southern corner of the last mentioned lot: thence southerly to and of the last-mentioned lot; thence southerly to and along the easern side of Atkins Street to the northeastern corner of lot 60 of location 1 as shown on Land Titles Office Deposited Plan 6912; thence southerly, easterly, again southerly and westerly along boundaries of that lot to its south-western corner; thence westerly along the southerwestern side of Reading Street and onwards to the western side of the South-Western Highway aforesaid; thence northerly along that side to a southern boundary of part of lot 2 of location 1 as shown on Land Titles Office Deposited Diagram 10200; thence west-north-westerly and north-westerly along bound-aries of that portion of that lot to the southern corner of lot 5 of location 1 as shown on Land Titles Office Deposited Diagram 10276; thence north-westerly, north-north-easterly and east-southeasterly along boundaries of that lot to the western side of the South-Western Highway aforesaid; thence northerly along that side to the south-east-ern corner of lot 123 of location 1 as shown on Land Titles Office Deposited Plan 2660; thence southwesterly along the southern boundary of that lot and onwards to and along the southern boundary of lot 10 of location 1 as shown on Land Titles Office Deposited Diagram 14162, to a point situate 2 chains 75 and nine-tenths links westerly from the south-eastern corner of that lot; thence 13 degrees 49 minutes, 10 chains 97 and six-tenths links; thence 283 degrees 51 minutes, 4 chains; thence 13 degrees 49 minutes, 2 chains 50 links to the southern side of road number 5338; thence westerly along that side to the south contarn side the southern side of road number 5338; thence westerly along that side to the south-eastern side of Clifton Road aforesaid; thence 338 degrees 57 minutes to the north-western side of that road; thence generally north-easterly along that side to the western side of Shines Crescent; thence north-easterly along that side to the western boundary of lot 25 of location 1 as shown on Land Titles Office Deposited Diagram 104: thence north-Titles Office Deposited Diagram 104; thence northerly along that boundary to the left bank of the Brunswick River aforesaid; and thence generally easterly upwards along that bank to the starting point.

Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956.

#### ORDER IN COUNCIL.

M.W.S. 1646/59.

WHEREAS by the Metropolitan Water Supply, Sewerage and Drainage Act, 1909-1956, it is provided that, subject to the provisions of the Act, the Minister of Water Supply, Sewerage and Drainage shall, with the approval of the Governor, have power to construct, provide and extend Water Works, Sewerage Works and Metropolitan Main Drainage Works; and whereas the preliminary requirements of the said Act have been complied with, and plans, sections, and estimates in respect of the works hereinafter mentioned have been submitted to and approved by the Governor-in-Council: Now, therefore, His Excellency the Governor, with the advice and consent of the Executive Council, does hereby empower the Minister for Water Supply, Sewerage and Drainage to undertake the construction of the following works under the said Act, namely:—

Metropolitan Sewerage.

- (a) Two Effluent Pumping Stations, and
- (b) a 42-inch diameter Reinforced Concrete and Steel Pipe Outfall, together with all other apparatus connected therewith.

This Order in Council shall take effect from the 22nd day of April, 1960.
